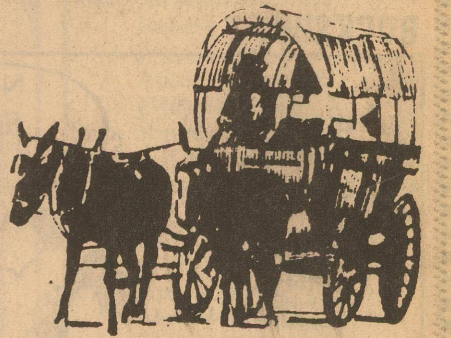

Ag. Commissioner Espy Resigns

Washington, D.C.

Following weeks of speculation, U. S. Agriculture Commissioner Mike Espy resigned Monday. Espy has been accused of accepting "inappropriate gifts" from persons and companies who do business with his department. In a public statement, Espy denied any wrong doing, claiming his resignation was prompted by his inability to do his job while being forced to defend himself against the mounting allegations.

President Clinton, who just two days earlier had given Espy his full support, accepted the resignation stating that Espy "had done a good job". A White House spokesman announced that no successor had been chosen and that a search was underway to find a replacement.

U.S. Troops seize weapons from Haitian military

Port-au-Prince, Haiti

U.S. troops this week began disarming the Haitian military in preparation for the return of exiled Haitian President Jean Bertrand Aristide. In a quick response to the wounding of a U.S. soldier on Monday, American military personnel carried out a raid on the headquarters of the Front for the Advancement and Progress of Haiti FRAPH. The U.S. troops seized weapons and arrested more than 30 people.

In a related story, U.S. Secretary of Defense William Perry announced this week that the first contingent of Marines will be leaving Haiti in the near future. The troops will be replaced by Military Police.

Ferry Sinks In Baltic Sea

Turku, Finland

The Finnish ferry Estonia sank last week in the Baltic Sea claiming the lives of all 900+ on board. The tragedy, one of the worst in maritime history came as the ferry attempted a crossing during a heavy storm. The first distress signals were received here only minutes before the ferry reportedly sank.

All attempts at rescue failed and authorities quickly shifted their efforts to trying to discover the cause of the wreck. Early this week, a robotic diver equipped with a camera located the sunken vessel and determined that the ferry's bow doors were open. It now appears likely that the doors were damaged by the heavy seas during the storm.

Eagles Soar Over Wall 17-0

5-0 Eagles

Ranked 14th In State

The Eldorado Eagles moved their season record to 5-0 last week by defeating their long-time foes, the Wall Hawks by a score of 17-0.

Traveling to Wall to face the Hawks at Wall's Homecoming, the Eagles found themselves challenged early as the Hawks drove to the Eagle's 3 yard line before fumbling the ball. Eagles' defensive end, #65 Jason Porter emerged from the pile with the pigskin and the Eagles offense took the field. Seven plays later, with 1:27 remaining in the opening quarter, #34 Reagan Bownds capped the drive with a spectacular 67 yard touchdown run. Mister Automatic, #62 Shylowe Middleton tackled on the extra point and the Eagles led 7-0.

On the first play of the second period, Eagles' quarterback, #5 Michael O'Daniel broke through

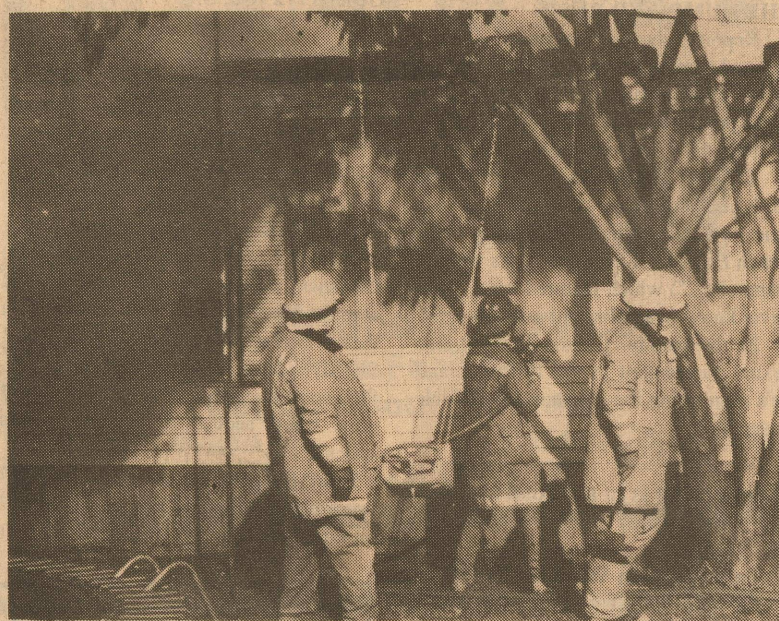
the Hawks' defensive line and ram-bled untouched for 44 yards and a touchdown. Again, Shylowe Middleton converted on the extra point and the Eagles led 14-0.

Middleton was called on for a field goal attempt with 5:02 remaining in the game and banged it through from 27 yards out to round out the scoring for the night. So far this season, Middleton has hit on 25 of 26 extra point tries and is 1 of 2 on field goal attempts.

Offensively, the Eagles pounded out 323 total yards. Reagan Bownds carried 26 times for 204 yards. Bownds also caught a pass for 11 yards. Michael O'Daniel carried 6 times for 52 yards. Cody McCravey gained 27 yards on 5 carries. Travis Whitten rushed 9 times for 26 yards while

Fire Destroys Mobile Home

Wednesday afternoon, Sept. 28th, a fire was reported at 406 Laredo Street at the home of Gene Rojas. Units of the Eldorado Volunteer Fire Department responded but were unable to save the mobile home. The Rojas family was home at the time of the blaze and all managed to escape unharmed. Gene Rojas' brother, Junior Rojas incurred an injury while attempting to extinguish the fire when he cut his arm. No other injuries were reported.

Fire department personnel reported that the fire was most likely caused by an electrical short. Chief Jerry Jones indicated that the structure was a total loss.

ASCS Election Slated

"Producers are asked to nominate candidates of their choice by October 31 to be on the ASC County Committee ballot," says Jan G. Wanoreck, County Executive Director.

The ASC County committee election will be conducted from November 25 to December 5 by mail ballot. Lanis Mikeska, who completed Matt Brown's term will be up for election.

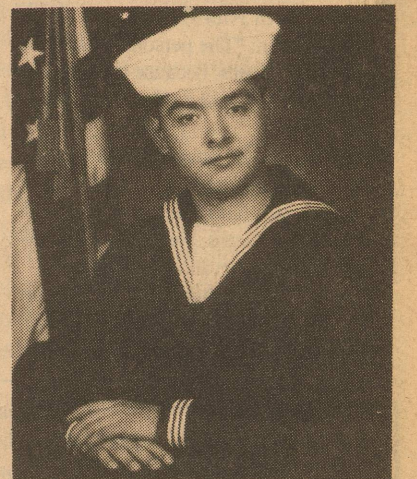
ASC committees are responsible for managing federal farm programs on the local level. To meet the needs of individual producers, ASC committee members must be concerned and responsible individuals, Wanoreck said. Schleicher County producers have the opportunity to nominate people they feel would best serve the farm community. Producers need to aware that nominating petitions will not be mailed out to each individual producer. If you wish to make a

nomination you will need to either come by the county office at 308 North West Street or give us a call to mail you one.

A few basic considerations should be kept in mind when circulating petitions, Wanoreck said. In order to be valid, petitions must be limited to one nominee each, must include written certification that the nominee is willing to serve if elected, must be signed by at least three eligible farm votes in the ASC county, and must be received in the county ASCS office by the October 31 deadline.

Producers should petition for and elect those individuals they feel would do a good job as a member of the ASC committee. The election of concerned producers to positions on ASC committees is essential in the administration of farm programs.

By the time I made it to the hospital, he was gone.

That evening, I stood on the sidelines of the JV football game and watched as Allan's son, Beau played an outstanding game. We all knew that Beau was grieving. And, we all knew that Beau was doing exactly what Allan would have wanted.

I will miss Allan Sallee, we all will. But, let us take comfort from the fact that even in his passing, Allan had one last prank up his sleeve. You see, he settled his score with his Savior long ago. So, Allan even managed to get the last laugh on death.

PROPERTY WRONGS

Senate committee hearings for Supreme court Justice were widely watched when a calculated assault on conservative, Clarence Thomas went "prime time." Unfortunately, not many paid attention to the recent quizzing of nominee (and now Justice) Breyer.

But some found the rhetoric "chilling." During the questioning, Sen. Biden, (D-DE) was expressing open angst over the latest Supreme Court decisions that reinforced property rights. His complaints were with cases Dolan and Lucas. One of his laments was: "...they refuse to give government the benefit of the doubt..."

The issue was environmental (meaning government) priorities vs. private property ownership. Dolan and Lucas involved governments telling business-owners to spend their own money to change their own property to fit government's plans. An old debate...BUT Biden complained it was unfair for government to prove ANY kind of necessity in imposing itself on private owners! His concern was how it would affect environmental laws.

Calling the burden of proof in these matters, "of phenomenal consequence," Biden gave this abbreviated hypothetical to illustrate his complaint: "If government outlaws CFC's because they go into the atmosphere, the manufacturers of CFC's could sue the government for taking away their 'property.' The owners could say to government: you can't prove our CFC's

harmed the ozone and caused cancer to people so you must compensate us for shutting down our business."

This is a billion-dollar consequence to the taxpayer. No one ever thought government would have to pay the manufacturers until Dolan."

[It clearly appears Biden was com-plaining that government has to prove any reason for taking away property! If government can prove their environmental theory, they don't have to pay for infringing Biden is since he can't prove some environmental theories, then government would end up paying -- and to him that's unfair!]

Here are Biden quotes: "No one ever realized the phenomenal consequence of reading the Fifth Amendment to its logical conclusion as espoused by Dolan, where it shifted the burden and changed the standard." Another: "Can you think of any principle that would stop the movement that was started by Dolan? [What!...Stop using the Constitution?]"

Breyer's response brought no comfort. His basic idea was that the Constitution is "flexible" [as opposed to literal interpretation], and that Dolan has important parts not written in "stone," and that if "it becomes very important to all of us that we protect the environment, the Constitution won't prevent that."

Breyer quotes: "Of course there is a Compensation Clause [in the Constitution]. Of course property is given some protection. But one must not go too

far."

If you take Biden's hypothetical at face value, it means that if some University researcher sought fame and fortune by theorizing that ... say ... cattle are harmful to Earth -- the government could just pass a law: "No more cattle."

Spin Begins on Warbler Wobble

At the urging of Gov. Ann Richards, Interior Secretary Bruce Babbitt ordered a stop to federal work on a proposal to designate 800,000 acres in 33 Central Texas counties as critical habitat for the endangered golden-cheeked warbler.

The songbird-habitat protection proposal became an issue in the governor's race when complaints were lodged by landowners, who said such a federal designation would deprive them of the use of their land and hurt property values.

Richards' Republican opponent, George W. Bush, came out early against the designation, and the Bush campaign suggested that the decision to abort the study should be credited to Bush, not Richards.

Environmental groups said the proposal's shutdown was a vote-getting measure by Richards, and warned that the governor should not count on the support of environmental voters in the upcoming election.

Other Highlights

Welfare recipients in parts of Harris County and all of Chambers County on Oct. 1 began using electronic cards to collect their state benefits.

The pilot program is scheduled to expand statewide in 1995, serving more than 1.2 million residents at 16,000 retail locations, Comptroller John Sharp said.

The State Bar will begin offering peer-review counseling to its members who have received complaints from clients about their desk-side manner.

El Paso will be the first city to offer the program, following a successful pilot version in Dallas.

RISK-ADDICTED

Apparently not content that they've inflamed enough controversy so far, the Clinton Administration is recommending embryo research. Outraged opposition groups point out it's the first time since Hitler's Nazi Germany such experiments have been authorized.

Experiments will be limited to the 14th day because recent scientific studies indicate a fetus can feel pain after the 15th day. (*U.S. News, The British Medical Journal, Lancet, Wa. Times, etc.*)

NO INTERROGATION AFTER 21-GUN SALUTE

Newsweek reports that DEA agents are furious that Janet Reno's Justice Dept. is prohibiting their questioning of Haitian President Aristide about drug deals. The report claims a Columbian druglord's bagman passed two polygraphs when naming Aristide.

The bagman delivered reliable info in the past, nailing the cousin of a Haitian General in a sting.

After Clinton's invasion speech, several TV pundits noted that the list of justifications did not include the well-known heavy drug-smuggling by way of Haiti.

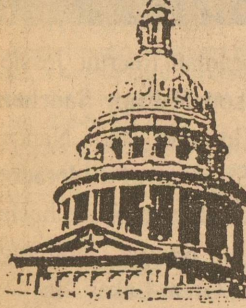

AUSTIN — Low-wealth school districts would get as much as \$261 million in state aid during the next biennium under a proposal by the Senate Interim Committee on Public School Facilities.

The money would be earmarked for renovation and construction of school facilities to help satisfy a court order by state District Judge F. Scott McCown setting Sept. 1, 1995 as the deadline for the Legislature to adopt a plan to aid poorer school districts.

McCown's order has been appealed to the Texas Supreme Court, which has not ruled.

Sen. Teel Bivins, R-Amarillo, chairman of the committee, said the proposal indicates that the state intends to pay its fair share for school facilities.

In a *Dallas Morning News* report, Al Kauffman, an attorney for low-wealth districts, said the state is funding less than a fourth of the construction and renovation expenses of Texas school districts.

And though he acknowledged that the money would help, Kauffman said the proposal "won't take care of the problem long term."

A report by the Texas Education Agency shows that to relieve overcrowding and replace substandard classrooms, \$1 billion is needed, and another \$1.7 billion is needed to libraries, gyms, laboratories and to replace thousands of portable classrooms.

Judicial Campaigns Capped

The Texas Supreme Court last week decided 6-3 to set time limits on campaign fund raising for judicial candidates, except for those candidates running for state Supreme Court or Court of Criminal Appeals.

Under the Code of Judicial Conduct, the revised time limits for fund raising -- 210 days before the filing deadline and 120 days after the general election in which the candidate is running -- will take effect Sept. 1, 1995.

Though no new limits were placed on amounts and sources of contributions, Chief Justice Tom Phillips called the time limits "a modest first step" in showing that judges are different from other elected officials.

Three of the nine Supreme Court justices -- Democrats Lloyd Doggett, Rose Spector and Bob Gammage -- opposed the time limits.

State Sen. Rodney Ellis, D-Houston, who wrote a campaign reform bill proposed in the 1993 legislative session, lauded the amendment. But he said limits on amounts and sources of campaign contributions still are needed.

Texas joins 24 other states that set similar limits.

Insurance Hearing Begins

Texas insurance companies are asking for an increase in standard rates for auto coverage, which have been frozen since 1991, but consumer advocates are requesting a cut.

In a hearing before Austin administrative law judges, the Texas Automobile Insurance Service Office asked for a 15.7 percent increase in "bench premiums," while the state's second-largest property insurer, Farmers Insurance Group, recommended a 9.8 percent increase.

A consumer advocate group, the Office of Public Insurance Counsel, however, recommended a 5.7 percent cut in standard rates. Rob Schneider, of Consumers Union, said the insurance industry has ignored the commissioner's directive to base new rate proposals on the "most efficient" insurance companies.

The judges are to pass on their recommendations to the state insurance commissioner for final review. Once adopted, the new rates will apply to all insurance companies doing business in the state.

Truan Not Paid; Associate Was

State Sen. Carlos Truan, D-Corpus Christi, received no commission for selling Nueces County a health insurance plan, but his business associate, Jose Reyes did, according to a report by The Associated Press.

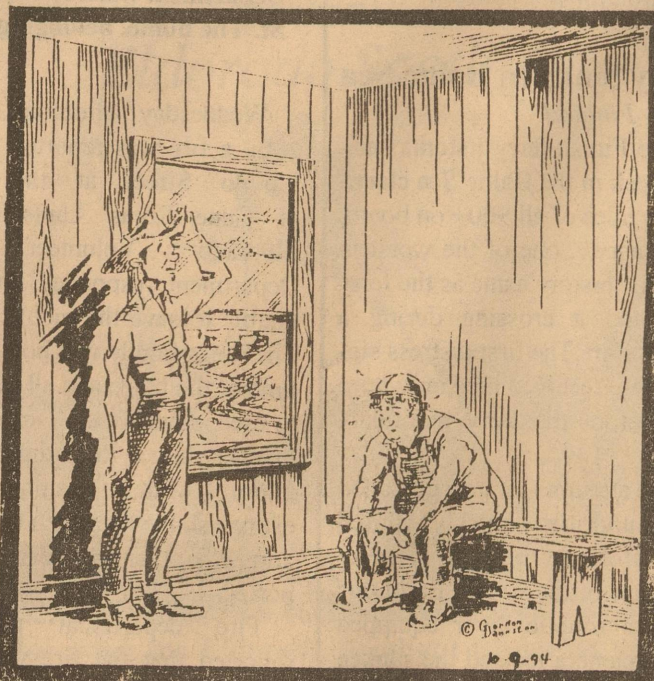
Truan is the subject in a probe being conducted by Nueces County District Attorney Carlos Valdez, who is investigating whether the senator's insurance business violated official conduct or ethics laws.

Truan never received his half of the sales commission because his company, Humana Health Care Plans, did not have a permanent HMO license, the report said.

Nueces County Judge Robert Barnes said he still wants to know who paid the commission, whether

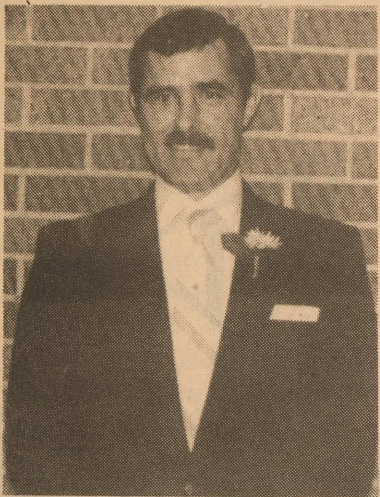

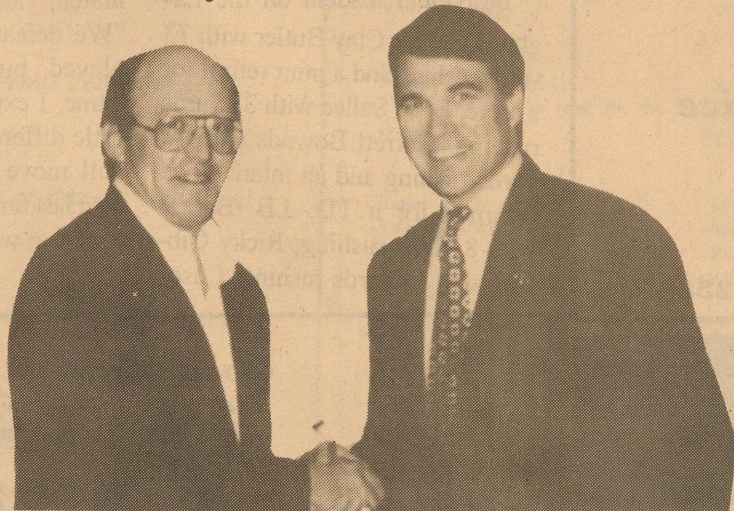

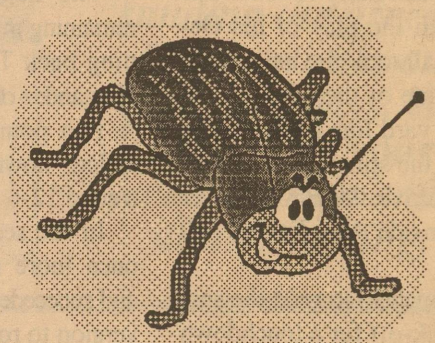

Landon Neal carried 1 time for 3 yards.

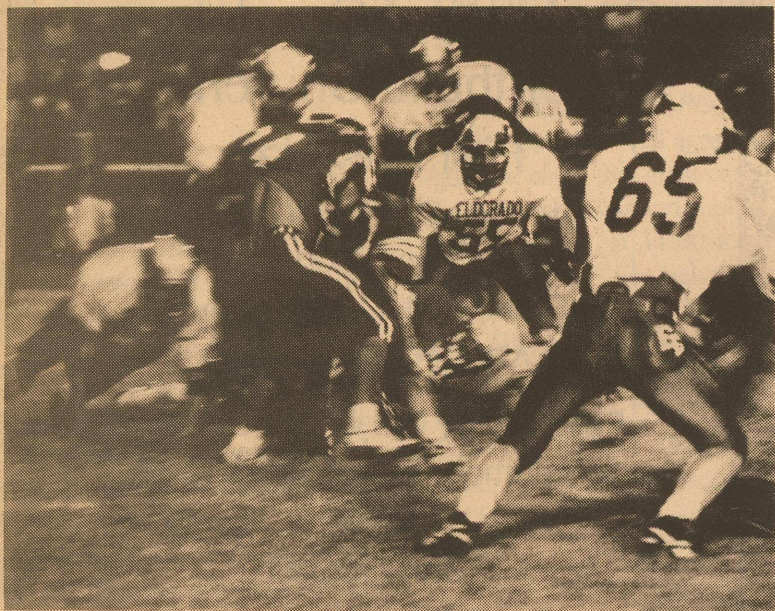

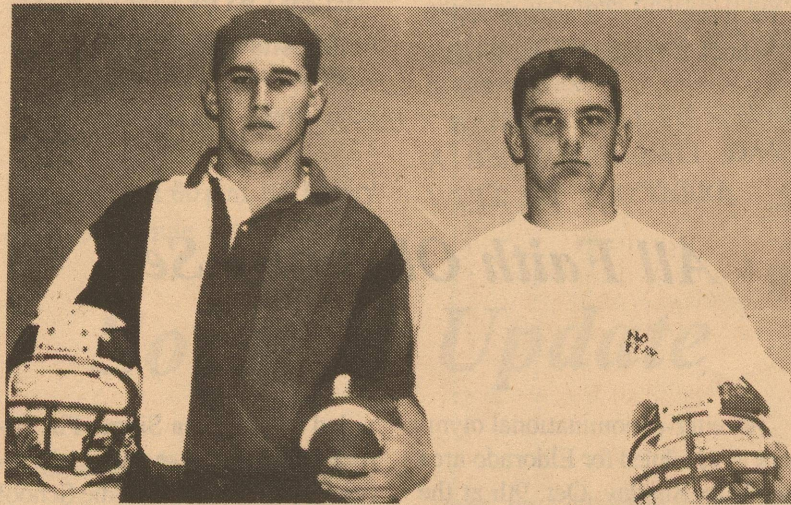
"We gave up some yards, but once they got inside our 30, our secondary didn't have as much field to cover."

After viewing the game films, the Eagles' coaching staff named Michael O'Daniel and Will Edmiston as the Offensive and Defensive Players of the week.

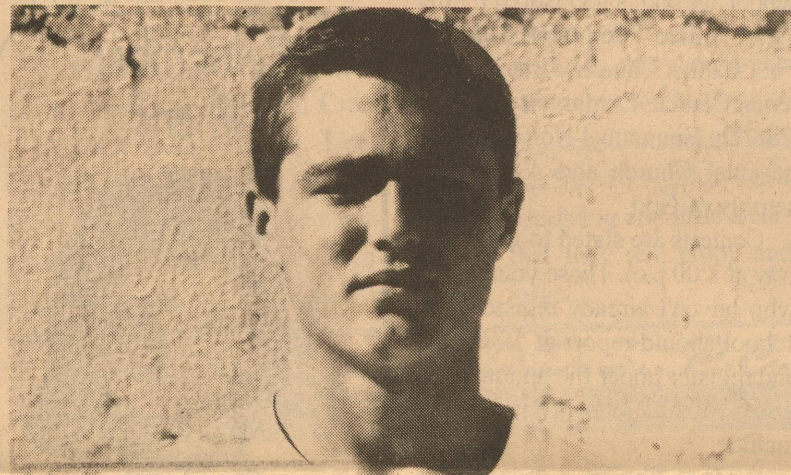

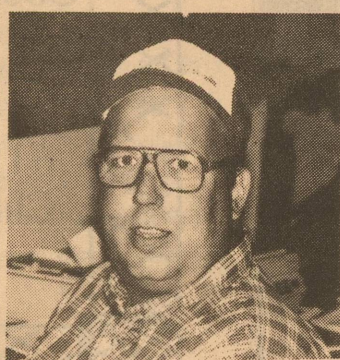

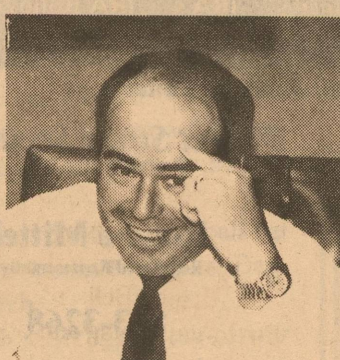

MEDITATION OF MY HEART

"And let us consider on another to provoke unto love and to good works, not forsaking the assembling of ourselves together, as the manner of some is, but exhorting one another: and so much the more, as ye see the day approaching." Hebrews 10:24-25

For a town its size, Eldorado has several churches. They all differ one way or another but they have one important thing in common and that is "People". However, there are more people in Eldorado who do not attend church than those who do. I do not have a scientific sturdy or survey to support that statement but a quick drive around Eldorado on a Sunday morning prove it out. I would venture to say that less than half of the people in our community attends church regularly.

There are various reasons why people don't go to church. Some excuses are truly valid while many are not. But will those excuses justify the closing of churches because of to lack of interest the coming years? Who will teach our children and grandchildren the religious heritage we received as a children? Who will rise to meet the needs of the community? We tend to take for granted that the churches will always be there but since the late 1980's there has been a steady decline in church attendance. It takes people to make up a church. When people lose interest and don't support their church, the doors will close.

I am sure the churches as Ephesus, Corinth, Sardis and many others mentioned in the New Testament thought they would always be strong thriving congregations, but where are they today? Britain had some of the greatest revivals ever recorded, yet very few Britons consider the church as being important to their lives today. Churches there are closing at an alarming rate.

Churches provide basic and very important elements to every community. The first element is the physical place to meet to worship God. As economic times get worse, the churches are being called upon more and more to meet the financial needs of those affected. There are outreaches to the youth, the elderly, the poor and disadvantaged. Plus, the fellowship of people coming together to love and encourage one another and to worship and experience the presence of God can not be duplicated by a civic organization. A church provides a moral base and structure for its people and community. Do we dare risk losing such an important part of our community?

I feel one of the most important functions of the church is its teaching mankind the truth of who God is and His plan for mankind. Being raised in a home where we went to church every time the doors were open and Sunday School was a priority - not an option, I was surprised as an adult Sunday School, teacher when several of my class were not familiar with who Daniel was. You know, the one who was thrown to the lions, basic Sunday School stuff! I was saddened when a pastor told me recently about two eight year-olds that were asked who Jesus was. They did not know. These boys don't live in Africa or Asia, but in Eldorado.

I remember as I was growing up, a great deal of discussion on how parents ought to let their children decide for themselves, when they were old enough, what to believe and not to "brainwash" them toward any particular religion. Well it seems that those parents didn't teach them anything, so the kids grew up and as adults decided to be nothing. I think our society reflects that past generation's decision not only in declining church attendance but also a rising crime rate and substance abuse problem.

When we "forsake the assembling of ourselves together", we forsake God. I know that is a strong statement but true nevertheless. I want to "provoke you unto love and to good works". The consequence of our "forsaking" reaches farther than the closing of churches. It touches the lives of an entire generation of boys and girls, including two eight year-olds in Eldorado, all because parents saw church as an option and not a priority.

There is a lot of discussion these days on how to save the Earth for our kids, on how to leave a heritage of a clean, safe environment. Please, leave your children and grandchildren a heritage - a Godly one. Don't send them, take them to the church of your choice every Sunday.
