On Monday, October 14th, the Gorman Junior High and High School Cross Country Teams competed in the District Meet at Cross Plains.

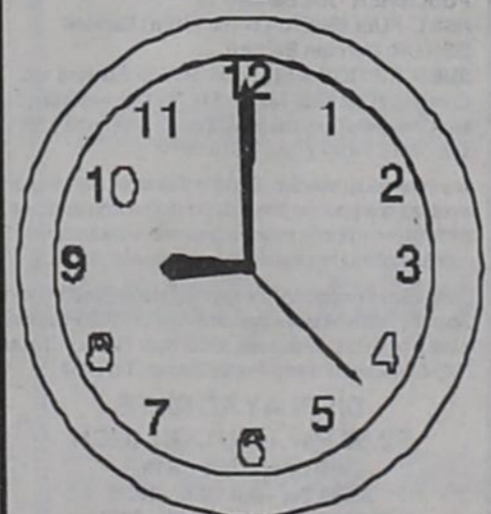

## Panthers Edge Santa Anna; Host Baird On Friday

The Panthers traveled to Santa Anna on Friday night for a District 8A game and edged the Mountaineers 7 to 6, scoring only one time after being inside the 10 on 4 occasions only to come out empty. The Panthers seemed to move the ball real well until they got close to the goal line, then just couldn't seem to get the score.

The lone Panther score came on their second possession after holding the Mounties on their first possession and getting the punt on their on 29. From there Gorman drove 71 yards in 8 plays with Adan Rodriguez getting the honors from 8 yards out on a great run with 2:50 left in the first period. The drive featured runs of 25 and 14 for first downs by Jeremy Bryan. Margarito Sanchez had two 9 yard runs. Kris Carlton booted the point after and Gorman led 7-0.

The Panthers had four more good drives, three of which got inside the Santa Anna 10 yard line, but failed to score.

With 6:17 left in the game Santa Anna got on the scoreboard taking the ball on their own 26 and scoring in just five plays. After first down runs of 14 and 40 yards to the Gorman 12, the Mounties then ran for 1 and 7 yards before Josh Lewens scored from 4 yards. Mounties then tried for the 2 point play but were held out by the Big Red Defense to preserve the lead 7 to 6.

The Panthers then took the ball on their own 26 and drove 44 yards before getting a 10 yard penalty, then failed to score and lost the ball on downs to Santa Anna on the 18. The Big Red defense then intercepted a Mountie pass on the Santa Anna 22, but ran out the clock to preserve the win.

This was a hard fought victory for the Big Red and they will really have to work on their offense this week as they host the always tough Baird Bears at Brogdon Field at 7:30 p.m.

Jeremy Bryan led the Panthers with 209 yards on 24 carries. Sanchez had 82 on 20 tries. Adan Rodriguez got 45 yards on 6 tries.

Let's all come out on Friday night and back the Panthers as they play another crucial District 8A game against Baird. Gorman will need a victory if they hope to stay in the running for a playoff spot.

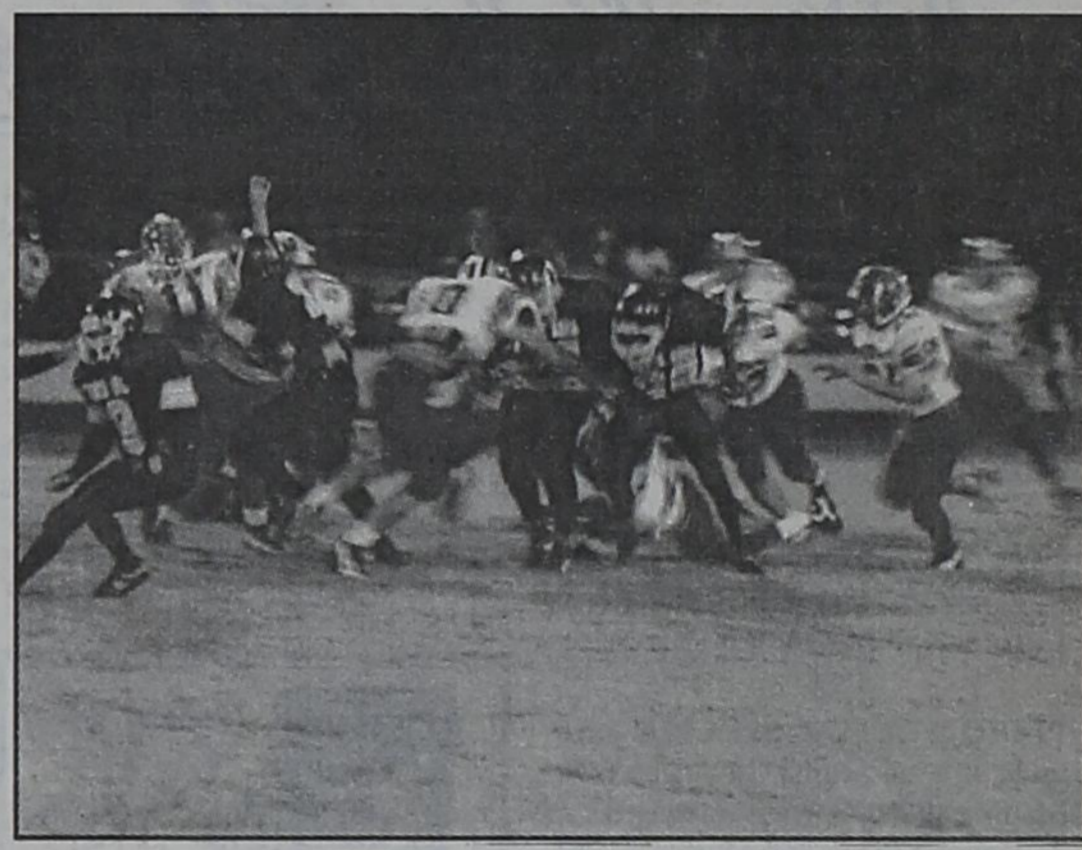
In my opinion, there are many factors which, when combined, make a good judge. The best judges are the

ones that have patience, are fair, are harsh when necessary, and listen to all sides before making a decision which is consistent with the law. A judge must be above reproach and must have the respect of his peers, not only professionally, but by all who appear before him. I believe that I have these qualities and that Governor Bush recognized these things in me when he appointed me Judge of the 91st District Court.

I further believe that since the 91st District Court is a trial court, a candidate for this office should be a person who has tried many difficult cases--both to the court and to a jury. This past year when Judge Wright was appointed to the Court of Appeals it was necessary for Governor Bush to appoint his successor. Of all the applicants who were called to Austin for the interview, I was the only applicant in the proceeding 5 or more years who had been actively trying criminal, civil, family and juvenile cases.

There are many reasons why you should take a personal interest in the selection of your next district judge. To begin with, the operations of the court are paid for by you, the taxpayer. Secondly, the district court are where

Many airlines now require ticket holders to present government-issued photo identification cards prior to boarding planes--and the Texas Department of Public Safety's photo identification card can meet that requirement.

"Any Texan, any age, can get a photo ID card at any DPS Drivers License Office," said Frank Elder, deputy administrator of the DPS Driver Licensing and Control Bureau. "People who don't have a drivers license often find themselves in need of an official photo ID. wether for cashing checks, proof of age, air travel or other purposes."

An applicant for a card must present a birth certificate, passport or military identification card and pay a \$10.00 fee. The card is valid for four years. Parents applying for cards for their children must bring one of the required documents for each child.

Security features on the identification cards are the same ones used to prevent forgeries of the drivers licenses.

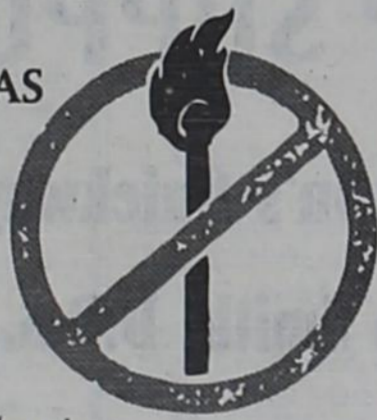

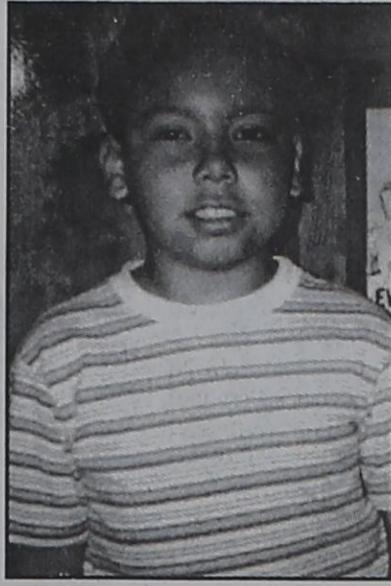

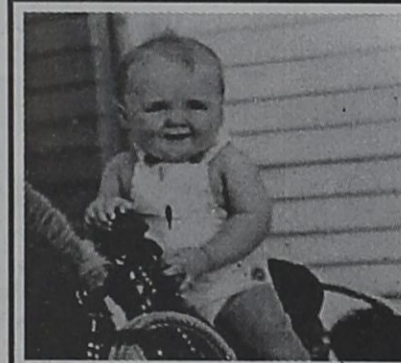

## Maxfield Elementary Being Recognized For Migrant Learning

Maxfield School in the Gorman Independent School District is among 218 Texas public schools being recognized for high levels of performance by migrant students on the Texas Assessment of Academic Skills tests, Superintendent Gene Shackelford announced today.

Maxfield Elementary received a rating of Acknowledged, on of four ratings schools were issued based on the number of migrant students taking the TAAS tests in grades 3 through 8 and 10 and their performance on the examination. Schools were rate as either exceptional, excelling, promising, or acknowledged, based on their migrant students' TAAS performance.

To be rated exceptional, schools had to have at least 10 migrant students tested on all TAAS subject areas, and 80 percent of those students passing each section of the TAAS. During the 1994-95 school year, more than 134,000 Texas students were educated through migrant education programs in 390 districts and 20 regional education service centers. About one-third of these students migrated to 42 other states where they were able to continue their education.

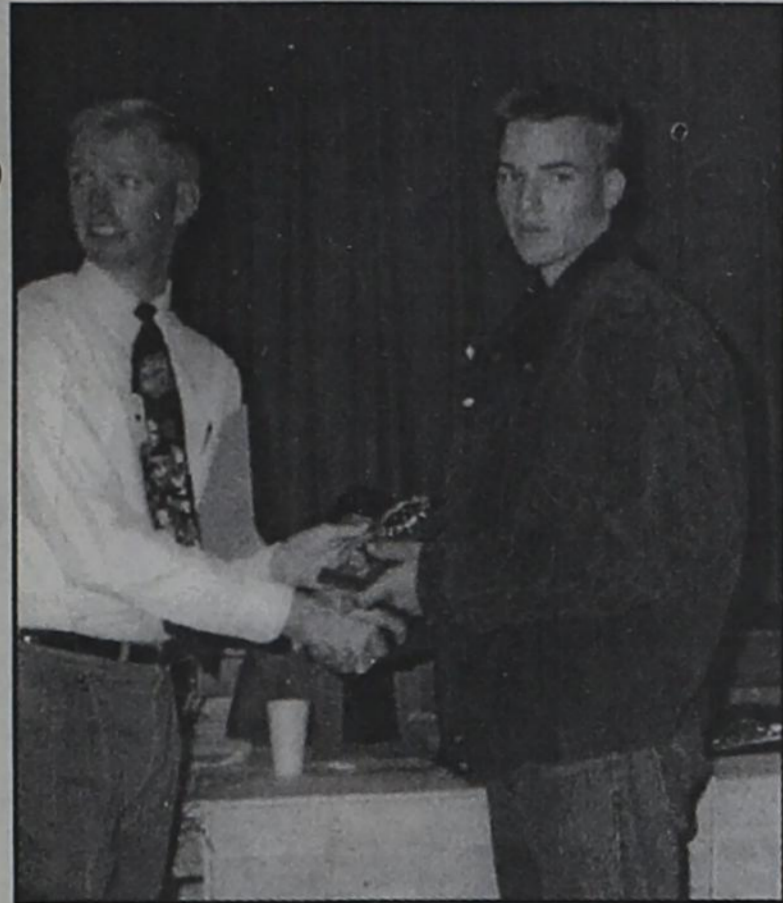


# Eastland County 4-H Awards Banquet

## Cattle Producers Plot Plan For Profitability

The volunteer leaders of Texas and Southwestern Cattle Raisers Association will meet in Abilene, Texas Oct. 25-26, to plot a course for industry profitability, says Chaunce O. Thompson Jr., president from Breckenridge, Texas. The financial well-being of the cattle industry which has a significant impact on the economy of many rural and semi-rural areas, has not been good in recent years.

The 119-year old organization has more than 14,000 dues-paying members who control approximately 1.9 million head of cattle on millions of acres of range and pasture land in Texas, Oklahoma and surrounding states.

The first day of the cattle producers meeting will be devoted to committee business and policy development. Topics to be addressed include natural resources, the environment, wildlife, marketing, brand and inspection, animal health, labor, agricultural research and legislative and tax issues important to all cattle producers.

Featured speakers will include spokespersons from the Texas Parks and Wildlife Department, the federal Natural Resources Conservation Service, Texas Animal Health Commission, Texas Agricultural Extension Service, Texas Agricultural Experiment Station, Texas Workforce Commission, Texas Tech University, Texas A&M Medical Diagnostic Laboratory, the federal Economic Research Service, cattle producers from the various industry segments and TSCRA officials, Thompson said.

The Saturday morning board meeting will include audience participation in a panel discussion involving a report made earlier by Dr. Ernie Davis, Texas A&M livestock economist, on a TSCRA-requested analysis of how beef packer concentration impacts cow/calf producers. Also, Paul Engler, a prominent cattle feeder who oversees Cactus Feeders, Inc., and Jack Hunt, the chief executive officer of the famous King Ranch, Inc., will share their ideas about the cattle industry today and in the 21st Century.

"This program is intended to address the concerns of most cattle producers today," Thompson said. "Yes, this meeting is for our directors and committee members, but, any TSCRA member or someone who joins TSCRA onsite can attend the committee sessions and the board meeting."

Registration is \$60 per person, which includes all social events. The cost of registration may be tax-deductible, but all participants are strongly encouraged to seek tax advice from professionals. Audio-cassettes of each meeting will be available for purchase at \$10 each by calling TSCRA Marketing and Membership Services Department at 1-817-332-7064.

## Chickenpox Vaccine Available In Health Clinics

A vaccine for chickenpox (varicella) is now available at most public health clinics and from providers who receive publicly purchased vaccines, according to the Texas Department of Health (TDH). People who want their children inoculated should check to see when the vaccine will be available in their area.

"The chickenpox vaccine is highly effective," said Dr. David R. Smith, Texas Commissioner of Health. "In one chickenpox vaccine trial, 97 percent of the 7,000 children inoculated were protected against the disease," he said.

Initially, TDH recommends use of the chickenpox vaccine for children in these categories who have not had the disease:

\*Children ages 12 months through 23 months \*11 - year olds \*Youngsters 18 years old and younger who live with people at high risk from serious complications from chickenpox.

For the past decade, Texas has reported about 20,000 cases of chickenpox annually. Although highly contagious, illness from chickenpox is generally mild and usually not life-threatening. But about 9,300 hospitalizations and 50 to 100 deaths are related to chickenpox annually, mostly in young children. From 1985 to 1994, Texas recorded 69 deaths associated with chickenpox.

The illness is transmitted by coughing and sneezing and through fluid from broken blisters. A person is contagious with chickenpox from one to two days before blisters or bumps appear until all lesions have dried, which usually takes four to five days.

Children 12 months to 12 years receive one inoculation; people age 13 and older receive two inoculations at least four weeks apart. Those who have had chickenpox do not need the vaccine.

"Most children will have few if any

## Much Accomplished - But Much to Do

When the 104th Congress convened in January of 1995, we had a rare opportunity to put government back in contact with what the country wants: less government, lower taxes and less federal meddling. I am pleased to report that we have filled the glass slightly more than half full.

At the top of Congress' agenda was a balanced budget. Congress passed a seven-year balanced budget with significant tax cuts for the middle class. Although the President vetoed that bill, Congress has stayed within the limits. So if we can get entitlement reforms, we still will be able to reach a balanced budget by 2002.

Another important reform enacted was the Congressional Accountability Act, a measure requiring the Senate and the House of Representatives to comply with the same rules imposed on the rest of the country. This is now the law of the land.

And that was only the beginning. The 104th Congress has enacted sweeping welfare reform and gone one step toward moderating regulatory overkill. Unfunded mandates, those unreasonable decrees from the federal government forcing states and municipalities to establish programs which end up raising local taxes, have been banished.

When you read this, the 104th Congress will have met for the last time. But this country still has, as the poet Robert Frost wrote, "... promises to keep, and miles to go before I sleep." Much remains to be accomplished.

The first priority on my personal legislative agenda is the Balanced Budget Amendment. Our federal budget deficits and daunting debt continue to inflict an enormous amount of harm on the American people and the American economy. It has become a cancer on the country that we are passing on to our children. I want to amend the Constitution to require future Congresses to pass and hold to a balanced budget.

Government borrows and spends money that would otherwise serve as capital needed for economic growth and job creation. We must curb this tendency to spend so far beyond our means.

Yet at the same time, Americans continue to pay unreasonably high taxes. The average two-parent working family of four now pays 38 percent of its income in direct taxes to the government — more than a dollar of every \$3 earned.

Economic history shows we can enact tax cuts without devastating deficit-reduction efforts. We did it in the 1960s under President Kennedy and in the '80s under President Reagan.

On taxes, my agenda remains the same: an across-the-board 15 percent tax cut, a \$500 per child tax credit and repeal of the 1993 Social Security tax increases on seniors. The enactment this year of my Homemakers IRA, which allows one-income couples to save for retirement at the same rate as two-income couples, goes a long way toward providing equity. Our next high priority item should be to do away with the "marriage penalty," which forces two-income married couples to pay higher taxes than if each were single. In addition to being patently unfair, this quirk in the tax law weakens one of the basic institutions of our society.

Finally, we need to finish the work begun this year on dealing with the problem of illegal immigration. Eleventh-hour changes forced on the Congress by the President (who threatened another government shutdown) weakened a key section of the illegal immigration bill enacted September 30. Among the enforcement provisions dropped from the final bill were items designed to ensure that illegal immigrants cannot come here and become dependent on our welfare and Medicaid programs. The President also insisted on a provision that allows illegal aliens to remain in public housing.

Despite some setbacks, critical reform has begun. We have started to move from promises to reality.

Participants were guided through the obstacle course elements by trained instructors with the chisholm Trail Boy Scout Council.

"The Challenge Course was a day well spent. We had the opportunity to learn techniques in teambuilding, communication, and in helping everyone step into leadership roles. Each individual has strengths and weaknesses, but it takes everyone's contribution for the group to be successful," said Donald Hughes, Assistant Superintendent of

Eastland ISD.

During the day-long activities participants had to use their skills in problem solving, decision making, communication, team work, trust and leadership to complete each element of the challenge course. Everyone agreed there was a sense of personal satisfaction each time the team was successful through their combined efforts.
