Panhandle South Plains Fair coming to Lubbock

Lubbock - Each year in late September and early October the Panhandle South Plains Fair returns to the fair grounds in Lubbock, much to the delight of South Plains fans. With the slogan "family fun for everyone," the fair provides a variety of wholesome, family oriented entertainment throughout its' eight day run and keeps alive the tradition of a county fair where people can always

find something new to see, hear or learn.

Because of widespread citizen support, drawn from the Panhandle and South Plains area of Texas as well as Eastern New Mexico, the exposition has become one of the largest attractions in West Texas. In 1998 more than 192,000 persons attended the 81st annual event.

Fairgoers can see a wide range of free entertainment and strolling

acts in every nook and cranny of the grounds, providing virtually non-stop activity every day. Free entertainment might include magicians, ventriloquists, racing pigs, clowns doing balloon sculptures, local and area talent on the outdoor stage, square dancers, high-wire artists, dancing monkeys, dog and pony shows, talent shows or even a children's barnyard and petting zoo.

Coyotes Roll Over the Leopards

The Borden County Coyotes rolled past the New Home Leopards in Gail last Friday. By defeating the opponent 56-0. The game was called at the half due to the 45 point rule. Ed Rodriguez and Joseph Hardinan paced the Coyote offense with three touchdowns each. The Coyotes accumulated 251 yards in 20 carries and held the Leopards to just 37 yards in 21 carries.

Rodriguez carried the ball 8 times for 114 yards and three touchdowns on runs of 29, 9, and 51 yards. Rodriguez added 8 points by kicking four extra points good for two points each. He also had 4 tackles on defense.

Hardman carried the ball 6 times for 77 yards and three touchdowns on runs of 5, 7, and 43 yards. He also had 2 tackles on defense.

Dale Grant and D.J. Smith each added a touchdown for 6 and 36 yards respectively. Grant led the defense in tackles with 6 tackles and a hurry of the quarterback.

Robert Stamper had 4 tackles, an interception he returned 25 yards, and two punt returns for 46 and 19 yards.

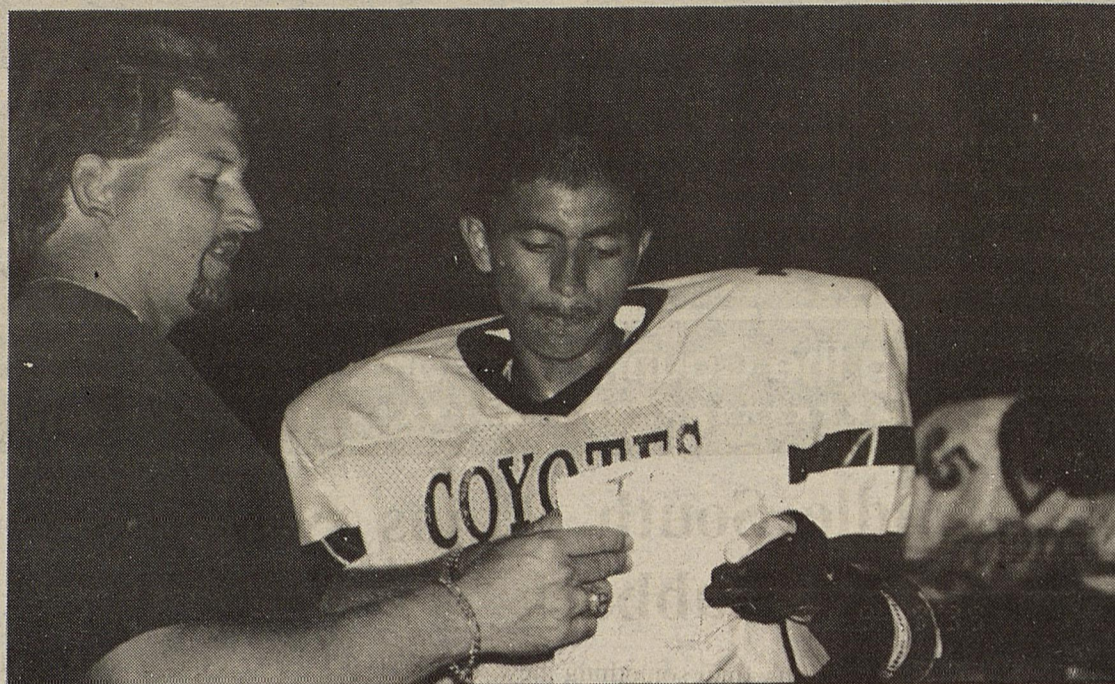
Tom Griffin had 4 tackles and an interception he returned for 10 yards.

Ramon Griffin had 4 tackles. Lee Pepper had 3 tackles. John Harding had 3 tackles and a fumble recovery. Nick Flanigan had 3 tackles and a quarterback sack. Kevin Pinkerton had two tackles. D.J. Smith had 2 tackles.

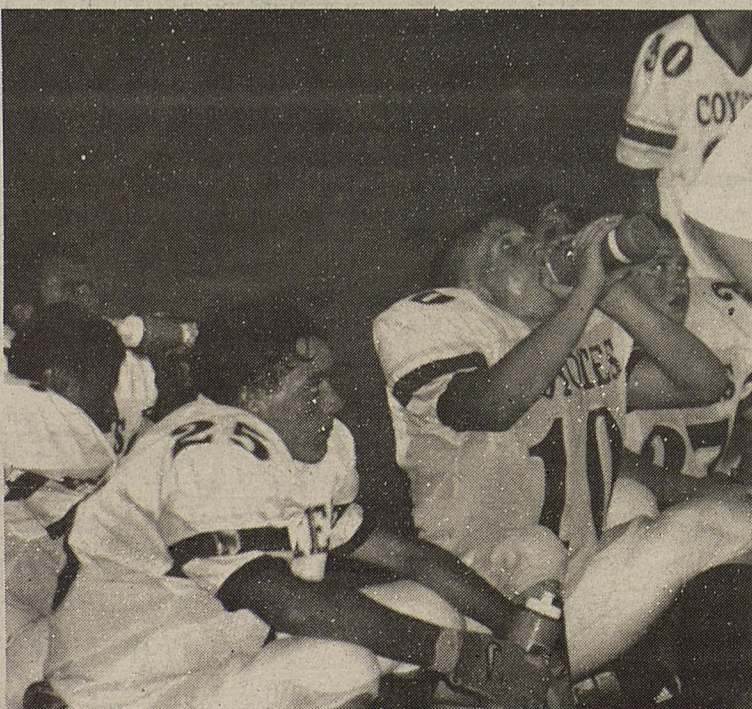

The Borden County Jayvee Coyotes traveled to New Home. Thursday night to take on the New Home Leopards in hopes of improving their season record to 2-0. The Coyotes

got off to a sluggish start as they failed to score on their first two possessions of the first half. On the next four Coyote drives some good running by T.J. Sharp mixed with some very good blocking enabled the Coyotes to take control of the game in the weaning stages of the first quarter and the early stages of the 2nd quarter.

T.J. got the Coyotes on the board with the first of his five touchdowns. T.J. busted loose from 32 yards out to give the Coyotes a 6-0 lead, a lead that they never relinquished. On the Coyotes next offensive series, T.J. busted loose on another long run as he hip pay dirt from 35 yards out to boost the Coyotes to a 16-0 lead after he booted his second of four extra points to close the first quarter.

After another super defensive effort by the Coyote defense, the Coyotes hit pay dirt again

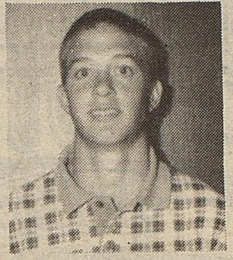
as Sharp finished off a Coyote drive that included three good completions. Coyote quarterback Brionne Jackson hit Payton Brown on a 22 yard pass play, and then T.J. hit Payton for another 15 yards and Cody Nowlain for 21 yards before galloping the final 8 yards of his own for a 24-0 score. The Coyotes got the ball again just seconds before the close of the first half, and again made good on the drive as T.J. dropped back to pass, but scrambled away from the pressure for a 48 yard touchdown run to give the visiting Coyotes a commanding 30-0 lead. The extra point made the score at halftime 32-0.

In the second half, the Coyotes played a little sluggishly as they committed three turnovers. Raul Rodriquez put the Coyotes up 38-0 as he scampered 65 yards. The Coyotes and Leopards

No team totals were tallied, but the Coyotes brought home six individual medals from the cross country meet in Seminole on Saturday. These included a gold medal by Trent Pepper, a seventh place medal by Holly Thomas, and a fourth place medal by Cassidy Rinehart.

In the varsity boys division, Trent Pepper won his second gold medal of the year by completing the 3.3 mile course in a time of 16:52. Teammate Payton Brown also ran in this division.

Holly Thomas led the high school varsity girls with a seventh place finish, covering the 2.2 mile course in 14:16. She was followed by medalist Julie Mayes' fourteenth place finish in 14:43. Other members of the varsity girls team included Bekah Hensley, Shaina Isaacs, Micah Hensley, Crystal Dye, and Staci O'Brien.

There were no Borden County individual medalists in the junior varsity girls division, but representing the Coyotes were Patty Rodriguez and Michelle Bond.

Evan Winegarner, Adam Carter, and Charles Grant all competed in the junior high boys division.

Cassidy Rinehart, Emily Mayes, and Shayla Gass all medalled individually in the junior high girls division. Cassidy covered the 2.2 mile course in 15:12, en route to a fourth place finish. Emily finished in a time of 16:00, placing tenth, and Shayla ran a 16:20,

finishing fourteenth.

The Coyotes next meet will be in Abernathy on Saturday.

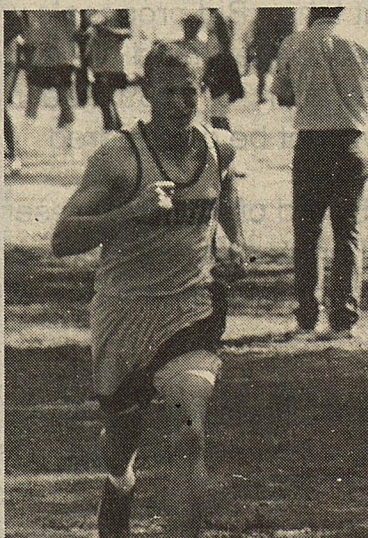

traded possessions without much excitement. 22 yards passing and did a super job of running the Coyote offense. The line of Rowdy Dunlap, James Bond, Cody Nowlain and Payton Brown did another solid job of blocking. On defense, Raul Rodriguez and T.C. Stipe broke up several passes each. Others turning in another solid defensive effort were T.J. Sharp, Cody Nowlain, Rowdy Dunlap, Payton Brown and James Bond.

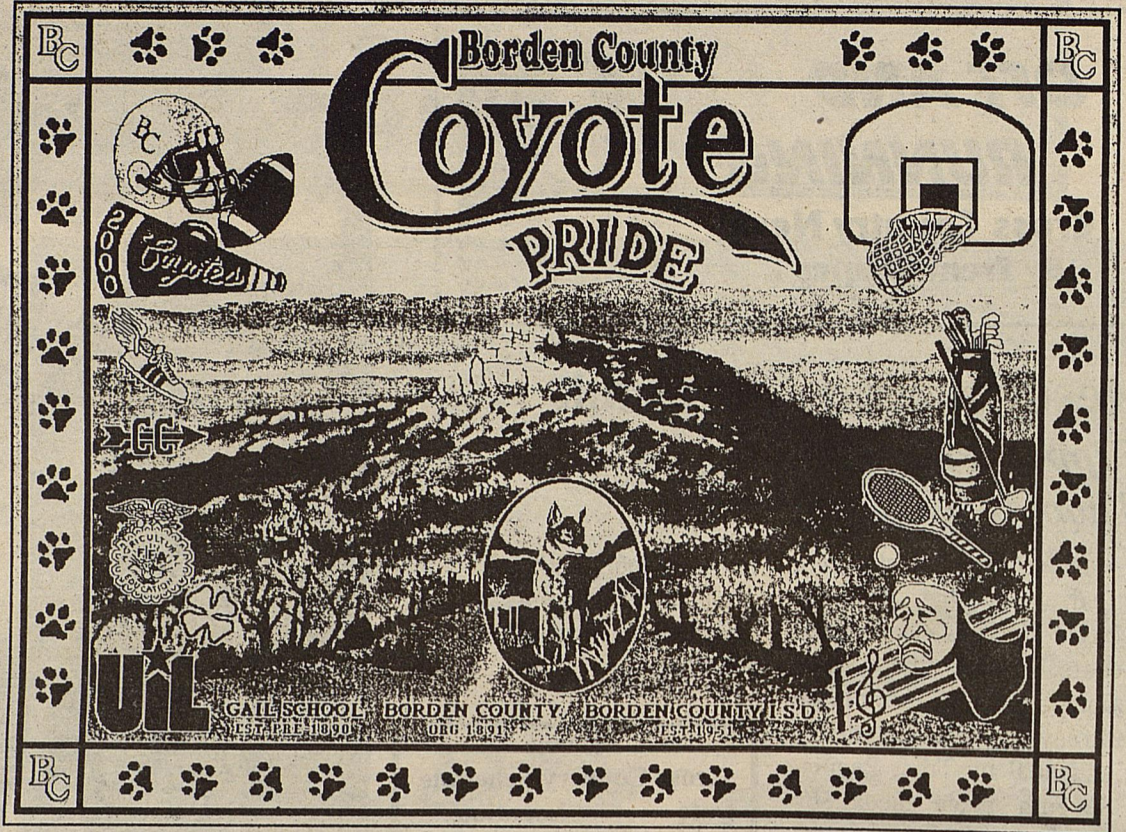
Gail FFA Chapter Begins Variety Meat Sale

SCHOOL BUS SAFETY

More than 24 million children will ride a school bus to and from school this year. If your child is one, take a moment to review the following safety tips with him or her:

- While waiting for your bus, stay away from the street and avoid rough-housing.
- Don't step into the street until the bus has stopped and the bus driver has opened the door.
- Inside the bus, take your seat and avoid loud talking or other behavior that could distract the driver. Show respect for the driver and other riders.
- When exiting the bus, don't stand up until the bus has come to a complete stop.
- If you have to cross the street, walk at least 10 feet in front of the bus and maintain eye contact with the driver. Don't forget to look both ways.
- If you drop something on the street, don't stoop to pick it up, unless you tell the driver.

School buses are one of the safest forms of transportation available. However, accidents do occur. The greatest risk to children is when they are approaching or leaving the bus. Remind your children to be especially alert at these times.

constituting a quorum, when the following proceedings were had, in accordance with the posted agenda:

MINUTES APPROVED

Minutes of the Commissioners Court meeting of August 9th, 1999 were read. Commissioner Lemons made a motion to approve said minutes and motion was seconded by Commissioner Smith. Motion carried.

ACCOUNTS ALLOWED

The current accounts were examined and Commissioner Wolf made a motion to approve and pay said accounts. Commissioner Lemons seconded the motion. Motion carried.

TITLE IV-PROGRAM CONTRACT

A motion was made by Commissioner Smith to give County Judge Van L. York the authority to sign a contract with the Texas Attorney General For Borden County to cooperate for Title IV-Program. Motion was seconded by Commissioner Wolf. Motion carried.

BUDGET HEARING

At 10:00 a.m., Commissioner Isaacs made a motion to recess the Commissioners Court Meeting and call the Budget Hearing to order, as advertised. Commissioner Lemons seconded the motion. Motion carried.

No interested persons appeared at the Budget Hearing.

A motion was made at 10:30 a.m. by Commissioner Smith that said hearing be adjourned and reconvene Commissioners Court Meeting. Motion was seconded by Commissioner Isaacs. Motion carried.

OFFICE OF CONSTABLE

Commissioner Isaacs made a motion to approve the Commissioners' Court Order stating the office of Constable is now vacant and that all compensation cease. Commissioner Lemons seconded the motion. Motion carried.

YEAR 2000 COUNTY BUDGET

Commissioner Isaacs made a motion to approve the County Budget for the year 2000. Motion was seconded by Commissioner Smith. Motion carried.

TAX RATE

A motion was made by Commissioner Lemons to set the tax rate at \$.485 (48-1/2c) per One Hundred Dollars (\$100.00) valuation. Motion was seconded by Commissioner Isaacs. Voting For: Commissioners Isaacs, Smith and Lemons. Voting Against: Commissioner Wolf

TAX DISCOUNT

Commissioner Wolf made a motion to allow discounts of 3%, 2% and 1% for early payment of taxes in October, November and December, respectively. Commissioner

Moderately priced reserved seating Fair Park Coliseum show tickets allow fair goers to be entertained nightly by top Country artists. Scheduled to appear on stage for the 1999 fair is Ricky Van Shelton, La Mafia, Mark Lowry, Anthony Burger, Sammy Kershaw and Jars of Clay. On other nights the coliseum is host to general admission free shows sponsored by local business and media.

Tempting food, ranging from grilled turkey legs to cheese sticks or hamburgers, is served by more than 4 dozen local non-profit groups who use their fair concession profits to benefit charities serving the South Plains. Since the early 1970's no new commercial food vendors have been allowed on the independent midway.

Isaacs seconded the motion. Motion carried.

TAXES - SPLIT PAYMENTS

A motion was made by Commissioner Smith to NOT ALLOW split payment of taxes. Motion was seconded by Commissioner Wolf. Motion carried.

ELECTION JUDGES

Shirley Bennett was appointed alternate Judge for Precinct No. 2A. Carolyn Stephens was appointed Alternate Judge for Precinct No. 1. Due to deadline of September 2, 1999 for appointment of election judges and alternate judges the following alternates for Precinct No. 1 are Mary Lynn Williams and Judy Kingston. The above appointments were made due to original appointees declining the appointment. Commissioner Smith made a motion to appoint the above for the respective positions and Commissioner Isaacs seconded the motion. Motion carried.

ADJOURN

Over the past 25 years the fair has contributed over \$500,000 to scholarship funds at Texas Tech, Lubbock Christian University, Wayland Baptist University, South Plains College and Texas Western College. Since 1986 fair goers have contributed more than 125 tons of canned food for the South Plains Food Bank during the carnival's popular two-for-one day. Patrons can contribute three cans of food and get one carnival ride coupon booklet free when they purchase a ride coupon booklet on Thursday only. Carnival ride coupons purchased during the food drive are honored throughout the remainder of the fair.

Heart pounding swirls of exciting carnival rides and games are furnished on the midway for those hearty enough to try them. Reed Exposition Midway of Houston provides 60 or more rides ranging from merry go rounds for the kiddies to high tech thrillers for adults, plus games of skill for one and all. Several of the rides expected for the 1999 fair have never been seen before in the South Plains area. Reed Exposition Midway is a family owned and operated carnival which conducts daily documented safety inspections of their rides.

Operating as a regional fair for education and encouragement of agriculture and horticulture, fair

exhibits include home crafts, crop, flowers, commercial vendors, art, ag-mechanics, open and junior livestock shows and small animal and bird competitions. The 1999 fair will offer competition in 31 different areas and anyone with a desire for a blue ribbon can compete in the shows and competitions. Many will take home a share of the more than \$100,000 in premium money awarded annually among the 12,000 or so exhibits.

Special "free-admission" days at the fair include school days, Monday through Wednesday, when the area public school children and staff members are admitted free with a ticket distributed to schools. Lubbock State School clients and handicapped children are admitted free on Tuesday, Senior Citizens day is Thursday when special gospel shows on the outdoor stage and the Coliseum are provided as free entertainment and college students are admitted free on Friday.

Admission for the fair is \$4.00 for adults 12 or older and \$1 for children 6-11. Parking is \$2 per vehicle. Parking and gate admission is charged after 1 p.m. on weekdays and 10 a.m. on weekends. All buildings open at 11 a.m. daily and the carnival opens at 11 a.m. on weekends and 1 p.m. on weekdays.

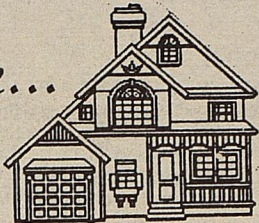

Do You Eat Five a Day?

Less than 25% of Americans eat five or more daily servings of fruits and vegetables. However, according to a recent national phone survey, 36% know they should eat at least 5 A Day for better health. On the other hand, only 195 of Americans know about the government's recommendation for moderate physical activity - 30 minutes or more most days of the week. But a substantial 40% say they're meeting or exceeding this goal.

Proper nutrition and physical activity are the two basic elements of fitness, according to most health experts' definitions. During National 5 A Day Week, September 12-18, the National Cancer Institute is reminding Americans to "get fit with 5" by eating five or more servings of fruits and vegetables a day.

Most of us tend to do ok with moderate physical activity, but most of us are not eating the recommended amount of fruits and vegetables. For many, adding 5 A Day to an existing physical activity routine would be an easy step toward more complete

fitness and overall better health.

One way to determine if you are eating your five is to track yourself. Those who want to see how they measure up have a new personal trainer in cyberspace. The National Cancer Institute and the Centers for Disease Control and Prevention recently launched an interactive Web site on www.5aday.gov. The site's interactive chart allows visitors to fill out how many fruits and vegetables servings they ate yesterday, along with how many minutes of physical activity they did. They then receive a personalized response showing how they are doing compared to other Americans and the experts' recommendations, and they receive a set of personalized, specific tips.

Take a 5 A Day challenge! During National 5 A Day Week, challenge your friends, family, and co-workers to eat five or more daily servings of fruits and vegetables every day. A combination of 5 A Day with 30 minutes of moderate physical activity most days of the week are two of the easiest and most concrete things to do for better health.

All varieties of fruits and vegetables - fresh, frozen, canned, dried and juice - count toward 5 A Day, and a serving is smaller than many people think. One serving can be a medium piece of fruit, 1/2 cup of cooked, canned, or cup-up vegetables or fruit, a cup of chopped lettuce and other raw leafy vegetables, 3/4 cup (6 oz.) of 100-percent fruit or vegetable juice, 1/2 cup of canned legumes (beans and peas), or 1/4 cup dried fruit.

PROPOSITION NO. 1
ON THE BALLOT

HJR 44 - HJR 44 proposes a constitutional amendment that would ensure a clear succession in event of vacancies in the offices of Governor and Lieutenant Governor. Specifically, the amendment would provide that if after qualifying for the office, the Governor is temporarily unable to serve, the Lieutenant Governor shall act as Governor until the Governor is able to serve; but if the Governor is permanently unable to serve, the Lieutenant Governor shall become the Governor for the remainder of the unexpired term. The amendment would require a Lieutenant Governor who becomes Governor to forfeit the office of Lieutenant Governor. The amendment would also provide similar succession procedures when a vacancy occurs in the office of Governor before the newly elected Governor qualifies for office, and when the newly elected Governor is temporarily unable to take office. The amendment also would provide that if there is a temporary vacancy in the office of Lieutenant Governor, the President pro tempore of the Senate will fill the position; but if there is a permanent vacancy in the office of Lieutenant Governor, the President pro tempore of the Senate shall serve as Lieutenant Governor only until such time as the whole senate can convene to elect one of its members to perform the duties of Lieutenant Governor. Finally, the amendment would provide that if the Lieutenant Governor, while temporarily exercising the powers of the Governor, becomes temporarily disabled or unable to serve, the President pro tempore of the senate shall exercise the powers and authority of the office of the Governor until such time as the Governor or Lieutenant Governor resumes those powers and duties.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to revise the provisions for the filling of a vacancy in the office of governor or lieutenant governor."

PROPOSITION NO. 2
ON THE BALLOT

SJR 12 - SJR 12 proposes a constitutional amendment that would resolve conflicts between the Texas Constitution and federal law relating to the definition, rules, and procedures of reverse mortgages. The amendment would define "reverse mortgage" in part as an extension of credit made against the homestead of a person who is 62 years or older, or whose spouse is 62 years or older. It would expand the list of circumstances under which payment of principal and interest become due and the procedures involved in foreclosure, and would require certain advances to be made according to specific terms in loan documents, including advances by the lender, on behalf of the borrower for payments necessary to protect the lender's interest. Finally, the amendment would require the Texas Supreme Court to promulgate rules of civil procedure expediting court-ordered foreclosures of reverse mortgage liens.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment relating to the making of advances under a reverse mortgage and payment of a reverse mortgage."

PROPOSITION NO. 3
ON THE BALLOT

HJR 62 - HJR 62 proposes a constitutional

amendment that would simplify and clarify the language of the Texas Constitution. The amendment would make no substantive changes, but would eliminate duplicative, expired, out-of-date, and ineffective terms.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to eliminate duplicative, executed, obsolete, archaic, and ineffective provisions of the Texas Constitution."

PROPOSITION NO. 4
ON THE BALLOT

HJR 4 - HJR 4 proposes a constitutional amendment that would broaden the definition of charitable organizations. The amendment would exempt from ad valorem taxation the property of any organization engaged primarily in public charitable functions, and it would allow such an organization to conduct additional activities to support its charitable functions.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to exempt property owned by institutions engaged primarily in public charitable functions from ad valorem taxation."

PROPOSITION NO. 5
ON THE BALLOT

SJR 26 - SJR 26 proposes an amendment that would remove the restriction prohibiting state employees who receive all or part of their compensation from the state from serving as members of a governing body of a school district, city, town, or other local governmental district unless the state employee receives no salary for such service. The amendment would allow state employees to receive compensation from the governing bodies of which they are members.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment allowing state employees to receive compensation for serving as a member of a governing body of a school district, city, town, or other local governmental district."

PROPOSITION NO. 6
ON THE BALLOT

SJR 22 - SJR 22 proposes a constitutional amendment that would increase the maximum size of an urban homestead, which is a homestead in a city, town, or village, from one acre to ten acres and require the urban homestead to be composed of either a single lot or several lots that are adjacent to one another. The amendment also would provide that the urban homestead must be used as a home or as both a home and place of business, whereas current law does not require that an urban homestead that is used as a place of business be used also as a home.

Current law further allows a person to secure a home equity loan on their homestead, provided that the loan does not overburden the homestead. That is, the principal amount of the home equity loan, when added to the total of the outstanding principal balances of all other indebtedness secured against the homestead, does not exceed 80 percent of the fair market value of the homestead on the date the extension of credit is made. The

proposed amendment would clarify current law by specifically allowing home equity loans on all or part of urban homesteads of up to ten acres and subject such loans to the same requirement that the refinanced or new loan not overburden the homestead.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment increasing the maximum size of an urban homestead to 10 acres, prescribing permissible uses of urban homesteads, and preventing the overburdening of a homestead."

PROPOSITION NO. 7
ON THE BALLOT

HJR 16 - HJR 16 proposes a constitutional amendment that would provide that if an employee is delinquent in paying court-ordered spousal maintenance, a portion of that employee's wages may be withheld to pay the spousal maintenance. Current law allows such withholding, or garnishment, only for payment of delinquent court-ordered child support.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing garnishment of wages for the enforcement of court-ordered spousal maintenance."

PROPOSITION NO. 8
ON THE BALLOT

HJR 95 - HJR 95 proposes a constitutional amendment that would provide that the adjutant general, who is appointed by the Governor and who serves as the governing officer of the state military forces, serves as long as the Governor wishes the appointed person to serve in that capacity rather than serving a specific two-year term set by the legislature.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to provide that the adjutant general serves at the pleasure of the governor."

PROPOSITION NO. 9
ON THE BALLOT

SJR 10 - SJR 10 proposes a constitutional amendment that would authorize the legislature to create a judicial compensation committee to make recommendations for salaries for the justices and judges of the Supreme Court, the Court of Criminal Appeals, the Courts of Appeals, and the District Courts. The amendment would mandate that the recommendations become law if neither the Senate nor the House of Representatives rejects them by majority vote.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to create a judicial compensation commission."

PROPOSITION NO. 10
ON THE BALLOT

HJR 74 - HJR 74 proposes a constitutional amendment that would provide that the commissioner of health and human services, who is appointed by the Governor, serves as long as the Governor wishes the appointed person to serve in that capacity rather than serving a specific two-year term set by the legislature.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to provide that the commissioner of health and human services serves at the pleasure of the governor."

PROPOSITION NO. 11
ON THE BALLOT

HJR 69 - HJR 69 proposes a constitutional amendment that would authorize a county, city, town, or other political subdivision to

spend public funds or extend credit to purchase nonassessable property or casualty insurance from a mutual insurance company authorized to do business in Texas. Under current law, a political subdivision is generally prohibited from spending public funds or extending credit to become a stockholder in a corporation but is permitted to purchase nonassessable life, health or accident insurance policies from a mutual insurance company authorized to do business in Texas. This amendment would authorize a political subdivision to also obtain non-assessable property and casualty insurance from such a company.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment permitting a political subdivision to purchase nonassessable property and casualty insurance from an authorized mutual insurance company in the same manner that the political subdivision purchases life, health, and accident insurance."

PROPOSITION NO. 12
ON THE BALLOT

SJR 21 - SJR 21 proposes a constitutional amendment that would exempt from ad valorem taxation a leased motor vehicle that is not used by the lessee primarily to produce income. The amendment would provide that the legislature also may limit the ability of a political subdivision to subject such a vehicle to taxation.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to exempt from ad valorem taxation leased motor vehicles not held by the lessee primarily to produce income."

PROPOSITION NO. 13
ON THE BALLOT

SJR 16 - SJR 16 proposes a constitutional amendment that would authorize the legislature to allow the Texas Higher Education Coordinating Board to issue and sell general obligation bonds in an amount not to exceed \$400 million in order to finance educational loans to students. The amendment also would authorize the Legislature to limit the amount of interest the bonds can bear and establish procedures for the investment of the bond proceeds. The proposed amendment would specify the method of repaying the bonds.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of \$400 million in general obligation bonds to finance educational loans to students."

PROPOSITION NO. 14
ON THE BALLOT

HJR 29 - HJR 29 proposes a constitutional amendment which would authorize the Legislature to require the board of regents of the state university and boards of trustees or managers of the educational, charitable, and penal institutions of the state, whose members serve six year terms, to be composed of an odd number of three or more board members (for example, 5, 7, or 9 members). The proposed amendment would allow approximately one-third of members of boards whose membership is not evenly divisible by three to be elected or appointed every two years. The amendment also would allow the Legislature to set the composition of constitutionally required boards, whose members serve for a term of six years, to a number divisible by three so that exactly one-third of the board members may be elected or appointed every two years.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide that a state board, commission, or other agency shall be governed by a board composed of an odd number of three or more

members."

PROPOSITION NO. 15
ON THE BALLOT

HJR 36 - HJR 36 proposes a constitutional amendment that would allow spouses, by an agreement in writing, to convert all or part of their separate property into community property. Separate property is primarily the property owned or claimed by the spouse before marriage and the property acquired by the spouse during the marriage by gift or inheritance. Community property consists of the property, other than separate property, acquired by either spouse during marriage.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment permitting spouses to agree to convert separate property to community property."

PROPOSITION NO. 16
ON THE BALLOT

HJR 71 - HJR 71 proposes a constitutional amendment that would allow a county with a population of 50,000 or more, rather than 30,000 or more, to be divided into four to eight justice of the peace and constable precincts. The amendment also would allow a county with a population between 18,000 and 50,000 to have two to eight justice of the peace and constable precincts, rather than the current maximum of five precincts. Furthermore, the amendment would limit Randall County to not less than two and not more than six precincts. Finally, the amendment would set a minimum of four precincts for any county that as of November 2, 1999, is divided into four or more precincts.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to provide that certain counties shall be divided into a specific number of precincts."

PROPOSITION NO. 17
ON THE BALLOT

HJR 58 - HJR 58 proposes a constitutional amendment which would require the board of regents of the University of Texas System to manage investments of the permanent university fund (PUF) according to the standards of a prudent investor. Generally, earnings from the PUF are distributed to the available university fund (AUF) and then ultimately distributed to the public university systems of Texas. Under the amendment, the amount distributed to the AUF would consist of distributions, as determined by the University of Texas System board of regents, from the total return on all investment assets of the PUF, instead of consisting only of the dividends, interest, and other income of the PUF minus administrative expenses. The amendment also would provide guidelines for minimum and maximum amounts to be distributed to the AUF, and require that the board of regents manage distributions to the AUF in a manner that will provide the AUF with a stable and predictable stream of annual distributions and maintain the purchasing power of the PUF investments and annual distributions to the AUF.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment relating to the investment of the permanent university fund and the distribution from the permanent university fund to the available university fund."
