Browning receives Golden Spur

J. Ernest Browning of the Mule Shoe Ranch near Willcox, Arizona has been named recipient of the prized National Golden Spur Award presented annually by America's major livestock associations.

Browning is the fifth to receive the crystal and gold presentation piece which recognizes significant lifetime contributions to the livestock and ranching industries.

Browning is a founder and former president of the American Quarter Horse Association, a cattleman noted for breeding and production of Herefords, a

member of the National Cowboy Hall of Fame Board of Trustees, and a former director of both the National Cattlemen's Association and the Livestock and Meat Board.

He will be presented the Steuben designed award at a National Golden Spur Award and Prairie Party at the Lubbock Civic Center Sept. 17. The event expected to attract 1,500 people follows a Livestock Day and precedes Ranch Day at the 14 acre Ranching Heritage Center of the Museum of Texas Tech University. A symposium on railroads of the Southwest and a national exhibit of western

art will be held in conjunction with the Sept. 17-18 events.

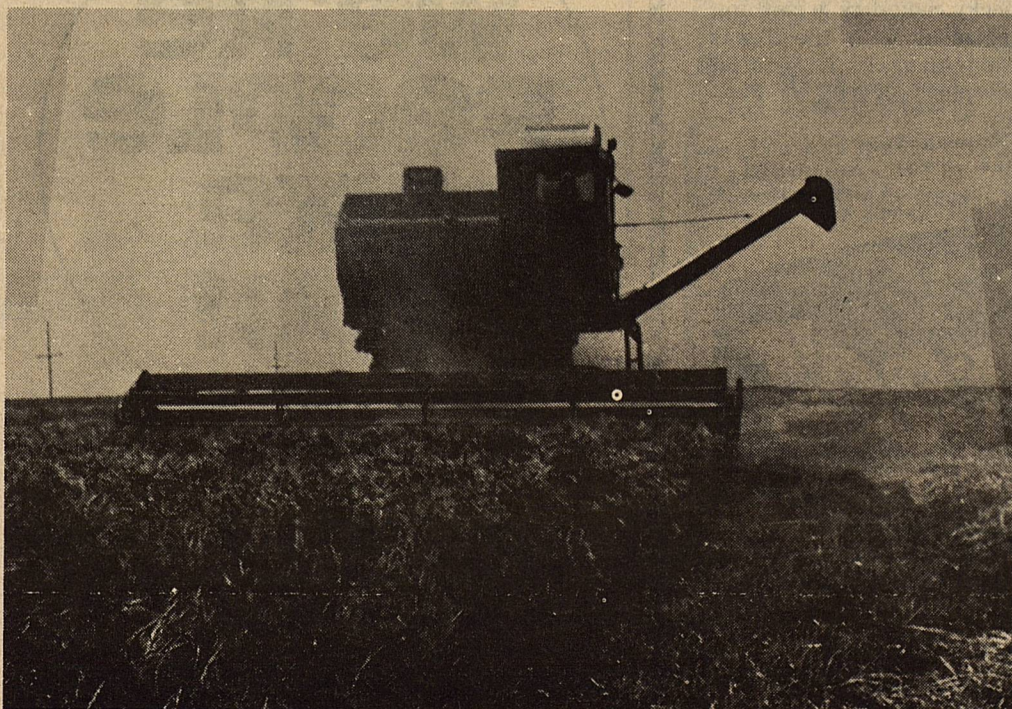
Announcement of the 1982 selection of Browning was announced by RHA Board Chairman John R. "Rich" Anderson. Anderson also outlined the plans for the Sept. 17-18 weekend.

Joining with the award sponsors for the Livestock Day is the Texas Cattle Feeders Association. Ranch Day is sponsored by the Ranching Heritage Association to enhance the public's understanding of one of America's bedrock industries-ranching as it developed in the American West, Anderson said.

Texas wheat farmers hope to harvest 163 million bushels



TEXAS WHEAT FARMERS expect to harvest approximately 163.8 million bushels this year, Agriculture Commissioner Reagan V. Brown has announced. This figure is 11 percent below the record wheat production of 1981. Tornadoes, high winds and heavy rains have severely damaged or completely destroyed several wheat fields in the Panhandle area, Brown added.

Clements announces relief to farmers

Gov. Bill Clements has announced the federal government will provide disaster relief to West Texas Farmers. That announcement follows the Governor's request that 26 counties be declared crop disaster areas by U.S. Department of Agriculture. Today Gov. Clements said \$350-\$400 million dollars will be available to those farmers with weather destroyed crops.

"I am extremely pleased that our Texas farmers will receive significant assistance from the federal government to help them in this economic emergency. Our farmers have suffered incredible devastation and we must utilize all resources to overcome this natural

disaster. I have been in constant contact with the White House and I have worked closely with Secretary of Agriculture John Block, and I am gratified by their response. I have already asked for disaster designation for 32 counties on the High Plains of West Texas, and I will amend my request to include other Texas counties as necessary. We will continue to seek ways to help the victims of this terrible disaster.

Recent heavy rains, hail, and tornadoes have left many Texas farmers in an economic emergency. The Governor says the disaster relief will be available to farmers in a number of west Texas counties.

Nearly 7,000 persons die each year in almost 700,000 home fires in the U.S. Since most of these deaths occur while people are sleeping, an early warning device such as a smoke detector can be a life-saver. Install a single smoke detector outside the bedroom area on the ceiling or wall for minimum protection. For a two story home with bedrooms on both floors, two units are needed one outside each bedroom area.

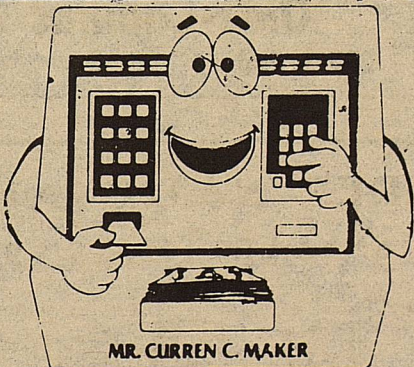

destroyed by the recent heavy rains, wind or hail, should be reported before plowing up or replanting to an alternate crop. This will protect your farm's eligibility for program benefits.

FINAL CERTIFICATION-REMINDER

August 2, 1982 is the final date to report your spring seeded crops of cotton, grain sorghum, corn and etc. You must also designate the Conservation Use Acreage required for program participation. An accurate acreage report is a must, if you miss your program acreage by over or under the 5 percent tolerance you will not be eligible for any program benefits, so take a little time and measure the acreage to assure that you are making an accurate acreage report.

SPECIAL DISASTER PAYMENT PROGRAM

Producers in Borden County are eligible for payments under the special disaster program. Details on payment procedure have not been received at this time, however producers must be in compliance with all program requirements

PUBLIC NOTICE OF INTENT TO CHANGE RATES

Notice is hereby given that Lyntegar Electric Cooperative, Inc. (the "Utility") intends to change rates for electric utility service effective July 30, 1982 or as soon thereafter as permitted by law. The changes are applicable to all areas to which the Utility provides electric utility service. All classes of customers are affected by the proposed changes. The Utility expects that the proposed schedule of rates will furnish the Utility 11.53 percent more in revenues than are furnished by the existing schedule of rates.

Implementation of the proposed changes is subject to approval by the appropriate regulatory authority. A statement of intent including the proposed revisions of tariff and schedules and a statement specifying in detail each proposed change, the effect the proposed change is expected to have on the revenues of the Utility and the classes and numbers of Utility consumers affected is on file with the Public Utility Commission of Texas, and the municipalities of Lamesa, Wilson, New Home, Meadow, Brownfield, Plains, Levelland and Sundown.

(Final Certification August 2, 1982) Payments will be based on the loss in production below 60 percent of the farms yield for feed grain and wheat, and below 75 percent of the yield for cotton. The rates are: Upland Cotton - 20.5 per pound; Grain Sorghum - .18 per pound; Wheat - \$1.75 per bushel. Producers will be notified as soon as other details become available.

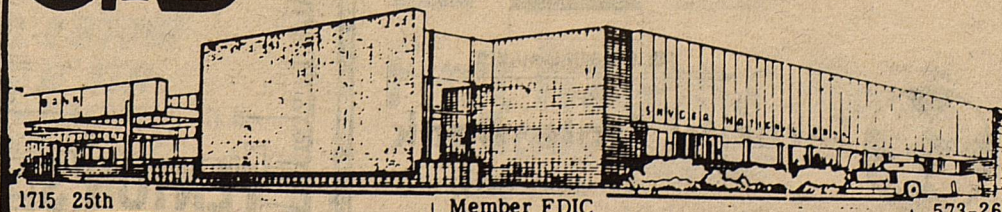
