(Ed note: The following is a letter to the New Mexico Cattle Growers written by their president Bob Jones and published in the August issue of The New Mexico Stockman. We thought it was worth re-printing.)

Dear Member:

Various groups representing different segments of agriculture (both state and nationally) have, over past years, professed the desire to get out from under subsidies and handouts and criticized others on the public dole. Strong self-reliant declarations have been produced in printed form and in self righteous rhetoric by representatives of these groups and from various individuals. Now an Administration trying to cut these welfare giveaways to farmers and ranchers, comes along expecting to be supported and welcomed as saviors of the American system. Lo and behold they find that all of these strong vocal stalwarts have fled to the other side or are hiding in the bushes. The National Cattlemen's Association says please don't cut any more money from our wonderful brucellosis program, and the good old conservative American Farm Bureau seems to want to increase the funds for this bird nest on the ground...for needy vets, bureaucrats and livestock owners who can't clean up their own act. Not only that, let's ground all of those dangerous individuals who if they dare protest or resent us, then find the britches off of them!

Why aren't all these organizations applauding the attempt to bring sanity back to the country and clammering for more cuts to be made even more quickly

## Registration deadline

Oct. 3

Eligible voters who have not registered to vote must do so by Oct. 3 if they wish to cast their ballot in the Nov. 2 general election.

All that is involved is filling out an application card available at the county voter registrar's office.

High school seniors are particularly encouraged to register to vote. Those who are 17 years and 10 months of age are eligible to register and may exercise the right to vote on or after their 18th birthday. Some 188,000 high school seniors should be eligible to vote in Texas this fall.

Everyone eligible to vote but unable to do so on Nov. 2 should apply at the county voter registrar's office to vote absentee. Oct. 29 is the deadline for voting absentee in person while absentee ballots will be accepted in the mail as late as 7 p.m. Nov. 2.

Any of the following conditions can qualify an individual to vote absentee:

1. Absence from the county or residence on election day.
2. Age 65 or older on election day.
3. Inability to appear at the authorized polling place on election day due to sickness, physical disability or religious belief.
4. Service as an election clerk or a poll watcher in an election precinct other than the precinct of residence.
5. Under certain circumstances, voters confined to jail may be eligible to vote absentee.

Every Texas House, Senate and Congressional seat is up for re-election this fall along with nearly every

## Voter Apathy Could Kill Amendment

Texas voters will go to the polls Nov. 2 to vote on six constitutional amendments, but voter apathy could kill chances for farmers, ranchers and consumers to hold the line on food costs, says Frates Seeligson, TSCRA president and member of the Vote for 3 Committee.

Proposition 3 would remove the limitations on the tax exemption for implements of husbandry, i.e., agricultural machinery and equipment. If passed, it will mean store prices for food items would no longer reflect additional production costs caused by property taxation. This action is one step we can take to help hold down rising food costs, he reiterated.

Passage would encourage a healthy agricultural industry in Texas and would contribute to the validity of the states overall tax revenues from many other sources.

Without a removal of this inequitable tax, some producers may conclude that it is no longer worthwhile to remain in the food production business. This would lower production and generally that results in higher food prices to the consumer.

## Senate Approves Immigration Bill On 81-18 Vote

The first overhaul of the nation's immigration laws in more than 30 years easily passed the Senate, but may run out of time in the House, Congressional sources say.

S.2222, introduced by Senator Simpson of Wyoming, calls for employer sanctions for knowingly hiring illegal aliens and stiff fines for those who do. Employers with three or less employees are exempt.

The bill also would grant permanent-resident status to illegal aliens who came into the United States before 1977 and have remained since then. Aliens who arrived between Jan. 1, 1977, and Jan. 1, 1980, would receive temporary-residence status.

They would be granted permanent-residence status after being here an additional three years.

The controversial legislation has the support of the Reagan administration, but has

drawn heavy criticism from business, labor, Hispanic groups and civil rights leaders.

Several amendments are expected in the house, if it reaches the floor before Congress adjourns.

TSCRA supports recent policy by the National Cattlemen's Association which opposes employer sanctions as a means of controlling illegal immigration, unless they are accompanied by a clear cut national identity program.

## Three Admit Rumor Spreading Was Wrong

Three persons recently admitted that they were wrong to have associated the Procter & Gamble company with satanism and to have encouraged others to stop buying P & G products.

The three have signed agreements not to spread the false rumors. As a result, P&G dropped charges it had filed against them in Federal Court. The company said it is still pursuing three other similar lawsuits, and added additional suits are possible.

"Our sole purpose in filing these lawsuits was to stop the spread of false and malicious stories about our company's 'moon and stars' trademark," said P&G spokesman Donald Tassone. "Since these people have publicly stated they were wrong to have believed and spread the rumors, there is nothing to be gained by continuing these two lawsuits, and they

are being concluded."

Tassone said in the past seven weeks, telephone calls to the company about the trademark have decreased dramatically, and the decline is continuing.

"It's apparent that the problem is deminishing as people involved become aware of the facts," the spokesman said.

P&G went on the offensive in June to stop false stories linking its century old trademark with devil worship. The company attributes part of its success in putting down the rumors to the public support it received from several nationally prominent religious leaders.

The Reverend Billy Graham said, "I urge Christians everywhere to reject these false rumors." The Reverend Jerry Falwell and others also have called for an end to the false statements.

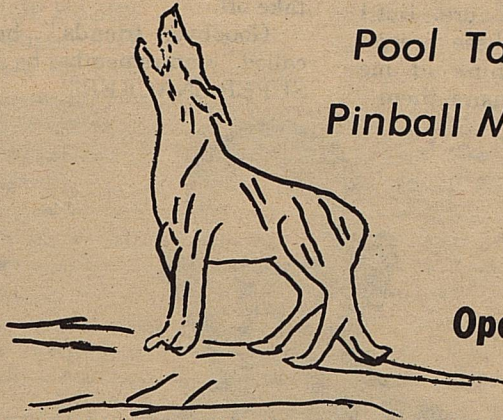

## CROP BASES

Wheat and feed grain bases for 1983 will be the same as for 1982, regardless of whether or not you participated in the program.

Based on information we now have, cotton bases for 1983 will be established as follows:

1. If you participated in the program, you will receive the same base that you had for 1982.
2. If you planted "0" cotton and certified "0", your 1983 base will be the same as for 1982.
3. If you were not in the program, your base will be the average of 1981 and 1982.

Conservation Use Acreage (CUA) Requirements

Conservation Use Acreage requirements for 1983 will be the same as 1982 except as follows:

1. Land given for Conservation Use Acreage (CUA) must have been in a

small grain or row crop in 2 or the last 3 years. Land designated for CUA in 1982 will be considered to have been cropped.

2. Land that is otherwise eligible may be established in permanent grass and used through 1985 for CUA providing the cover is maintained.

3. No crop can be harvested from CUA.

Small grain or other cover crop on CUA can be grazed until May 1, 1983. Stock must be kept off of CUA from May 1 until November 1, 1983.

## 1983 ADVANCE WHEAT DIVERSION AND DEFICIENCY PAYMENTS

An advance on 1983 diversion and deficiency payments may be requested at the time of sign-up. The advance will be 50 percent of the diversion payment (5 percent of your base X your yield X \$2.70 per bushel) and 50 percent of the 1983 projected deficiency

payment. The advance deficiency payment will be made at the rate of 32½ cents per bushel times your intended acreage for harvest times your yield.

## OVERPAYMENTS ADVANCE PAYMENTS

If you request an advance payment and are determined to be ineligible for program benefits for any reason, including withdrawing from the program, you must refund the amount of the advance plus interest. Interest will be charged from the date of disbursement until the date of repayment. The interest rate will be the rate in effect on the date of disbursement plus 5 percent.

## DISASTER ON PARTICIPATING FARMS

If you have a crop that fails, come in and sign an ASCS 57 before you destroy the crop.

If you have a crop that produces a low yield, come in and file an ASCS 574 and turn in your production within 15 days after you harvest the crop and before evidence of the crop is destroyed.

Failure to do either of the above will make the crop ineligible for disaster consideration.

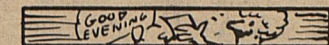

## CROSS AND OFFSETTING COMPLIANCE

Cross and offsetting compliance will not be effect for 1983. In other words, what you do on one farm or with a particular crop will not affect other farms or other crops in regard to program participation.

## SIGN-UP FEED GRAIN AND WHEAT

The sign-up period for wheat and feed grain will be from October 1, 1982 through March 31, 1983.

If we are successful in raising more campaign funds, you are likely to see more columns. I hope so, for this seems to be a good way to get the issues to the people.

These columns are needed. Without them Mr. Hobby will clearly avoid the issues and seek to confuse us with 30-second TV commercials created by his image builders. 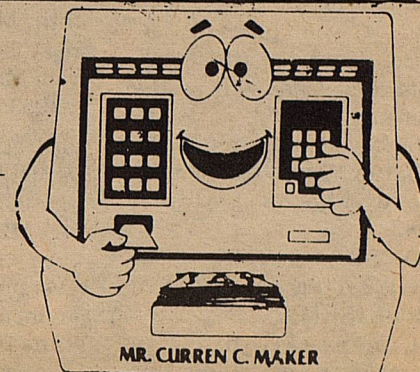
