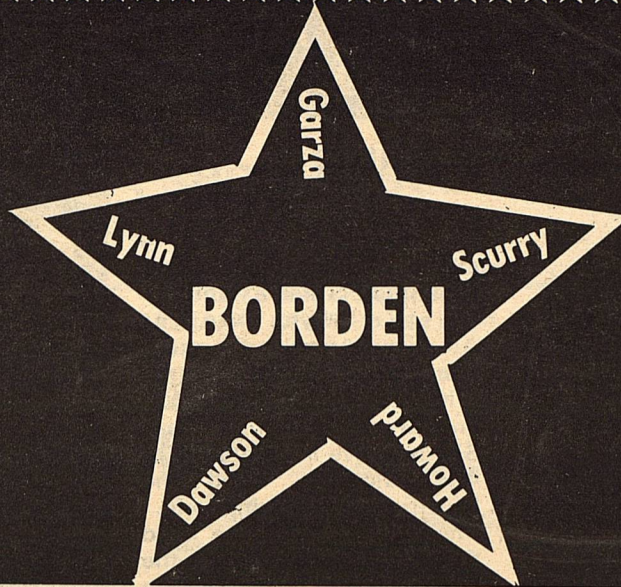

## Stone Takes Overall Showman Award

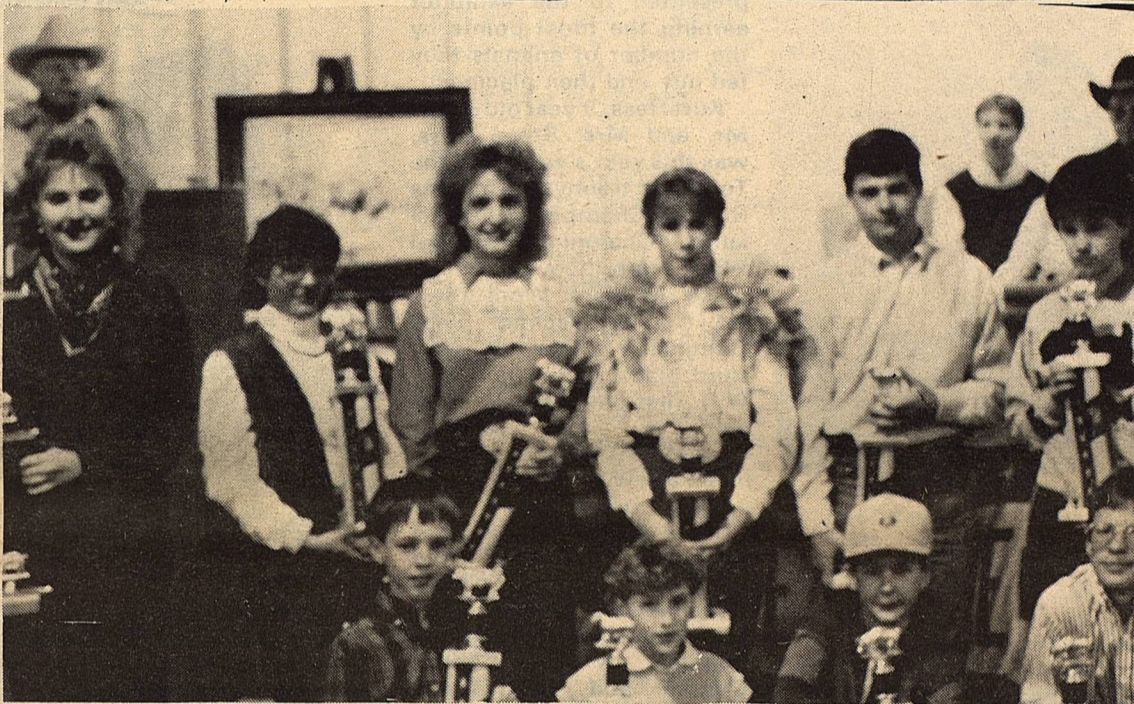

## BORDEN COUNTY JUNIOR LIVESTOCK SHOW

### BARROW SHOW

An anxious audience of family and friends crowded the Borden County Show Barn at Gail Thursday January 29 to watch 4-H's and FFA students exhibit their swine, lambs and steers in the three day Livestock Show. Exhibitors showed seventy-five barrows, thirty steers and one hundred and thirty-one lambs.

Announcing the shows was Pat Ray, pastor of the Gail Baptist Church.

Mr. Johnny Peugh, a Stanton hog farmer judged the show. He complimented the young showmen on their behavior and courtesy to him and fellow exhibitors.

He found the "volumn" and overall hog in Kurt Hess' heavy weight cross. The Reserve Champion was shown by Leslie Fryar.

### LAMB SHOW

Lamb Judge Jim Mazurkiewicz of Bryan showed a marked preference for leaner animals in the individual class judging Friday, but chose heavyweight crossbred lambs for the grand and reserve champions of the 1987 Borden County Junior Livestock Show.

The grand champion's award went to Tammy Voss and the reserve championship was awarded to Shane Hess--both of whom exhibited animals in the heavyweight crossbred class.

The Voss and Hess lambs were also the breed and reserve breed champions for the crossbred lambs.

Kurt Hess who had claimed the grand championship of Thursday's swine show,

added two more major awards to his trophy case in Friday's lamb show.

Mazurkiewicz chose his heavyweight finewool lamb as reserve breed champion for that class and his mediumweight mediumwool lamb as breed champion of that division.

Michael Murphy won the breed championship of the finewool division while the reserve breed championship in the mediumwool class was awarded to Stormy Gass.

### STEER SHOW

The 1987 show was to conclude Saturday with the Borden County FFA and 4-H youth exhibiting 30 animals in the steer show starting at 9 a.m. Bob Benson of Plainview was to judge that event.

## Sale Average Is High

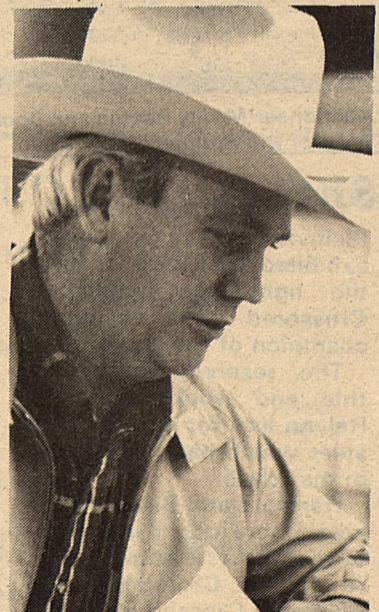
Longtime friend of the Borden County Junior Livestock Association, Monty Paxton opened the bidding for the auction Saturday.

The floor price was set at 62 cents for steers by Sweetwater Cattle Auction, 75 cents for lambs by Kenny Hart of Snyder, and 47 cents for barrows by Plains Hog Company of Lubbock.

The economic slump was really brought home to the exhibitors as the total sales for 76 animals of \$36,775.00 was a large decrease from last year's sale. The average price per animal was \$480.00 which was an increase of thirty dollars from the previous year.

Kristi Stone's Grand Champion Steer brought top price of \$1500.00, purchased by the Muleshoe Ranch, Rich Anderson; Tammy Voss' Grand Champion Lamb, purchased

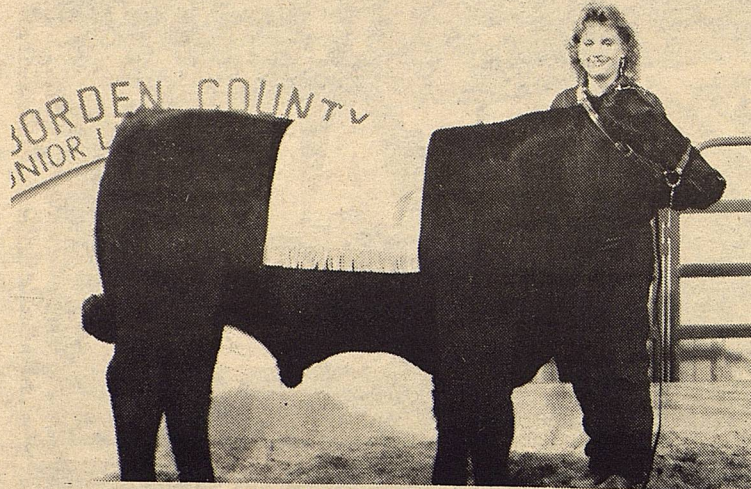

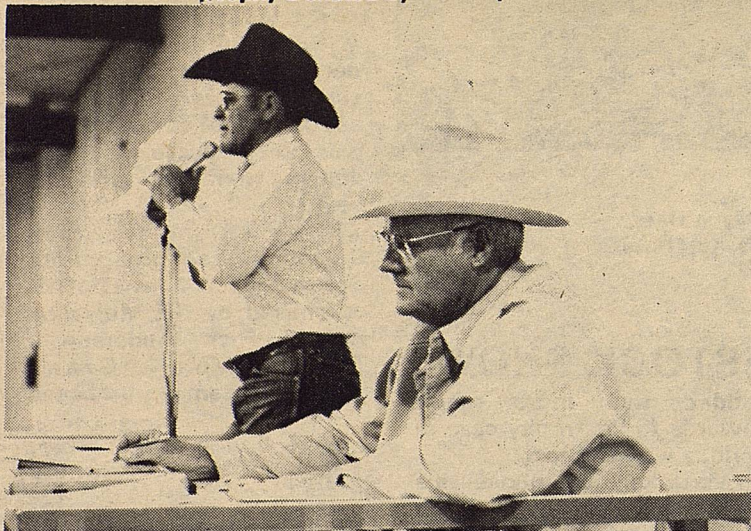

The Top Hand trophy is presented to the exhibitor earning the most points by the number of animals they fed out and their placings.

Kurt Hess, 9 year old son of Mr. and Mrs. Steve Hess, was this year's winner of the Top Hand trophy. He had the Reserve Champion Finewool lamb, Champion Medium Wool Lamb (lt. wt.), second place Medium Wool (hvy. wt.) lamb, second place Hampshire barrow (lt. wt.), third place Hampshire (hvy. wt.), first place lt. wt. cross barrow, and Grand Champion Cross Barrow to name a few.

Kurt also won the Elementary Barrow Showmanship Award and was the third place salesmanship winner. The Showmanship Awards are donated by Dr. Charles Church and Linn Travel donated the salesmanship trophy.

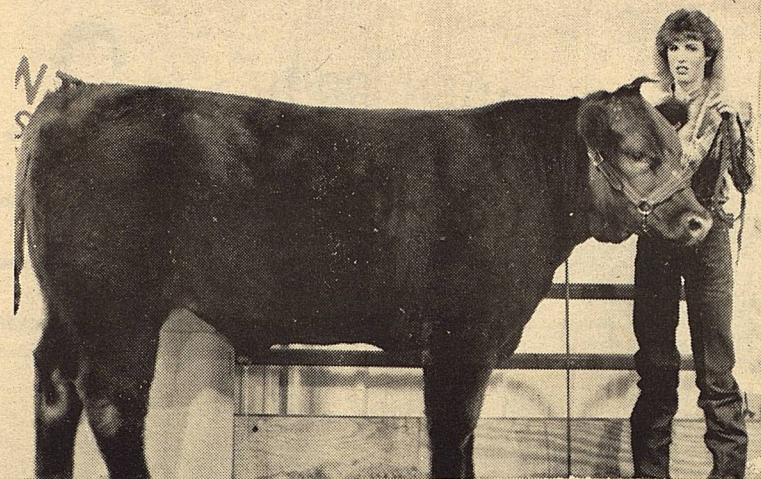

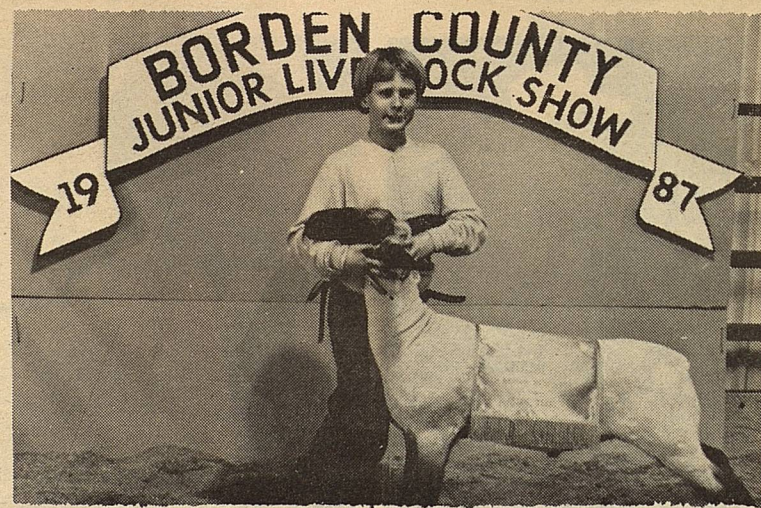

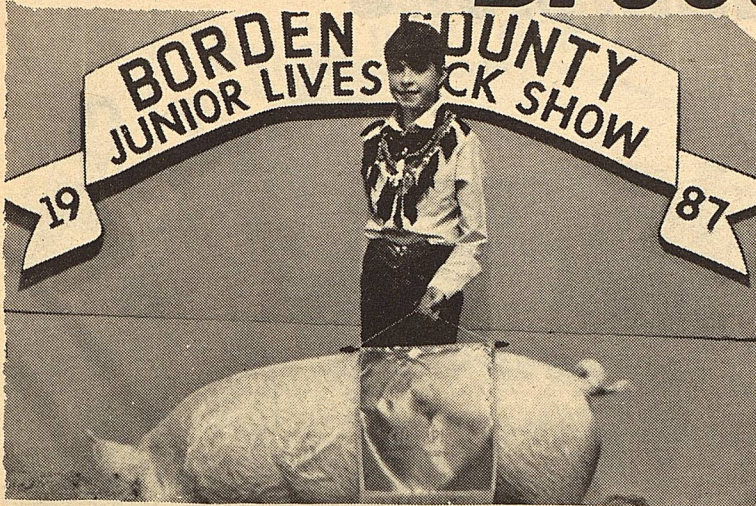

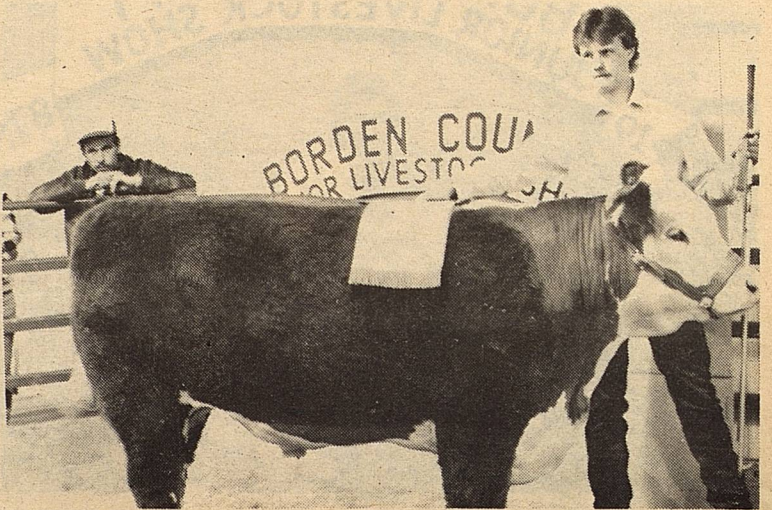

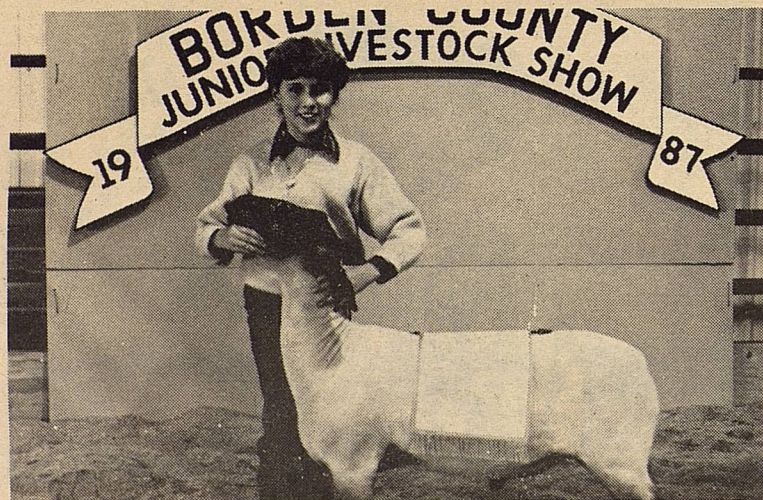

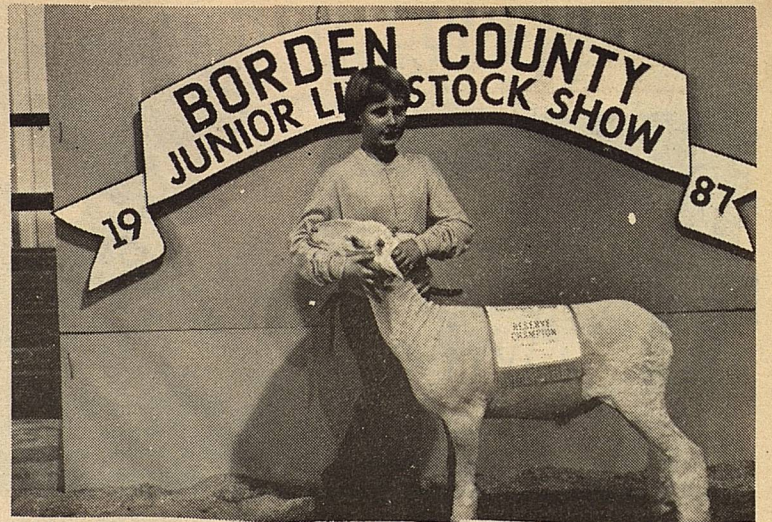
M'Lys Lloyd with her Reserve Champion British Breed

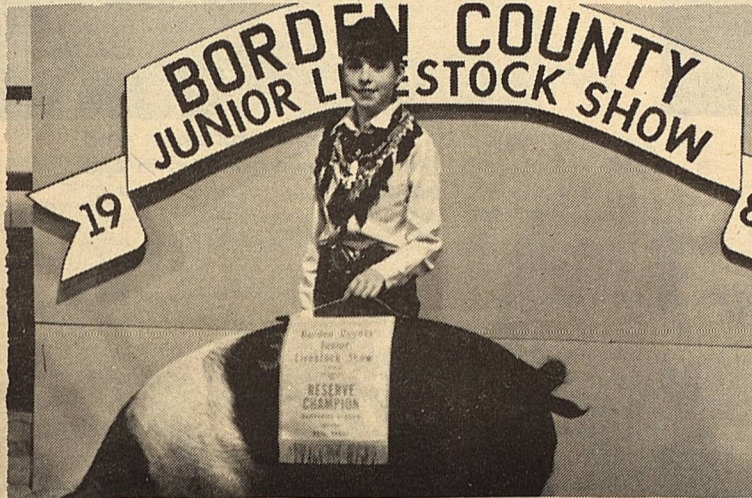

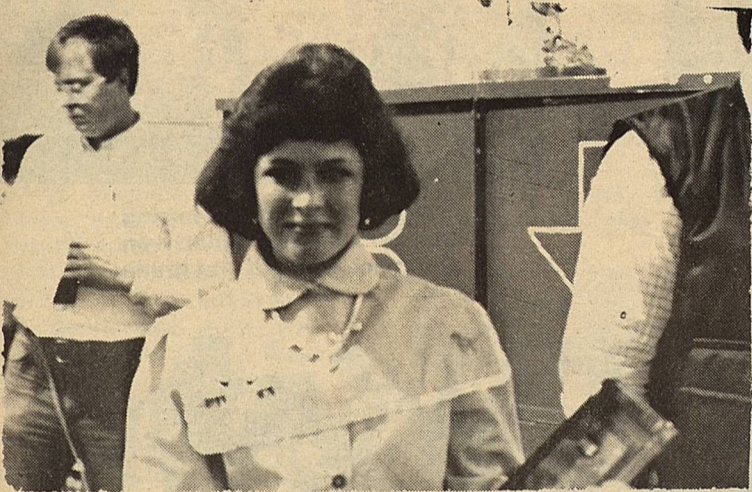

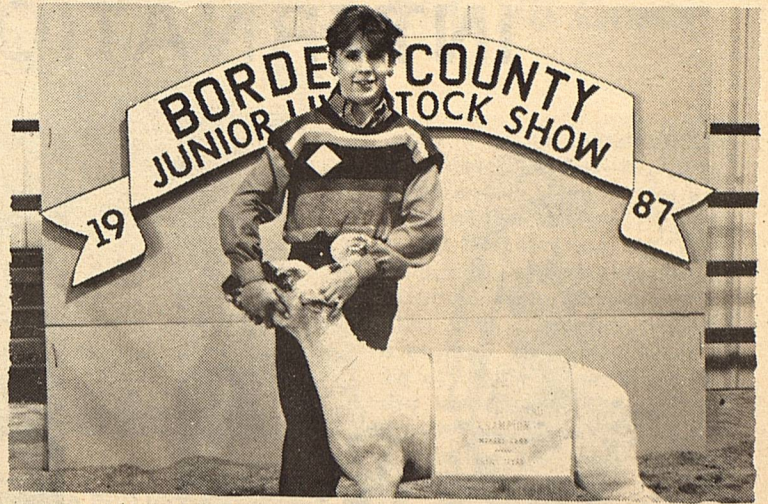

A very telling statistic in Friday night's defeat was the number of points scored from the free throw line. Borden connected on one of only four opportunities, while Klondike was 10 of 17.

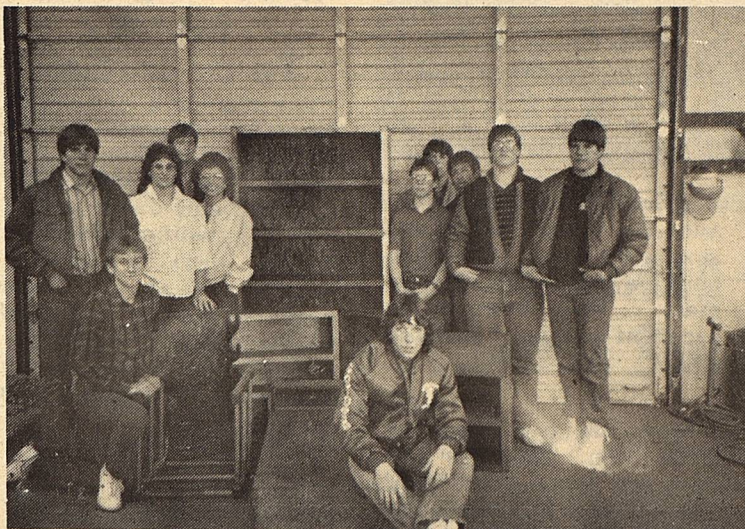
Another big factor in the loss was the second quarter scoring. Borden got into early foul trouble, getting

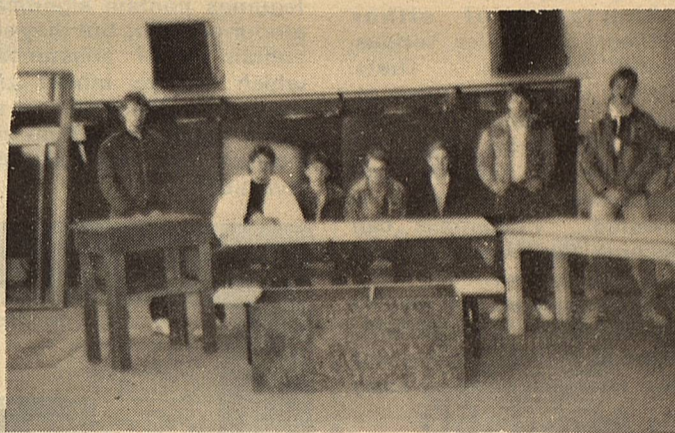

# Extension Home Economics Report

## PUMPING DIETARY IRON

How much iron has your child pumped today? How much have you? No, not the kind with barbells and muscle shirts. This iron is strictly dietary and the lack of this mineral in the American diet is affecting the well being of millions.

Adult women and young children in the United States consume only about two-third of their recommended dietary iron allowance, according to the Department of Agriculture's 1985 Nationwide Food Consumption Survey. In fact, iron is one of the nutrients most often lacking in the American diet.

It is not the only mineral Americans are forgetting to pump either. The statistics for zinc are equally sad. Women from 19 - 50 years consume only an average 61 percent of the recommended daily allowance (RDA) of zinc. Children, 1-3, fall short of their zinc RDA by an average 23 percent.

Shortages of either nutrient can cause serious health problems. Diets lacking in iron can lead to anemia, irritability, apathy and reduce work capacity. Digestion is hindered and resistance to infection is lowered. Fingernails can become thin, spoon-shaped and pale in color.

Zinc shortages will lead to loss of appetite, poor growth, retarded sexual maturity and skin changes, such as scaly

How do you insure an adequate supply of iron and zinc in the diet? One of the best ways is to include red meat. Red meat is an excellent source of iron and zinc.

There are two types of dietary iron: heme iron and nonheme iron. The body absorbs heme iron five to ten times better than the nonheme version. Plant sources supply nonheme iron while animal sources supply both. About 40 - 60 percent of the iron in beef and other red meats is heme iron.

Zinc content of foods is highest in foods with a high protein content. It is also found in vegetable protein sources such as nuts and whole grain breads and cereals. However, just because you include foods high in zinc, does not mean that your body will get enough zinc. The availability of zinc differs from one food to another. Cereals and legumes contain significant amounts of zinc but they also contain other substances which act to inhibit zinc availability. Red meat, on the other hand, has a high zinc content as well as high availability.

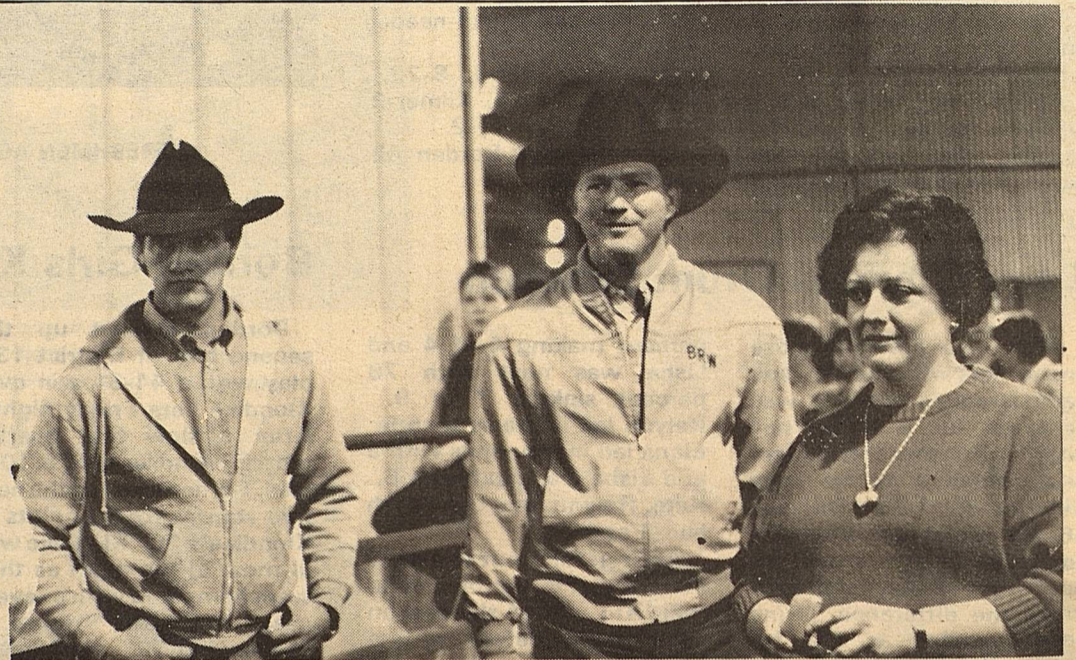

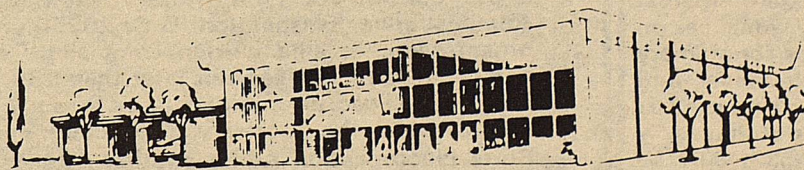

### PRO<sup>SM</sup> TEXAS A NEW OPTIONAL CALLING PLAN FROM AT&T

On November 13, 1986 AT&T Communications of The Southwest, Inc. ("AT&T") filed with the Public Utility Commission (PUC) of Texas to introduce a new intrastate, optional calling plan, PRO Texas. A comparable interstate plan, known as PRO<sup>SM</sup> America, is currently available to Texas customers.

**PRO Texas gives Texas consumers an opportunity to save money on direct dialed in-state long distance calls.** Customers who choose this new AT&T plan will receive a 10% discount on all AT&T intrastate direct dialed station calls by paying a monthly charge of \$15.00.

**The PRO Texas discount applies to calls placed during all rate periods and all days.** The discount is in addition to the AT&T intrastate evening discount of 25% and the night/weekend discount of 40%. A one time charge of \$6.00 will be billed to initiate the service. However, this charge will be waived during the first 90 days that the offering is available.

PRO Texas will be available to all Message Telephone Service customers in Texas. AT&T estimates that it will generate revenues in the first year of almost \$8 million, which is .7% of AT&T's annual revenues for all Texas intrastate service.

The PUC has assigned Docket No. 7194 to this proposed service offering. The proposed effective date for PRO Texas is March 16, 1987.
