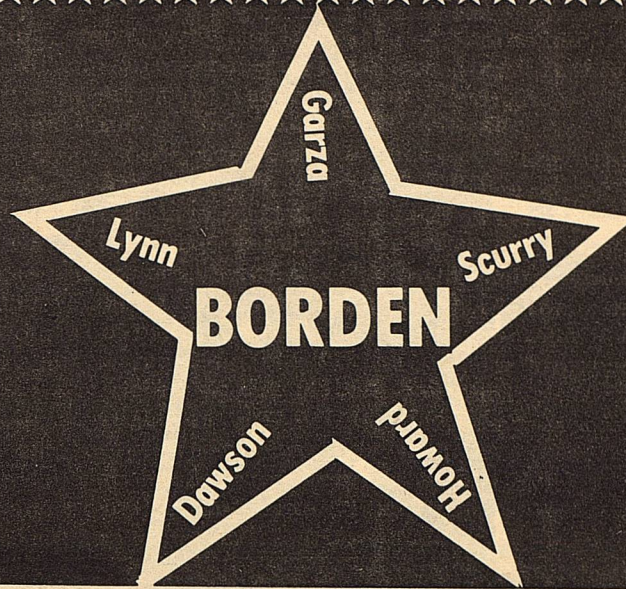

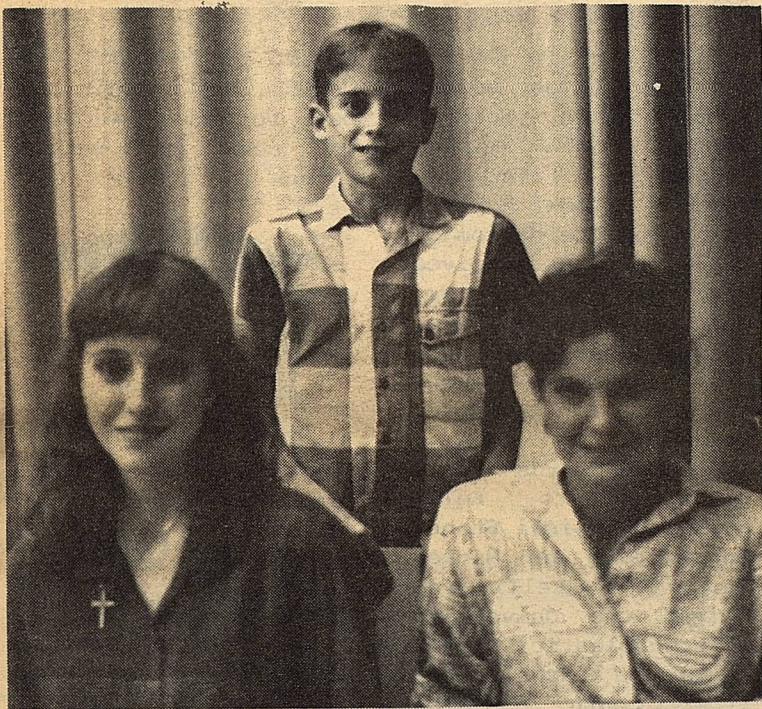

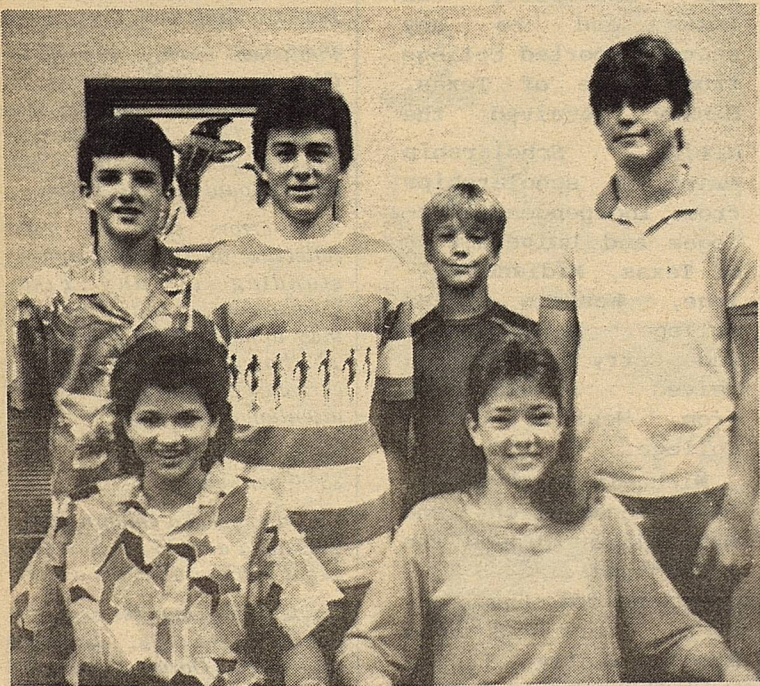

Mickey Burkett gave the Salutatorian Ad-dress. "We have finished the basic stage of our education. True edu-cation never stops", said Mickey.

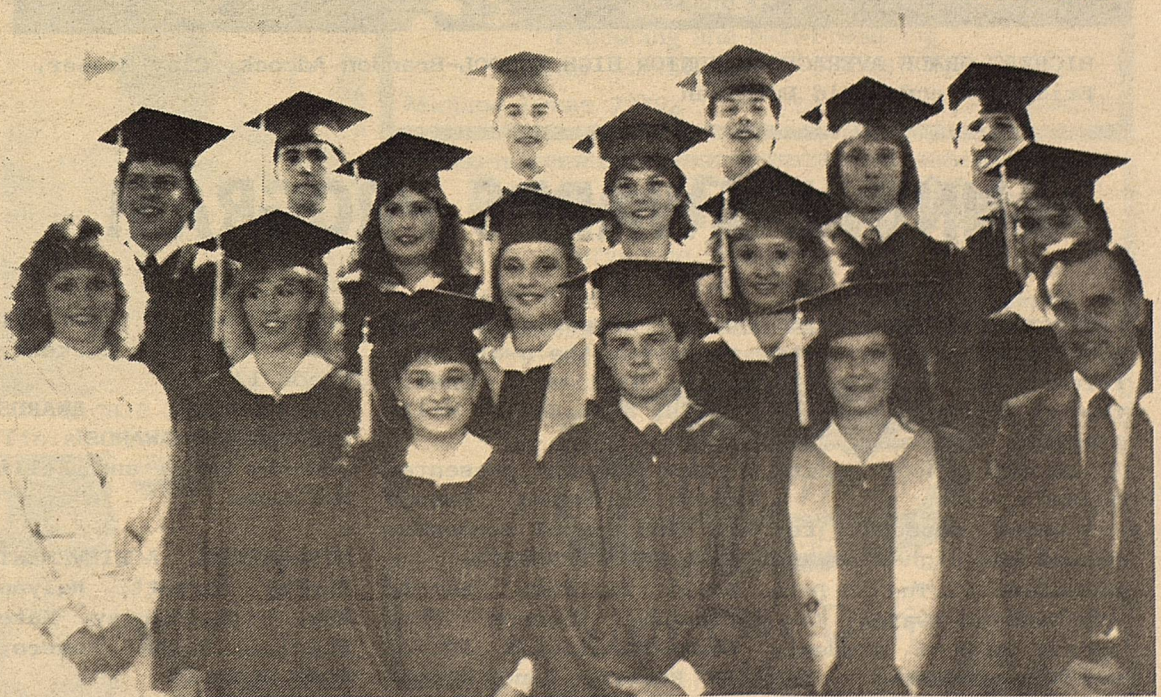
John Stephens gave the Class History, Kristi Stone, Prophecy and Gerry Smith, the Class Will.

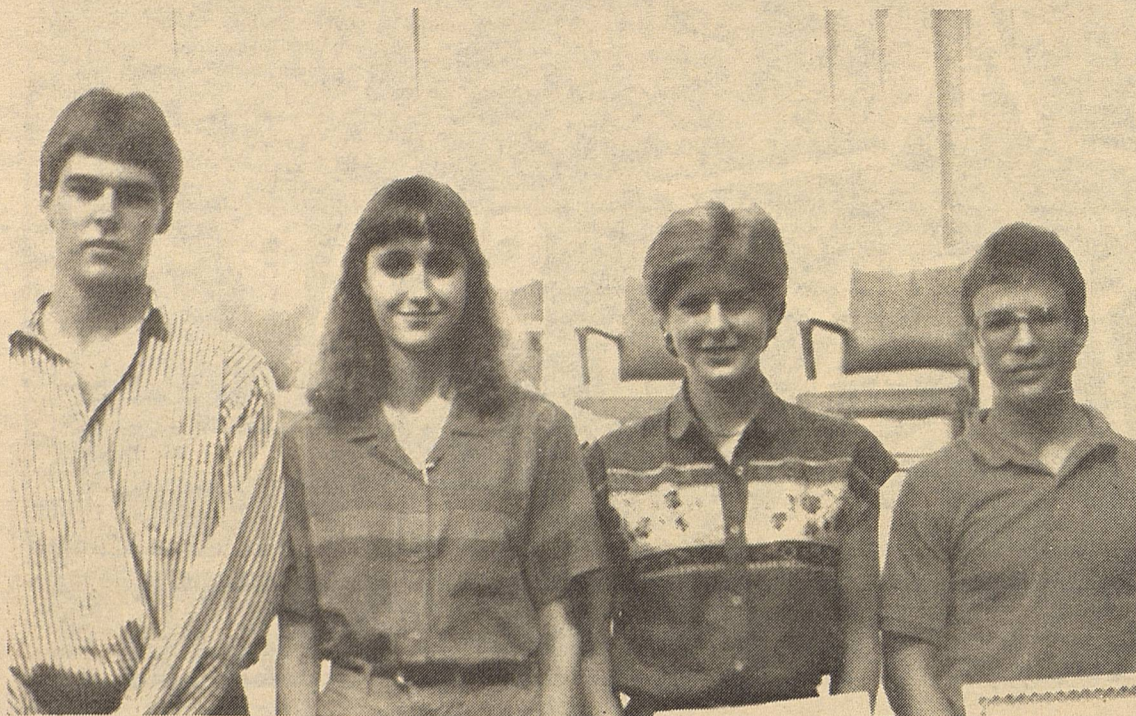

Screwworm Cases Confirmed

The first confirmed screwworm case in the United States since August of 1982 has been identified in Denver, Colo., as a result of commuting flies that apparently traveled back to the U.S. from Venezuela with several hunting dogs.

Worms were collected from a wound in one of the hunting dogs by a veterinarian in Denver on April 7, and the worm sample was sent to a number of laboratories before it was identified as a positive screwworm case April 23 by a lab in Ames, Iowa.

The dogs had been flown from Colorado to Venezuela for an earlier hunting trip. Upon their return to the U.S. on April 4, the owner of the animals took them with him to Albuquerque, N.M., where he spent two days visiting a brother. He then took the dogs with him in a pickup truck to Pigosa Springs, Colo., and thence to Denver, where the veterinarian collected the worm sample.

Treatment over the Albuquerque-Denver areas began immediately after confirmation of the screwworm case, with sterile fly drops being dispatched from Tuxtla Gutierrez, Mexico. In addition, the U.S. Department of Agriculture's Animal and Plant Health Inspection Service is operating Screwworm Adult Suppression System (SWASS) traps to help in monitoring the situation.

A caution to all owners of household pets and livestock to be on the alert for screwworms. When worms are found in animal wounds, representative samples of worms in a wound should be collected and sent to the Screwworm Laboratory, Box 969, Mission, Texas 78572, for laboratory identification.

When any suspected blowfly larvae is found by a veterinarian, livestock or pet owner, great care should be used in getting a truly representative sample

USDA CELEBRATES 125th BIRTHDAY

The U.S. Department of Agriculture is celebrating its 125th birthday. The theme, "Serving Agriculture, Serving America," emphasizes the role USDA has played in providing a wide range of services throughout its 125-year history.

USDA was established May 15, 1862 when President Abraham Lincoln signed a law establishing "a Department of Agriculture..to acquire and to diffuse among the people of the United States useful information on subjects connected with agriculture in the most general and comprehensive sense of the word." Lincoln also dubbed it "the People's Department."

When the Department was established, most people were farmers, and USDA programs were primarily for farmers. Now, farm families and workers represent a smaller share of America's population, but USDA still has a very wide range of responsibilities through which it serves the nation. These include protecting our soil, forests, and other natural resources; protecting public health by safeguarding our food supply; conducting domestic and international marketing programs; and research and education. These activities serve not only American agriculture but all Americans.

USDA has stayed in touch with the needs of Americans, even though most Americans no longer live on farms, agriculture and its related industries still represent the largest sector of our economy and USDA continues to respond to President Lincoln's charge to be "the people's department."

FINAL PLANTING DATE

Borden Counties final planting dates are, for cotton June 20th and for grain sorghum, June 30th. However this does not prevent producers from planting after the established dates, and crops that fail due to natural disaster will not be required to be replanted beyond this date.

For prevented planting credit the operator must file an ASCS-574 within 15 days after the final planting date for the crop prevented. Request for disaster credit on failed acres must be filed within 15 days from the date of the disaster and before destroying any evidence of the affected crop.

FINAL CERTIFICATION DATE

Producers must certify to their spring seeded crops by July 15, 1987. As you are well aware, it is of great importance to have an accurate crop certification. Again this year there will be a tolerance the smaller of 1 acre or 5%, on the reported acreage. Should your report be out side this tolerance you might well lose all program benefits.

MEASURING SERVICE

Measuring service is available to all producers that wish to apply. The service is guaranteed, and is the cheapest insurance available to you; if within allowable tolerance the producer is allowed to certify to the measured acres and if the measured acreage is outside the tolerance the producer will be allowed to adjust the acreage.

Deworming Pays for Cattlemen

Preliminary results of deworming trials conducted by the Texas Agricultural Extension Service in cow-calf and stocker calf herds show that deworming is a profitable practice for beef producers.

Production benefits of strategically timed deworming programs in Texas showed an average 28-pound advantage in weaning weights for spring-born calves from dewormed cows and a 16-pound gain advantage for stocker heifers dewormed in the spring.

The 28-pound advantage represents an increase of 7.3 percent in calf weaning weights over the control group, and a return of about \$16--almost a 6-1 return for dollar invested. In one trial, treated cows gained an additional 43 pounds per head over those in a control group.

The 16-pound gain in the stocker heifers was a return of \$8.25 per head to the producer.

The trials are aimed at evaluating deworming programs and the economics of internal parasite control for beef cow-calf and stocker calf herds in distinctly different environmental areas of Texas. The Hoechst-Roussel Agri-Vet Co., which manufactures the dewormer SAFE-GUARD (fenbendazole), cooperated in the study.

A total of 195 spring calving cow-calf pairs were involved in the statewide study. One group received the recommended dosage of SAFE-GUARD the last week of February for control of internal parasites while the control group received no deworming treatment. Both treated and control groups were pastured separately in areas not previously grazed that year and kept there until calves were weaned. Calves in the treatment group also were treated with the recommended dosage of SAFE-GUARD at about 3 months of age.

The deworming studies are a part of the on-going Extension beef program focusing on "Integrated Resource Management." Additional studies are planned over the state this year and into 1988 to evaluate more accurately the strategic timing of deworming both spring and fall calving herds.

Here is an outline based on cost effective, seasonal control practices for producers regarding deworming:

- Cow/Calf
--Deworm cows between March 1 and April 15 (before extended grass growth).
--Deworm the calves by June 1. Calves should weigh at least 200 pounds at deworming.
--Depending on the length of the grazing season, treating the cow in late fall or early winter may be beneficial.
Stocker Cattle and Bred Heifers on Permanent Pastures.
--Deworm when spring grass growth begins, followed by a second treatment three to four weeks later, and a third treatment three weeks after the second treatment.
Stocker Cattle on Small Grains
--Deworm stocker cattle at time of placement on small grain pastures.

The Parable of the Sower  
Matthew 13:3-9, 18-23

Jesus said, "A farmer went out to sow his seed. As he was scattering the seed, some fell on rocky places, where it did not have much soil. It sprang up quickly, because the soil was shallow, but when the sun came up, the plants were scorched, and they withered because they had no root.

## Plague Virus Uncovered In Four Area Counties

Officials at the Texas Department of Health's Bureau of Veterinary Public Health have reported that evidence of plague has been found in wild animals in Crane, Hudspeth, Glasscock, and Midland counties, according to South Plains Health Department Sanitarian Sanders.

Although plague is primarily a disease of wild rodents, it can be transmitted to humans by direct contact with infected animals or dead animal carcasses, and also by the bites of infected fleas.

The disease is caused by the organism responsible for the infamous "Black Death" in 14th century Europe, but there is no danger of

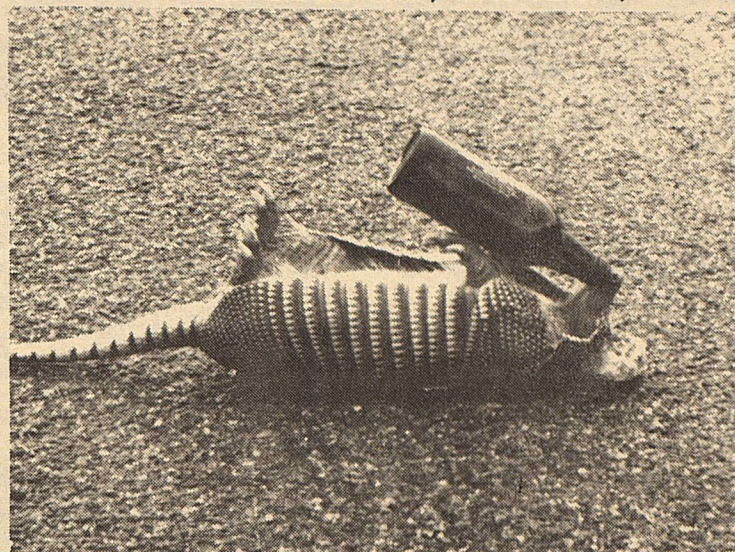
such a massive problem today, according to Dr. Evret C. Newman, regional veterinarian for the TDH. Although human cases of plague in West Texas are very rare, he warned, the disease remains a threat.

Of some 44 samples of wild animal blood examined in April, said Newman, 11 tested positive for antibodies against plague, which indicates the animals had recently been exposed to the disease.

Newman suggested several simple precautions to reduce the risk of people becoming infected with plague.

"Stay away from squirrels, prairie dogs, wild rabbits and other wild animals; avoid sick or dead wild animals, and keep dogs and cats free of fleas and confined to the owner's premises."

Since the beginning of the plague surveillance program, evidence of the disease has been found in 14 of the 23 counties in this public health region. In addition to the recent reports, plague-positive animals have been found in past years in Andrews, Borden, Brewster, Culoberson, Ector, El Paso, Howard, Pecos, Ward and Winkler counties.
