Stenholm Seeks Seventh Term

Congressman Charles W. Stenholm today announced his plans to seek a seventh term as representative of the 17th District of Texas.

The conservative Democrat from Jones County said he wants a two-year extension on his contract to serve the people of West Texas. He wants to continue strong support for rural health care providers and a 1990 Farm Bill that insures sufficient quantities of top quality food. Our system produces the safest food at the least cost of any in the world and we must keep it this way.

"The people of West

Texas are the best in the country and being their representative is a serious responsibility for me," Stenholm said.

Stenholm has been present for over 96 percent of all recorded votes during his time in office.

Congressman Stenholm was recently appointed one of 15 Deputy whips in the Democratic leadership. He serves as Chairman of the Livestock, Dairy and Poultry Subcommittee of the Committee on Agriculture and is a member of the Veteran's Affairs Committee.

Announces Candidacy

Fourteenth Court of appeals Justice Ross A. Sears today announced his candidacy for the Texas Supreme Court, stating: "Texas deserves a Supreme Court Justice who has the courage to apply the law equally and who is totally dedicated to the judiciary."

Running for Place Two, a seat which Justice C.L. Ray will vacate in 1991, Justice Sears said he has the experience, the background and the qualifications the voters of this state should expect from a Supreme Court candidate.

In addition to his seven years on the Fourteenth Court of appeals, Justice Sears was a criminal prosecutor and a criminal defense attorney. He has also represented plaintiffs and defendants in civil cases in eight states and four foreign countries.

Wanting to bring to the Supreme Court his various experiences to insure that the law is applied fairly and equally, Justice Sears stated again he has a very broad, equally balanced base of support from all segments of the bar. "I am endorsed by lawyers who recognize they need a judge who knows the law and has the courage to apply it equally."

4-H FOOD SHOW WINNERS NAMED

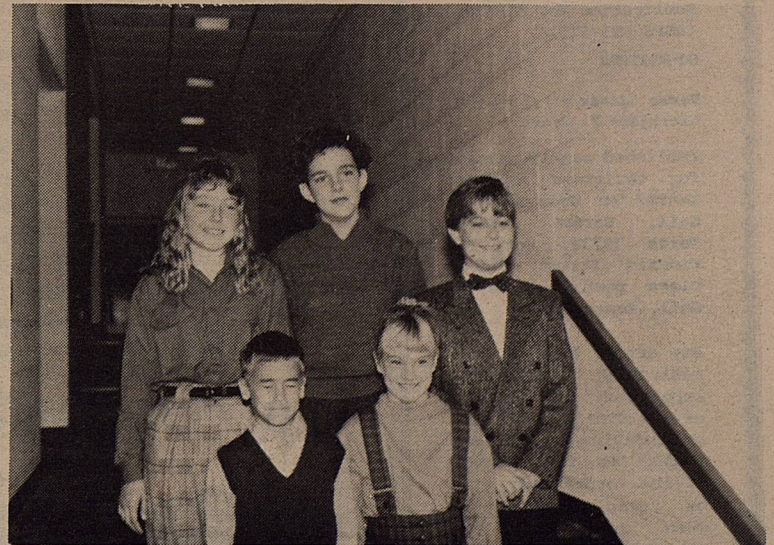
Knowledge of good nutrition and skills in cooking were blended into scores of delectable dishes Saturday (Dec. 2) as nearly 200 youths from 20 counties competed in the South Plains District 4-H Food Show at Texas Tech University.

The contestants, between ages 9 and 19, participated in the district show after winning their county show. Prior to the shows, they were active in foods and nutrition projects involving food science, safety, nutrition, fitness and career opportunities.

In the district show, contestants were interviewed on nutrition facts and preparation principles. Judges then evaluated each dish on taste, appearance, texture and aroma.

4-H is the youth development program of the Texas Agricultural Extension Service, an arm of the Texas A&M University System.

Educational programs conducted by the Extension Service are open to all persons, regardless of socioeconomic level, race, color, sex, religion, handicap or national origin.

BORDEN COUNTY TOURNAMENT RESULTS

The Borden County Coyotes met and defeated the Wellman Wildcats in the opening round of our tournament. The final score was 56-41, and the Coyotes led all the way. In the first quarter the Coyotes cold shooting (3 out of 11 from the field) slowed down the scoring, but they managed to outscore the Wildcats 9-6. The second quarter was a little better as the Coyotes made 5 out of 17 from the field and outscored the Wildcats 11 to 6. The third quarter opened up the second half with the Coyote's best effort with 8 out of 14 field goal tries. The fourth quarter was also a good one for both teams.

Cole Vestal led the Coyotes scorers with 16 points. He also made 2 steals, 7 offensive and 6 defensive rebounds, and 1 assists. Brian Bond and Jimmy Rios scored 15 points each. Brian also had 5 steals, 3 offensive and 5 defensive rebounds, and 6 assists. Jimmy came up with 4 steals, 3 offensive, and 7 defensive rebounds. Shane Kemper scored 8

points and had 3 steals, 3 offensive and 2 defensive rebounds, and 2 assists. David Buchanan scored 2 points and had an offensive rebound. Cody Stone had a steal, 1 offensive and 3 defensive rebounds, and 2 assists. Klint Kemper had 2 steals. Clint Wills had 2 offensive and 1 defensive rebounds. Jason Sharp had an assists. Clint Anderson and J.J. Kincheloe played, but did not score.

In the second round of the tournament the Coyotes were defeated by the New Home Leopards. The Coyotes played very well in the first half and only trailed 32 to 29 at half. In the second half the Coyotes only made 7 out of 24 field goal attempts and 2 out of 12 from the free throw line. They also lost Brian Bond for the season as he tore a ligament in his left knee when a Leopard moved into him

on a baseline drive. Brian Bond led the Coyote scorers with 17 points. He also had 2 steals, 1 offensive and 5 defensive rebounds, and 3 assists. Jimmy Rios made 8 points and had 2 steals, 1 offensive and 6 defensive rebounds, and 2 assists. Shane Kemper made 7 points and had 2 offensive and 1 defensive rebounds, and an assist. Cole Vestal scored 5 points and had 4 offensive and 4 defensive rebounds. Klint Kemper scored 6 points and had 2 steals along with 3 offensive and 1 defensive rebounds. Clint Wills played but did not score. He did have a defensive rebound.

The Coyotes played the Westbrook Wildcats in the third place game and were defeated 62 to 50. The Coyotes first quarter was a very slow start, but then they got things together and played well for the rest of the game. The Coyotes

trailed by 13 at half (36-23), but in the third quarter they pulled within 7 points (44-37). The Wildcats pulled away a little more in the fourth quarter.

Cole Vestal led the Coyote scorers with 21 points. He also had 3 steals, 3 offensive, and 3 defensive rebounds. Jimmy Rios scored 10 points and also had 5 steals, 4 offensive and 3 defensive rebounds, and 4 assists. Shane Kemper scored 7 points and had a steal, 3 offensive and 3 defensive rebounds, and an assist. Cody Stone scored 4 points and had 4 steals, 1 offensive and 2 defensive rebounds, & 3 assists. Klint Kemper scored 4 points and also had a steal, 3 offensive and 1 defensive rebound, and 3 assists. David Buchanan scored 3 points and had a steal and a defensive rebound. Clint Wills scored 1 point and made 4 steals and an offensive rebound.

The Borden County Coyotes traveled to Jayton on their first day back after the Christmas - New Year break, and they were defeated 68-39. The long break took its toll on the Coyote's shooting with only three players able to connect on field goal attempts. The Coyotes stayed close to the Jaybirds thru 3 quarter's, but then the lack of conditioning became evident in the fourth quarter. The Coyotes only trailed 14-7 at the end of the first quarter. The second quarter score was 31-19. The third quarter score was 45-31. In the fourth the Jaybirds outscored the Coyotes.

Jimmy Rios led the Coyote scorers with 18 points on 9 field goals. Somehow the layoff didn't seem to bother him as he made an unbelievable 9 out of 10 field goal attempts. Lady Coyotes Romp Roby

Borden County's Lady Coyotes completely dominated the first half of play in Friday night's basketball game with Roby and cruised to an easy 60-35 win. It was preceded by the J.V.'s 45-17 win over the J.V. team from Roby. In the Varsity game, Borden jumped out to a 17-7 first quarter lead and extended it to 43-14 in probably their best first half of play this year. Roby, a Regional Semi-finalist last year in Region II, never could get untracked as the Lady Coyotes hit well over 50% from the floor in the first half and forced many Lady Lion turnovers. All nine players that suited up scored for Gail led by Lisha Sternadel with 18 points and Amy Lewis and Amanda Anderson with 10 each. Leslie Fryar followed with 9, all coming from the 3 point line. Rachel Romero had 5,

Randi Woodward hit 3, Kristi Adcock and Kelly Jo Ogden each had 2, and Shara Dee Woodward had 1. Amanda led in field goal percentage with 100%, making 5 of 5. She was followed by Leslie with 75% and Amy with 57%. Amy led in free throw percentage with 100%, hitting 2 of 2 followed by Lisha's 4 of 6 for 67%. Lisha led in steals with 6 followed by Kristi and Shara Dee with 4 each. Kristi and Randi tied for honors in rebounds with 8 each followed by Amy and Amanda with 7 each. Lisha led in assists with 5 followed by Shara Dee and Leslie with 2 each.

In the J.V. game, Shayne Hess led a six member scoring attack with 15 points followed by Kristin Kilmer with 10. Kristin Monger with 8 and Jacquelyn McPhaul with 7. Kelly Jo Ogden hit 4 points and Heather Armstrong rounded out the scoring with 1. The J.V.

Jr High Drops Game To Sands 57-27

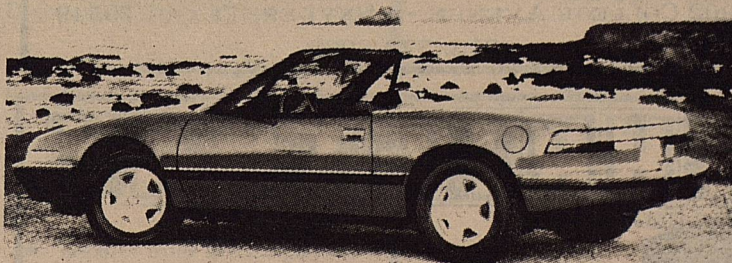

TAXATION OF FREEPORT GOODS

A motion was made by Commissioner Currey to pass the following Resolution, to-wit:

STATE OF TEXAS I

COUNTY OF BORDEN I

A RESOLUTION PROVIDING FOR THE TAXATION OF PROPERTY EXEMPT UNDER ARTICLE VIII, SECTION 1-j, TEXAS CONSTITUTION BEGINNING WITH THE 1990 TAX YEAR; AND DECLARING AN EMERGENCY.

WHEREAS, the Commissioners' Court finds that the taxation of certain goods, wares, ores, and other tangible personal property that is forwarded out of this state within 175 days of its acquisition or importation into this state is in the public interest,

NOW THEREFORE: BE IT ORDAINED BY THE COMMISSIONERS' COURT OF BORDEN COUNTY

SECTION 1: All of that property described in the Texas Constitution, Article VIII, Sec. 1-j, shall be fully taxable in Borden County beginning January 1, 1990.

SECTION 2: This Resolution shall take effect immediately from and after its passage and the publication of the caption, as the law in such cases provides.

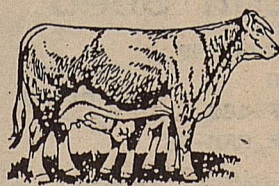

FACTS & FIGURES

The Health Care Crisis

America's health care crisis affects just about everyone. Consider these facts:



- Health care costs are increasing at rates twice and three times the overall inflation rate. Today, close to 50 percent of corporate profits is spent on employee medical benefits.

- U.S. spending on medical care has doubled in a little more than 20 years to \$500 billion at present or 11.1 percent of GNP.

- Yet fewer people are receiving needed care. 37 million Americans have no medical insurance whatsoever. Many more have inadequate coverage. The cost of providing care to these people is passed on to everyone in higher doctor and hospital bills.

The United Food and Commercial Workers Union (UFCW) and its 1.3 million members, is working to bring together labor, management, the health care industry and government to develop a solution to this serious problem.

As a first step, the UFCW believes all employers should be required to provide health insurance coverage to employees and their families. When companies don't provide basic coverage, taxpayers and other businesses wind up paying more. That isn't fair to responsible employers or their workers who are asked to pay higher deductibles and coinsurance.

More sweeping reform of the health care system, including public insurance administered by state and regional boards, may be needed. Such a system already exists in Canada, where medical expenditures are one-third less than in the U.S., even though everyone is covered.

You: Abused By The IRS?

If you've ever felt harassed by the Internal Revenue Service, you're not alone. In fact, so many have, Congress is investigating charges of widespread corruption and illegal activities among management officials of that agency. Investigations found corruption hurts both taxpayers and honest IRS workers. Documented cases include:

- IRS employees ordered to ignore IRS overassessments of taxpayers in violation of IRS regulations.
- Illegal quota systems in some branches.
- Reports from IRS employees about programs targeting legitimate church and political groups for tax audits based on religious and political affiliations and ignoring legitimate tax considerations.
- Attempts to reduce the effectiveness of the agency's internal audit by pressuring employees to

relocate or quit.

WOOL INCENTIVE

Producers are encouraged to file wool, lamb and mohair sales receipts by January 31, 1990. For shorn lambs producers must file an original sales receipt signed by the purchaser, showing the number of head shorn, the month the lambs were shorn, and whether or not they were purchased or raised. For unshorn lamb purchases, the place of purchase must be on the original sales receipt. To be eligible for wool and mohair incentives, a producer must have owned the animals for at least 30 days.

1990 PROGRAMS

Cotton - Producers who participated in the cotton program can plant no more than 87.5% of their base. ACR requirements are 14.29% of the acres planted for harvest. Provisions for 50-92 will be in effect. The target price is 72.9 cents per pound with a national loan rate of 50.27 cents a pound.

Sorghum - Producers who participated in the sorghum program can plant no more than 90% of their base for harvest. ACR requirements are 11.11% of the acres planted for harvest. Provisions for 0/92 will be in effect for 1990. The target price is \$2.61 a bushel.

Wheat - Producers who participate in the wheat program can plant no more than 95% of the base. ACR requirements are 5.26% of the acres planted for harvest. Provisions for 0/92 will be in effect. The target price is \$4.00 a bushel and the National loan rate is \$1.95 a bushel.

Wheat producers also have the option of participating in what is called MODIFIED CONTRACT OPTION. Wheat acreage may exceed 95 percent of the CAB or the permitted acreage, but shall not be more than 105 of the CAB. 0/92 provisions are not applicable on the modified contract option. Advance payments will be issued to 1990 wheat modified contract option participants that request an advance during the signup period equal to 40% of the projected deficiency rate up to 95% of the CAB.

Provisions common to all programs:

1. The effective payment yield will be the same in 1989.
2. The base acreage will be calculated the same as in 1989.
3. Limited cross compliance will be in effect.
4. No paid diversion will be in effect for 1990.

1989 DISASTER PROGRAM

Signup for the 1989 Disaster Assistance Program is underway and will continue through April 2, 1990. Producers who harvest crops must provide production evidence for all farms they have an interest in before disaster payments will be issued. This means all farms in all counties.

Insurance production and appraisal worksheets, if applicable.



Stephen Foster Memorial Day

Remember sitting around a campfire singing "Oh! Susanna" and "Camptown Races"? January 13 honors the writer of those songs, Stephen Foster, one of America's most famous and best-loved songwriters.

Foster, born July 4, 1826, in Lawrenceville, Pa., began writing songs as a young boy. He was influenced by popular, sentimental songs; minstrel show songs; music from local black church meetings; and songs from black laborers.

Foster published his first song, "Open Thy Lattice Love," in

1842, followed by "Oh! Susanna" in 1846. Later, he was commissioned to write songs for Edwin P. Christy's minstrel show, the most famous being "Old Folks at Home," also known as "Swanee River," in 1851.

At the time of his death on Jan. 13, 1864, Foster had composed more than 200 songs, including "Beautiful Dreamer" and "Jeanie With the Light Brown Hair." The anniversary of his death has been remembered by presidential proclamation since 1952. **lll**
