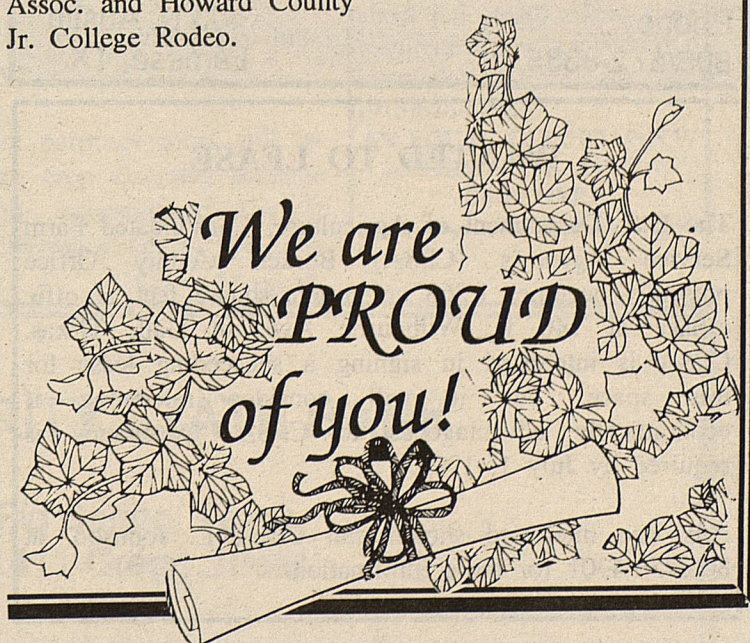
Jill was elected Miss BHS, Most Likely To Succeed, and Most Beautiful. She also made basketball All-District Honorable Mention.

talent team was elected.

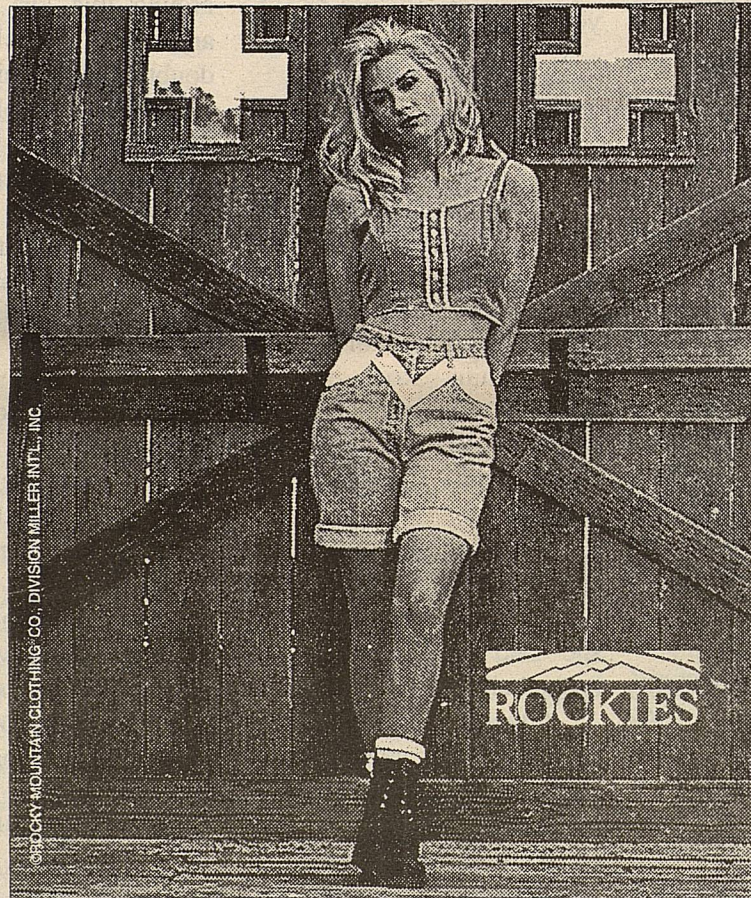

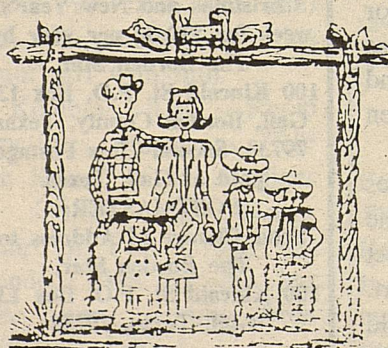

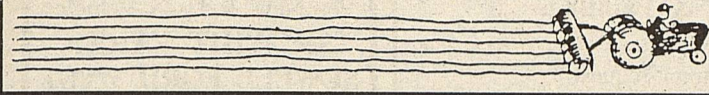

**ELIGIBILITY**

The United States Department of Agriculture (USDA) prohibits discrimination in its programs on the basis of race, color, national origin, sex, religion, age, disability, political beliefs, and marital or familial status. **CROP FAILURES**

Producers with failed crop acreages must report the acreage, file an ASCS-574, furnish a copy of the insurance appraisal, and be notified of approval, prior to making other use of the crop. An ASCS-574 may be filed for failed acreage. To be eligible for failed acreage credit, the total appraised and assigned production for the acreage must be less than 50 percent of the calculated APH. If the production potential is less than 50 percent of the calculated APH. If the production potential is less than 50 percent of the calculated APH, the crops considered failed for program purposes. Determinations shall be made on a field-by-field basis. If the field is considered failed for program purposes, a "ghost" crop may be planted on that field.

Anytime a crop is destroyed without an appraisal, COC shall assign a yield.

**SIGNATURE AUTHORITY FOR SPOUSES**

A husband and wife can sign document on behalf of each other for CFSA and CCC programs in which either has an interest, unless written notification denying a spouse this authority has been provided to the county office. Spouses cannot sign on behalf of each other for powers of attorney (ASCS 211 or ASCS 211-1). Spouses must have a power of attorney on file or sign personally for WRP easements, CRP easements, or claim settlements.

**SIGNATURE FOR EARLY RELEASE FROM CRP-1**

In December 1994, the Department announced an intention to allow CRP participants to release all or part of their acreage under CRP-1 before the expiration date without penalty, along with other provisions. The early release option shall be available to CRP participants with acreage devoted to certain practices, enrolled in signup periods 1 through 12 during a signup to be held May 15 through June 2, 1995.

Late filed requests shall not be accepted.

**1994 Loan and LDP Availability**

The final date to place 1994 crop cotton and/or grain sorghum into the loan is May 31, 1995.

**WITHDRAWING FROM THE 1995 FARM PROGRAM**

New regulations would allow producers to withdraw from the farm program, without penalty, up to the final certification date of effected crop(s). Final certification date for cotton and other spring seeded crops is July 15, 1995. Signing up for measurement service doesn't extend the July 15, 1995 date for withdrawing from the farm program.

**NONGRAZING AND NONHAYING PERIOD**

Producers, who are participating in the 1995 Acreage Reduction Program, are reminded that regulations provide the haying and grazing of ACR or CUPAY shall NOT be allowed during the consecutive five-month nongrazing and/or nonhaying period (April 1, 1995 through August 31, 1995).

This means that livestock are not permitted on these acres during this period even if the fields are plowed clean. It will be necessary that this acreage be fenced to comply with procedure.

Random field visits will be made during this time to ensure that these regulations are being followed.

**MAINTENANCE OF PROGRAM ACRES**

Producers should remember that they have a responsibility to maintain their program acres in a normal and workmanlike manner with a reasonable intent to produce a normal crop. This provision also includes the maintenance of CRP and Conserving Use acres. Weeds, wind and water erosion must be properly controlled. Producers who do not farm their land in a workmanlike manner are subject to payment yield reductions and possibly repayment of deficiency payments or other benefits.

**ACREAGE REPORTS MORE VITAL THAN EVER**

Farmers were reminded today that their crop insurance and certain U.S. Department of Agriculture benefits are in jeopardy, if they fail to file their planted acreage reports on time.

The crop insurance acreage reports must be signed by the insured or a designated agent by the required deadline, which differs by crop and locality.

Acreage reports for farm program purposes must still be filed at the CFSA office; however, crop insurance acreage reports must also be filed with the insurance provider. If insured through a private crop insurance agent, the crop

insurance acreage report must be submitted to that agent. If farmers purchased the basic, catastrophic insurance coverage (CAT) through the CFSA office, they can sign their crop insurance acreage reports at the same time they report acreage for farm program purposes.

### ACREAGE TOLERANCE

For crop year 1995 the tolerance on reported acres is the larger of 1.0 acre or 5% of the reported acres, not to exceed 50 acres.. The tolerance applies to both over and under reported crop acres.

Paid Measurement Service is available through this office for a nominal fee. Rates for aerial measurement are \$20 per farm plus 3 cents per acre for acres in excess of 25. Measurement service is a tool to help producers who are unsure of their crop acres. It can help insure compliance. Something new for 1995 is, producers choosing to utilize measurement service may keep crops in excess of maximum permitted as long as the initial measurement finds the acres to be within tolerance. producers utilizing measurement service must plow back to maximum permitted acres if initial measurement finds the crop acres to be in excess of tolerance.

Also new this year, producers wishing to comply must certify all crop acreages by July 15th. This includes producers who make application for measurement service. Producers requesting measurement service must certify prior to July 15th but will be allowed to revise their certification after measurement service is completed.
