FY13 Agriculture Appropriations Delayed

The FY13 House Agriculture Appropriations bill was delayed and has not been rescheduled.

Meanwhile, House Agriculture Committee Chairman

Lucas (R-OK) announced that committee's markup of the farm bill will be on July 11.

According to a news story in AgriPulse, Chairman Lucas said he made it very clear to leadership that he preferred not to have the agriculture appro-

priations bill at the same time. "As of this moment, I don't anticipate having ag appropriations in the House at same time as the farm bill markup in the committee," he said.

Fruits of Summer

Sinking your teeth into a lush, juicy and audibly crunchy slice of watermelon is one of life's sweetest joys. It does not take much to get the cream of the crop, finding that perfect watermelon, peach, nectarine, or other summer fruit simply requires good detective work and an active use of all your senses.

Here are a few tricks of the produce trade every smart shopper should know:

* Follow the Golden Rule of Choosing Fruits: Your nose knows. If fruit is supposed to be sweet, it should smell sweet. Sometimes though, we find it necessary to poke and shake, prod and squeeze fruit to determine if it is ripe.

* Pick the fruit toward the bottom or at the back of the rack. It tends to be fresher because the produce department regularly rotates fruit when new stock is added.

* Separate your fruit from other groceries in the cart, and ask for the sacker to bag it separately as well. This will prevent it from being bruised while shopping and when transporting it home.

* Avoid fruit with visible blemishes, bruises and discoloration. These are warning signs of spoilage.

* Beware of buying fruit in bulk. You will spend less initially, but waste more in the long run because of spoilage. However, if you do buy fruit in bulk, inspect each bag/carton thoroughly for bruises or signs of mold.

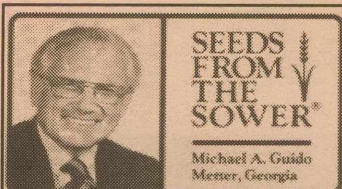
* Wash and clean your fruit thoroughly to get rid of any pesticides and dirt. Remember to eat it right away or let it dry before you put it back in

the refrigerator because wet fruit is more apt to spoil.

* Refrigerate melons, seed fruit and berries (especially raspberries and blackberries) to extend their freshness.

* Ripen bananas and stone fruit (peached, plums, nectarines and other pitted produce) at home by placing them in a brown paper bag away from direct sunlight and at room temperature for a day or two.

* You can easily freeze fresh fruit by washing thoroughly and drying well then freezing in appropriate freezer bag or container. Thaw and enjoy or use frozen in smoothies, ice cream or in fruit salads.

When you think someone else has it better than you, you are distracted from appreciating all the good that is in your life. You can even start resenting your situation if you are

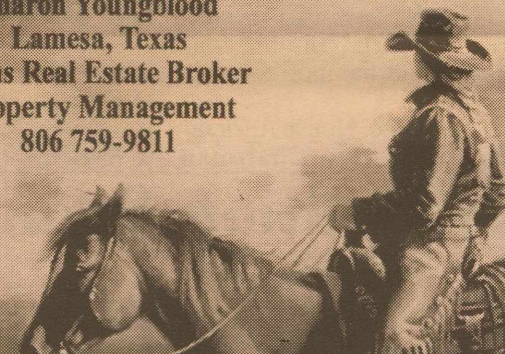
jealous of others. It's a shame that so many people waste time thinking someone else has is better than them.

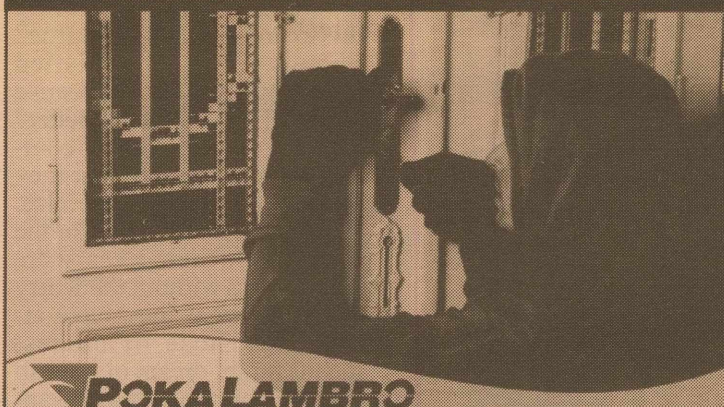

In the meantime, Lucas is focused on marking up the farm bill on July 11, and noted "we need several days to get our work done and if necessary we'll delegate people among ourselves to the floor." He said he has not yet pressed House leadership on floor time for the farm bill, because he "doesn't have a bill to press," but when the committee completes markup in the days after July 11, "that becomes the next biggest issue for me."

When the time comes to reconcile differences between the House version and the Senate bill, or the "Agriculture Reform, Food and Jobs Act of 2012," S. 3240, Chairman Lucas said he's confident the two chambers will be able to reach an agreement, using the

"Super" Committee process as an example. "Just as we achieved consensus back in September in the hurry-up, we'll achieve consensus this time," he said. "We're just not at that point of hashing out the details."

Lucas noted that regarding differences between each chamber's legislation, Senate Agriculture Committee Chairman Stabenow (D-MI), "understands I have to do my work with the committee. When we get to conference certainly the bills will have to be melded together, but we've not talked about particulars. I understand the importance of crop revenue to her; she understands the importance of letting a safety net to southern farmers and people in southern plains to me."

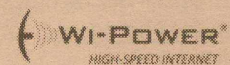

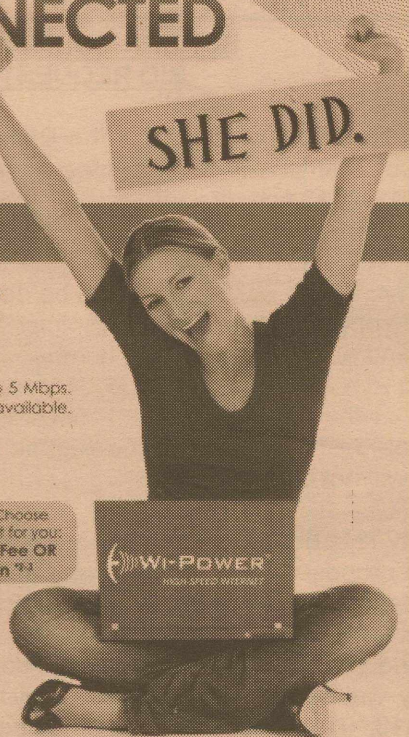

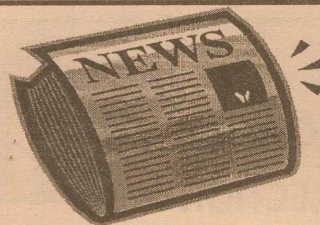
