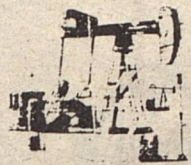

Pat Green of Brownfield is Royal

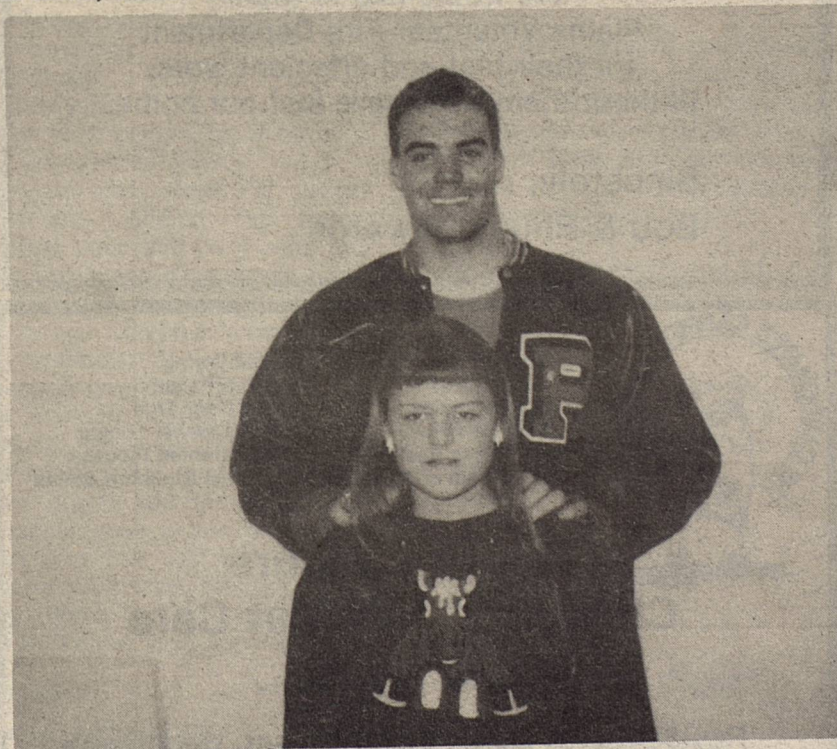
Bounders coach. Ashley Winn is their trampoline coach.

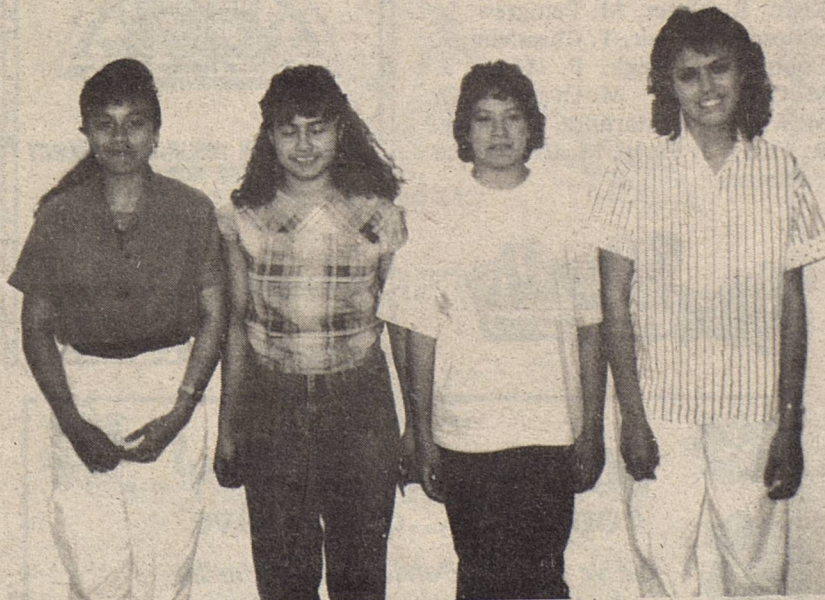
City Candidates May File

School Board Extends Contracts

School board members met in regular session Monday evening with Melvin Lowrey, president, presiding.

Recommendations of the textbook committee were unanimously accepted. Board members cast ballots in the Region XVII Education Service Center board of directors election.

Bid of \$24,432 by Bridges-Hemphill Enterprises Inc. was accepted for the purchase of a fifteen passenger Collins Super Bantam school bus. Bids were also accepted for repair of school buildings by Karr Tuckpointing. The bids included high school, \$22,000 - \$23,300; junior high, \$27,000 - \$29,100 and elementary, \$12,100 - \$13,700.

Lowrey was named representative to the TASB Legislative Network. February bills were approved for payment.

Superintendent Dean Andrews presented financial reports for general operating, cafeteria, tax and transportation.

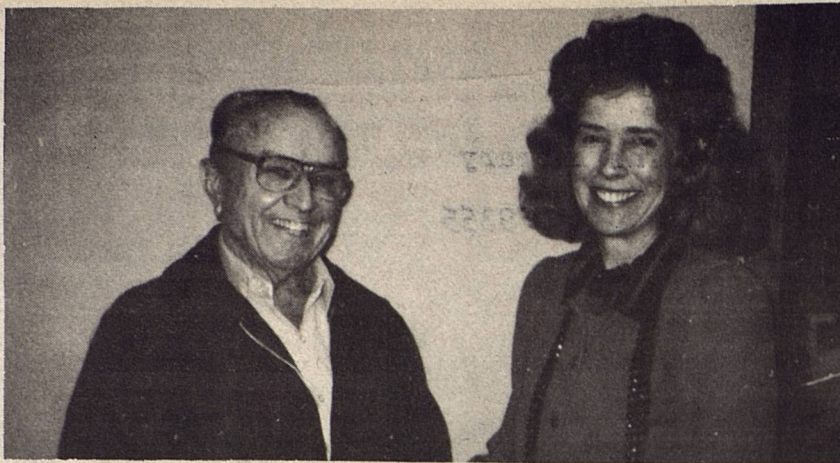

Adult Probation Explained For Lions Club Thursday

Mary Guetersloh, Adult Probation Officer for Yoakum and Terry Counties, was guest speaker at Thursday's luncheon meeting of Plains Lions Club.

Sharing an update of the Criminal Justice System, Ms. Guetersloh cited examples of how the sheer numbers of offenders has complicated the system, especially Texas Department of Corrections.

She explained probation's role and stressed its role and affect on each local community. She noted that each Adult Probation Department is directed by a Chief AP officer appointed by the District Judge (or Judges).

Parole is directed by the State, she said.

"Probation works to prevent an offender from continuing illegal behavior by close detailed supervision in the local community while the offender lives, works and hopefully becomes a responsible, tax paying member of society," she stated.

"When the probationer violates conditions of the probation order, the probationer faces incarceration. The parole system deals only with

the offenders leaving the Texas Department of Corrections."

"In short," she added, "probation is designed to be proactive and preventive with intervention hoping to divert offenders from incarceration, while parole is designed to be reactive and monitor offenders after incarceration in the state penitentiary. Probation serves local judicial systems; parole, the state executive system."

Ms. Guetersloh stated, "The purpose of probation supervision is two-fold. One is to protect society by close surveillance and two is to assess and address the needs of the probationer."

Recipes are shared with the readers of Plains Pride this week by Jimmie (Mrs. Milton) Bayer.

SWEET & SOUR PORK

1 1/2 lb lean pork, cut in 2x1/2 inch strips (shrimp may be substituted)
2 T melted shortening
1 chicken bouillon cube
1 lge can pineapple chunks
1/4 c brown sugar or Sugar Twin
2 T cornstarch
1/4 c vinegar
1 T Soy sauce
1 med green pepper, cut in strips
1/4 c thinly sliced onion

Brown pork slowly in melted shortening. Add 1 cup water, bouillon cube and 1/4 t salt, mix well. Cover and simmer one hour. Meanwhile drain pineapple, reserving syrup. Combine brown sugar and cornstarch; add reserved pineapple syrup, vinegar, Soy sauce and 1/2 t salt. Cook and stir over medium heat until thickened and bubbly. Remove from heat. Add sauce to pork and mix well. Stir in pineapple, green pepper and onion. Cook over low heat two to three mins or until vegetables are tender crisp. Serve over hot cooked rice and with chow mein noodles.

LINDA'S CREAMED CHICKEN TACOS

Have Ready:
1 chicken, boiled and diced
2 c cubed Velveeta cheese
1/3 c chopped onion
12 corn tortillas, lightly fried until soft, as for enchiladas)
Saute in 4 T butter:
Onions
8 oz can green chilies

Add:

2-3 T flour, for thickening
2 - 8 oz cans of tomato sauce
1 can evaporated milk

Blend and add cheese and stir over low heat until melted. Add diced chicken.

Spread a thin layer of sauce; then a layer of tortillas in a baking dish. Continue to build layers, reserving enough sauce to cover the final layer of tortillas. Bake 30 to 40 mins in moderate oven. Let stand briefly before serving. (6 servings)

MAMA'S CHERRY COBBLER

1 can sour cherries
2 c water
1 c water
2 T flour
1 t almond extract
1 1/2 c flour
1/2 t salt
1/2 c sugar
1/2 c Crisco
1 t baking powder
1/2 c milk

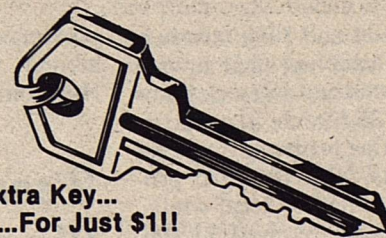

Around The Cinder Track



Plains High School Cowboys hosted the Cowboy Relays last week and finished the event in a tie for second place. Eleven teams competed with O'Dell taking the title with 130 total points. Plains and Meadow compiled 117 points each. Sudan, finishing third, had 91 points.

The PHS 400 Relay won first place with a 45.36 performance by Blake McWhirter, Alex Barrientes, Michael Diaz and Jeff Lowrey. The 1600 relay team finished in third place with 3:38.3 by Diaz, Mario Medina, Lowrey and Jeff Ashburn. The distance medley relay team came in second. Running 12:51.7 were Medina, Irvan Matta, Lebert Powell and Chad Guetersloh.

Ashburn also collected first place wins in the 110 high hurdles and 300 intermediates. His times were 16.2 and 41.9. Also placing in the 110 hurdles were Monte Pierce, third, 18.7 and Medina, fifth, 19.9.

Diaz won the long jump with a leap of 19'9".

Other placings included Daniel Canada, sixth in the 200 yard dash, 25.2; Matta and Ricky Vasquez, se-

cond and third respectively, in the 800 yard run. Their times were 2:16.3 and 2:19.4. Vasquez came in fourth in the 1600 run with 5:13.

Guetersloh finished fourth in the 3700 run with 11:43.6. Pole vaulters were McWhirter, third with 9'6" and Pierce, 9'.

The Cowboys also competed in the Denver City Track Meet, claiming first place. They earned 82 points in the fourteen-team competition. Sudan and Meadow tied for second with 77 each.

Composed of McWhirter, Barrientes, Medina and Booth, the 400 meter relay team won first with 46.7. The 1600 relay team placed second with 3:40.7. Runners were Lowrey, Ashburn, Booth and Barrientes.

McWhirter and Barrientes took the one-two wins in pole vault with 10' and 9'6" jumps.

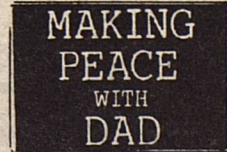

20-Page Manual On Chapter 12 Now Available To Farmers

A 20-page manual on Chapter 12, the new Debt Settlement provisions of the Agricultural Credit Act of 1987 and the Tax Reform Act of 1986 is now available for family farmers and ranchers in West Texas, Bruce Magness, Operation Bootstrap Director, announced Monday.

The manual, called "The Bureaucracy Buster," covers topics ranging from some of the tax treatments afforded farmers who elect to engage in debt settlement to the effect of disposal of crop proceeds and ASCS sign-up on Chapter 12.

He said the manual is not the final answer on the new legislation, but that it does try to give some early indications on the law and alternatives it provides. The manual is available by sending \$1.00 for postage and handling to: Bruce Magness, 2302 34th Street, Lubbock, TX 79411.

Magness, with co-counsel Don Richards and Lane Arthur, Monday obtained a dismissal of the Family

Farm Defense Fund-financed lawsuit filed in April of 1986 to enforce time deadlines for loan consideration under the Food Security Act of 1985. The case, entitled Mark Frick et al v. USDA and FmHA, was filed in Lubbock due to delays in loan processing and funding.

He said the lawsuit had accomplished its purpose of educating both the public and farmers as to the deadlines and that the issues were now moot. One of the farmers is now in Chapter 12, one in Chapter 11, one retired from farming with his land in the CRP program and one is considering debt settlement.

"We want to continue our pledge, though, that farmers will never again be left without information on alternatives again like they were in 1986," he said.

"I hope this book will help farmers still in debt to deal with the cloud of debt which still hangs over many of our West Texas farms," he concluded.

Yoakum County Delegates Attend TFU State Convention

Ty Earl Powell and Mr. and Mrs. Melvin Lowrey attended the recent 84th Annual State Convention of Texas Farmers Union in Fort Worth. The trio represented Yoakum County as delegates.

Lowrey chaired the policy drafting committee.

Delegates passed a special order requesting Congress to repeal the new requirement that agriculture producers pay the diesel fuel tax of 15.1 cents per gallon. Under current

law, farmers are exempt from paying taxes on the purchase of wholesale diesel used strictly for on-farm and off-highway purposes. Effective April 1, farmers will be required to pay the tax and then file for a refund.

Farmers Union at the State and National levels are urging members of Congress to appeal the new law.

Number one goal of Farmers Union is the preservation of America's family farms.

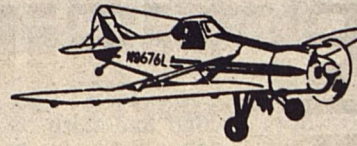

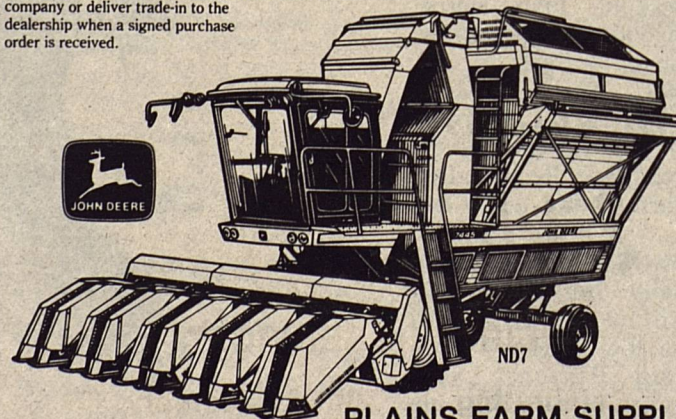

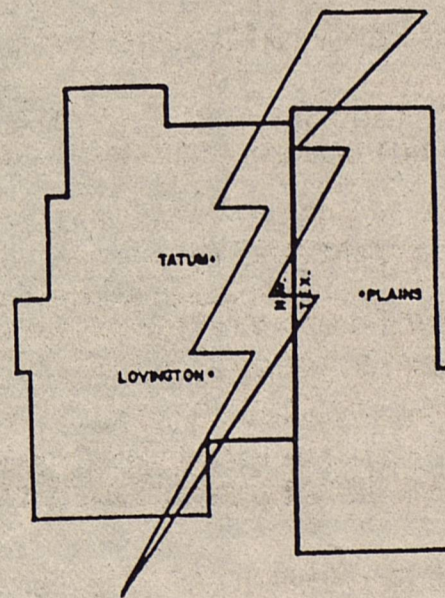
