Community Education Courses Being Planned For Fall

Community Education classes in a number of different fields are being readied by Plains Independent School District. Individuals may enroll in all classes by mail or by calling Mary Pettigrew or Arlon Alexander at 456-7490 or 456-7445. Classes are open to both adults and children.

Fees and minimum attendance must be met the first night of class or the courses will be cancelled. Class fees have been assigned according to the cost of the instructor for a minimum enrollment. Most courses require a minimum of 10 participants.

Woodworking will be offered beginning Oct. 2. A minimum of 15 students is required for the 10 weeks course. Classes will be taught by Robert Canon from 6 to 9 p.m. Tuesdays in the high school shop. Fee is \$30.

Intermediate micro-soft works will be taught by Brenda Canada for a period of eight weeks. Classes will be 6 to 8 p.m. Tuesdays in the high school computer lab. Beginning Oct. 2, the course must have a minimum of 12 enrolled and requires a fee of \$20.

Tisha Allman will be the instructor for Beginning Apple Works. To be taught from 6 to 8 p.m. Mondays in the junior high computer lab, the class will begin Sept. 24. Fee for the eight weeks is \$20. Minimum number is 15.

An eight weeks course in Jazzercise will begin Oct. 1 in the elementary PE room. Cathy McKinzie will be instructor. Classes will be held from 5:30 to 6:30 p.m. Mondays and Wednesdays. Fee is \$20.

Vivian Rice will be the instructor for an Oil Painting Class that will meet from 6 to 9 p.m. Tuesdays beginning Oct. 2. A minimum of eight students are needed and the fee is \$32. The class will meet in the art room.

Basic and Creative Sewing Apparel and Home Furnishings will be offered for four weeks beginning Oct. 2. Classes will meet in the home economics room from 6 to 8 p.m. Tuesdays. Fee is \$10.

Mary Pettigrew will teach Calligraphy in the resource center. The three weeks course begins Oct. 1 with meetings from 6 to 8 p.m. Mondays. Fee is \$8.

As we, tax collectors and property tax payers', approach the 1990 tax collection year, our thoughts turn to the dollar amount of our tax statements - WHAT IS IT GOING TO BE THIS YEAR? The Board of Trustees of Plains Independent School District was able to lower the tax rate from \$.4284 per \$100.00 of value to \$.4092 per \$100.00 of value. This was due in part to the increase in property values from \$692,528,637 in 1989 to \$780,722,437 in 1990.

This decrease in tax rate will mean a reduction of \$1.92 for each \$100.00 of value you have in taxable property. If you have property with a taxable value of \$30,000.00, and the value did not change from 1989 to 1990, your 1990 taxes will be \$5.76 less than your tax amount in 1989.

The 1990 tax statements will be mailed out of the Plains I.S.D. Tax Office the last week in September and become due October 1. A discount of 3% will be given on taxes paid in October, 2% discount if paid in November, or a 1% discount if paid in December. Taxes become delinquent if not paid prior to February 1, 1991, with penalty and interest being added and increased each month. Therefore, a saving in tax dollars is realized if you pay your school taxes in October.





PROPOSITION NO. 1 ON THE BALLOT

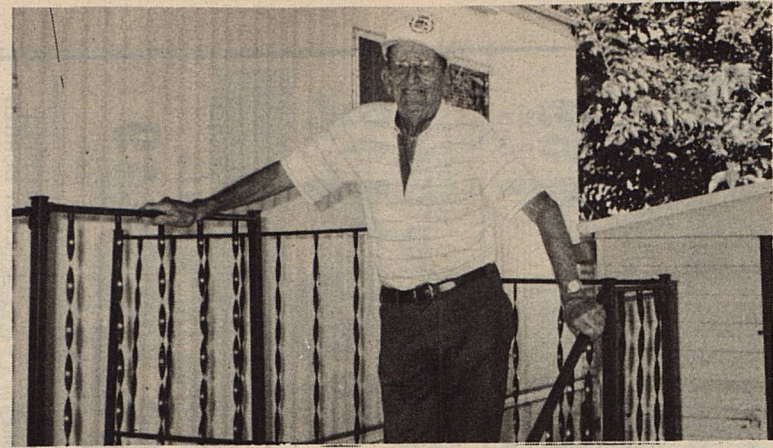
Senate Joint Resolution 2, Sixth Called Session, 71st Legislature, proposes a constitutional amendment to provide that if the Senate, at any special session, does not take final action to confirm or reject an appointee of the Governor made during a recess of the Senate, the appointee is entitled to continue in office until the Senate rejects the appointee at a subsequent session or until the Governor appoints another person to fill the vacancy, but such a nominee whom the Senate does not act to confirm or reject at a subsequent regular session is considered to be rejected when the session ends.

The proposed amendment will appear on the ballot as follows:

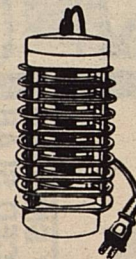
"The constitutional amendment to clarify the authority of the senate to consider certain nominees to state and district offices and to provide for filling vacancies in those offices."

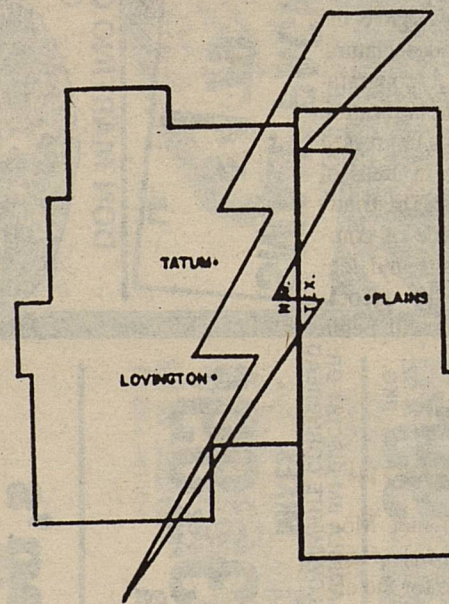

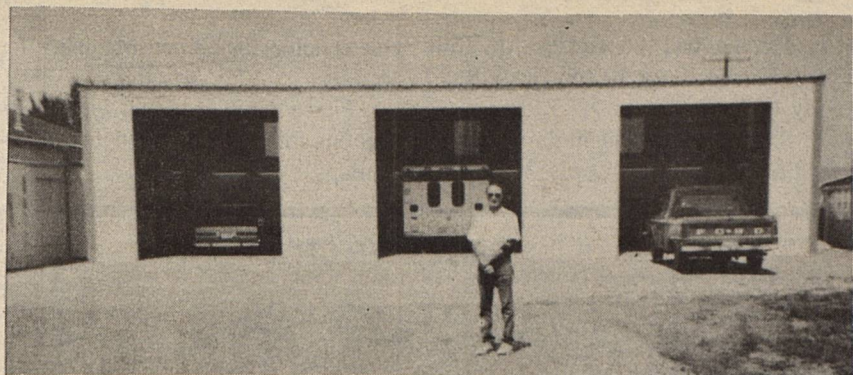

NOTICE OF ELECTION

An election for directors to serve Zones 1 and 2 on the Yoakum Soil and Water Conservation District Board is scheduled for Monday, October 1. The election will be held at 8:00 A.M. at Johnnie's Restaurant in Plains, according to David Turnbough, Chairman.

Fred Squyres, Chairman of the State Soil and Water Conservation Board will be on hand to speak and to answer questions.

State law decrees that to be eligible to vote in the Yoakum Soil and Water Conservation District election, a person must own agricultural land within the county and live in the county.

The legal qualifications state that a director must own land in the zone he or she represents, be at least 18 years old, and be actively engaged in farming or ranching. The law also states that a director must live within the county or district. The term of office for a Soil and Water Conservation District Director is four years.

Zone 1 of the District is the southeast one fourth of Yoakum County - bounded by the Brownfield/Plains Highway on the north and by the Plains/Denver City Highway on the west. An area six miles by six miles is excluded from the zone on the northwest corner.

Zone 2 of the District is the southwest one fourth of Yoakum County - bounded by the "Old Lovington Highway" on the north and the Plains/Denver City Highway on the east. An area six miles by six miles is excluded from the zone on the northeast corner.

Current members of the board of directors are David Turnbough, serving Zone 1; R.M. Jones, serving Zone 2; L.J. Sanders, serving Zone 3; R.B. White, serving Zone 4; and Linda Grau Powell, serving Zone 5.

The purpose of the Yoakum SWCD is to promote sound soil and water conservation practices on all the lands within the district and to serve as a voice for farmers and ranchers in Austin and Washington on conservation matters.

The district board of directors coordinates the conservation efforts of various local, state, and federal organizations and agencies. The district has the authority to enter into working agreements with governmental agencies and private concerns in carrying out its purposes.

All conservation programs managed by the district are of a voluntary nature to the landowner or operator.

All programs of the Yoakum SWCD are available to anyone without regard to race, creed, color, sex, age, handicap, or national origin.

Texas Tech Professor Hired As Interim Superintendent

School board members met in special session Monday evening to hear Dr. Michael P. Stevens, professor at Texas Tech University, present information on the process concerning the selection of a superintendent. By unanimous approval, the board voted to employ Dr. Stevens as interim superintendent and consultant in a superintendent search.

Jury Finds Hines Guilty; Maximum Sentences Given

A jury of four women and eight men Thursday, Sept. 13 found Billy Ray Hines guilty of two counts of indecency with a child and two counts of aggravated sexual assault. Convening Monday, Sept. 17, jurors deliberated approximately one hour in the punishment phase.

On the second degree felony counts of indecency with a child, jurors assessed maximum sentences of 20 years. On first degree felony counts of aggravated sexual assault, jurors assessed two 90 year sentences. Judge Ray D. Anderson, presiding at the trial, announced the sentences would run concurrently.

Represented by Criminal District Attorney Linda Shoemaker Lowrey, the State produced 13 witnesses during the trial while defense attorney Warren New called seven witnesses.

The defendant is in Yoakum County Jail pending transfer to the State penitentiary.

All jurors were from Denver City.

Water District Hosts State Meeting

Sandy Land Underground Water Conservation District hosted a meeting Friday of Texas Groundwater Conservation Districts Association, an organization of underground water conservation districts of Texas.

Gary Walker, local manager, is serving as treasurer of the state association. County Judge Dallas Brewer spoke the welcome.

Following lunch, Representative Jerry Yost, R. of Longview, gave the address. A member of House Natural Resource Committee, Yost congratulated underground water conservation districts on "a good job". He expressed the need to create districts in areas of the state in which there are no districts. He also cited the importance of communication between districts and legislators, especially during the upcoming legislative session that will begin in January.

We are fortunate to have people like you and your board members who find time in their busy schedule to help children in need. I am sending this letter to the local newspaper so that people in our county can be aware of your good work.
