## City Council Meets

During their regular meeting on Monday, Sept. 23, the City Council for the City of Plains amended the City's billing policy dealing with "cut-off" procedures for past due customers.

The new policy will require that utility service to accounts that become delinquent will be discontinued following ten (10) days notification of delinquency. Accounts will be considered delinquent and notices will be mailed to "past

due" customers on the first working day following the 15th day of the month. In order for utility services to be reconnected, the customer's account must be paid in full and a reconnect fee must be paid. This policy will require that all utility bills be paid during the month that the bills are received.

In other action, the Council discussed revisions to the City's personnel policies and approved minor renovations to the City Hall office.

## City Of Plains Closes Landfill

In a special called meeting at 12:00 Noon on Thursday, Sept. 26, 1991, the City Council for the City of Plains voted to close all active portions of the City's Landfill prior to the U.S. Environmental Protection Agency enacting the recently passed Subtitle D rules and regulations.

Landfills that remain open after the promulgation of these rules and regulations will be subject to the closing criteria outlined in the new rules and regulations. These closing criteria include: ridged cover requirements, ground water and methane gas monitoring, and post closure liability for a number of years following the closing of the landfill.

The City of Plains has been operating a Type 3 landfill and it has been determined that it would not be cost effective to upgrade to a Type 1 landfill in order to meet the requirements set out in the new rules and regulations. For the present, the City will transport solid waste to Brownfield for final disposal. Long range plans are presently being made for a permanent disposal method that will meet the requirements of Subtitle D and prove to be a less expensive alternative to long distance hauling.

### Yoakum SWCD To Hold Election To Elect Director

An election of a soil and water conservation district director to serve in Zone three on the Yoakum Soil and Water Conservation District is scheduled for October 9 at Johnnie's Restaurant in Plains, Texas announced David Turnbough, chairman of the board. The election will be held at 8:00 A.M.

State law decrees that to be eligible to vote in a soil and water conservation district director election, a person must own agricultural land within the district where the election is being held. The person must also live in a county all or any part of which is in the district and the voter must be 18 years old.

Legal qualifications state that a candidate for the office of a soil and water conservation district director must own land in the zone he represents, be 18 years of age and be actively engaged in farming or ranching. He must also live in a county all or part of which is in the district. Soil and water conservation district directors serve four-year terms of office.

Zone three of the district includes all of the Northwest 1/4 of Yoakum County excluding a square six miles by six miles on the Southeast corner.

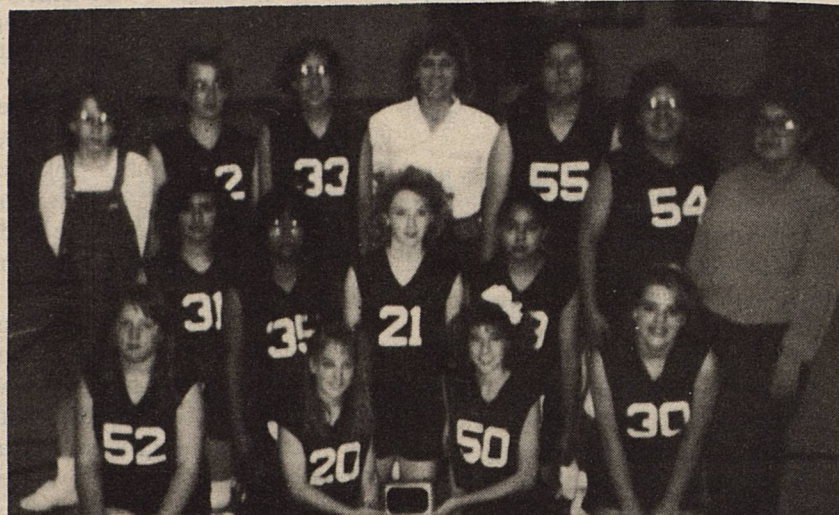

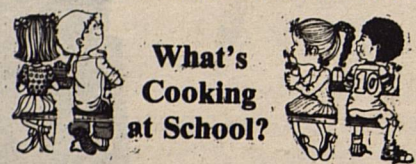

They traveled to Brownfield to compete in the Brownfield Freshman Tournament this weekend.

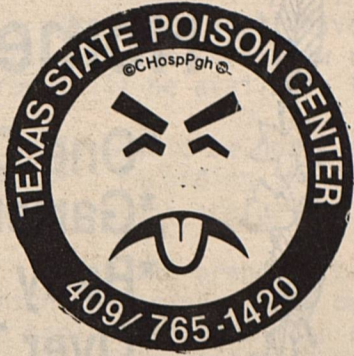
**VARSITY**

and 4 kills each and Leslie posted 7 digs defensively.

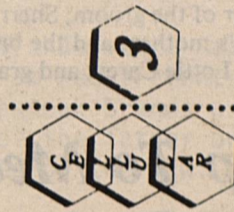
They advanced to the finals by defeating Albany 15-7 15-4 and Water Valley 15-5 15-1.

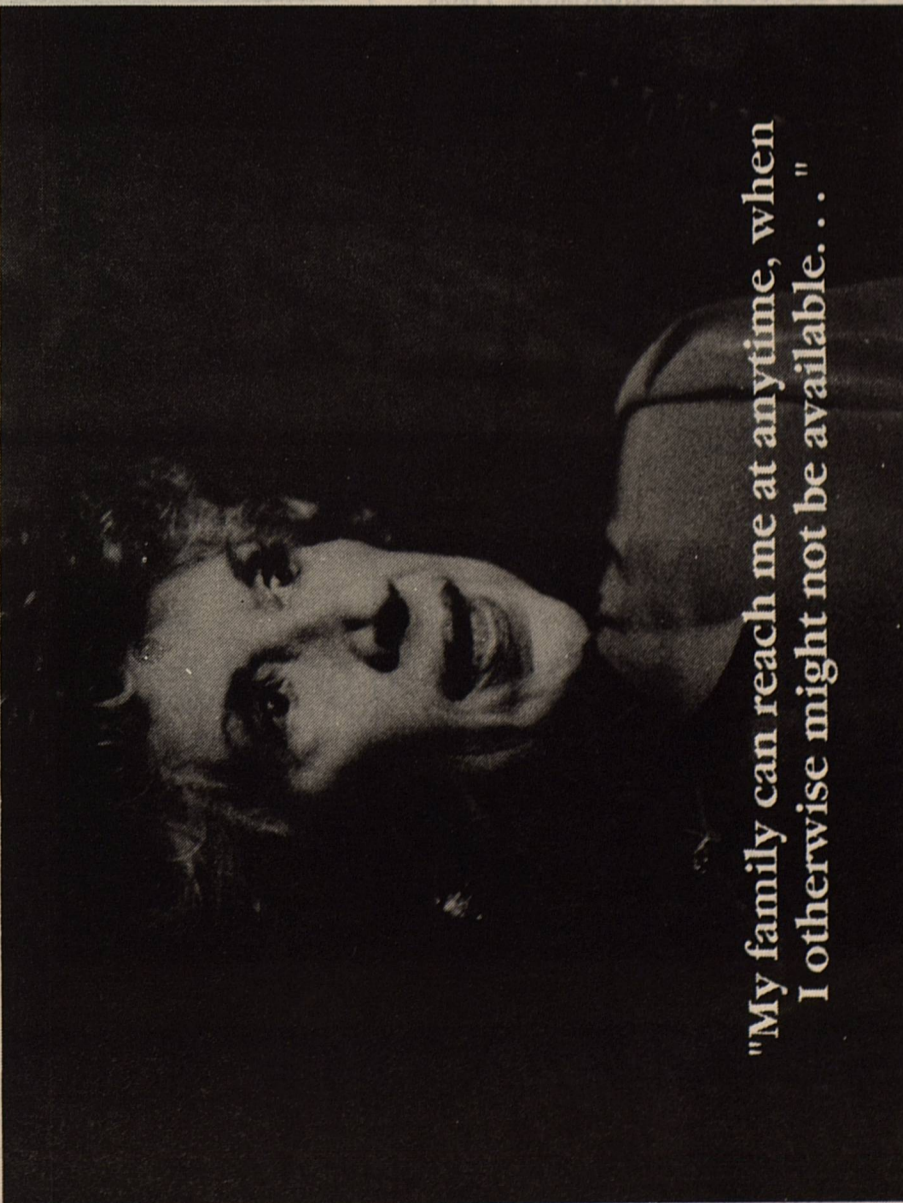

one's failing health or that of a loved one, or the death of a loved one.

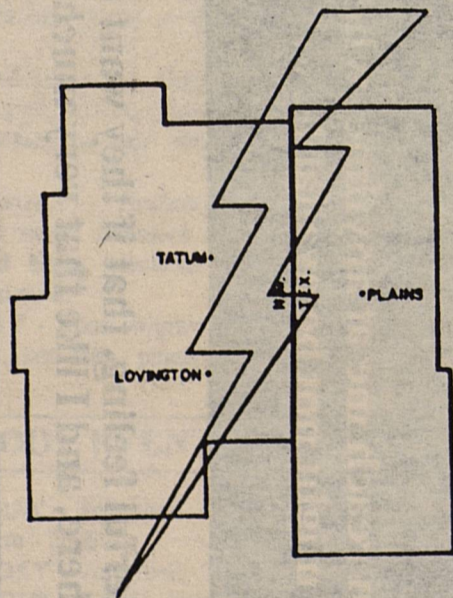
"Everyone who needs help with this is welcome to attend," says a spokesperson for the group. "We talk about things that are bothering us...it helps to know you are not alone."

ALL BRANDS AND MARKS ON TEXAS LIVESTOCK MUST BE RERECORDED WITH COUNTY CLERKS WITHIN SIX MONTHS OF AUGUST 30, 1991 ACCORDING TO ARTICLE 6899j, VERNON'S TEXAS CIVIL STATUTES. (September 2, 1991 thru February 28, 1992)

The owner shall have the right during this six-month period to file the brand and marks now recorded in his name. After this time any unrecorded brand will be available for use on a "first-come" basis.

It should be noted that it is illegal to brand livestock without first properly recording the brand with the County Clerk in the county in which the livestock are held.

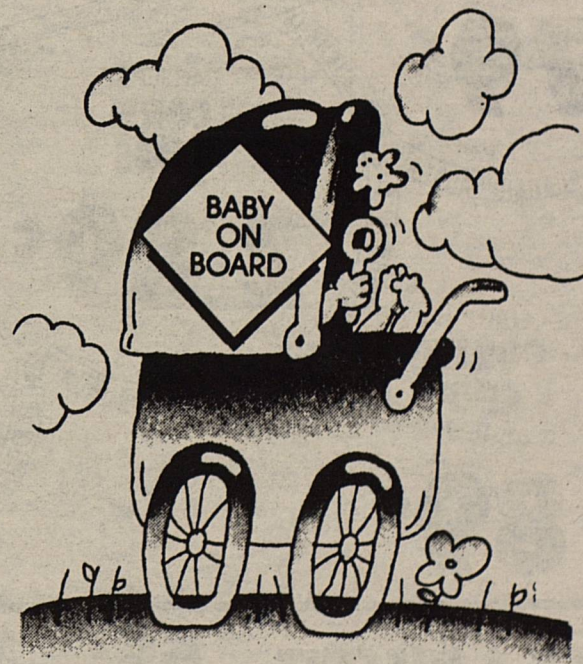
When the brand or brands are recorded, the location on the animal on which the brand is to be applied must be designated. If the brand is to be applied to more than one location on the animal, it must be recorded and each additional location for the brand on the animal shall constitute a separate recording of that brand.

There is no limit to the number of brands and/or marks which may be recorded in a county by a person as long as requirements of this law governing the recording and rerecording of livestock brands are met. Minors may have marks or brands separate from that of the father or guardian, which must be recorded or rerecorded as provided by the law.

The fee for each separate recording of brand is \$5.00.
