Enhance the self-esteem and we expand the possibilities. The development of an adequate and realistic self-esteem is our goal for every student. Enhancing the self-esteem of our students will improve our chances of success.

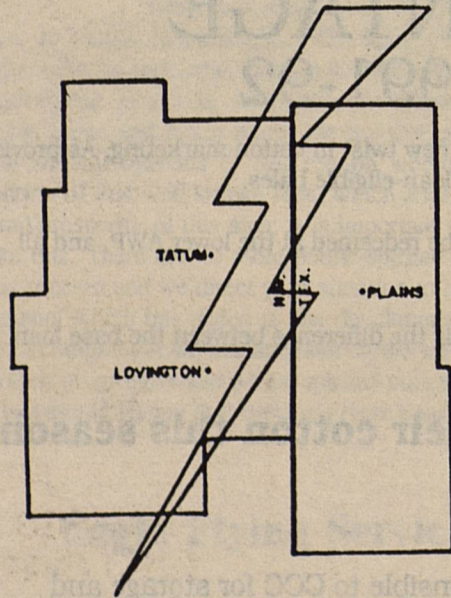
Students must experience a feeling of self-worth. This is the chief method of motivation. A simple statement of caring is often of major significance to a student. Students should be praised and complimented at every opportunity, but these opportunities must be honest and sincere.

Students thrive on a feeling of competence. They must be assured that their capabilities are limitless. Every effort must be made to give honest praise for their efforts as well as the potential of students as individuals. This praise must be extended to include a basic belief in students' ability to achieve and perform.

Self-esteem can and must be enhanced in all students. Research shows that parents have the greatest influence on a child's self-esteem. All Parents and Educators should work to instill positive self-esteem in our children. Five esteem-building skills that parents can practice to increase a child's self-esteem are: 1) Give lots of praise, for effort as well as accomplishment. 2) Help your child set realistic goals. 3) When correcting, criticize the action, not the child. 4) Give your child real responsibility. 5) Show your children you love them.

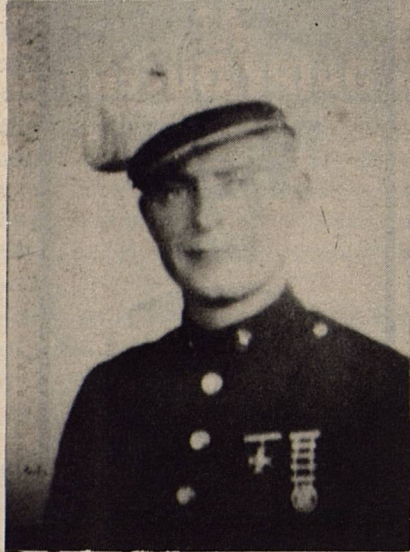

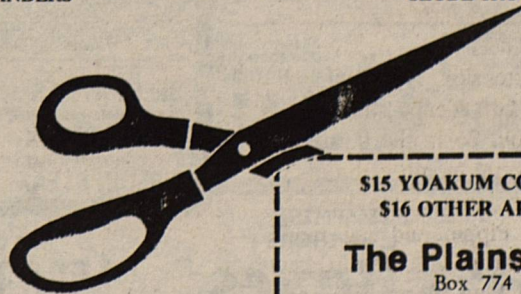
