Cowboys Beat Lorenzo Hornets

The Cowboys extended their record to five wins, two losses with their second district win. They also strengthen their claim to the district crown with a convincing 36-6 win over the Lorenzo Hornets.

The Hornets caught the Cowboys off guard on the opening kick off. David Guzman returned the ball 95 yards for Lorenzo's only points of the game. The PAT was no good.

Plains took the ball on their first possession and moved steadily down the field. Jose Ramirez carried twice for 13 yards. Ace Williams gained ten. Victor Bernal tossed a six yard pass to Brad McMinn. A six yard catch by Lenny Morrow capped the drive for the Cowboys and put six points on the scoreboard. Bernal's kick was good.

The Cowboys next score came when McMinn forced a Hornet fumble and David Bitolas recovered the ball in the end zone. Bernal's kick was good.

McMinn recovered a fumble on the Hornet's next possession. Shannon Ward took a pass to the Hornet 12 yard line. He then pulled in the ball for an eight yard gain. As the second quarter began Ramirez ran the ball in for six

more points. Bernal's kick split the up-rights.

After a couple of possession changes, the Cowboys got back on

track. Starting at the Cowboy 25 yard line, Bernal found McMinn for eight yards, then again for 20 more yards. Ward grabbed one in for eight yards.

Bernal found Dan Partin in the end-zone for the TD. The kick was good.

Halftime score was Plains 28, Lorenzo 6.

Jr. Lira returned the ball to the

Cowboy 42 yard line. Ramirez rushed for seven, then carried to Lorenzo's 47

for the first down. Williams gained another first to the Cowboy 32. Ramirez scored the touchdown from 11 yards out. Kick was good.

Williams had 118 yards rushing, Ramirez 117. Bernal threw 10 passes with seven completions for 82 yards. McMinn had three catches, Ward two; Partin and Morrow, one each.

Ramirez lead the defense in tackles.

Orders For Tree Seedling Packets Being Taken At Yoakum SWCD

The Yoakum Soil and Water Conservation District is again selling windbreak trees.

Those interested may contact Beverly Lowrey at the Soil Conservation Service Office in Plains for further details at (806) 456-3703.

Properly designed and maintained windbreaks can help make life more comfortable, provide protection, and help reduce erosion, and add aesthetic value to property.

Conifer and hardwood seedlings are useful in blocking wind, noise, and sights around homes, gardens or fields. Blocking winds around crops has also been proven to increase yields, especially in orchards and gardens.

The hardwood species that are available include red oak (shumard), desert willow, green ash, honey-locust, osage orange, pecan (native), Russian olive, nanking cherry, hackberry, mulberry (fruiting), sandcherry, and catalpa. These sell in bundles of 100 trees.

Conifers available are Afghanistan

pinus, Arizona cypress, Austrian pine, ponderosa pine, red cedar, Rocky Mountain Juniper and White Pine. These sell in bundles of 40 trees.

The Afghan pine also have a smaller seedling size called a bullet that is for sale in groups of 30.

Wildlife packets for quail and pheasant, deer, turkey, or squirrel will be available. These packets are 25 plants of four species that wildlife prefer. Each packet will contain 100 plants. The wildlife packets are in short supply, therefore these need to be ordered early.

The Yoakum Soil and Water Conservation District encourages wildlife plantings to promote wildlife habitat development in the county. The benefits of wildlife plantings are evidenced by the increase of game in our county.

The last day to order is February 25, 1992 and delivery will take place at the Soil Conservation Service office on March 4.

Please place your order as soon as possible because the trees are going fast.

Plains Water Supply Recognized By Texas Water Commission

The Texas Water Commission announced the special recognition of eight water systems and eight wastewater treatment plants located in the TWC District 2/Lubbock area. TWC awards are given annually to honor those water systems and wastewater facilities that have maintained full compliance with the provisions of their operating permits and TWC rules.

The award recipients for exceptional water systems are the city of Lubbock's Bailey County Wellfield, the cities of Denver City, Lamesa, Plains and the community of Ransom Canyon. In addition, the White River Municipal Water District in Crosbyton, Cargill Hybrid Seeds in Aiken and Reese Air Force Base near Lubbock were recognized as outstanding water corporations.

Wastewater treatment facilities recognized are those in the cities of

Plainview, Crowell, Throckmorton, Albany, Rochester and Hamlin. The city of Lubbock's Southeast Water Reclamation Plant and Land Application Site were also commended.

"We're proud of the effort the cities and operators are putting forth in maintaining their plants and the quality of their water and wastewater system," said Larry Smith, TWC District 2 Manager.

The plants honored will receive certificates of achievement during a noon luncheon on Wednesday, Nov. 4 at the West Texas Regional Water Utility School, taking place at the Lubbock Civic Center, Nov. 3-5.

The TWC is the state environmental regulatory agency charged with the duty of permitting, inspecting and overseeing the operation of drinking water supplies and wastewater treatment facilities.

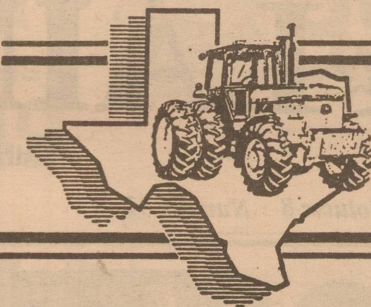
VARSITY

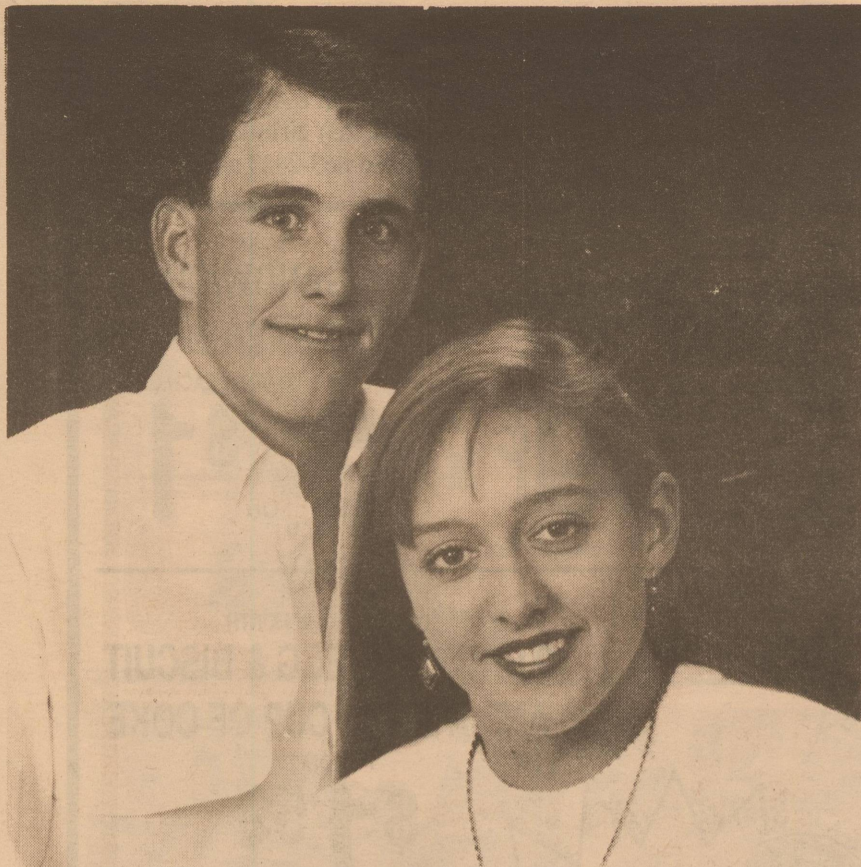

BREAKING METER SEAL IS ILLEGAL

Seals on electrical meters are the same as locks on doors. Breaking a meter seal is the same as breaking a door lock and illegal entry. And, it is extremely dangerous to break a meter seal because wires located in the meter base are energized. Serious injury or electrocution could result if contact is made with the meter wires.

Stealing electricity is like stealing from your neighbors. Your electric cooperative is a nonprofit organization, owned and controlled by its members. One member taking electricity without paying for it contributes to the overall increase in the price of electricity for all members. Your electricity is purchased from a wholesale power supplier and passed on to members through your cooperative's distribution system. The membership pays the real cost of providing service.

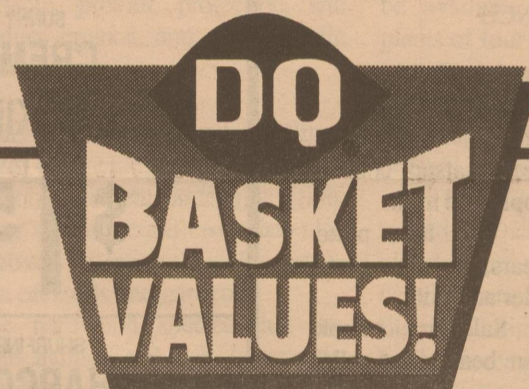
Tampering with a meter, unauthorized connections of service and diverting electrical energy for the purpose of reducing KiloWatt-hour registration or to avoid payment for energy is illegal.

All members/owners of Lea County Electric should report any case of meter tampering to the Cooperative. As an owner of the Cooperative, when someone steals electricity from the Cooperative, you are going to end up paying for it. This is one way you, as a member, can help control the cost of electricity.

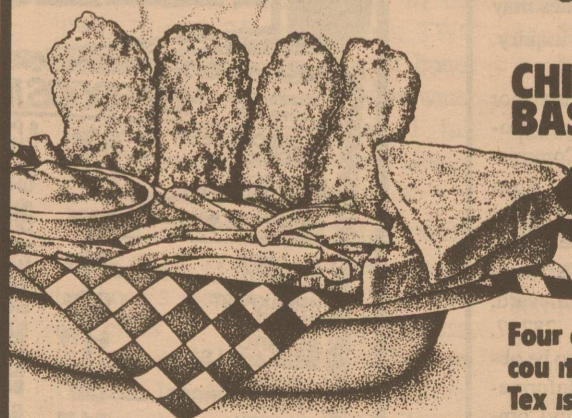
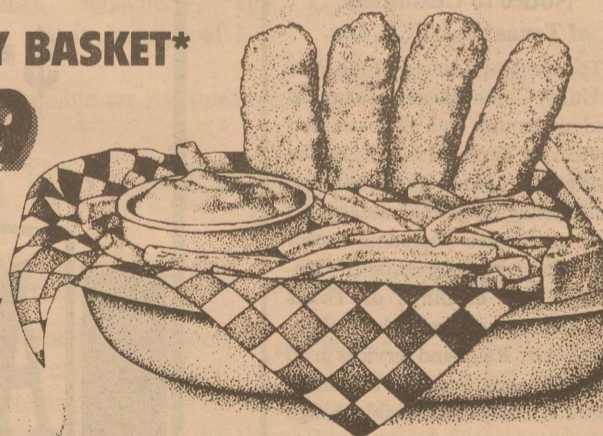

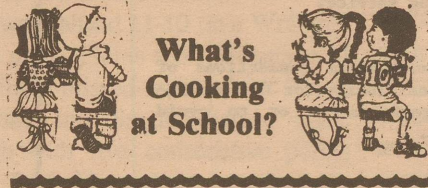
