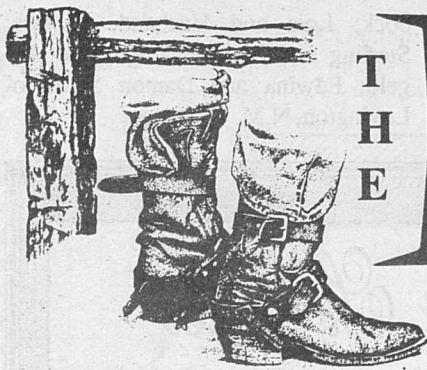

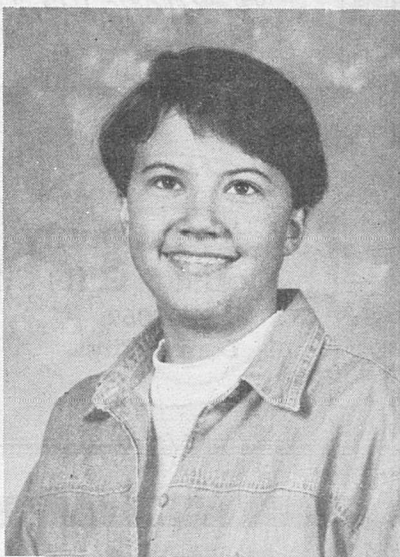

Plans are being finalized for the fortieth annual Rodeo and Old Settlers Reunion Aug. 5-7. The fun-filled weekend promises lots of excitement for all.

during Saturday night's rodeo performance.

Joe Orsak and Special F/X Band of Bryan will play for the cowboy dances following each evening's rodeo performance.

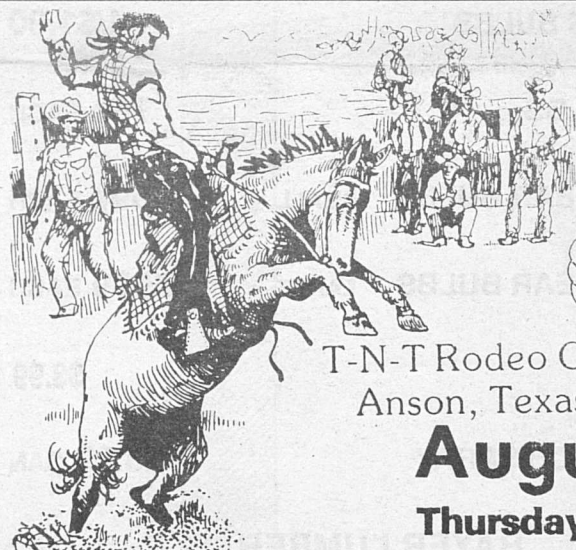
Admission to the rodeo is \$3 for adults and \$2 for children five to 11 years.

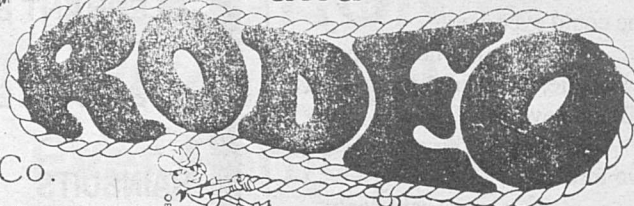
### ATTENTION

Matt gave up two runs on three hits, struck out one and gave up one homerun to Brownfield's Jeremy Miranda.

Umpires are furnished by the District Administrator in Lubbock. They were Tim Hadley, A.B. Morris and Myron Bennik.

Tuesday July 6, the first game at 6:00 p.m. was between the two losers from the first round, Plains and Denver City. After Plains jumping out to a 11-3 lead in the fourth inning, Denver City came back to win 13-12. Winning pitchers were Adam Stanton, one inning, Eric Horton one, and Damian Yanez six innings. Adam allowed six runs on five hits, walked one and gave up one home run to Matt Morgan the Plains second baseman. Eric Horton allowed four runs on no hits, walked five and struck out one. Damian Yanez allowed two runs on seven hits, he walked three and struck out six. The three pitchers for Plains were Adrian Rios four innings, Colt Winn two innings and Matt Morgan the last inning. Adrian allowed ten runs on ten hits, walked two, struck out five, hit one batter and gave up one homerun to the Denver City second baseman Damian Yanez. Colt Winn gave up two runs on two hits, walked two and struck out one. Matt Morgan allowed one run on two hits and struck out one batter.

The second game at 8:00 p.m. on Tuesday was between Seagraves and Ropesville who had drawn a bye in the bracket. Seagraves defeated Ropesville soundly in four and a half innings, 25-0. Greg Knight went the distance for Seagraves. He pitched a shut-out, no runs one no hits, walked one batter and struck out nine. Ropesville used two pitchers. James Martinez pitched two innings allowing 11 runs on nine hits, walked two, struck out one and gave up one homerun to the Seagraves pitcher, Greg Knight. Juan Sigala worked the last two innings. Juan allowed 14 runs on nine hits, walked six and struck out seven.

Zane Johnson, Plains Little League President presented all the players with their Little League All-Star pins. The first three nights of the tournament, the National Anthem was performed by the Plains Band Director and All-Star Coach Byron Morgan and his son Matt Morgan on their trumpets.

Wednesday July 7, the 6:00 p.m. game was between Denver City and Ropesville. Denver City won 20-1 in five innings. The two winning pitchers for Denver City were David Folmer who worked four innings and Harvey Casas who closed the game. David allowed one run on two hits, walked one and struck out six. Harvey didn't allow a run or hit, walked one and struck out two. Ropesville used four pitchers in their second loss. John Escobedo, two innings, Robert Cavazos two innings, Mark Rhoads one and Jessica Pena one innings. John Escobedo allowed ten runs on eight hits, walked five and one fanned. Robert Cavazos gave up six runs on seven hits. Mark Rhoads allowed one run on one hit, walked one and struck out one. Jessica Pena closed, she allowed three runs on four hits, she struck out one.

The second game of the evening was Brownfield and Seagraves in the winner's bracket. Brownfield won 7-1, winning pitcher was Mic Quinterilla who threw a complete game. He allowed one run on one hit. He only walked one and struck out 16. He did hit two batters in the last inning. Eric Gober went the distance for Seagraves. Eric allowed seven runs on 11 hits. He walked three and struck out eight. Thursday, July 8 there was only one game at 7:00 p.m. to decide who would face Brownfield in the Championship game scheduled for Friday.

You are hereby notified that NEW-TEX GIN COMPANY has applied for Texas Air Control Board (TACB) Permit No. 22867. This permit, if approved, will authorize operation of a Cotton Gin in Plains, Yoakum County, Texas. The location of the existing facility is 15 miles west of Plains on US 82. This facility will emit the following air contaminants: particulate matter, carbon monoxide, unburned hydrocarbons, sulfur dioxide, and nitrogen oxides.

A copy of all materials in the public file is available for inspection and reproduction at the TACB Lubbock Regional Office at 4630 50th Street, Suite 600, Lubbock, Texas 79414, telephone (806) 796-3494, and at the TACB Central Office, 12124 Park 35 Circle, Austin, Texas 78753, telephone (512) 908-1000. The facility's compliance file, if any exists, is available for public review in the regional office of the TACB. Inquiries about the permit application should be directed to the TACB Permits Program in Austin or the TACB Lubbock Regional Office.

You may submit written comments concerning the permit application to the TACB Executive Director in Austin. All written comments received within 30 days after the second publication of this notice shall be considered by the Executive Director in determining whether to issue or not issue the permit. All written comments will be made available for public inspection at the TACB Central Office in Austin. This notice is to be published on July 28, 1993 and August 4, 1993.

Any person who may be affected by emissions of air contaminants from the proposed facility may request the Board to hold an informal public meeting and/or contested case hearing on the permit application pursuant to Section 382.056(d) of the Texas Health and Safety Code. The Board is not required to hold a contested case hearing if the basis of a request is determined to be unreasonable. All requests for a contested case hearing must be received in writing within the 30-day comment period regardless of whether an informal public meeting has been held or scheduled on this matter.

Before a permit can be issued for this facility, the applicant must demonstrate that all emission sources are in compliance with all TACB Rules and Regulations and all applicable Federal Regulations. This includes the application of "best available control technology" to each new or modified emission source and compliance with all ambient air quality standards.

WHEREAS, the five options proposed to achieve equalized funding levels are: (1) consolidation with another district(s), (2) detachment of territory, (3) purchase weighted average daily attendance, (4) contract for nonresident students and (5) tax base consolidation; and

WHEREAS, Options 3, 4, and 5 require voter approval; and


WHEREAS, the board of trustees for Plains Independent School District has reviewed each of the options and after careful consideration has determined that Option 3 will cause the least harm to the quality of education for the students of the school system and will provide for some hope of maintaining the integrity of the school district's tax base; and


WHEREAS, this special election will have a profound impact on City of Plains taxpayers and the Plains Independent School District; and


WHEREAS, the City Council for the City of Plains has a responsibility of leadership in the community;
