Kyley Bearden reigns over 1993 Plains Rodeo

Two hundred and six cowboys and cowgirls participated in the fortieth annual Old Settlers Rodeo and Reunion Aug. 5-7. Fourteen-year-old Kyley Bearden was named Rodeo Queen in a climaxing ceremony Saturday evening.

Selected on the basis of the number of memberships sold, Miss Bearden sold 3328. Runner-up Dusty Beckham sold 2402.

Kenneth Hale was the lucky winner of the saddle given away Saturday evening when four-year-old Kimberly Jackson drew his name.

Calf scramble winners were Jared Bell and Adam Garcia, Thursday night; Colt Winn and Dusty Morgan, Friday night and Jose Lorazano and Taylor Gray, Saturday night. They received \$5 each.

Buckles were presented to Mike and Tanner Blount for their first place win in membership team roping. Second place finishers were Joe Pierce and Wayne Lee Davis. Times were 9.75 and 10.82, respectively.

Membership ribbon roping buckles went to Wesley Bowers and Tanner Blount with a 9.54 time. Runners-up, Tim Bowers and Mike Blount finished in 12.97.

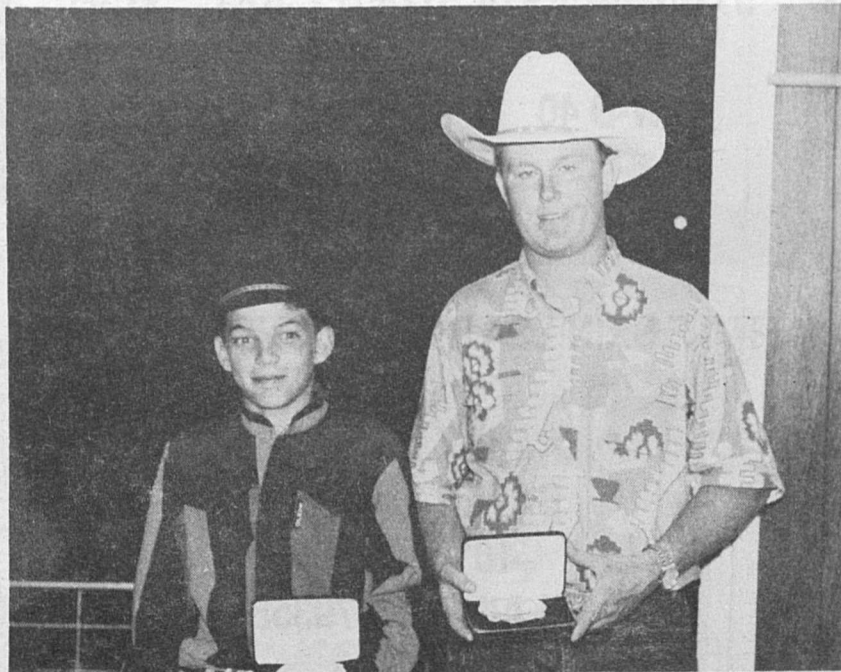

Texas leads the nation with formation of committee

Gary Westmoreland, assistant state conservationist for water quality and water resources with the USDA-Soil Conservation Service, announced the recent formation of the Texas Water Management Coordinating Committee.

"This will have far reaching benefits for the people of Texas," Westmoreland said. "It represents the first time in our state's history that all the state and federal agencies, together with input from the private sector, have agreed to work together voluntarily to coordinate the technical aspects of our various water management programs for Texas. This is also the first committee of its kind in the nation."

Westmoreland emphasized this group will not involve itself in policy making or legislative decisions. "Rather we are simply trying to improve the efficiency and the effectiveness of all our efforts by coordinating our activities," he said.

To illustrate, he mentioned that most of the state and federal agencies dealing with water resources have been developing geographic information systems (GIS) for various watersheds in Texas. "This involves digitizing the watershed-based planning and management. We discovered, for example, that several agencies are doing this, but they're using different techniques. Many times we digitize the same boundary, but with different results. We intend to coordinate our efforts on items like this to make more effective use of the dollars the public has entrusted us with."

Coach McAdams introduced the Cross Country Team whose season has just opened.

Boosters manned a table selling tee shirts and memberships. Persons may purchase tee shirts by contacting Toni Jones. Cyndy Koncaba, vice president, and Lola Bryan, secretary, are accepting memberships.

Teresa Stroup is committee chairman for the club's fund raising project of selling yard signs. The signs, large white star shapes with a black "P" in the center, are selling for \$15 each. Persons are invited to personalize their signs.

It was noted that the schedule posters are expected to be ready soon.

Plains Athletic Boosters would like to announce the addition of a special Booster Club member, The Plains Pride. "We look forward to a productive partnership supporting all of the PHS activities. We'd also like to THANK everyone for the refreshments donated and for the great turnout of fans to start the year off right."

Next meeting of the club is Wednesday, Sept. 1 at 8:30 p.m. in the clubhouse. Homecoming plans are to be discussed.

"We expect that additional state and federal agencies will want to become members of this committee," Westmoreland said. "We extend an open invitation to them to join and work with the group. This represents a great day in Texas history. It will help ensure that we will have agencies that are responsive to the public for the public good about water resources and water resources management in our great state."

Officers for the newly-formed committee, who will serve three year terms, are Gary Westmoreland, chairperson; George Fore, vice-chairperson, chairperson of Southwest Range and Wildlife Foundation; and Cheryl A. Hinckley, director-at-large, executive director of the Texas Rural Development Council.

He is married to Ann, a Plains ISD Kindergarten teacher. All four of their

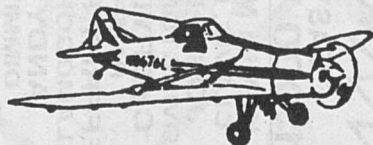
children are or have been active 4-H'ers. They are Nikki, Brandon, Kelly and Ragan.

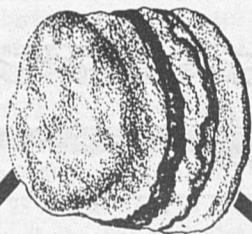

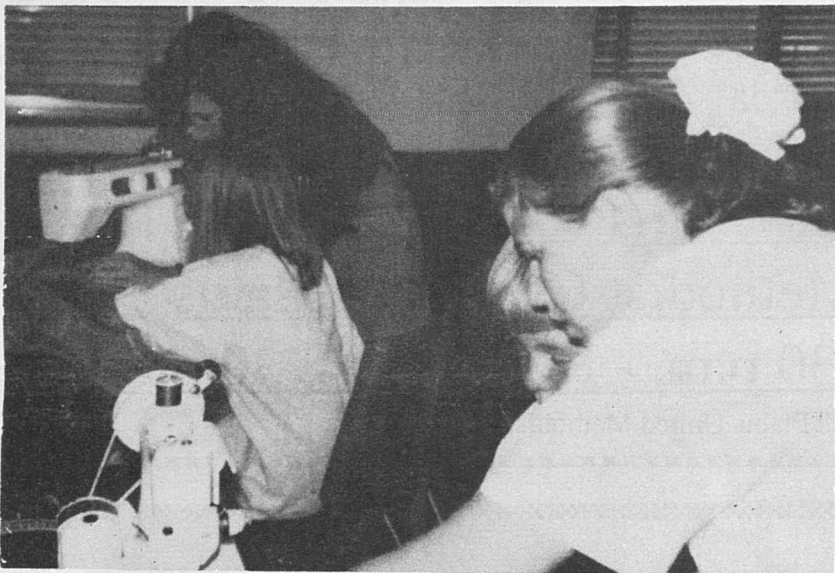
