## Country Thoughts by Dana Jameson

### If you can't say something nice...

Peyton Manning is once again center stage but not for being a great athlete or in an insurance commercial. Sexual harassment has brought him to the forefront of the news, again.

Harvey Weinstein has perfected sexual harassment over the years in Hollywood and has made everyone that has felt harassment come out of the woodwork.

I am pretty sure when I say that every person, male or female, can say they have been sexually harassed, I would not be far off.

But sexual harassment can mean different things to different people.

Men can be sexually harassed. It is not a strictly female issue.

Women can be sexually harassed by other women. Same goes for men.

Women can sexually harass men.

The legal definition of sexual harassment is unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature that tends to create a hostile or offensive work environment.

The key to this definition is the word UNWELCOME.

There is always that one person that will tell an off-color joke because they find it funny. Unfortunately there may be someone in the group while he tells the joke to that might take the joke personally and determine it as being sexual harassment.

In Peyton Manning's case he was 19-years-old and said he was horsing around with his buddies and mooned them while have a female trainer, Jamie Naughtright, look at his foot injury.

This is no excuse but Manning was 19. Do you remember when you were 19? Not quite all kid and not quite an adult. At 19, most of us were still trying to come to grips with the fact that we weren't little kids anymore. We were still trying to find our place in the world. We did STUPID things.

This was in 1996. Twenty-one years ago.

The news reported that Naughtright had filed suit against the Manning's when it was mentioned in a book they wrote. The suit was settled and money exchanged.

Now she is getting 15 more

minutes of fame by resurrecting the issue that was supposedly settled.

Let me say now that I am not a Peyton Manning fan. In fact, I find his commercials annoying. But I am not a Jamie Naughtright fan either.

I know that harassment of any kind can cause scars and become embedded in your memories. Flashbacks to the harassment can be terrifying and very embarrassing.

For there not to be any more harassment, sexual or any other, we need to learn to watch our words before we say them and not after. Maybe we need to be issued a roll of duct tape when we get old enough to speak, so we can keep those sexually charged statements from falling out of our mouths.

Here a few statistics:

One in three women between the ages of 18-34 have been sexually harassed at work, and 81% of women have been verbally sexually harassed (jokes, name-calling, etc.). Men are victims roughly 17% to 20% of the time.

The three most common forms of workplace sexual harassment are sexual coercion, unwanted sexual attention, and gender harassment.

Sixteen percent of women said "No" when asked if they have been sexually harassed at work but said "Yes" to experiencing sexually explicit or sexist remarks.

Eighty-one percent of women experience harassment in verbal form.

Forty-four percent of women say they've encountered unwanted touching and sexual advances

Twenty-five percent say they've received lewd texts or emails.

Who is doing the sexual harassing? 75% of women say they are targeted by male co-workers; 49% say they were harassed by male clients or customers; 38% say they were harassed by male managers; 10% say they were harassed by female coworkers.

The fields with the highest levels of reported sexual harassment: Food/Service Hospitality-42%; Retail-36%; Arts & Entertainment-31%; Legal-30%; Education-23%; and Medical/Health Care-21%.

Only 29% of women report being sexually harassed. That leaves 71% not reporting incidents. Out of the 20%, only

15% felt the report was handled fairly.

Educated women are not protected from sexual harassment: 45% have Bachelor's Degrees; 29% have some college education; and 19% have a graduate degree.

The statistics for charges filed by males who were sexually harassed rose from 16.1% to 17.8%. In recent years, more women have begun taking high-level managerial and executive positions that have altered the traditional power dynamics between supervisors and employees and resulting in more sexual harassment of men. The report went on to say that men are increasingly being harassed by male co-workers and supervisors and these men are more comfortable reporting the harassment than male employees did in the past.

The 1998 case of Oncale v. Sundowner Offshore Services brought to the forefront the discrimination and harassment

of men. In the case, a male oil-rig worker claimed that he was subject to sexual harassment by his male co-workers. The Supreme Court held that Title VII's protection against workplace discrimination involving member of the same sex and that "sexual desire" was not required to prove such claims.

If you have been sexually harassed, you have the right to report it the authorities. I have been sexually harassed but did nothing about it because I just wanted to be away from that boss. I was wrong to not report it because he went on to do the same thing to the lady that took my place. He may well still be out there doing the same thing to someone else.

I am starting to believe that the duct tape should be a standard issue item. No, I think I will make sure I report it next time.

Tom Byars is gin manager. The bale weighed 500 pounds, came from 2,300 pounds of seed cotton. The first bale yielded 780 pounds of seed.

\*An official groundbreaking ceremony was held at the Friona Nursing Home site Tuesday morning. Breaking ground were June Spring, Mayor R.L. Fleming, Dr. Bob Alexander, Andy Hurst and Delton Lewellen, contractor. Lewellen has estimated the job to take nine months to complete, and says he might beat that estimate if the weather is favorable.

\*The FFA leaders for Friona High School's chapter for 1975-76 are Kent Miller, reporter; Bobby Zetzsche, secretary; Davy Carthel, sentinel; Danny Campbell, vice president; Gary Self, president; David Barnett, historian; Keith Pryor, parlia-

mentarian; and Jody Menefee, treasurer. Paula London is chapter sweetheart and Mary Schilling is plow girl.

\*Late Friday there was quite a "hustle and bustle" all over town. Many persons got busy and gathered vegetables, which were in danger of freezing. Saturday morning's temperature readings made us realize we had not gathered the vegetables too soon.

Fortunately, for the home-makers flats for canning jars were available in local stores, so we were able to seal chow chow, tomatoes, soup mixture, and whatever else we wanted to preserve for winter eating.

\*Well Parmer County Farmers, you've done it again!

Statistics released from the USDA and Texas Department of Agriculture on the 1974 cash receipts from the sale of farm commodities show that Parmer County grossed \$158,205,000. This ranked Parmer County third in the state in 1974 with Hidalgo being first with \$201,993,000 and Deaf Smith second with \$160,690,000.

Parmer County ranked second in crops behind Hidalgo with \$93,052,000 being received.

In livestock, sales Parmer County ranked fourth with \$65,153,000. Parmer County's number one ranking in corn and number two ranking in fed cattle helped push the overall gross income to number three in the state.

## ~Psalm 54~ Backstabbed

Backstabbed, front stabbed, side stabbed, betrayed, belittled and bewildered was the experience of a portion of David's life as he was on the run from his master, King Saul. Saul's craziness led him to a point of attempting time and again to hunt down David. Saul's wicked obsession cast him deeper into his sin and rebellion, and creating a treacherous environment for anyone connected with David.

Psalm 54 is written out of one such episode where David is backstabbed by those who seemed to be giving him refuge. The Ziphites sneakily went and reported David's location to bloodthirsty Saul, and conspired to bring David to his doom. David's response, though, was not rage and anger, but crying out to and trusting in the Lord.

David's cry was an urgent plea for God to save him from his enemies closing in. Despite the trials and troubles of life, the gravity of difficulties spur prayer to a holy, desperate clinging to the Lord, but the reality is that temporary rescue is not one's greatest need. That's why in Psalm 54, David cries out for rescue, but moves to the assurance of his relationship with God. A relationship with God is more important than a rescue from difficulties, because the rescue is temporary, but true relationship with God is eternal. Therefore, when trials come, cry out for God's rescue, but focus on the relationship He invites us to enjoy with Him through repentance of sin and faith in Jesus Christ.

### Quality Time with God

Do you ever have trouble finding quality time to pray or study God's Word? You know, the time when it is quiet, and it is just you and God, and your focus is on nothing but God?

I know I do. I pray when I am walking these days, but my mind wanders, and I don't stay focused on God and my prayer concerns. And, being easily distracted, I don't make the time or effort to listen to God.

I have gone through various stages in my life when I had an organized prayer and study time, but I would let the busyness of life encroach on that time, and before I knew it, I was using that time for things other than God.

I have yet to find the ideal way or time to study and pray. But, I just started a new 90-day devotional by Priscilla Shirer called **Awaken**, and she talks about the "morning" principle.

Shirer reminds us of Old Testament Israelites who gathered manna each morning. "This was a critical part of their day. An appointed activity. For they knew, once the sun ascended toward its towering position in the sky, this bread from Heaven would melt away....Perhaps this ancient illustration depicts for us the reason why our hearts so often stir for a fresh word from God--fresh bread--early in the morning, before the heat of the day has set in."

Shirer points out that not everyone is a "morning" person, so the "morning" principle may have to be applied at a different time of day. But, she says, "Morning signifies a position of priority, a place of preeminence." If we will begin our morning "waiting before God, feeding on His Word, listening...while your heart is most open and refreshed and able to assimilate truth," you will be prepared to "receive the manna He is always so faithful to supply. A fresh word and fresh mercies." What a wonderful way to begin a day! This is just "food for thought," but hopefully it will give you something to think about if you are having trouble finding time to study and pray.

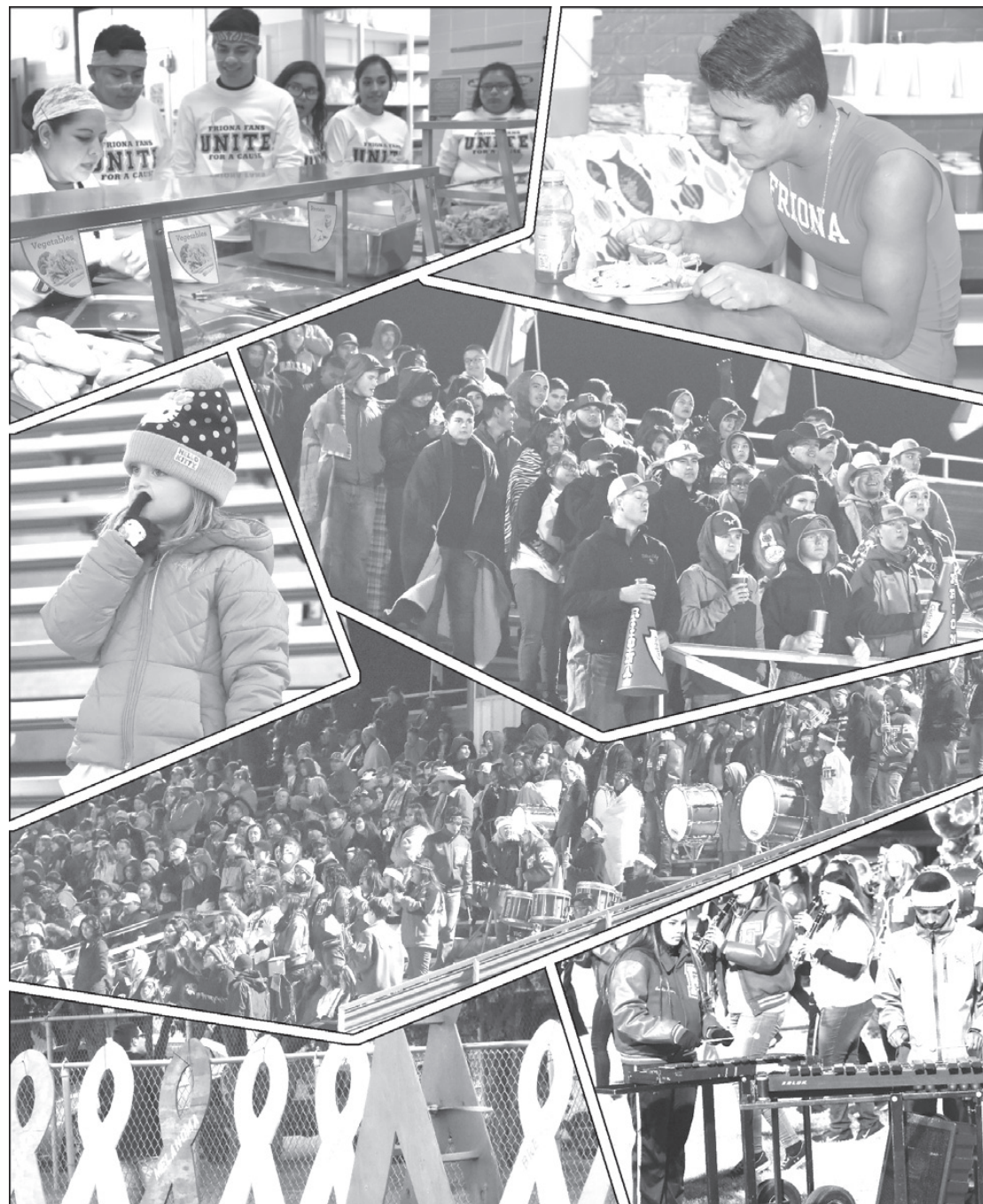

# Reports of tainted Texas corn raise concern among some deer hunters

Concerns over corn tainted with Fusarium fungi, which can produce Fumonisin, continue to flow into Texas A&M AgriLife Extension Service specialists' offices, but with the main deer hunting season only days away, the calls are increasingly from concerned hunters feeding corn to deer and less from corn producers, said agency experts.

"Shelled corn is the traditional 'go-to feed' in Texas for deer, so it's understandable there would be concerns considering how much of it is fed to wildlife," said Dr. John Tomecek, AgriLife Extension wildlife specialist at Thrall, who also serves West Texas.

Tomecek said it's best for hunters to be aware of the problem and know what they are buying, but not to be overly concerned.

"I think what is important to remember when we feed corn to free ranging deer, is chances are we aren't providing much more than a treat to these animals in the greater

scheme of their diets," Tomecek said. "Granted, corn helps provide energy during cooler months and is a great bait for hunting success, but it really doesn't make up a high percentage of most deer diets."

Dr. Cat Barr, veterinary toxicologist with the Texas A&M Veterinary Medical Diagnostic Laboratory at College Station, had similar thoughts.

She said the upper limit for deer feeding on Fumonisin-tainted corn should be no more than 30 parts per million and should be no more than half their diet. These rates are limits set for confined breeding cattle, a scenario not likely to occur in free-ranging deer.

"Even if the corn kernels themselves are nearing the recommended toxin ceiling, the deer are diluting it with all the greenery they're eating as well," she said.

Tomecek said the excellent growing conditions most of the state has enjoyed this year resulting

in this greenery is another strong reason for lesser concern. Aside from its diluting effect, the lush growth tends to limit corn-feeder visits by wildlife.

As far as a human health threat from consuming Fumonisin-eating game, Barr said studies of ducks, turkeys and pigs showed no measurable Fumonisin B1 levels in muscle tissues when animals were fed up to 20 ppm at 50 percent of the diet, a level unlikely to occur in free-ranging animals during favorable growing conditions.

"As for the effects on game birds, we know these kinds of toxins can have serious adverse effects on birds in general," Tomecek said. "But again, unlike a domestic poultry production scenario where the birds are confined, wild birds — be they game birds or those frequenting a backyard feeder — are using the corn as only a part of their diet, although perhaps at a higher proportion than do deer.

"A concerned hunter can always examine the crops of birds harvested to determine how much of their diet is coming from the corn, but most will find there is a great variety in diets of wild birds."

Fumonisin toxin is produced when certain Fusarium fungi are present on corn, a condition exacerbated by moisture during seed development, Tomecek said.

"The good news about Fumonisin is that Fusarium molds don't grow in storage, the way Aflatoxin-producing molds can," Barr said, "so at least the amount of Fumonisin in the corn is not going to increase, regardless of changes in temperature or moisture. Just keep in mind that some corn may contain both mold types."

"An Aflatoxin problem can increase inside metal feeders where corn heats and cools at a different

rate than the outside air, so condensation forms inside," Tomecek said. "We see this pretty frequently any time of year where dew or condensation forms on vehicles and such things as metal fence posts and uninsulated tin roofs. Typically, this problem is minor, especially in mostly dry West Texas, but when it does occur clots of dust from corn or other feeds may form and toxins can grow in this environment."

"I recommend cleaning feeders before and after the hunting season, or when it's convenient at some point during the year. Letting them run low or out, then refilling them with tested corn devoid of toxins should keep your animals coming, while keeping the feed and your investment in that feed, protected."

Tomecek said corn shouldn't be feared and is an excellent and

cost-effective feed for wildlife, but he does recommend knowing the product and how it should be handled.

"I don't think folks should shift away from corn entirely," he said. "But these outbreaks are good reminders to hunters of the importance of proper feed and feeder management; namely to buy quality corn and ask your supplier if they have test results. Ask when the corn was tested and how it has been stored since that date."

Tomecek said not all corn storage is created equal, especially in productive years, as the grain may have been left outside and is of lower quality, hence lower in price.

"The main take-home points are to purchase a quality product, store it in dry containers and clean your feeders. Do these things and you'll have no worries."

# Deadline for Pasture, Range and Forage Insurance sign-up Nov. 15

Texas landowners who rely on perennial forage to feed their livestock may want to purchase Pasture, Rangeland and Forage Insurance to protect the income potential of these acres, according to a Texas A&M AgriLife Extension Service expert.

DeDe Jones, AgriLife Extension risk management specialist in Amarillo, said the U.S. Department of Agriculture Risk Management Agency offers the program and policies covering the 2018 calendar year through crop insurance agents until Nov. 15. Premiums are billed on Sept. 1, 2018.

"While conventional crop insurance has been out there for many years, there's little out there for ranchers," Jones said. "They need to be focusing as much on risk management as a farmer. This is a relatively new program and one they might want to consider."

"Producers are not required to insure all of their acres or for the entire 12-month period," she said. "Instead they can choose the acres and months most important to their grazing and/or haying operations."

Payment is not determined by individual damages, but rather area losses based on a grid system, she explained. Producers can select any portion of acres to insure, but they must select between 11 of the two-

month intervals outlined, choosing at least two and not more than six.

Coverage levels between 70 and 90 percent are available, Jones said. Once coverage is selected, the producer also chooses a productivity factor between 60 and 150 percent. The productivity factor is a percentage of the established county base value for forage.

The base value is a standard rate published by the Risk Management Agency for each county. It is calculated based on estimated stocking rates and current hay prices, she said.

Jones said the program uses a rainfall index to determine potential indemnity payments.

Additionally, she said alfalfa and other irrigated hay can be insured under a Pasture, Range and Forage Insurance policy at different coverage levels and higher base values.

### Being that November is BLAZE COFFEE ACCIDENT AWARENESS Month, we would like to share our story...



In August 2009, our son, Blaze Coffee, was in an accident while working with heavy equipment. He was rushed to the hospital where a surgeon was awaiting his arrival. Blaze was taken to surgery immediately. After what seemed like an eternity, the doctor came to talk to us. The doctor informed us that Blaze had sustained a terrible trauma and that his injuries were life-threatening.

When they let our family see Blaze for the first time after the surgery, it was then we noted the large number of blood components that were being used. This day was the start of our twenty-eight day stay in the hospital. Each day, Blaze would overcome one crisis and then another would arise. He required blood products daily – platelets, plasma and red blood cells. We quit counting how many he was given at about 68 yet the transfusions continued. Through all of this, Blaze demonstrated a remarkable will to live and a fighting spirit that astounded those around him. Thanks to donors that responded, we never worried that blood would be available...and we never lost hope!

On September 8, our hometown of Panhandle pulled together for one of the biggest single blood drives for an individual. The communities of Booker and Darrouzett held drives in Blaze's honor as well. The drives brought in about 140 units of blood thanks to the community of Panhandle, to our friends and neighbors and to the other communities who showed their support.

Our story is a little different from those usually shared with Coffee Memorial. Blaze did not receive an earthly healing, he passed away on the very day the blood drives were held in his honor – September 8, 2009. He was 20 years old. We wanted to share our story because the blood products Blaze received gave us 28 extra days with our son to say the things we needed to say. That is why we contacted Coffee Memorial (name is just a coincidence) to ask if we could obtain sponsors and host blood drives in our son's honor. With generous support from our friends, family and area businesses, the Blaze Coffee Memorial Drives have grown so much that we are now able to sponsor t-shirts for the entire month of November in Blaze's memory.

Blaze truly lit up his little corner of the world during his 20 years. We may no longer be blessed with his physical presence, but his flame still burns brightly through all of those who have already donated blood in his memory, and those who will do so in the future. Because of the gracious donations from strangers every day, families in crisis do not have to worry about blood being there for their loved ones.

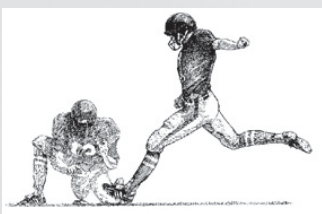

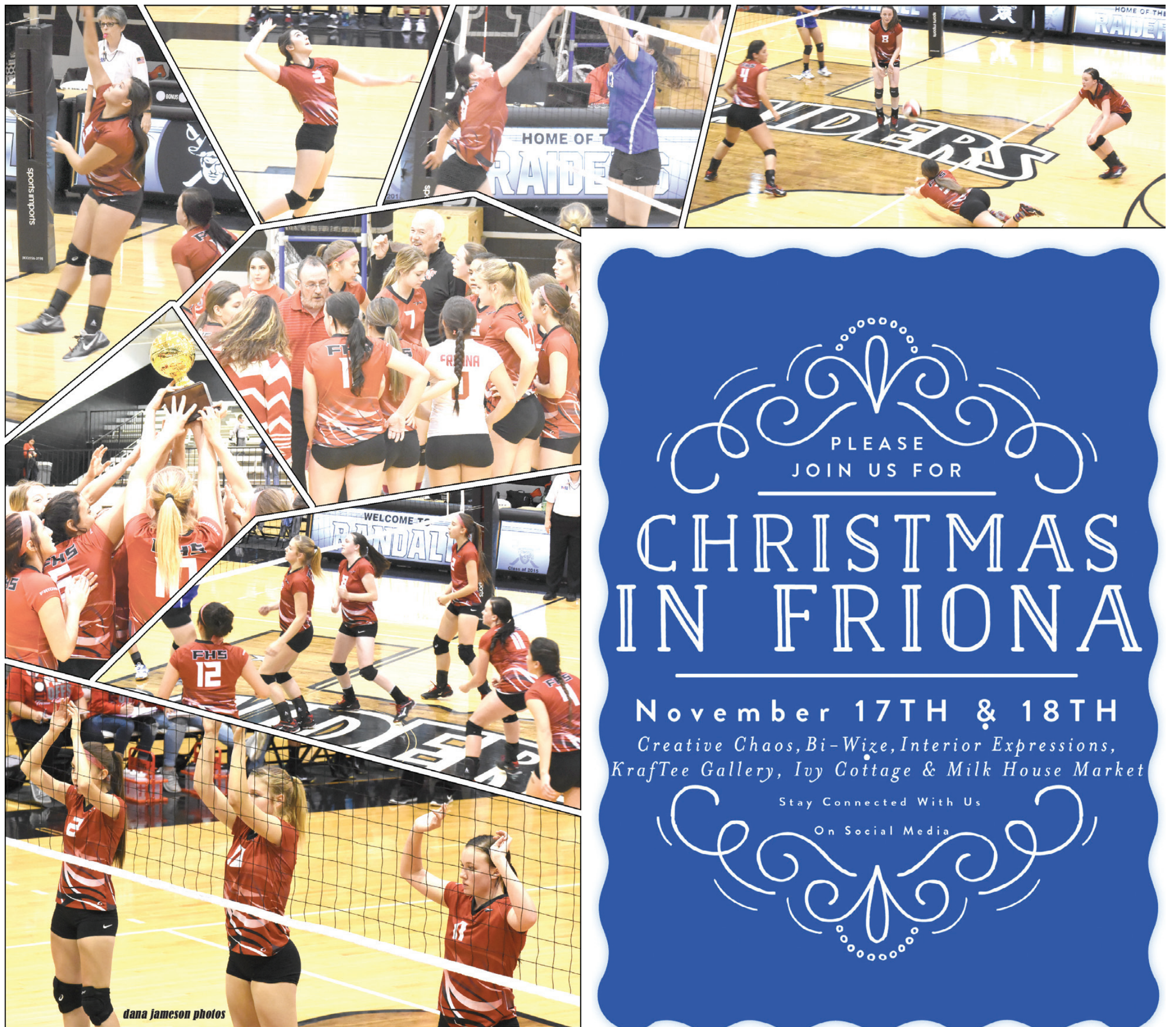
