PMC offers Medicare Open Enrollment Education

Medicare open enrollment period has once again arrived. Parmer Medical Center and the Friona Rural Health Clinic want you to know that the hospital and clinic providers have not contracted with any Medicare Advantage Plans. We encourage you to carefully evaluate any Medicare Advantage Plan before you decide to give up traditional Medicare, and to check with the business office at 806-250-2754 to see how the plan will cover you at your local hospital and providers.

Medicare Advantage Plans are not traditional Medicare. Medicare Advantage Plans are insurance plans operated by private companies.

Medicare Advantage Plans are not Supplemental Plans. The name Medicare Advantage is confusing to individuals because they often assume it is a Medicare supplemental or secondary plan. Also known as Medigap Plans, supplemental insurance plans are designed to work with traditional Medicare to cover the cost of deductibles and co-payments not paid by Medicare. If you have a Medicare Advantage Plan, you

cannot be sold a supplemental plan so you must pay 100 percent of any deductibles and copayments associated with the Medicare Advantage Plan.

If you later drop your Medicare Advantage Plan and return to original Medicare, there is no guarantee that you will not pay a higher premium for a supplemental plan based upon your current health status and pre-existing conditions.

You can purchase a Medicare Drug Plan without enrolling in a Medicare Advantage Plan. Some individuals who sign up for drug benefits may unintentionally sign up for a Medicare Advantage Plan. Be sure to read your plan benefits carefully to know exactly what

program you are selecting. Individuals with Medicare Advantage Plans may have to pay more to use many providers and hospitals, including Parmer Medical Center and the Friona Rural Health Clinic. Individuals with traditional Medicare have the choice of seeing ANY provider that accepts Medicare, including Parmer Medical Center and the providers at the Friona Rural

Health Clinic. The hospital and clinic, however, may not be innetwork providers for many Medicare Advantage Plans. As a result, individuals may not be able to use our services without paying more out-of-pocket than presented by the Medicare Advantage Plan.

Parmer Medical Center will be featuring several more educational articles during open enrollment. Additionally, PMC will be offering a free community education event focusing on Medicare Plan "D" on October 30th at 1:30 p.m. in the conference room at PMC. The educational program is being presented by Amarillo Area on Aging of the Panhandle. This agency does not sell anything. They are the government agency that acts as a liaison between Medicare and the individual recipients of Medicare. They will have benefits counselors present to assist you in determining which Plan "D" works best for your prescription needs. Halloween Makes It More Than Spooky on the Road

Halloween Safety for Pedestrians, Bicyclists, and Motorists

Halloween means children getting outdoors to enjoy treats, fun, and games. Although Halloween comes before the change back to standard time this year, the days are getting shorter, and the nights are getting longer. With shorter days comes more night driving. Because nighttime driving is more dangerous, it requires extra attention from motorists, as well as pedestrians and bicyclists. Sadly, Halloween also increases the number of drunk drivers on the road at night. The National Highway Traffic Safety Administration (NHTSA) reports that from 2012 to 2016, 44% of all people killed in motor vehicle crashes on Halloween night were in crashes involving a drunk driver.

NHTSA also reports that nearly twothirds of all fatal pedestrian crashes and about 20% of fatal bicycle crashes occur in low-light conditions. The large number of young pedestrians out on Halloween evening makes this an especially dangerous time.

That's why Texas A&M AgriLife Extension Family and Community Health Educator Wendy Case, Parmer County reminds motorists, parents and children of the following safety tips to keep in mind during Halloween and all year long.



Tips for Motorists

- Slow down. Watch for children walking on roads, medians, and curbs. Enter and exit driveways carefully.
- Be especially alert for children darting out from between parked vehicles and from behind bushes and shrubs. They're excited - and they are not paying atten-
- Never drink and drive tonight or any night. If you are partying, designate a driv-

Tips for Parents

- Adults should accompany children at all times and supervise their "trick or treat" activities.
- Teach children to "stop, look left-right-

- left, and listen" before they cross the street. · Use a flashlight, and wear retro-reflec-
- tive strips or patches on your clothing or costume to be more visible to motorists.
- · Be certain that the mask does not obstruct vision or hearing.
- · Ensure that costumes do not impede walking or driving ability.

Tips for Pedestrians (children and adults)

- Before crossing a street, stop at the curb or edge of the road and look left, right, and left again to be sure no cars are coming. Continue to check for traffic while on the street.
- Walk never run from house to house or across the road.
- · Cross the street only at intersections and crosswalks.
- · When crossing at an intersection with a traffic light, be sure to watch for turning cars. Obey all pedestrian signals.
- Walk on sidewalks whenever possible. If there are no sidewalks, walk on the left side of the street facing traffic.

By taking some extra time to make sure drivers, pedestrians, and bicyclists obey the rules, Halloween can be a safe time for

According to Wikipedia, the art of chainsaw carving is an art form using modern technology along with the ancient art of woodcarving. The Parmer County Museum has an Indian statue carved using this art form. The Indian was originally given to Friona High School in 1999. Keith and Jacque Martin went to the Amarillo Tri State Fair in the fall of 1999 and watched the artist carve the Indian with a chainsaw out of a log. They gave the carved statue to Friona High School in honor of their parents, Clarence and Wyonna Martin and their nephew, Landon Martin, who graduated in the spring of 2000. The statue was placed in the office until Denver Crum, high school principal, remodeled and asked the Martins if the Indian could be moved. Wendy Carthel, Parmer County Museum curator, was glad to accept the Indian. It makes a perfect addition to the Native American exhibit to honor Quanah Parker. There is one missing piece of information, however. The artist carved his initials, R.C., into the base, but the Martins don't remember the full name. 

Wednesday nights rain which measured 1.1 inches in the official Friona gauge brought a halt to the cotton harvest in the local area, which had gotten underway during the past week. The lasts rain added .69 from earlier in the week. And a light shower last Friday morning. On the positive side for cotton farmers—if the temperatures had been about two degrees colder Wednesday night, there could have been a snowfall of just over 12 inches on the level, or some freezing rain which could have damaged manager of Friona Farmers Co-op Gin, said that his gin had processed about 700 bales before the rain called a halt to the harvest proceedings. Butman said that all of the cotton ginned to date had been defoliated and was on dryland or semi-irrigated land. The farmers owning the cotton which had been ginned indicated that early yield amounts were surprisingly better that they had thought it might be. None of the better irrigated cotton had been ginned Butman said. The 1.69 inches of the rain received during the past week, added to the light showers earlier in October, brought the months total moisture to 2.51 inches, and supports one longtime area farmer who said about a month a go that "we're probably going to get about as much rain (during the harvest season) as we wished we had received back when we really needed it."



County Commissioners adopts Health Wellness Program

The Parmer County Commissioners Court met in regular session on Monday, October 22nd at 10:00 a.m. in the County Courtroom of the Parmer County Courthouse in Farwell, Texas. The meeting began with prayer and the Pledge of Allegiance to the American Flag and the Texas Flag.

The first item of business was the approval of the Covenant Health Wellness Program. Made available through the insurance provider at no cost to the county, this annual check-up provides basic health tests for all county officials and employees. Next, the Court approved the Enterprise Zone designation for the Cargill plant outside of Friona.

The Minutes from the previous meeting were then read and approved. Approval was also given for the payment of the accounts payables as presented by County Auditor Larry Johnston. The Commissioners also reviewed the Treasurer's Report presented by Altha Herington and approved the calculated payroll and disbursement for all county employees and elected officials. Approval was also given for the budget amendments and transfers.

Next, the Commissioners approved the acceptance of cash donations from Wilbur-Ellis and Affordable Bail Bonds to the recent National Night Out event. By law, all cash donations must be processed by the Court. The Court also appointed County Auditor Larry Johnston to audit the Parmer County District Attorney Forfeiture Report and the Court renewed the maintenance agreement with Holland's Clovis Office Equipment Company.

The Commissioners then gave approval to Farwell High School to hold a bonfire using the area by the Precinct #3 barn. The Court also approved payment to a Parmer County employee for unused vacation days. The Court then voted not to pay Region O Water Planning dues.

The last item of business was the approval to sign up for the Indigent Defense Resolution. This is a \$21 million fund that s designated for all 254 Texas counties to use for indigent care. The amount that Parmer County receives is usually around \$10,000-\$12,000.

The next Commissioners Court meeting was rescheduled for Tuesday, November 13 at 10:00 a.m. because of the Veterans Day holiday on Monday. The meeting was then adjourned.

All meetings are open to the public. The Commissioners Court reserves the right to go into Executive session at any time. Meeting agendas can be found on the Parmer County website. Information in this article is only a summary. Any questions concerning specific actions should be directed to the Court.



The first twenty verses of Mark 5 displays Jesus' power over demonic forces. Texas Weekly Fuel Update and Outlook

Gasoline prices in Texas have fallen 3.7 cents per gallon in the past week, averaging \$2.61/g yesterday, according to Gas-Buddy's daily survey of 13,114 stations in Texas. This compares with the national average that has fallen 4.7 cents per gallon versus last week to \$2.83/g, according to

Including the change locally during the past week, prices yesterday were 36.3 cents per gallon higher than a year ago and are 1.3 cents per gallon higher than a month ago. The national average has dropped 1.6 cents per gallon during the last month and stands 39.6 cents per gallon higher than a

"Much of the country continues to enjoy broad decreases in gas prices as oil prices drop to \$69 per barrel. In fact, with the exception of the West Coast where an earlier natural gas pipeline shut down caused prices to up, nearly every state saw prices move lower," said Patrick DeHaan, head of petroleum analysis at GasBuddy. "The Great Lakes has seen prices drop 30-50 cents per gallon at individual stations since the start of October, leading decliners. The fall relief that has been expected for weeks has finally arrived. Gasoline economics typically weaken shortly after summer, but we experienced somewhat of a delay due to concern over Iran sanctions and OPEC production, but seemingly the market has become more concerned with other factors, and thus far, the affect on motorists has been lower gas prices. While Great Lakes states may see prices bounce of current lows in the week ahead, much of the rest of the country will likely see additional downward movement," DeHaan added.

- 1 clove garlic salt and pepper to taste
- 1 Tbsp. chili powder
- 3 cups water
- ¼ tsp. sugar
- 28 oz. can chopped tomatoes
- 16 oz. can whole kernel corn
- 23 oz. can Ranch style beans
- 6 medium potatoes, cubed

Scramble the hamburger meat until browned. Then add it to a large stew pot with the rest of the ingredilents. Simmer until potatoes are done.

- Ginger snap cookies

In a large bowl, beat cream cheese and confectioners' sugar until smooth. Beat in the pumpkin, sour cream, cinnamon, pie spice and ginger until blended. Serve with ginger snaps. Makes 4 cups.

Jack-o-lantern Turnovers By Marge Free- Kids Approved Cookbook

- ½ pound ground beef
- 1 Tbsp. finely chopped onion
- 4 ounces cubed mozzarella cheese
- ½ cup prepared mustard
- 2 tubes (16.3 ounces each) large refrigerated flaky biscuits
- 1 egg, lightly beaten
- 1. In a large skillet, cook beef and onion over medium heat until meat is no longer pink; drain. Add cheese and mustard; cook and stir until cheese is melted. Cool slightly.
- 2. Flatten each biscuit into a 4-in. circle; place four biscuits in each of two greased 15-in. x 10-in. x 1-in. baking pans. Spoon 2 heaping tablespoons of meat mixture onto each.
- 3. Using a sharp knife or cookie cutter, cut out jack-o-lantern I faces from remaining biscuit circles. Place over meat mixture and pinch edges to seal tightly. Re-roll scraps if desired and cut out stems for pumpkins.
- 4. Brush with egg. Bake at 350 F for 10-15 minutes or until

The greatest dangers for teen drivers are alcohol consumption, inconsistent or no seat belt use, distracted and drowsy driving, speeding, and driving with passengers in the vehicle. Motor vehicle crashes continue to be the leading cause of death for teens 15-to-18 years old in the U.S. and in Texas.

Parents can be the biggest influencers on teens' choices behind the wheel if they take the time to talk with their teens about some of the biggest driving risks, including:

- are too young to legally buy, possess, or consume alcohol. However, nationally, in 2016, nearly one out of five teen drivers of passenger vehicles involved in a fatal crash had been drinking. But alcohol isn't the only substance that can keep your teen from driving safely: In 2016, 6.5 percent of adolescents ages 12 to 17 were current users of marijuana. Like many other drugs, marijuana affects a driver's ability to react to their surroundings. Driving is a complex task, and marijuana slows reaction times, affecting the driver's ability to drive safely. Remind your teen that driving under the influence of any impairing substance - including illicit, prescription drugs, or overthe-counter medication - could have deadly consequences. It is critical that teen drivers understand why they shouldn't drive impaired, that they know that they will lose their license if they are caught driving impaired, and that they will face additional consequences for breaking the rules they agreed to follow when they started driving.
- Seat Belts: Wearing a seat belt is one of the simplest ways for teens to stay safe in a vehicle. Yet too many teens aren't buckling up. In fact, there were 569 passengers killed in passenger vehicles driven by teen drivers, and more than half (54%) of those passengers who died were NOT buckled up at the time of the fatal crash. Even more troubling, in 85 percent of cases when the teen driver was unbuckled, the passengers were also unbuckled.
- Distracted Driving: Distractions while driving are more than just risky — they can be deadly. In 2016, among teen drivers involved in fatal crashes, 10 percent were reported as distracted at the time of the crash. This age group (ages 15-18) also has the largest percentage of drivers who were distracted at the time of a crash. The biggest

distraction for teens is other teens in the vehicle.

- Speeding: In 2016, almost one-third (31%) of all teen drivers of passenger vehicles involved in fatal crashes were speeding at the time of the crash, and males were more likely to be involved in fatal speeding-related crashes than
- Passengers: Teen drivers transporting passengers can lead to disastrous consequences. Research shows that the risk of a fatal crash goes up dramatically in direct relation to the number of passengers in a car. The likelihood of teen drivers engaging in risky behavior triples when traveling with multiple passengers. Just one teen passenger can increase a teen driver's crash risk by 44 percent.
- Drowsy Driving: Teens are • Alcohol and Drugs: All teens busier than ever: studying, extracurricular activities, parttime jobs, and spending time with friends are among the long list of things they do to fill their time. However, with these activities, teens tend to compromise something very important sleep. This is a dangerous habit that can lead to drowsy driving. Even after 7-8 hours of quality sleep, people are most likely to feel drowsy between the hours of 2 p.m. and 6 p.m., which is generally when teens are driving home.

What the solution? Talk regularly to your teen about the dangers of driving. Parents - you've guided your teen this far. Driving is a new chapter and a step toward independence for many teens. But your job is not done. Self-reported surveys show that teens with parents who set and enforce firm rules for driving typically engage in less risky driving behaviors and are involved in fewer crashes. But your kids can't listen to you if you don't talk to them.

That's why Texas A&M AgriLife Extension Community Health Educator Wendy Case in Parmer County reminds parents to take advantage of National Teen Driver Safety Week to talk to their teens about staying safe on the road. Remember, one of the most important safety features for your teen driver is YOU! Know the Graduated Driver License Law and be familiar with the restrictions placed on your teen's license - it can better assist you to enforce those laws.

Parents should start the conversation with their teen about safe driving habits during National Teen Driver Safety Week, but continue the conversation every day throughout the year. Even if it seems like they're tuning you out, keep reinforcing these rules. They're listeningyour constant reminders about these powerful messages will get through.

Get creative! Talking is just one way to discuss safe driving. You can also write your teen a letter, send e-mail or text reminders, leave sticky note reminders in the car, or use social media to get your message across.

Get it in writing. Create a parent-teen driving contract that outlines the rules and consequences for your teen driver. Hang the signed contract in a visible place as a constant reminder about the rules of the road.

Follow the Rules of the Road: 1. Don't Drive Impaired - this includes alcohol or drugs.

- 2. Buckle Up Every Trip. Every Time. Everyone — Front Seat and Back.
- 3. Eyes on the Road, Hands on the Wheel. All the Time. Avoid distractions in the car.
- 4. Obey All Posted Speed Limits. 5. Passengers- avoid driving

FSA News - Lone Star State Edition

As harvest continues and many areas of the state have experienced heavy rainfall, I encourage you to visit your local FSA office to meet several upcoming deadlines.

Producers with generic base acres have until Dec. 7, 2018, to allocate generic base acres, update yields, make a program election for seed cotton base acres and enroll farms that formerly contained generic base

I know some sources have advised producers to wait out the enrollment period to have a better idea of market prices. I understand this idea but want to point out that our offices will not be able to enroll 80 percent of producers a week before the deadline. Please make an appointment now and know that you can change your election up until Dec. 7.

While you're in the office make sure to complete your grass acreage reports by Nov. 15, sign up for the 2017 Wildfires and Hurricanes Indemnity Program (2017 WHIP) by Nov. 16 and enroll in the Market Facilitation Program (MFP) if harvest is complete.

Additionally, producers who suffered eligible livestock, honeybee or farm-raised fish losses from Oct. 1, 2017, to Sept. 30, 2018, have until Dec. 3, 2018, to file their application for payment.

As a reminder, we've started issuing 2017 crop year payments for ARC/PLC and for the Conservation Reserve Program. To apply for these programs or to discuss eligibility requirements, contact: Parmer County FSA Office, PO Box H, Farwell, TX 79325, or call 1-806-481-3311.

After technical review of the application is complete, the Executive Director may prepare a draft permit and will issue a preliminary decision on the application. Notice of the Application and Preliminary Decision will be published and mailed to those who are on the county-wide mailing list and to those who are on the mailing list for this application. That notice will contain the deadline for submitting public comments.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting on this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material, or significant public comments. Unless the application is directly referred for a contested case hearing, the response to comments, and the Executive Director's decision on the application, will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting reconsideration of the Executive Director's decision and for requesting a contested case hearing. A contested case hearing is a legal proceeding similar to a civil trial in state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period and, the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period. TCEQ may act on an application to renew a permit without providing an opportunity for a contested case hearing if certain criteria are met.

The District 16 TRTA fall conference took place in Amarillo on October 18, 2018. Seventysix members of Canyon High School's choir sang a beautiful rendition of the Star Spangled Banner, and Caprock High's ROTC presented the colors.

Panhandle legislators addressed the group, noting several interesting facts. Representative Ken King of Canadian stated that the average tenure of a Texas teacher is only three years. Improvements such as more insurance choices and cost of living increases for retired teachers are needed to encourage young educators to continue in the profession. Representative John Smithee said that the rainy day fund should be utilized to help retirees, although it will also be needed in other areas such as hurricane and flood relief this year. Senator Kel Seliger emphasized his belief that the state and local school district should contribute equally to fund education instead of the current 37% state versus 63% local distribution. He stated that each district should be able choose the best way to approach school safety.

The average annuity of a retired school employee in Texas is \$2000 per month, with many retirees receiving less than \$1000 per month. Ninety five percent of retired educators do not receive Social Security payments. Subtract health insurance premiums, and there is very little annuity left for many retirees.

Current retirees' annuity is guaranteed for life, a plan called Defined Benefit. There is a move to change the plan to Defined Contribution, which would operate like a 401K, with no guarantees, and interest rates based on the individual's contribution only,
