Wildcat Track Team Takes First Place at Knox City

Kenneth Sellers Is High Point Man in Entire Meet

A record-shattering four-man relay team, with a substitute runner in both events, set new records in the sprint relay and the mile relay at Knox City Saturday and brought the tournament championship to the Crowell Wildcats.

Coach Scott Boyd's charges accumulated a total of 95 points in the 23-team meet. New Home was second with 76 and Rule third with 49.

The relay team members took first in the sprint relay with a 43.9 and repeated with a mile relay victory with a 3:27.8. Junior Urquizo ran his leg of the mile in 52.2, while his brother, Johnny Urquizo, substituting for the ailing George Evenson, turned in a credible 54.1. Mike Weathered ran his leg in 52.4, and Kenneth Sellers, the high-point man of the entire meet with 37 points, blistered the track with a 49.1.

Sellers also won the 100-yard dash in 10 flat; was first in broad jump with 19-11 and tied for second and third in the high jump with 5-8.

Weathered was third in the intermediate hurdles with a 41.6; Junior Urquizo was third in the 880 with a 204.8; Harry Lee Swan was fourth in the mile with a 4:55.9 and Jesse Barrera was second in the shot put with 49-1. Rocky Bachman was fourth in the discus with 115-11.

To Boswell Saturday Coach Scott Boyd said Monday that the track team will enter a meet at Boswell Saturday. Originally, the track team was slated to go to Jayton for a meet Saturday.

During the past three weeks, the CHS track team has brought home nine large trophies from track meets held in Vernon, Holiday and Knox City.

Social Security Increase Coming To Area Residents

First checks to include the new 10 per cent monthly benefit increase authorized in legislation acted upon last week by Congress will reach 26 million social security beneficiaries on June 3. Robert M. Ball, commissioner of social security, said that the regular June 3 checks covering benefits for the month of May will reflect the new higher monthly amount.

Separate checks, scheduled to reach beneficiaries later in June will cover the amount of the increase for the months of January through April.

Ball emphasized that social security beneficiaries do not need to get in touch with a social security office to get the checks. The payments will be mailed to beneficiaries automatically.

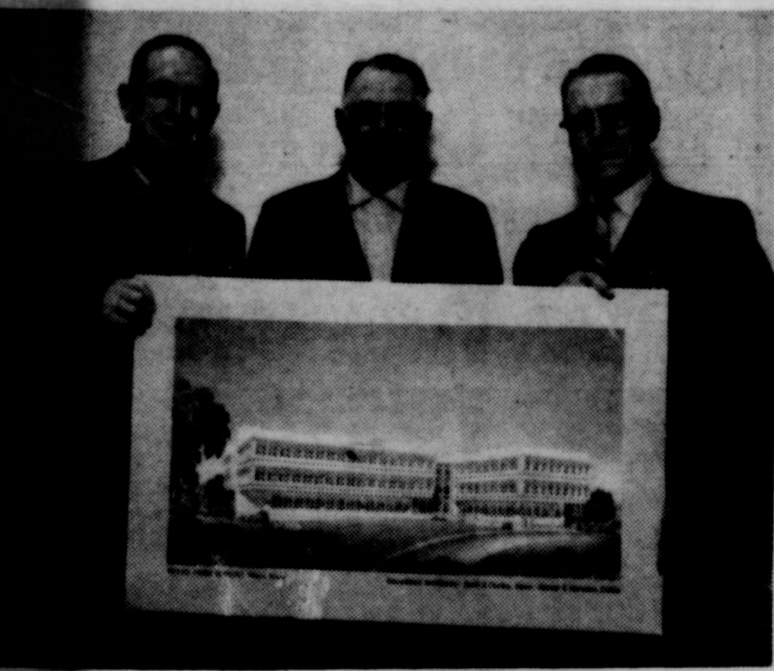
John Gillispie Attends Bible Conference in Dallas Last Week

Wheat Referendum and Producer Board Election

Being certified by the Commissioner of Agriculture of the State of Texas for this purpose, the Texas Wheat Producers Assn., Suite 600, Bank of the Southwest Bldg., Gray, Rillo, Texas 79109, proposes a referendum election on May 11, 1971 under provision of Article 55c, Vernon's Civil Statutes, on the proposition of whether or not wheat producers in a 34-county area of the State of Texas shall assess themselves a maximum amount of five mills per bushel to be collected at the point of first processing, handling or sale and to elect members for a 9-man Wheat Producers Board to administer proceeds of such assessment to be used for research, disease and insect control, education and promotion designed to encourage the production, marketing, and use of wheat. Rotarians Hear Annual Wheat Forecast Talk

Ray Brown predicted that Foard County will make about 275,000 bushels of wheat this year in his annual wheat predictions forecast at the Rotary Club meeting Wednesday of last week. When questioned about when a rain would be too late to help the crop, Mr. Brown cited 1966—the year of Foard County's 75th anniversary celebration—when a rain the day of the parade—April 28—helped make an "average" crop.

He said forecasts are that the nation will have about 2 billion bushels of wheat on hand after this year's harvest.

Glenn Jones Attends Farm Bureau Meeting

Several Farm Bureau programs activities, including plans for constructing a brand new state headquarters building, were discussed at a District 3 conference county Farm Bureau presidents held in Wichita Falls.

Glenn Jones, president of the Foard County Farm Bureau, presented the local county organization at the conference.

Construction on the four-story, temporary design building of approximately 100,000 square feet, is expected to start in the near future, Mr. Jones reports. A new headquarters for TFB will be located on a suburban site overlooking Lake Waco in north-west Waco.

"Front burner" matters discussed at the meeting included: state national legislative issues, program expansion activities, coordination of county and state Farm Bureau programs, responsibilities of county and state Farm Bureau leaders, and a financial report from the TFB.

Farm Bureau members in Texas center have been contributing toward the Martha Martin fund, through program membership dues, for the past 19 years. The membership at that time foresaw the need for a permanent home for the state Farm Bureau.

The total cost of constructing the new building, which will be located on 59 acres of land and called the Smith Building, is \$3.1 million. Low bidder for the building was Smith Building Co. of Waco. The architectural firm of Bush & Dudley of Waco, association with the firm of Merrill-Hamilton of Dallas, designed and planned the building. When the Texas Farm Bureau moved its headquarters to Waco

from Brownwood in 1938, it moved into a rent-free, two-room office over the Waco Chamber of Commerce. The Farm Bureau had a membership of only a few thousand farmers and ranchers at that time.

As the TFB grew, it changed locations in Waco three times, moving to its present location in the Citizens National Motor Ramp Bank building in June 1968.

The Texas Farm Bureau has 121,158 member families in 204 organized county groups.

March 31 Is Important Date for Some People 65 Years and Over

For some people who are age 65 and over, March 31 could be a very important day, stated Wayne Klipping, social security manager in Vernon. That date will mark the end of the current "general enrollment period" for Part "B" of Medicare or doctor bill insurance, as many people know it.

A general enrollment period, stated Klipping, provides many people who had previously refused or neglected to enroll with the opportunity to do so. Anyone who does enroll on or before March 31 will have Medicare Part B coverage effective with July 1 of this year.

The current enrollment period will be the last opportunity for those people born between Oct. 1, 1902, and Sept. 30, 1903, to enroll. If they do not enroll now, they will never be able to obtain this coverage.

People who wish to enroll or who wish additional information have only to write or phone the Vernon social security office at 1928 Fannin Street, phone 552-9346. An application to enroll for Medicare or whatever information a person needs will be quickly supplied.

U. S. Wheat "Plugged" in West Germany

A group of 80 German flour millers and grain traders were recently provided with a current report on the baking properties and blending values of U. S. wheats at a symposium sponsored by Great Plains Wheat, Inc. The meeting, held in Munich on Feb. 25, was aimed at gaining increased interest in U. S. wheats in the southern portion of West Germany, particularly among those millers who have not been using U. S. wheats in their grists.

Melvin G. Maier, European director of Great Plains Wheat, reported that the information was well received by the millers, some of whom came over 500 miles to attend, and that GPW would attempt to set up similar meetings in other parts of Germany and Europe in the future. The market development work of GPW is carried out in Europe in cooperation with the Foreign Agricultural Department of the USDA.

Of primary interest to the audience were the results of laboratory milling and baking tests on various blends of both U. S. spring and winter wheats with German wheat. The study showed that mixtures of 20 per cent U. S. wheat and 80 per cent domestic wheat resulted in near optimum milling and baking characteristics.

The two U. S. wheats used in the tests, Dark Northern Spring and Dark Hard Winter, were taken from recent cargoes arriving at European ports. The U. S. and German wheats tested were typical of what millers in South Germany are presently able to purchase.

The tests, conducted and presented by Sydow Laboratories in Munich, were typical of those conducted by U. S. laboratories on wheats and flours. Samples of the wheats, flours and bread baked from the mixtures were provided to the group for examination.

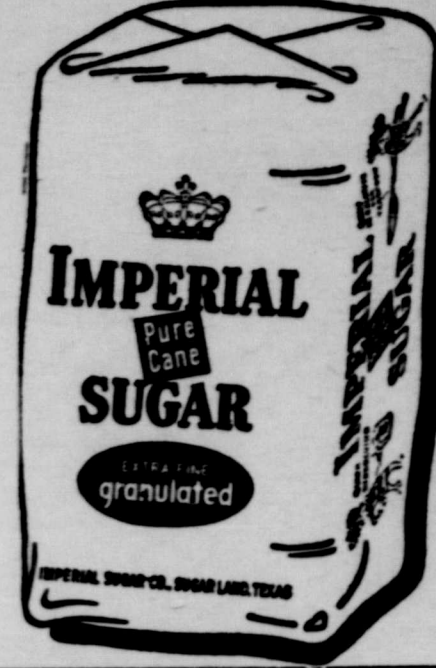

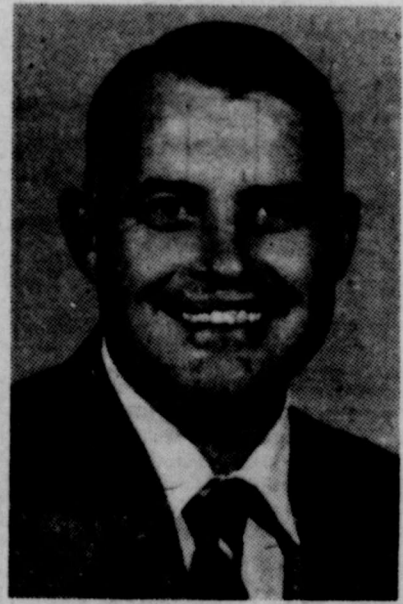

Austin, Tex.—Welfare beneficiaries late last week got the bad news they had been expecting—there will be substantial cuts in their assistance payments on May 1.

Level of aid will be reduced to Aid to Families with Dependent Children by about one-third, according to Welfare Commissioner Burton G. Hackney. Board of Public Welfare scheduled a meeting Monday (March 22) to place its inevitable approval on the reduction.

"The hard fact," said Hackney, "is that no more state money is available under the present constitutional ceiling on welfare expenditures. The Legislature has appropriated all that it can appropriate."

Average AFDC grant last month based on PWD's formula of 75 per cent of "budgeted needs," was \$118.

Hackney estimated the average level will drop on May 1 to about \$80 a month.

In addition to steep cuts, about 4,500 families will be dropped from the rolls altogether, since at the newly-contemplated 50 per cent level of "budgeted needs," they will no longer be eligible for aid. Their income will meet the "standard of need" PWD must recognize with the limited funds available.

As of last month, there were 87,616 Texas families with 263,809 children receiving AFDC benefits. Rolls for the last five months have been increasing at a rate of almost 11,500 a month, according

Texas Cattle Numbers Continue Up

For the sixth consecutive year, the number of cattle in Texas on January 1, 1971, was up, this time by three per cent. At the same time, the Texas Crop and Livestock Reporting Service released figures on the 1970 calf and lamb crops. For the first time since 1961, lamb and sheep numbers were up by two per cent. The calf crop was estimated at 5.4 million head in 1970. Texas cattle on feed on February 1 numbered 1.6 million head, 12 per cent above a year earlier.

A proposed constitutional amendment to increase the \$85 million a year ceiling on aid to aged, blind, disabled and AFDC will be voted on May 18.

Almost simultaneous with PWD's announcement of the cut (actually first predicted by Hackney last November 12), Texas Citizens for Welfare Reform announced start of its active campaign to win approval of the amendment (Proposition 3) on the May 18 ballot.

SENATE PASSES LIQUOR BILL—Senate voted 22-7 approval of the local option liquor-by-the-drink bill and sent it to the House.

Biggest battle in the Senate was whether retail package stores or wholesalers would sell to bar operators. Package stores won out over the protest of Sen. Joe Christie of El Paso, author of the bill (SB 346).

Measure now calls for \$2,500 license fees for mixed beverage licenses, with \$2,500 first renewal fees after one year, \$500 thereafter.

Bars would be able to serve drinks in one-ounce mini-bottles or standard size containers. Senators rejected by 16-13 a "dram shop" amendment to hold liquor dispensers liable for damages of their intoxicated customers.

Rep. L. DeWitt Hale of Corpus Christi said he will ask for a hearing next week and expects an early floor debate.

"I don't think there is any question but that we will pass a bill of some kind," said Hale. "The fight is not over final passage, but what's in the bill."

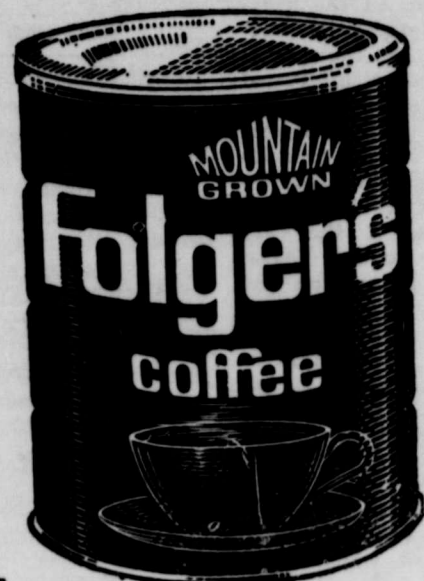
