

QCCADA Will Serve County From Judge's **Conference Room**

At 10:00 a.m., Thursday, April 13, 1995, the Kinney County Commissioners met to take up items from Monday's recessed session and items from a properly posted special

Commissioners Freddie Frerich, Joe Montalvo, Cordelia Mendeke, and Paul O'Rourke were present. Judge Tommy Seargeant presided.

Department heads and budget managers had previously been contacted with a request to present plans of intent as to how they could cut their remaining 1994-95 budget by 10% with cuts to become effective April 13. It was indicated that a cooperative response had been received.

Jeri Thompson, chairman of the Library Advisory Board, spoke for the county library and pledged conformity although all figures could not be compiled immediately. Sheriff Hooten was present and reported that he had been told to expect 10 federal prisoners within a few days although an earlier expectation of 13 did not materialize, he had also been told that the reason federal prisoners had not been sent to Kinney County was because prisoner slots had been available in federal prisons that had to be filled first. Rancher Stan Conoly and predator control officer Gary Lettauer expressed appreciation for the Trapping Club being included in county funding for predator control in over one million acres in Kinney County. In response to questions, Mr. Lettauer said that coyotes in the rabies vaccine drop zone were being collected for statistics, and that strain of rabies had not yet reached Kinney County although rabid foxes were of major concern in the im-

mediate area. Judge Seargeant reported that through Joy Ralston, local JTPA field specialist, an agreement had been reached that provided 1/2 of his secretary's salary through the JTPA "On Job Training" for six months.

A lone bid had been received for the purchase of two vehicles for the AANTF. Project manager Steve Woollen reviewed the bid and confirmed that the vehicles met all specifications and were slightly less than the projected costs. On a motion by Paul O'Rourke, seconded by Freddie Frerich, all four commissioners voted to award the bid to Graf & Barton at a combined cost of \$44,630.

Simon Sotelo, QCCADA (Quad County Council Alcohol Drug Abuse) related that the council was funded through the Texas Commission Alcohol and Drug Abuse, and their mission was identification/prevention/referral vices in Val Verde, Kinney, Maverick, and Edwards counties. All they were asking for was office space one day per week so they could see clients locally, and the appointment of two citizens to an advisory board. The judge offered the use of his conference room with the stipulation that it was already in use on the first Thursday of each month by the Veterans Service Officer. Frerich made the motion to make the judge's conference room available with the day to be announced. The second came from Mendeke and all four commissioners voted for the motion.

A discussion ensued concerning contract management services of county jails and juvenile detention centers. Various ideas were discussed but this was not an agenda item to be considered. Also possibilities of contracting with other counties and the state for housing overflow populations were discussed. Sheriff Hooten and the court listened attentively but noncommital.

Frerich moved to pay bills as presented, Montalvo seconded the motion which passed with all commissioners making the approval.

Kinney County again has two full time highway patrolmen. On April 1995, Kinney County native Richard Slubar joined Robert Cano at the Brackettville office of the Texas Department of Public Safety.

The son of Rose Mary and Dennis Slubar, Richard graduated from Brackett High School in 1981. While working with his father at Slubar Insurance Agency, Richard was invited by Mr. Cano to ride with him on patrol. After several such excursions, Cano offered Slubar an apapplication for the highway patrol. That was about eight years ago.

Slubar applied, was accepted, attended the Academy (finest in the tion) at Austin sa through the rigorous routine of IQ testing, reading comprehension, physical training, extensive back ground checks, and oral interviews at the academy. He was then assigned to the Eagle Lake area where for seven years he patroled Interstate 10 east

He requested a transfer to Brackettville which had had a vacancy off and on since Buddy Burgess retired last year.

During the seven years Slubar was stationed at Eagle Lake, he met and married lovely Mindy, a native of El Campo. They are proud to be at this duty station even though they are still in the house hunting process

Slubar is friendly, outgoing, confident, physically fit, and has a delightful sense of humor. In casual conversation he recalls numerous incidents while going through the Academy and at his previous location. One incident he recalled with a grin was of having stopped a car at about 12:30 one day near Columbus for a minor traffic violation and an small, intoxicated 62-year old man "piled out swinging his fists." Now, he can laugh at how motorists stared as the scuffling duo as they sped by without stopping to

From his school days at Brackett, he said he used to play at Bud Breen's house and would peer over Bud's shoulder as he painted. His oft repeated question was, "What is that going to be?" Bud would just keeping painting and patiently reply, "I don't know, I haven't decided yet."

On a serious note, Slubar said that although he worked solo most of the time, he was completely confident of his own training, experience, and skills and he knew that any time he needed assistance, it would come from the local border patrol, the sheriff's department, and other highway patrol units.


He related that Kinney County had 200 lane miles of state highway and he, with his ten employees in Kinney County, were responsible for maintenance as well as a number of other public safety and transportion concerns. Widening two miles of Highway 334 is scheduled to begin in the near future. He discussed and distributed brochures with at least two needing mention: following an accident, if a vehicle could create a hazard and can be moved; and another very important one deals with child restraint (while passengers in moving vehicles) laws. He also distributed Texas Highway Department maps (the best map of Texas printed), and bumper stickers pertaining to seat belt use.

Mr. Hernandez stated that the state, too, was facing budget cuts and he expected more and more services to be contracted out.

Mr. Hernandez is another example of outstanding leadership Kin-County blessed with...knowledgable, presentable, proud of his profession, secure in the fact that he is doing his job well, and willing to share information with the community.

Sheriff's Corner

Kinney County is currently experiencing a very serious financial crisis caused by many factors, though the two primary causes are being attributed, rightfully so, to a decrease in income from two primary sources of cash flow income to the county: DPS Highway Patrol traffic citations and federal prisoner care income through the county jail.

Due to the financial crisis the County Commissioners, County Judge, and the various department heads have been meeting in Special Meetings in an attempt to address the serious issue and come up with ideas to help get us through this dark time. The Commissioners Court has asked the various department heads to make voluntary 10% cuts in existing departmental budget balances to help cut expenses and this has been done. This is, of course, only a temporary "band-aid" and does not address the overall problem.

County Judge Tommy Seargeant has been working closely with this writer in attempts to obtain commitments from the U.S. Bureau of Prisons and the U.S. Marshal's Service to enhance the federal prisoner numbers at the county jail. They have promised to try and do all they can to increase our federal prisoner numbers. The problem is that BOP must fill up their own prison facilities first before they are authorized to start using county jail facilities for large numbers of federal prisoners. Many other counties throughout Texas that have come to depend too much on federal prisoner care revenue as we have are experiencing the same financial crunches.

Judge Seargeant and I have also met on several occasions to discuss

other avenues and possibilities of obtaining paying prisoners from other sources such as prisoners from other counties that have an overflow and/or state prisoners. To date no solid decision has been made, however, the Bureau of Prisons has recently designated eight federal prisoners to the Kinney County Jail which will give us a total of ten. At \$35.00 per man-day this will give us monthly income of some \$10,500.00, about half our usual income when things are normal. But this will help and every effort is being made by the Commissioners Court and the various elected officials/department heads to some-

how survive this current financial crisis without having to lay off employees and/or cut services to people Hopefully, by working together in the spirit of mutual cooperation this can and will be accomplished. The Commissioners Court and County Judge Seargeant are to be commended on their efforts during these hard times. They are doing their best to hold things together until we pass through this crisis.

In the meantime, the Sheriff's Department is going about business as usual and we have been kept busy on patrol and responding to various calls for assistance from the people of Kinney County. A few of those calls are listed herein as representative of the numerious and similar calls we respond to.

WEDNESDAY, April 12th - 6:00 p.m. - A call received by S.O. dispatcher about four illegal aliens in Spofford. Local Border Patrol contacted and dispatched to scene.

WEDNESDAY, April 12th - 7:42 p.m. - S.O. dispatcher contacted by a local tavern bartender about an

unruly patron. Patrol Deputy Chism dispatched to scene and the problem taken care of. No charges filed.

THURSDAY, April 13th - 1:19 a.m. Local housewife contacted S.O. dispatcher about prowlers at rear of her home. Patrol Deputy Chism contacted and dispatched to scene, arriving at 1:24 a.m., response time 5 minutes. Prowlers contacted and identified, due to their being juveniles were sent home with admonitions. No charges filed.

THURSDAY, April 13th - 6:30 p.m. Local resident contacted S.O. dispatcher by mobile phone to report loose cattle on roadway south of Spofford. S.O. dispatcher contacted owner of cattle and the cattle were removed from the roadway and put back in a pasture.

THURSDAY, April 13th - 1:00 p.m. Local rancher contacted S.O. dispatcher to report that two illegal aliens had been passing through his land and that one of them, a female, had fallen and injured her leg, possibly broken. He advised the S.O. to contact the Border Patrol and advise them that he was transporting the pair to the hospital in Uvalde. Border Patrol so advised.

THURSDAY, April 13 - 1:30 p.m. -A local resident called the S.O. dispatcher to report a swarm of bees at her residence. Attempts to contact local beekeepers were negative. The bees finally left the residene with no harm to anyone.

THURSDAY, April 13 - 4:46 p.m. -Local homeowner contacted the S.O. dispatcher to report a burglary at her residence had occurred while she was out of town. Several items of personal property were taken, no sign of forced entry. The case is currently under investigation.

THURSDAY, April 13th - 6:53 p.m. - S.O. dispatcher contacted by Spofford resident who reported a brush fire on Hwy. 1572 approximately 3 miles east of Spofford. Fire Department contacted and dispatched to scene and the fire was put out.

SATURDAY, April 15th - 9:08 p.m. - Local resident called the S.O. to report that his son was drunk and disorderly and threatening to burn the house down. He requested an officer at the scene. Chief Deputy Fritter responded to the call situation was resolved with no charges filed.

SUNDAY, April 16th - 3:04 a.m. - A local resident called the S.O. to report a one car rollover on Hwy. 90 approximately two miles west of Brackettville. Patrol Deputy Chism responded to the scene of the accident at 3:10 a.m. No serious injuries though the female driver of the vehicle was later transported to Val Verde Hospital for a check-up. She had dodged a deer on the road and overcompensated and the car went off the roadway on the wrong side of the road, then back onto the highway, overturning and sliding across the highway on its side. When going into the bar ditch the car righted itself and ended up back on its wheels. Quite a wild ride for the driver. No charges filed.

SUNDAY, April 16th - 1:14 p.m. - A Uvalde woman called the Kinney County S.O. to report a domestic dispute with her husband earlier that morning in which she had been assaulted by her husband. She did not want to file any charges but just wanted to report the incident so that there would be a record of it. HUM!

MONDAY, April 17th - 9:52 a.m. -Nutrition Center Director Tencha Pena called the S.O. to report the theft of four hubcaps from one of the Nutrition Center vans the night before. The case is under investigation.

Wind Dance





KUMQUAT MARMALADE 3 quarts water

2 cups thinly sliced kumquats 11/2 sliced orange peel 11/2 cups chopped orange pulp 1/3 cup lemon juice Sugar, about 9 cups

Add water to fruit; cover and let stand in a cool place overnight. Bring to boiling and cook until peel is tender. To each cup of fruit mixture, add 1 cup sugar. Stir until sugar is dissolved. Cook rapidly to jellying point, about 45 minutes. occasionally to prevent sticking. Pour boiling hot into jars, and process 10 minutes. Yield: about 8 half pints.

POMEGRANTE JELLY 4 cups pomegranate juice

(1 large pomegranate gives between 1/3 and 1/2 cup juice) 1 bottle liquid pectin

Shell out juice filled sacs. Crush and press to remove juice. Strain into non-metal container through double thickness of white cloth.

Measure juice into kettle. Stir in sugar. Place on high heat and stir constantly. Bring quickly to a full rolling boil that cannot be stirred down. Add the pectin and heat again to full rolling boil. Boil hard for 1 ? minute.

Remove from heat; skim off foam quickly. Pour jelly immediately into ? hot jars and seal. Yield: 11 or 12 sixounce glasses.

CACTUS FRUIT JELLY 31/4 cups juice from cooked fruit Juice of 2 lemons 1 bottle liquid pectin 8 level cups sugar

Remove fine thorns and blossom ends from 3 pounds of ripe cactus fruit. Cut into small pieces, crush and add 1 cup water. Stir until boiling, cover pan and simmer 10 minutes. Place in cheese cloth bag and squeeze out juice.

Measure sugar into a separate must lie in water for 12 hours. Stew pan. Bring juice and pectin just to the fruit in water to cover until tenboil, stirring constantly, and begin to add sugar slowly with constant stirring, taking about 5 minutes to add sugar, and keeping juice nearly at a boil. Then bring to a rolling boil and boil 1/2 minute. Remove from fire, let stand a few minutes, skim, pour quickly into jars and seal hot.

> MESQUITE BEAN JELLY 4 cups bean juice

4 cups sugar 1 pkg Sure-Jell

Pick a handful of ripe mesquite beans. Wash them and put in a pot. Cover with water; bring to a boil. Boil about 15 to 20 minutes. Let cool and strain through a clean cloth. Put 4 cups of juice in a clean pot. Add 1 pkg. of Sure-Jell and bring to a boil. Boil for 1 minute. Add 4 cups of sugar, bring to a boil. boil 1 minute. Pour in jars and seal while hot.

PYRACANTHA JELLY

Place 7 cups washed pyracantha berries in a very large pan with 5 cups of water. Simmer, uncovered, for 20 minutes. Strain through a cloth.

Measure 3 cups of berry juice, ½ cup lemon juice and 7 cups sugar into a very large pan. Over high heat, bring to a boil, stirring constantly. Immediately stir in one bottle liquid pectin. Bring to a full rolling boil for minute, stirring constantly. Remove from heat, skim off foam and pour into sterilized glasses. Cover with 1/8 inch melted paraffin. (Prepared berry juice may be refrigerated or frozen prior to making jelly)

LOQUAT JELLY

Wash loquats and remove seeds. Place in saucepan and add enough 5 water to barely cover fruit. Cook gently for 10 to 15 minutes, then strain through jelly bag or four layers of cheese cloth. (For greater yield of juice, twist the two ends of the bag in opposite directions until most of the juice is extracted. Then, strain through clean cheese cloth or jelly bag, but do not squeeze or

Francis Henry French was born n Fort Wayne, Indiana on September 27, 1857. Deeply impressed from his youth by the stirring deeds and stories told by veterans of the Civil War, he realized his ambition for a military career by entering the United States Military Academy at West Point, New York where he graduated twelfth from the Class of 1879. He was assigned as 2nd Lieut of "E" Company 19th Infantry and came West. Following service at Fort Garland, Colorado Territory and Fort Leavenworth, Kansas, the regiment moved to Fort Brown at Brownsville, Texas where Lt French was detailed as the Regimental Adjutant. In December of 1882 the 19th Infantry was posted to Fort Clark.

At Fort Clark, on January 1, 1883, Lt French began diaries which he faithfully maintained for the next thirty years.

April 1883: Lt French enters his third month in camp, as commander of the Seminole Scouts, at Mayer's Spring (now Meyer's Spring) on the newly completed Southern Pacific Railroad, near present day Dryden. He improves his accommodations by building a frame for his tents; feels the Scouts are being unjustly treated by being kept out in camp so long; participates in a "senseless indian scare;" and by the end of the month is relieved by a troop of cavalry. He starts the journey back to Fort Clark where he "...shall have to obey others. But there will be pleasant society there which will more than make up for a little brief authority."

Thursday, April 19, 1883

Went to the house this morning and after waiting there a half hour or so, young Ramsey came up driving some horses, the missing horse being one of them. So the Indians did not take him. He went with Corp'l. Perryman up the Pecos for the wounded pony and I returned to camp and sent the men out to hunt for signs. About one o'clock Corp'l. P. came in and said the pony was at the house. Went to the house, saw the pony and ate dinner there. The pony was fat and had a cut six in. long on left rump made by sharp instrument. If Indians did it, it is strange that they did not kill him & eat him or put him in some place where he would not be found. Returned to camp, and had things packed. The men came in soon afterwards and reported no signs. About 2-30 or 3 o'clock, moved camp six or seven miles up Independence Creek. Corp'l. Perryman went up the creek to where the pony had been found, hunting in the bottoms along the creek but could find no signs. Other men went out hunting but no signs were found. Feel confident that no Indians are in the country. Shall return to Mayers Spring out a hunting party to let them hunt for game and see if they can find

any indications of Indians.

Common-Sense Ideas For The **Environmental Protection** Agency

Last week, the National Academy of Public Administration (NAPA) completed an 18-month study of the Environmental Protection Agency. Commissioned by the House and Senate Appropriations committees, the 200-page report revealed a startling recommendation: the EPA could solve many of its problems by transferring more authority to states, local governments, and corporations.


What an astounding revelation! That sounds like common sense to us, yet it takes a year-and-a-halflong study for the government to conclude that if you return more power to people at the local level, things work better.

Here are some of the other problems cited by the report: too much congressional oversight, too many narrow and fragmented environmental regulations and a tendency for EPA staff members to get bogged down in bureaucratic procedures.

The EPA is in need of a top-tobottom overhaul. It is one of the most unpopular government agen-

cies because of its search-anddestroy approach to problem solving. Instead of working with companies and communities to find a suitable way to preserve our surroundings, it has treated businesses and cities like the enemy, destroying jobs and people's livelihoods in the wake of its bureaucratic zeal.

The report suggested that the EPA should give more authority for fighting pollution to states and localities and allow states and private enterprises to devise their own ways to reduce pollution. It also says the EPA should figure out the risks and costs of its actions beforehand, as well as merge its ©1994 THE VINTON TRUST

Friday. April 20, 1883

Reached Camp about 4-30 P.M. after a dull ride and was very glad to get back. Made arrangements to start out 9 men under Sgt. Gordon with 5 days' rations to Independence tomorrow, and down the Pecos to Fielders & then to camp. Found two letters from home, one from Cunningham, Capt. Vance & some official mail. Was quite tired tonight and retired early.

Saturday. April 21, 1883

Started the men off for Independence Creek giving the Sergeant strict orders to send a courier to me immediately if he found any signs. Feel certain he will do his best as he is a thoroughly reliable man. Started to write my report but did not copy it in the book today. It is such a long time since I have written any that I am out of the mood entirely for it. Harvey's back is healing splendidly. In two or three weeks more the hair will commence to appear on the wound. Rode over to Thurston in the afternoon with the Doctor & found McCarthy and Young there. Saw McGeary when the train came along. McCarthy telegraphed to Langtry and told me that Randlett was still there, waiting for a company to relieve him. In the evening copied the report and wrote some official letters but felt too tired to do much. Went to bed

Sunday. April 22, 1883

Wrote a letter home this morning. The couriers came in about one o'clock bringing me a letter from Gen'l Smith saying that "E" Troop would relieve the Seminoles by the end of the month. This Troop was out on the Nueces but was ordered in when the letter was written, the 18th, and ought to be out here in a week or so. Carried the letters over to the railroad, saw Mc-Carthy, Young & Smith there, and Rodgers the conductor. In the evening read papers from home. Must commence to prepare to be

Tuesday. April 24, 1883

The Doctor went up to Sanderson but returned without getting any vegetables as the man who kept the store there has left. This will make it rather rough on the company that is coming out here. The Doctor brought a telegram from Hall sent yesterday saying that "E" Troop would leave Clark today. It ought to be here next Monday. Wrote a letter to Guard to collect \$5 from Murphy for me, one to N.Y. to enquire about the check I sent over a month ago for some socks, and made out my pay accounts. Shall send all tomorrow.

Wednesday. April. 25, 1883

Wrote my usual letter home today. In the afternoon Doctor & I rode over to Thurston. Saw Mr. Tracy there. McGeary was conductor of the train and saw him. Sent letter with my pay accounts asking to have the checks sent to Clark instead of out here. Had tank cleaned out near the springs today. "E" Troop ought to camp at Devil's River today. Ruled some red lines in the Muster Rolls and prepared them for filling out at the proper time. Sgt. Gordon and party returned this evening and report no stock missing and no signs of Indians. This report makes me feel much easier for I was afraid that I had been too hasty when I was over in the Pecos Valley. Besides I have been disappointed before when I expected to go into a Post from detached service and dreaded a report of Indians for

then we would have to go out for a campaign. Our rations are nearly exhausted, so that we cannot make much of a campaign without a new stock. I have not sent in for more as I dont want to carry any unnecessary weight back to the Post.

Thursday April 26, 1883

Wrote a report of Sgt. Gordon's scout and then rode over to the railroad in time to meet the morning train and see Conductor Roberts. Made out my first muster roll for this muster today, but shall wait until later in the month to make out the others. The two Ramseys and Stone came over from the Pecos today, Stone and young Ramsey on their way to Uvalde, & the elder Ramsey going to Del Rio. It has been quite warm today, but I found it comfortable under the shade between the two tents. Read a light novel called "Allerton Towers" by Annie Thomas. It does well enough to pass the time, but is not much of a book. Read a little law in the

Texas Senate Action

Senator Bill Sims of Paint Rock returned to the Senate after recovering for several weeks from a stroke suffered last January. Sims was greeted with a round of applause when his name was called during the roll call to establish a quorum He was also greeted in the Texas House with applause. Sims serves as Chairman of the Senate Natural Resources Committee.

The Senate passed Committee Substitute Senate Bill (CSSB) 115 and CSSB 117 sponsored by Senator Chris Harris of Arlington which will deny licenses for persons who do not meet child support obligations. CSSB 115 authorizes the Attorney General and the Texas Dept. of Public Safety to deny or suspend the license of a person who is delinquent in payment of child support. CSSB 117 establishes a procedure for revocation of a state professional license of a person who is 30 days or more delinquent in payment of child

The Senate passed SB 337 sponsored by Senator Judith Zaffirini of Laredo which requires the use of protective bicycle helmets by individuals younger than 18 years of

law for failure to comply.

There are no penalties in the

SB 294 sponsored by Senator Mike Moncrief of Fort Worth passed which defines "criminal street gangs" and includes gang members in penalties for conspiracy. Under the current version of the Organized Crime Statue, collaboration between three or more persons must be proved. This legislation allows prosecution if one or two people are involved if evidence shows an offense is gang related.

The Senate passed CSSB 130 sponsored by Senator Royce West of Dallas which creates the offense of transferring a handgun to a person who is the subject of a protective order. The bill is an attempt to help victims of domestic violence with protective orders against their abusers.

The Senate passed CSSB 1298 and CSSB 1229 sponsored by Senator David Cain of Dallas which relates to the transfer of higher education institutions in Texas. CSSB 1298 transfers Baylor College of Dentistry to the Texas A&M University System. CSSB 1299 abolishes the Board of Regents of East Texas State University and transfers East Texas State University and East Texas State University at Texarkana to the Texas A&M

Pinkeye is a common, contagious childhood ailment

Question: My son's preschool teacher sent home a note saying there were several cases of conjunctivitis in the classroom. How can I tell if my son has contracted the disease?

Answer: Conjunctivitis (also is known as pinkeye) is common among children and extremely contagious. In fact, conjunctivitis can spread through an entire classroom of children in a matter of days, making its way home to infect entire households.

The symptoms of this disease are fairly easy to detect. The whites of the eyes become pink or red, and the eye feels gritty when blinked. The eye also produces a yellowish discharge that forms a crust during the night. This sticky crust can seal the eyes shut and you may have to pry the lids gently apart or soak off the crusts in the morning. There also can be blurred vision and a sensitivity to light.

The irritating but usually harmless condition results from an inflammation of the transparent membrane that lines the eyelids and a portion of the eyeball. It is caused by a viral or bacterial infection, or by an allergic reac-

Because it is so contagious,

pinkeye must be diagnosed and treated early. Visit a physician as soon as the signs of the disease appear. Your physician may prescribe antibiotic eye drops if the infection is bacterial; viral conjunctivitis disappears on its

Good hygiene is the most useful method for controlling pinkeye. Once it has been diagnosed, the following steps may be useful to help keep others from contracting the problem:

- Keep hands away from the Wash hands frequently.
- Change the towel and wash cloth each day, and don't share with other people.
- Change the pillowcase each night.
- Don't share eye cosmetics. Throw away eye cosmetics, particularly mascara, after a

few months.

Congress Working to Restore The American Dream

ast fall I pledged to help put an end to "business as usual" in Washington. I'm here to report that political "business" has been anything but "usual" for more than three months now, and things have

The 104th Congress got off to a fast start, and proceeded at the same breath-taking pace. Less than three weeks into the New Year, Congress had passed and the President had signed one of many measures designed to restore the American people's confidence in their government: the Congressional Accountability Act, which requires Congress to live under the same laws it imposes on everyone else. Congress has stopped telling the American people, "Do as we say, not as we do." The new approach has to be, "If it's good for you, it's good for us as well."

Also signed into law is a landmark measure that changes Congress' approach to individuals and state and local governments, the Unfunded Mandates Reform Act. This legislation requires Congress to pay for any new federal programs it mandates for state or local governments. Congress and federal agencies must now calculate the costs of federal laws, mandates and regulations they impose on the private sector.

As one strategy among several to bring the federal budget deficit under control, both houses of Congress have voted to grant the President a line item veto. The measure gives the occupant of that office - regardless of political party — the ability to strike out wasteful spending in appropriations bills without vetoing an entire measure. This is the same tool that 43 state governors now use, effectively, to balance their state budgets.

Congress has also voted to restore, enhance and make permanent an important tax break for more than 3 million self-employed persons. These individuals will again be allowed to deduct the cost of their health insurance premiums, giving them, in effect, equity with those whose insurance is supplied by their employers. The president signed this measure into

In the critical area of regulatory reform, I am happy to report that the Senate passed and a Senate-House conference committee left intact an amendment I introduced last month that will have the effect of suspending any further designations under the Endangered Species Act until the end of this fiscal year, September 30. This measure will give Congress some breathing room during which we can go back and amend the act itself to take into account the economic and social impacts of its administration.

The Senate took another important step toward curbing regulatory excess by creating a 45-day window during which Congress may review and veto proposed federal regulations. The House has not yet passed this measure, but I hope it will.

Much remains on our agenda to get the country back on course: We must balance the federal budget and begin to lower the national debt. We have to implement real criminal justice reform in order to take back our streets and make them safe for all Americans. We must work to restore America's competitive edge, and keep our standard of living among the highest in the world. We are on our way to restoring the American dream. The voices of the people are being heard in Washington, D.C. What a nice change!





Home Rule School Districts

A Bad Idea

By RICHARD KOURI, President **Texas State Teachers Association** The concept of home rule school districts is one of the most dangerous ideas to be introduced into this legislative session. Masquerading as local control, it is in fact a dirty little plot to rob children of educational opportunities

and to punish Texas teachers. Home rule advocates advance the peculiar idea that schools will be somehow better if their governing boards are free of all state standards. Never mind that the standards that are in place have been responsible for demonstrable improvement in student achievement over the past several years.

Home rule advocates want local school boards to be free to increase class size in elementary grades, to hire uncertified teachers, to ignore the state required curriculum, to eject children from school and to fire teachers without cause, to do anything they want with our children's education.

Home rule is like a drive-by shooting that indiscriminately mows down every positive education reform that's been enacted over the past several years. It's little wonder that this untested idea has not been seriously proposed, much less adopted, in any other state.

Since home rule advocates are careful to mask their arguments in local control rhetoric, often talking about empowering parents and teachers, well-intentioned people are often misled. Advocates argue that home rule will get rid of bureaucratic red tape that stands in the way of innovative local programs. On close examination these arguments don't hold up.

First, home rule does not empower parents and teachers. The real benefactor of home rule, the group that stands to gain tremenpower, is the Texas dous Association of School Boards that writes the cookbook of recommended school board policy which is adopted verbatim by almost every to win in life. This played golf realize that it's the next truth can be easily tested by pulling 20 or so local school board policy manuals from across the state and noting the similarity from district to

district. TASB has a history of opposing the reforms that have led to recent improvements in education. TASB opposed class size limits; they opposed site-based decision making to involve community and teachers in campus and district decisions; they opposed every single teacher salary increase that has been introduced; they opposed five days of sick leave for support personnel like aides and bus drivers; they even opposed the pre-kindergarten program. This group and the local school boards they represent over whose objection every important standard and employee benefit has been won will now be put in charge under home rule. Is there something wrong with this picture?

Second, although advocates argue that state standards are restrictive, no one has yet come forward to claim that they had a really innovative idea for an educational program that would have benefited children that couldn't be implemented because of state law or rule. Texas already has a very liberal waiver process. This movement is not motivated by a desire to make schools better. It is a mean-spirited concept that is fueled by the desire to save money.

Texas voters have already turned down home rule in one of its disguises quite recently. Constitutional Amendment 2 on the May 1, 1993, ballot called for local school disticts to be free of state standards that were not fully funded by the state. The voters said no.

The Constitution of the state of Texas charges the state with the responsibility to provide free public schools. The state cannot relieve itself of the constitutional responsibility by handing it off to local school boards. Thus, the question really boils down to this. Who should set minimum standards for Texas schools, the Texas Legislature or the Texas Association of School Boards? Our choice is the Legislature.



Silver Anniversary For Archbishop Flores

On April 21, 1995, an area comprised of 16 parishes and 29 Catholic communities will observe the Silver Anniversary of the ordination of Archbishop Patrick F. Flores as auxiliary bishop for the San Antonio Archdiocese. Brackettville is part of this area. This anniversary is the latest milestone in the distinguished life of service of Archbishop Flores.

The first Mexican-American bishop in the United States, he was elevated to the post of archbishop in October 1979. As pastoral leader, his life has been one of courage and inspiration. After graduating from St. Mary's Seminary in LaPorte, Texas, in 1956, he became a champion for social justice from Houston to San Antonio and in El Paso as bishop.

He has been in charge of the Cursillo Movement in Texas. He founded the Office of Catholic Services for Immigrants and supported the founding of COPS.

He has been held hostage in Ecuador and named in "Time Magazine" in "200 Rising Leaders"

on July 15, 1974.

After being consecrated Fourth Archbishop of San Antonio in 1979, Flores was appointed president of Bishop's Committee for Latin America in 1985 and has visited Cuba twice.

As spiritual head of an archdiocese numbering 125,000 households, Archbishop Flores maintains an energetic and full schedule. He maintains a high profile in the community and has been the subject of the book "Mariachi Bishop."

His list of accomplishments are numerous, but the ones which gratify him most are those that enhance the quality of people's lives. He has supported and promoted, among others, women's rights and educational opportunities for minorities.

Tribute will be paid to Archbishop Flores and the public is invited to be a part of this memorable event. A special mass will be held in Uvalde, Texas, 7:00 p.m., April 21. 1995, at Sacred Heart Church.
