# HOW TO BUILD A SILO.

Interpreter.

To the inquiry of a gentleman who wishes information how to build and of what dimensions will be required for a silo sufficient to feed sixteen or eighteen cows, Mr. John Gould, the best authority in America, thus answers:

"You will want a silo about 16x 20, by 18 feet deep, holding something over 100 tons, and will furnish a 50-pound per day ration for 18 cows for over 200 days. I know of no reason why the silo should be double where 18 or 20 head of cattle are to be fed twice a day for the winter. If you build out doors and want a cheap silo, I would build all of wood and make a roof over it of cheap material that wo'ld shed the rain and keep out storms. You can use cheap hemlock lumber, sound and free from shakes, and the silage will keep just as well as if made of forty-dollar lumber 1 would plant some 10x10 inch sills in the soil where I wanted the silo and make the foundation secure against water in any way you think would be effectual. Dig : trench just the size of the sills, and after painting them well. and the joints with gas tar, put them in place and pack the earth tight about them. Put your 2x8 inch studding in place 48 inches apart from center to center. Toe-nail them on the sills with 20d-wire nail. Line up up the inside with the inch hemlock lumber, put on horizontally. Then mix gas tar and gasoline, two parts and one part gasoline, and paint the studding and boards, both sides, up three or four feet. Paper the inside of the silo saturated tar paper, put it on up and down, with a good two inch lap, ceil up again on the inside withe another layer of inch lumber put on so that the crack of the inner layer will center the first course the first course of boards. Then paint the inside with a good coat of this same paint. Make it a little thinner, so it will run into all cracks, and tighten all knots. "For the floor, draw the clay from the center of the pit up against the sides, so that it will be at least eight inches above the sills and pound it down hard. It is best to have the lumber single surfaced, so as to make a smooth wall. Tie the tops of the studding together so as to prevent spreading, and put on any kind of a roof that will keep out rain and melting snow. should build a square silo. I think vou will be well pleased. 
painted with gas tar. There is no evidence that a good board, filled with gas tar, is not as durable as lath and plaster, and far lessl iable to crack, if the frame should spring in filling. Whether a \$10per M board is more or less expensive than a lath and plaster wail. I would not use any matched lumber in a silo. When the lumber has fairly true edges, and is put on with a half lap, with tarred paper between and well nailed, the walls are absolutely air proof, nor will the paper rot between the boards."

Cerrilloc and White Oaks Attracting the Union Pacific's Attention -Long' Canon Line.

COAL AND RINES AL.

Here is a very significant paragraph from the Trinidad Advertiser which came to hand this morning:

"It has been learned from a most reliable source that a party of Union Pacific surveyors who left Trinidad early last spring have just returned from Chihuahua, Mexico, where they had lately finished a preliminary survey for the read running from the Long Canon extension, through to Chihuahua. The line touches Las Vegas and runs thro' the White Oaks mining district, a section of southeastern East New Mexico with mineral possibilities exceeding any other portion of the territory. That the new line will be pushed through immediately is not likely, but that it will be built eventually is a cortainty. The company has spent too much money on their Long's Canon branch not to complete it through to a section from which it would draw its greatest revenue." Thus at last the secret back of the Uuion Pacific operations toward the southwest in Colfax county seems to have leaked out. It has long been known that there was a big scheme involved in the Union Pacific company's invasion of the A. T. & S. F. territory, but just what that scheme was has until now been kept very quiet. The Cerrillos mineral and anthracite coal fields and the splendid undeveloped resources about White Oaks, together with the inviting tield which northern Chihuahua, offers are responsible for this movement. New Mexico, and especially that portion lying between Santa Fe and White Oaks, has much to hope for as the out-come of the above quoted statements.





The Congressional apportionment bill recently introduced has called attention to a very important and interesting subject-the number of members of the House of Representatives. It would be expecting too much of poor depraved human nature to ever indulge in the hope that this question will be considered by the present House without reference to party politics. It has been the custom, since the first census, and consequent apportionment, for the party in power to get all possible advantage out of the apportionment, and so it will probably be to the end of the chapter. To the student of our form government the apportionment tables from 1790 to 1880 make a very interesting study. In 1790 each member of the House represented 33,900 people, and in 1880 151,912 people, and if the new bill becomes a law he will represent 180,000 people. Many of the States have a smaller number of Representatives now than they had in 1790. For instance, Virginia had 19 where now she has only 10; Connecticut had 7 while she now has only 4; Maine had 7, but now she has just 4; Massachusetts had 17 while now she has to content herself with 12; New Hampshire had 4, and now has 1: Delaware started with one and still has one, though for the ten years between 1810 and 1820 she had two; Rhode Island started with 2 and has always had the same number. Mr. Dunnells' bill will make the membership of the House 324, which is about twice as large as it ought to be. From the Albuquerque Democrat. 

#### DEMOCRATIC PLATFORM.

We, the Democratic party of the Territory of New Mexico, in convention assembled, reaffirm our allegiance to the time-honored principles of the National Democratic party as enunciat-ed in the platform adopted at St. Louis in 1888,

We demand the free coinage of silver.

We arraign the National Republican party for squandering the surplus revenues in the treasury in order to furnish a pretext for increasing tariff taxation on the necessaries of life -for depriving Democratic constituencies of their representatives in Congress (and arbitrarily seating republican candidates who were not elected by the people-for adopting an arbitrary and unconstational system of rules in the House of Representatives and thereby suppressing the rights of the minority—and for attempting to pass the Lodge election bill to suppress free elections and subvert the rights of the states, in utter disregard of the Constitution of the Umited Stutes—and practically for having award-ed seats in the Senate of the United States to two Senators from the state of Montana, who were not lawfully elected thereto.

As heretofore, we reiterate, that the General Government has been and still is, heedleas of the rights of New Mexico and its onligations un-der the treaty of Guadalogpe Hidalgo in failing and refusing to pass such a law as will se-cure the prompt and speedy settlement of land titles in New Mexico,

We declare that the native population of New Mexico are entitled to the lands held by them or their predecessors under the laws of the Re-public of Mexico, and that their rights thereto is out the respected a should be respected.

We endorse the course of Hon. Antonio Joseph, our delegate in Congress as a zoalous and faithful public servant, at all times tireless in his efforts in behalf of the people of New Mexi-co, and heartily command him for re election.

We denounce the action of L. Bradford Prince Governor of New Mexico in requesting the quartering of United States troops in the coun jy of San Miguel to overawe the people under the pretext of resistance to the civil authority. when no process was in the hands of the officers of the law unreserved. as in keeping with the spirit of contempt for the civil authorities usu-nety reserved by the Republican party. We arraign the Republican party of New Mex.





#### INTERPES-THEE

Arrest on a telegram has jus come up before a Chicago court which held it to be illegal-as probably every lawyer would unhesitatingly decide. Two years ago Secretary Bayard formally declined to make such an arrest on a cabled request from Belgium, and the proposal was made that a convention arranging for arrests on telegraphic requests be negociated. In this praying that the respective rights of country it is probable but not certain that legislation would be neccessary to render legal an arrest under such a convention. For years past our local police authorities all over the the country have made arrests on telegraphic requests, which often far more attention is paid than to a warrant, but all such arrests are irregular under existiog law. They ought to be legalized aud proper restrictions placed about their use.
