## STRUCK OIL AT PASTURA

Three Barrels of Fine Grade Fuel Fluid Taken Out.

HAS PARAFINE BASE.

President and Directors of the Company Wired to Come From New York—Railway to be Built.

The El Paso News yesterday contained an important dispatch announcing that the O. K. oil company had struck oil near Hugo Goldenberg's place on the Salado. The dispatch bore on its face strong evidence that it was true. Last evening Judge Long received a dispatch from Colonel F. A. DuBois, formerly of DuBois & Marsh, merchants of Santa Rosa, and this morning a second telegram from the same source confirming the news.

Col. DuBois' dispatch to Judge Long says:

"Struck oil yesterday on the Salado. Will meet Rice Monday at Santa Rosa."

Soon as the news came yesterday. The Optic wired for reliable information, and this morning received the following dispatch from the Western Union agent at Pastura, on the Rock Island, near the new well:

PASTURA N.M. Nov. 13

Las Vegas Optic:

O. K. Crude Oil company of Newport are boring for oil on the Salado just south of Pastura, the El Paso-Northeastern station Guadalupe county. The company yesterday struck oil at 719 feet.

Five barrels were taken out and reports show a better grade of oil than Beaumont. This company is prepared for very extensive operations and will bore a group of wells as fast as the work can be completed. The officers of this company east have been notified by wire and are expected on every train.

A railroad from Pastura to the oil wells is now assured. The distance from Pastura to the wells is about twenty miles, with a perfectly level road-bed and a down hill pull from the wells to Pastura."

The optic has great confidence in the reliability of this news. Last summer, Colonel DuBois, Judge Long, Surveyor Rice, Messrs. Manzanares, Ross, Mr. Hos-

kins and Frank Springer, jointly located about 4,000 acres of oil land near this new well, Messrs Long, Rice and DuBois selecting the company locations in person.

Specimens of the oil rock were exhibited to Mr. Springer, who at once said if oil were found it would have a parafine base.

His predictions has proven true. The whole country in that region contains rock carrying a strong odor of oil. Specimens of this rock have been in Judge Long's office for a year.

The Optic has urged experimental boring for oil for a long time past, and congratulates not only the parties named whose locations adjoin the new oil well, but also the people of New Mexico on the developments apparently in the near future.

It is hoped now, not only that local capital but also foreign may now give these new oil fields a thorough test.

Chief Justice Mills will also be in luck if the field proves what it now promises, as his sheep ranch is within a mile of the oil well.—Optic.

This same oil rock was found in the Comrey Brothers well near Ancho; and is the greatest evidence that we have the same conditions that are reported at Pastura.—Editor:

### Our County's New Road.

The survey of the New Mexico and Pacific railway is progressing as rapidly as possible between Raton and Elizabethtown. The surveying corps now numbers sixteen. It is expected that the survey will be completed some time next month and that about the first of the year the work of grading will begin.—Raton Range.

### Thanksgiving Proclamation.

WHEREAS, The time honored custom in all the United States of setting aside a day annually at this season of the year to be observed by the people especially as one of thanksgiving for benefits and mercies shown during the past, which the President of the United States has recognized and followed by issuing his official proclamation that Thursday, the 27th day of November, A.D. 1902 be a Day of National Thanksgiving:

Now, Therefore, I, Miguel A. Otero, Governor of the Territory of New Mexico, in accordance with said custom and the Proclamation of the President, do hereby proclaim Thursday, the 27th day of November, A.D. 1902, as a day of Public Thanksgiving and prayer throughout the Territory of New Mexico, and earnestly urge that on that day all public and private business be suspended; that the Territorial Institutions and public schools be closed, and that the people assemble in their respective places of worship there to give thanks to Almighty God for the manifold blessings granted them during the past year, for the bounteous crops and increase in material gain, as well as for their exemption from the natural disasters and human wrought evils which have afflicted some portions of our country, and to pray for a continuance of these blessings in the future. Also on that day that each of us remember the poor people and give to them of our material store in order that they may have additional cause for thanksgiving.

Done at the Executive Office this the 8th day of November, A. D. 1902.

When the time came to remove the young man with both legs off, at 10 o'clock at night, to a Pullman, to take him to his home in Texas, there was no one about to lift the stretcher. So those two old soldiers, who years before had met in deadly conflict, did the work, the one at the head and the other at the foot; an unparalleled scene, since when, some times, after great battles, in the south, details from the opposing forces went out under flag of truce to assist each other in burying the dead.—San Marcial Bee.


### The Public Schools.



**DISTRICT COURT.**

District Court adjourned at Lincoln Wednesday morning. These were some pleas of guilty in misdemeanor cases and six jury trials in which there was a one mistrial, two acquittals and three convictions. The cases tried were the following: Manuel Aragon, violating Sunday law, hung jury; Charles Gilbert, carrying pistol, verdict of guilty, and fine of fifty dollars; Francisco Aguillar, theft of horse, verdict of guilty and sentence of a year and a half in the penitentiary. Amos Eaker, larceny of cow, verdict of guilty and fine of \$500; Severo Gallegas, larceny of calves, verdict, not guilty, and Robt. Fauvet, maliciously killing a goat, verdict not guilty.

No civil cases were tried.

**NEW RAILROAD PROJECT.**

Dr. F. A. Jones, mining engineer and expert, is authority for the statement that a rail road is to be built from San Antonio through the Carthage and Oscura mining districts to a connection with the El Paso & North-eastern System at Coyote 12 miles northeast of Carrizozo and about the same distance from White Oaks. Dr. Jones has mining interests along this route and says he has eastern capital sufficiently interested to insure the building of the road.

**Council Contested.**

A contest is on between G.A. Richardson and A.B. Fall. The grounds for contest grew out of something like a hundred votes at Alamogordo being sworn in, the voters not being registered. This may cause a pretty little rumpus legally but can only result in seating Mr. Fall by a republican council.

**HAWKEYE SOLD.**

The Hawkeye group of gold mines in Jicarilla, property of W. S. Ross, have been sold, so we understand to Chicago capital, through Messrs. Fox and Smith who have had bond with a working option for the last two months. Some almost startling developments have been made in the mine lately, and some purchase money paid.

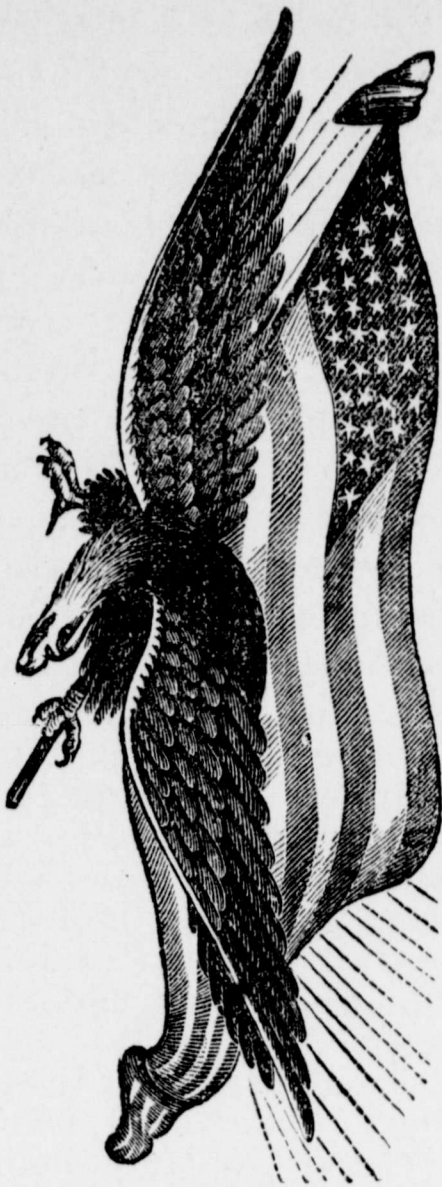
Large bodies of rich gold ore have been cut and those best acquainted with the property say it should rank with the Helen Rae and the Old Abe.

Roosevelt will shoot big game in the cane brakes of Mississippi.

Luna county's first election gives good majorities to all democratic candidates but one, probate judge. Good for Luna!

The El Paso Times had its safe cracked and \$40 taken. Now we don't doubt the Times having a safe, but how the thunder do you account for the \$40 in cash?

The Daily Mining Record at Colorado Springs and Denver says that the mining industry of the country is in better condition today than at any period since its inception.

A rich copper strike is reported at San Acacio, Socorro county. J. M. Wilson is the discoverer and claims a rich body of ore, running 60 to 90 per cent copper, and small values of gold and silver.

The senate statehood committee has agreed to report Oklahoma favorably. Statehood Rodey would feel like 30 cents if both Arizona and Oklahoma should be admitted and New Mexico left out, wouldn't he?

Hurst, Congressman elect from New York, and owner of the San Francisco Examiner, Chicago American and New York Journal, says that Hill's Coal plank in the New York state platform beat Coler for Governor. This is probably true, Hill has been an enemy to democracy so long that the people are slow to place confidence in him; his actions are rather credited to political cunning.

#### STATEHOOD COMMITTEE.

The Statehood committee appointed by the senate to investigate the claims of New Mexico, Arizona and Oklahoma to statehood, who are just now completing a trip through this territory and Arizona are as follows:

Beveridge of Indiana, Dillingham of Vermont, Burnham of New Hampshire, Nelson of Minnesota, Bard of California, Bate of Tennessee and Heitfeit of Idaho.

#### Beveridge Against Statehood.

Santa Fe, N.M., Nov. 15—The visiting senators were especially astonished at the facility with which the Spanish interpreters translated the words of the speakers. Senator Burnham said: "In my state, New Hampshire, we have in the northern portion many French Canadians and it is frequently necessary in our courts to have an interpreter for them. Their testimony is interpreted, but that is as far as it goes and the arguments to the jury are only in English. It is a little hard for us to grasp how an interpreter can follow along just a few words behind the speaker, how two speeches can be made at the same time and yet be followed. back in New Hampshire an attorney is expected to get excited. How do you arrange that here?"

When told that the interpreter got excited too, and frequently made a better speech than the attorney, the senator laughed heartily and said he would like to see it.

Senator Beveridge was non-committal, but those close to him are convinced that his anti-statehood views have not changed and that if anything, he is more determined than ever to fight the admission of New Mexico to statehood.—Herald

From the import of the foregoing we infer that Senator Beveridge's trip through New Mexico has not effected his opposition to the admission of our territory to the union. He objects to the interpreter in our legislature, in the courts, or in other words, he would like to see us taking our loquacious exercises in English before we even presume to play in Sam's back yard.

#### Provisions of Rodey's Omnibus Bill.

The constitutional convention in New Mexico shall consist of 111 delegates, one delegate for every 1,950 inhabitants or fraction of 400 and over according to the census of 1900. Bernalillo county is to have 13 delegates, Chaves 3, Colfax 6, Guadalupe 3, Luna 2, Lincoln 4, McKinley 2, Mora 6, Otero 3, Rio Arriba 7, San Juan 3, San Miguel 12, Santa Fe 8, Sierra 2, Socorro 7, Taos 6, Union 3, and Valencia 7. The election for delegates is to be held on the sixth Tuesday after the passage of the enabling act and the convention is to meet on the third Monday after the election. The constitution drafted by this convention must guarantee religious tolerance, must prohibit polygamy, must disclaim all right to the unappropriated public lands in the territory or land and owned by the Indians, must provide for equality in taxation of government and Indian lands, the assumption by the state of the

depts of the territory, and a public schools system, the public schools to be conducted in English. This constitution is to be submitted to the people at such time as the convention may set. While not specifically providing that the constitution be submitted to the people as one document yet this is evidently implied. Until the next general census or until otherwise provided by law, the new state will be entitled to one representative and two senators. It is thus seen that congress may give New Mexico two representatives on account of its rapid increase in population and to overbalance the electoral vote of Arizona which is counted in the democratic column and has much less population than New Mexico.

Upon the admission of the territory, the new state will receive for the support of its common schools, sections 13 and 36 in every township; 50 sections for public buildings at the Capital; two townships and 100,000 acres for the University of New Mexico, 100,000 acres for Colleges of agriculture and Mechanic Arts, ten per cent of the public land sales for public school fund, 50,000 acres for insane Asylum, 50,000 acres for the School of Mines, 50,000 acres for Deaf and Dumb Asylum, 50,000 acres for reform school, 100,000 acres for State Normal Schools, 50,000 acres for asylum for the blind, 50,000 acres for a miners' hospital, for the Military Institute 100,000 acres, and for the penitentiary 50,000 acres. The sum of \$30,000 is appropriated to pay the expense of holding the constitutional convention.

#### Diaz vs Trusts.

President Diaz knows a few things about breaking up trusts himself and has just issued a decree to break up the wheat corner in that country. The order admits American wheat very cheap for several months to come. The proclamation is as follows: "Porfirio Diaz, constitutional president of the United Mexican States, to the inhabitants thereof, know ye:

"That in order to obviate the damage that might arise from the scarcity that is beginning to be felt in the stock of native wheat and by virtue of the power granted to the executive by article 2 of the revenue of May 28th, last, I have seen fit to decree the following:

"Art. 1. The wheat imported through the custom houses of the republic from the 15th of the present month until March 31, 1903, will pay a duty of 50 cents per one hundred kilos gross weight.

"Art. 2 From April 1 1903 imported wheat will again be subject to the duty set forth in section 146 of the importation tariff."

It is to be regretted that we haven't a Diaz in this country, the trust nuisance would soon be history.

Comrey Bros. Oil Company is just now a-borning here, and by the way, promises to be one of the strongest companies of the kind in New Mexico. A meeting has been called to convene at the congregational church tomorrow night at which time a permanent organization will be effected.

The plan of organization, so far as the Eagle has been able to learn, is unique and at the same time commendable. Recently the Comrey Brothers, H. S. and Edward, Comrey, sunk a well near Ancho station on the Rock Island, and struck oil, in small quantities, at a shallow depth, less in fact, than 300 feet, and immediately following located 2080 acres of land adjacent to and including the 320 acres on which the strike was made, placing on the location notices names of friends and acquaintances in White Oaks whom they desired to become interested with them. This done they proceeded to effect a temporary organization, under the name of "The Comrey Bros. Oil company," with H. S. Comrey, president and A. P. Green, sec. & treas.

At the meeting tomorrow night at which only those who have been included in the locations and agreed upon as stockholders will be represented, permanent organization will be entered into and officers elected as that organization may direct. So far as we are informed the new company will begin business by the issuance of \$300,000 in stock, of which the Comreys will hold \$100,000 and; \$100,000 will be offered for development purposes and \$100,000 will be divided among the number of person whom they have located with them on these 2080 acres of oil lands each individual holding of the \$100,000 worth of stock as his 20 acres or one claim is to 2080 acres.

If any who have been included in these locations do not care to co-operate with the company under these conditions, the locations will be given to others of those selected who want more than one claim.

The EAGLE does not remember of our having seen just such a system as this of the Comrey Brothers instituted, but it is certainly a capital plan by which to interest a community in a home enterprise and will be a sure winner in securing funds for development.

There seems little question about the outcome of this company. It is not a question of striking oil with them they have it already, the one question being quantity and nobody doubts that quantity will come with a few hundred feet of depth.

The EAGLE's prayers are for a

good strike, and it is useless to say that we have been included among the locators, but will add another line to say we appreciate it.

**Ready for Business.**

The Chapman-Ludlam oil well is again going down. The new outfit is rigged and the big drill dropping every day. Since the report of the strike at Pastura, north of us, and the Comrey strike nearer home, a new interest is being felt in the progress of the White Oaks well. John Brotherton, the driller, is certain that a strike will be made and all who are directly interested are reasonably sure of success.

Of course there are always "doubtful Thomases" and chroniclers, with the cold storage disposition, who can't see any merit in anything or anybody unless they are Colonel of the regiment; and who are ever ready to diagnose an enterprise for the other fellow, but just as ready to drop out of sight when it comes to backing their own judgment with their own dollars, here, but, it is hard to defeat good sense and energy, and if there is oil here these people are going to get it. They are going at it in the right way and their present equipment will take them to a depth of 3,000 feet. If less than 1000 feet at Pastura and Ancho reaches oil stratum, it is reasonable to suppose that less than 3,000 feet will strike it here, if we have it, or demonstrate that it is not here, if it don't strike it.

Oil is what we need to set White Oaks apace with the foremost mining sections of the Rocky Mountains, and it will take a good head to estimate the change it would make in this district from the first announcement of oil. Aside from those holding stock in the well, business men and realty holders will receive the first fruits and from them it will spread to the wage earners and finally, yes quickly, to a complete revolution in the development of all our resources. Our town and our people should in every way possible encourage this enterprise.

A town never goes ahead of the people who inhabit it, and there is no stand still to either. It must go forward or it must go backward. A soldier was never known to mark time for a decade in one place, neither will White Oaks stand sentinel for twenty years longer counting the hours, waiting for her people to order her forward.

You will hear some anxious say, "What can we do?" There is much that we can all of us do. Everything is in this locality that goes to make a good town and a prosperous community. Resources are plentiful—Gold, Coal, Iron, Marble, Building stone, Sulphur

and Oil indications. While around us is open ranges, cattle ranches, fruit farms, etc., etc. All that is needed is to tell the truth about these things—show them to other people, and the least that should be done, by any is to speak courageously for the fellow who is trying to do something for the community—help instead of hinder.

**NEW MEXICO.****Well Drilling to Resume.**

It will be a source of satisfaction to the stockholders in the oil company, and many of them reside in El Paso, boring the Newman well in hand, has succeeded in getting out the tools that were fastened in the well. The hole is about 800 feet deep and this success of the professor will enable the company now soon to begin boring again. The well is full of water which must be cased off and as soon as that is done, work will begin. Within a week operations will commence. The good news from the Salado well will be encouraging to the Santa Rosa people.—X

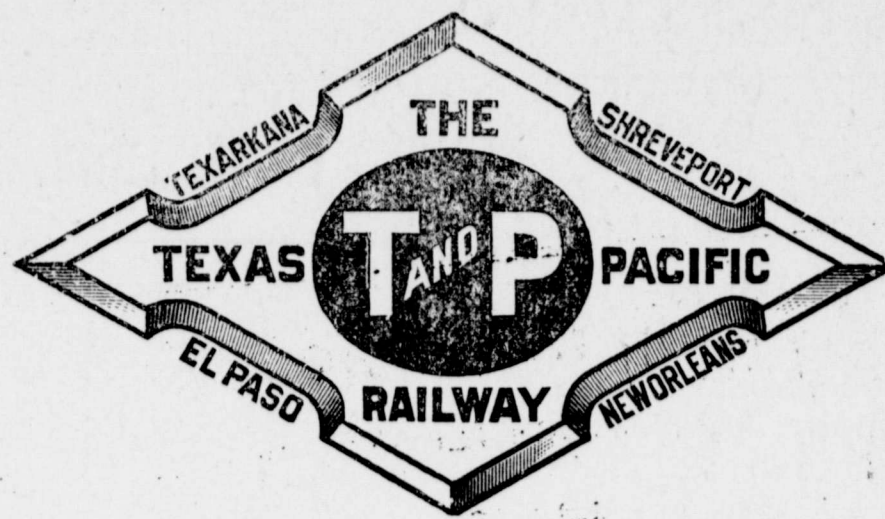
