VOLCANO BUILDS NEW MOUNTAIN

Deposit Piled Up by Flow of Lava in Hawaii.

RECORD FLOW IS PREDICTED

Only Once in Known History of Kilauea Has Present Flow Been Ex- Male, 12 mo. old, 1st prize, \$5.66. ceeded-For Generations Craters Have Been the Homes of the Large White "Bosun" or "Frigate" Birds, Now Driven to Find Other Nesting

Lava flowing from the Kilauea volcano onto the Kau desert, near Hilo, T. H., in eight months of activity has built up a miniature mountain. several hundred feet in height and two miles long, and has covered 75 miles of country with a thick coating of volcanic de-

The Kau flow burst from the southmiles from the main crater, December 21 last. It is still in action and shows few signs of diminishing in volume.

In point of duration of time the flow, or combination of flows now running, have been exceeded only once in the known history of Kilanea, by the flow of 1880-81, which was active ten months, traveled more than 40 miles and reached to within one mile of Hilo. "Mauna Iki" Its Name.

Sources of the present flow in December last were merely a series of cracks in the Kau desert's surface. Today, as a result of the piling up of continually spouting lava, they have built a mountain several hundred feet high. So permanently has this mass altered the contour of the county that it has been officially named "Mauna Iki," or "Little Mountain," to distinguish it from its 14,000-foot-high volcanic neighbor, Manua Loa, or "Big Mountain."

The lava flows have reached a series of deep pit craters ten miles in one direction from their source. For generations these craters have been the homes of the large white "bosun," or "frigate" birds which are now driv- of other strains. en to seek other nesting places. As the Heav'est Turkey Goboler advancing flows dispossess successive colonies of these birds, they fly out over the hot stream with piteous

Constant Observations.

Constant observations are made by the staff of the volcano observatory, but, as yet, it is said to be impossible to form any conclusion as to when this process of earth-building and earthdestroying will end. Volcano observers say that there is every indication that as this year progresses toward fall and winter, activity is likely to increase rather than diminish.

For weeks the lava column in the crater of Kilauea, the supply base of until it is more than 300 feet below the rim of the pit. This sinking, say observers, is coming to the end of its season, and will be followed by a rise of the lava column, which, it is stated, will increase the Kau flows reaching the air on the crest of Maru Iki.

Scientists express the opinion that the present Kau flows will reach the sea within the next few months.

If all the motor cars in the United States were evenly distributed over all the public highways of the country, they would still be thick enough to throw dust on each other's wind-

The total road mileage in this country, Anderson says, is about 2,475,000. The number of motor cars is close to 8,000,000, the registration for last year being 7,565,446. This makes an average of a little more than three automobiles for every mile of roadway in the country.

Wireless Telephone Being Used Along the British Columbia Coast.

NEW FOREST PROTECTION

The airplane forest patrol systems as adopted in California and Oregon in the national forests for fire protection is giving good service this season, & marked improvement being shown over last year in accurate location of fires says the Forest Patrolman of Portland. Plans are being made to protect Colorado national forests by air patrol.



ON WAY TO SEE SECOND ADVENT

Members of Unnamed Sect Are Headed for Palestine.

TRAVELING IN AUTOMOBILES

Five Men and Eighteen Young Women Are Following Gray-Whiskered Faith Healer From Northern Maine—They Have No Funds but Declare the Lord Provides for All Their Needs.

A strange little caravan of six men and eighteen young women gathered in Bangor, Me., recently from distant parts of the world to begin a wandering which they believe will eventually lead them to Palestine in time to witness the second coming of the Lord. They expect to augment their forces by hundreds and thousands before the Holy Land is reached.

Meanwhile they remain nameless pilgrims, who have severed all home ties and profess to have left behind them all worldly desires and pleasures. They live in tents until they set out or journey from point to point in three large automobiles, to their first stopping place, being in the neighborhood of Boston.

"Jehovah Provided."

Their leader, a tall, gaunt, gray-whiskered individual, had already created considerable interest in northern Maine by the practice of faith healing. Hundreds visit his tent seeking cures from various ailments.

Perhaps the most astonishing fact about this sect is their ability to provide for themselves on the proposed journey to Jerusalem.

"We neither beg, borrow nor steal," said the chieftain of the little band. "We don't lack for anything. Jehovah provides. We know that God has sent us on this mission, and he works on the hearts of people. The expressman drove up to our camp yesterday and left two bags of potatoes. I have no idea who sent them."

He denied that anyone in the party had funds. During their stay in Bangor the men folk made necessary repairs on the motors. Small contributions left by visitors to the camp were hoarded to buy gasoline.

Their Meager Fare.

A kettle of boiling water, in which were poured two cans of cocoa, and a few loaves of bread, constituted breakfast for the pilgrims. Only one other meal was served each day, usually consisting of potatoes baked in the open, bread and whatever is brought by neighboring residents, occasionally a few strips of meat, but usually vegetables.

"Most of us started from Philadelphia," said their leader. "Our first stop was Washburn, Me., where we were scheduled to hold a number of meetings at a certain date. Now we are actually on our way to Pales-

THEALL'S AMAZING CASE

Marine Corps Colonel Recovers From

The complete recovery from what was believed to be a fatal accident last November has restored Col. Elishat Theall to duty at the headquarters of the marine corps. As secretary of the house committee on naval affairs, and later as special legal adviser to the secretary of the navy, Colonel Theall is probably the best known officer of the naval service on duty in Washington, his acquaintance including practically every prominent many in public life in the last twelve years.

Colonel Theall's case will undoubtedly be recorded in medical circles as an a amazing one. Not only did he suffer a compound fracture of the skulk, within other complications, when strack by an automobile in Washington last November, but he had previously been retired as a marine officer in 1897 and invalided from active service. He was restored to active duty twenty zears later, at the outbreak of the war. Throughout the war he was stationed at Philadelphia and Norfolk. He graduated from the naval academy in 18811 and transferred to the marine corpotwo years later after completing two years' sea duty.

MARINE HERO'S NEW DETAIL

General Feland Placed In Charge of the Planning Section.

Brig. Gen. Logan Feland of the marine corps, one of the few general officers of the A. E. F. who won the distinguished service cross, has beet ordered to Washington to take charge of the planning section of the marine corps staff. He is now in command of the brigade of sea-soldiers in Santo Domingo. He will be relieved at Santo Domingo by Brig. Gen. Charles G. Long, who has in turn recently beet relieved as chief of staff of the corps by Maj. Gen. Wendell C. Neville who commanded the marine brigade overseas.

General Feland, in addition to winning the coveted distinguished service cross for personal bravery in troop leading when the marines launched their attack at Belleau Wood on June 6. 1918, was also awarded the distinguished service medal. The French army decorated him five times with the Croix de Guerre, his red and green ribbon bearing two palms, two bronze stars and one gold star, and also made him an officer of the Legion of Honor, for various feats of gallantry and leadership performed at Belleau Wood, Solssons, Mont Blanc and im the Argonne while either second in command or in command of the fifth regiment. YANKEE TAX SLEUTHS **GET POINTS ABROAD**

British Could Not Understand Need of U. S. Treasury Officials to See Books.

At first some surprise was expressed among British insurance and shipping companies transacting business in the United States, when it was learned that United States treasury officials were coming to England to investigate their books in connection with taxation, says a London Times article. However, any unfavorable feeling that may have been aroused at first has been overcome by the personality of the officials who were commissioned for the purpose and by an appreciation of the attitude of the United States treasury officials toward taxation assessments.

British business men have learned that the work of chartered accountants has hardly the same standing in the United States as it has in this country. Here the certificate of a first-class firm of chartered accountants attached to a balance sheet means that the figures of profits are accepted as stated, without question. It seems that there is not always the same unquestioned acceptance of figures as certified in the United States Texas.



HOW THE SOVIET CAME TO ITALY

Unexpected Answer to Lockout by the Employees.

NOT POLITICAL

Workers in Great Metallurgic Region Have Taken Over the Control of More Than 300 Foundries and Factories and the Government Tries Only to Prevent Bloodshed and Preserve Order.

More than 300 of the foundries and factories of Italy's great metallurgic center, extending on both sides of the river Po and covering its estuaries from Turin on the west to Mantau on the east, from Milan and Novara on the north to Voghera and Parma on the south, have the red flag of bolshevism floating over them, while the works themselves are being operated by soviet committees organized by the proletariat, to the exclusion of the socalled bourgeois owners, proprietors, and the directorates.

This wholesale appropriation of prirate property by the workers has been going on for more than two weks. According to a special cable dispatch the movement is rapidly spreading to centers of central and southern Italy.

The great danger, according to Italian sources of information, lies in the facts, first, that the industries of the metallurgic region have succumbed to bolshevism, and, second, that the government seems powerless to restore the sequestered property to its legal

Rich Industrial Region.

It was this region which during the war supplied the nation with the material means of combat and was the aim of successive Austro-German offensives. It utilizes more than 1.000,-000 horse power and employs more than 500,000 men. Its products enter into nearly every Italian industry-particularly that of agriculture, which is the chief of all-while its by-products keep going the small manufacturers and artisans of the nation. And now the great Ansaldo, Fiat, Italia, Gnome, Mont Denis and sub-Alpine foundries and factories, to mention only those of worldwide fame, are being operated on the soviet plan and without the consent of the owenrs.

According to the best current information on the subject, there is nothing political in the movementnot yet-and that may have caused the minister of labor, Signor Labriola, to regard it as a mere dispute between capital and labor, and the minister of war, Signor Bonomi. in the same light, and so restrain his hand until blood was shed and property destroyed. The fact that the workers in large industries have illegally taken over the plants and are Megally operating them and appear to be trying an experiment which threatens, according to the Russian analogy, to ruin the country, has not driven either minister into action. The prefects of the affected provinces, who have large bodies of carbinieri under their command, and may call upon the local garrisons in case of emergency, may not act except under orders of the minister of the interior, and the minister of the interior, Premier Glo-Mtti, has given no sign, since he issued his command to the prefects over two months ago to put down rioting. and to suppress seditious gatherings. It is believed that the prefects regard the sequestration of private property

by force majeure, if accompanied by neither riots nor seditious gatherings, as a matter not calling for their inter-

Government's Position.

The position of the government is deemed logical by many on the ground that the factory-seizing movement was presented as a result rather than a cause, the cause being the general lockout declared by the Employers' National syndicate, which exercises administrative control over the mechanical and metallurigical trades and industries throughout the peninsula. When the lockout came the workers invaded the property, took possession, established the soviet regime and went

The lockout, however, was to anticlpate, it is said, a general strike accompanied by the usual destructive demonstrations, and the government had informed the Employers' National syndicate that such a strike would be most hazardous for it to deal with, for each riotous demonstration since the war which had been dispersed by force of arms had rendered the government more and more unpopular and had laid it open to criticism that it was protecting the "pescecani," or war profiteers, against the rational remonstrance of the laboring man. It was criticism which caused the downfall of the Nitti government.

In taking their precautions against the results of a general strike-for the results of the lockout they did not foresee-the directorates of the various threatened works removed all their treasure and business accounts from their plants. So if the workers they have hitherto manufactured they will be unable to place these products, having no market, no means of transportation and, what is more important, access to no treasury from which to pay the men.

On these handicaps both the government and the Employers' National syndicate repose their hopes of an early surrender of the industrial soviet. Still, in certain factories the workers are said to be forging arms with which to defend their labor, their organization and the property they have appropriated for their own doubt-

ful profit. Seek Control of Products.

The metallurgical plants controlled by the Employers' syndicate have had to deal with two organizations of workers, called the Federazione Italiana Operai Metallurgical and the Sindacato Nazionale Operai Metallurgici, or, respectivly the Italian Federation of Metallurgical Workers and the National Syndicate of Metallurgical Workers. Both seek the same end, complete control of products from factory to consumer, but while the federation would proceed by slow means and through co-operative methods between the workers and the directorate, the syndicate would go the limit at once and absorb both factory and business office with all their functions without more ado.

The scheme of the syndicate has prevailed over that of the federation, hastened toward its end by the general lockout. Up to the time of the "direct action" the manifestos printed in the press of either disclaimed all idea of any political revolution and affirmed that the crisis which they were facing and the means they would take to win were purely economic.

Ever since the Giolitti government came into power, in the middle of June, the revolutionary industrial press has taken pains to separate itself from the press that was politically revolutionary, for it was discovered that while articles in the former were ignored by the government, articles in the latter, alleged to inspire sedition and armed revolt, caused the suppres-

sion of the papers printing them. At the same time many persons be

lieved that the advocates of an industrial revolution really had a political revolution in contemplation, and that to make the latter inevitable they had simply to press the industrial revolution to its logical conclusion, when, with all the industries of the country under the soviet regime, all political government would cease, having nothing more to govern, just as all capital would become useless, having no longer any function to perform.

To these persons the establishment of soviet rule in the industries of the metallurgical region did not come as a surprise, for they had seen the syndicate at work before it had attempted to divest itself of its political character on the coming of Giolitti. There was the campaign carried on against "pescecani," which had even caused Nitti and the representatives of the great metallurgical plants to defend themselves in the chamber. And there was the epidemic of strikes, often merely called for a day and in sympathy with an unfortunate worker who had been killed by the police or who had been merely discharged for some reason or other.

Anarchy Before the Selzure

The demonstrations against the had accompanied the strikes, called for whatever cause, had been accompanied well-organized agents of Enrico Mala- the side of order as never before, be-

testa. All had contributed to augment public unrest, to increase disinclination to work under present conditions and to excite distrust toward the authorities, which permitted the red flags to be flown in the north and dispersed mere parades in the south by rifle

Meanwhile two schools of socialism were gathering members everywhere: the school of Christian socialism, which advocated co-operation between labor and capital, and individual ownership with certain restrictions, and the school of politico-industrial socialism, which advocated everything from government ownership to ownership by the proletariat organized according to the soviet scheme. The former, which has the support of the Popular or Catholic party, through its press and the speeches of its members, has undertaken to save the country from the extreme program of the latter. There are two leaders of the Popular party in the Giolitti government, Filippo Meda and Giuseppe Micheli, holding respectively the portfolios of the treasury and agriculture, but so far the revolutionary demonstrations, whether political or economic, have not affected their departments. Once on the ground, he was pounced upon by all of the crows, which picked his bones clean in short order.





NEED MORE MONEY TO DEPORT INSANE ALIENS

New York Official Says 290 Were "Repatriated" During the Last Fiscal Year.

Increased appropriations to enable the United States immigration authorities to deport aliens in whom insanis discovered, was urged here by limited number of high Dr. Spencer L. Dawes, medical examcommission.

Dr. Dawes declared that although 290 insane aliens were deported during the last fiscal year, there are still a great number in the state who might be deported if funds were available, thus cutting down an item of expense which is second only to education in New York. Dr. Dawes said that there are 39,000 insane persons in state institutions who cost the people annually \$11,500,000.

Of the 290 aliens deported for insanity last year 147 were sent to their home countries in the usual way by the federal authorities, while 148 were "repatriated" by the state with the permission of relatives or guardians of the patients.

Explaining this process of "repatriation," Dr. Dawes said:

"After securing the consent of relatives to 'repatriate,' we arrange for passports to his or her home country and then give the insane person clothes, toilet articles and a new suitcase for the return trip. Under escort or guard, we send the patient all the way and see that he or she is safely delivered to relatives or friends on the other side.

"Last year the state of New York appropriated \$40,000 for this purpose alone.

Dr. Dawes said that in addition a great deal of time and money was devoted to returning insane persons to other states in which they are residents, whether citizens or aliens.

"With the exception of Connecticut," he said. "we have no difficulty in getting other states to take back their insane. We have written agreements with Massachusetts, Ohio, Illinois, Wisconsin, Iowa, Washington and several others. Not infrequently we send parties of insane persons across the continent to the Pacific coast."

The law provides that insane aliens may be deported at any time provided that legal processes are instituted within five years of their landing here. As New York is the greatest port of entry, Dr. Dawes said, this state becomes the dumping ground for thousands of these people who must be taken care of at public expense until they can be


