## **USPS to cut Saturday mail to trim costs**

WASHINGTON — The U.S. Postal Service will stop delivering mail on Saturdays but continue to deliver packages six days a week under a plan aimed at saving about \$2 billion annually, the financially struggling agency says.

In an announcement scheduled for later Wednesday, the service is expected to say the Saturday mail cutback would begin in August.

The move accentuates one of the agency's strong points — package delivery has increased by 14 percent since 2010, officials say, while the delivery of letters and other mail has declined with the increasing use of email and other Internet services.

Under the new plan, mail would be delivered to homes and businesses only from Monday through Friday, but would still be delivered to post office boxes on Saturdays. Post offices now open on Saturdays would remain open on Saturdays.

Over the past several years, the Postal Service has advocated shifting to a five-day delivery schedule for mail and packages — and it repeatedly but unsuccessfully appealed to Congress to approve the move. Though an independent agency, the service gets no tax dollars for its day-today operations but is subject to congressional control.

It was not immediately clear how the service could eliminate Saturday mail without congressional approval.

But the agency clearly thinks it has a majority of the American public on its side regarding the change.

Material prepared for the Wednesday press conference by Patrick R. Donahoe, postmaster general and CEO, says Postal Service market research and other research has indicated that nearly 7 in 10 Americans support the

## Texas news in brief

#### San Antonio man allegedly sought nude photos

SAN ANTONIO (AP) – Prosecutors say a man accused of being a fake reality TV producer lured two South Texas girls into texting nude photos to people they thought were models helping with portfolios.

The San Antonio Express-News reports prosecutors on Tuesday said the texts were from Gemase Lee Simmons.

Testimony continues before a federal judge in San Antonio as Simmons faces 39 counts related to child pornography, extortion and bank fraud.

Prosecutors say Simmons in 2011 approached one girl in a fast-food restaurant and the other in a grocery store and claimed to be seeking models. The 16-year-olds testified they later received texts from two purported models who convinced them to send naked photos.

The calls were later traced to the defendant's cellphone. Investigators believe as many as eight youths were victims.

#### Prosecutors curb \$3B

#### Texas cancer agency testimony

AUSTIN, Texas (AP) – A top Republican says former leaders of a troubled \$3 billion cancer-fighting agency in Texas won't publicly testify because of "significant legal concerns" raised by prosecutors.

House Appropriations Chairman Jim Pitts said Wednesday the request came from the Texas attorney general's office and Travis County public corruption prosecutors. Both began investigating the Cancer Prevention and Research Institute of Texas following an \$11 million grant to a private company that skirted agency rules.

Pitts said former executive director Bill Gimson and chief scientific officer Alfred Gilman were willing to testify before prosecutors stepped in. Both resigned last year as problems within the agency mounted.

Neither has been accused of wrongdoing.

Lawmakers are vowing to reform the once-celebrated agency battered by controversial awards and state auditors exposing widespread problems with accountability.

#### Retired Sen. Hutchison to practice law in Dallas

HOUSTON (AP) — Retired U.S. Sen. Kay Bailey Hutchison has joined the Dallas law office of Bracewell & Giuliani LLP as senior counsel.

The hiring was announced Wednesday by the Houston-based international law firm. Her husband, Ray Hutchison, is also a senior counsel at the firm's Dallas office.

Kay Bailey Hutchison holds a law degree from the

University of Texas. She was a television reporter in Houston before turning to politics.

Hutchison served nearly 20 years in the Senate before deciding not to seek re-election in 2012. Texas voters in November elected fellow Republican Ted Cruz as her replacement.

### Man who robbed same **Texas bank twice pleads guilty** CORPUS CHRISTI, Texas (AP) — A man who

robbed the same South Texas bank twice in 2012 and hid some of the loot in his boots has pleaded guilty and faces up to 20 years in prison.

A federal judge in Corpus Christi on Tuesday accepted the bank robbery plea from 52-year-old Nicholas Vernon Tolmie.

Investigators say Tolmie held up Texas Champion Bank in Corpus Christi last July 11 and Nov. 19. Police say the robber slipped threatening notes to tellers before fleeing with cash.

Tolmie was captured shortly after the second heist when police located him in a restaurant. The Corpus Christi man had ditched the clothes he wore in the holdup and hid some of the stolen money in his boots.

Tolmie remains in custody pending sentencing in May.

## **3 Harris County deputies**

#### fired in sex. car scandal

HOUSTON (AP) — Three Houston-area deputies have been fired amid allegations they had consensual sex with a female law enforcement volunteer while in their patrol cars.

A statement late Tuesday from the Harris County Sheriff's Office says improper conduct will not be tolerated.

The department on Monday fired Deputies Adam Wright, Michael Medina and Robert Johnson following an internal investigation that began in late 2012.

Investigators say the men — in separate incidents with the same woman — used their patrol cars as a place to have sex with her. The sheriff's office says the encounters happened when the deputies should have been working.

The woman is no longer with the Citizen's Police Academy. The sheriff's department program is meant to give Houston-area residents close knowledge of law enforcement protocol and procedures.

#### Jury considers penalty of Texas man in mutilation

DALLAS (AP) — A North Texas jury continues deliberation of the punishment of a man convicted of a 2011 mutilation attack that left his former girlfriend needing more than 500 stitches.

The Dallas County jury could sentence Jose Arreola to up to life in prison. Jurors deliberated for three hours Tuesday before recessing for the night.

The woman had testified that Arreola first attacked her in 2009.

He was free on bail when he raped and sexually mutilated her in March 2011.

Arreola had argued that the woman was the aggressor in earlier fights. He testified she drank heavily and had repeatedly attacked him with knives.

#### Deputy shot serving warrant near San Antonio

SAN ANTONIO (AP) — A deputy is hospitalized after he was shot twice as he and four other deputies tried to serve felony warrants at a house just outside northwestern San Antonio.

Bexar (BAYR) County sheriff's Deputy Jose Esquivel was shot about 6 p.m. Tuesday.

Sheriff Susan Pamerleau says he and the other deputies were trying to serve seven felony arrest warrants on 38-year-old Juan Daniel Gonzales Jr. The warrants accused him of felony theft, retaliation and failing to register as a sex offender.

Pamerleau says as deputies searched the house. Gonzales surprised a deputy in the laundry room and shots were fired.

No condition was available on the deputy, but Pamerleau says the 28-year veteran of the sheriff's office was alert as he was taken to a nearby hospital.

Gonzales is in custody.

### Police: Houston man

#### killed wife, injured stepson

HOUSTON (AP) — Houston police say a 40-yearold man is charged with murdering his wife and seriously injuring his teenage stepson in a weekend attack.

Lawrence Clinton Chambers was charged Tuesday with murder and injury to a child.

A Houston police statement says Chambers was apprehended Monday for the attack at a home in south Houston and is held without bond at the city iail.

Police say he fatally stabbed 43-year-old Jemal Lockridge Chambers on Sunday and seriously injured his 13-year-old stepson.

Authorities say Jemal Chambers' teenage daughter came home to find the door locked and her mother's car missing.

She used a key to enter the home and found the victims in her mother's bedroom.

Chambers was dead at the scene and the boy was taken to a hospital in serious condition.

"The Postal Service has a responsibility to take the steps necessary to return to long-term financial stability and ensure the continued affordability of the U.S. Mail." He said the change would mean a combination of employee reassignment and attrition and is expected to achieve cost savings of approximately \$2 billion annually when fully implemented. The agency in November reported an annual loss of a record \$15.9 billion for the last budget year and forecast more red ink in 2013, capping a tumultuous year in which it was forced to default on billions in retiree health benefit prepayments to avert bankruptcy. The financial losses for the fiscal year ending Sept. 30 were more than triple the \$5.1 billion loss in the previous year. Having reached its borrowing limit, the

mail agency is operating with little cash on hand.

The agency's biggest problem — and the majority of the red ink in 2012 — was not due to reduced mail flow but rather to mounting mandatory costs for future retiree health benefits, which made up \$11.1 billion of the losses. Without that and other related labor expenses, the mail agency sustained an operating loss of \$2.4 billion, lower than the previous year. The health payments are a requirement imposed by Congress in 2006 that the post office set aside \$55 billion in an account to cover future medical costs for retirees. The idea was to put \$5.5 billion a year

Since 2006, it has cut annual costs by about \$15 billion, reduced the size of its career workforce by 193,000 or by 28 percent, and has consolidated more than 200 mail processing locations, officials say. They say that while the change in the delivery schedule announced Wednesday is one of the actions needed to restore the financial health of the service, they still urgently need lawmakers to act. Officials say they continue to press for legislation that will give them greater flexibility to control costs and make new revenues.

"The Postal Service is advancing an important newapproachtodelivery that reflects the strong growth of our package business and responds to the financial realities resulting from America's changing mailing habits," Donahoe said in a statement prepared for the announcement. "We developed this approach by working with our customers to understand their delivery needs and by identifying creative ways to generate significant cost savings."

But the president of the National Association of Letter Carriers, Fredric Rolando, said the end of Saturday mail delivery is "a disastrous idea that would have a profoundly negative effect on the

on Saturday delivery for commerce and communication.

He said the maneuver by Donahoe to make the change "flouts the will of Congress, as expressed annually over the past 30 years in legislation that mandates six-day delivery."

There was no immediate comment from lawmakers.

The Postal Service is making the announcement Wednesday, more than six months before the switch, to give residential and business customers time to plan and adjust, the statement said.

"The American public understands the financial challenges of the Postal Service and supports these steps as a responsible and reasonable approach to improving our finanmake such a payment for future medical benefits. Postal authorities wanted Congress to address the issue last year. but lawmakers finished their session without getting it done. So officials are moving ahead to accelerate their own plan for cost-cutting.

# **O**THER VIEWS Who was that guy?

man calling himself Rick Perry addressed the Legislature (last week). That's the same name used by the Texas governor.

He said many things that indicate he might have been the real Gov. Perry: a sweet reference to his wife, a lot of bragging about how well the Texas economy is doing and how it's the envy of all other states, a push for stricter limits on state spending, a proposal for tax cuts, complaints about Washington. You know, the usual.

But this Rick Perry also proposed spending \$3.7 billion out of the state's rainy-day fund and not letting that fund build up to its projected \$12 billion during the next budget cycle. That's just the opposite of what Perry said last session, when he wanted to make the rainy-day fund untouchable.

What's more, the guts of his proposal made a lot of sense and probably will get bipartisan support among legislators. It was enough to make your head swim.

This new Perry fellow pushed a plan he said "will support critical water and transportation systems across our state, addresses our needs both short-and long-term, and ensures both water and traffic will continue to flow in Texas for generations to come."


He wasn't specific about exactly how to use that \$3.7 billion. It could be by direct spending of rainy-day money on water or transportation projects. Or, there has been talk about setting up infrastructure "banks" through which the state could guarantee bonds for those same projects, reducing finance costs and stretching the rainy-day dollars to cover more new infrastructure construction. It's up to the Legislature to flesh out this idea, and a lot will depend on the details. But the bigpicture version is intriguing. That's not to belittle the other points in Tuesday's speech. The man who sounded more like the old Perry wants \$1.8 billion in "tax relief" during the next two years.

# **Recalling the turbulent '60s**

very once in a while, when time and schedule allows, Leah and I will look for a good movie to watch on TV. We are relatively easy to entertain, albeit unapolo-

getically conservative when it comes to gore, graphic violence, bad language and any kind of immoral behavior.

We aren't prudes or self-righteous by any stretch of the imagination. We just don't see any reason to poison our minds



Even though we are capable of enjoying different genres of cinematic accomplishment, the stretch for us comes with the movies released in the 1960s. Granted, there were a few good movies produced during that era, but there was also a plethora of really odd and off-the-beatenpath celluloid disasters. By and large, I suspect the movies from that era were a reflection of the times and that's probably why many of them are senseless and idiotic unless you are high on something, which I never was or ever have been.

The decade of the '60s was a strange tapestry of profound cultural and political changes which resulted in rebellion against authority, moral decline. a rejection or redefinition of traditional values and so much more. I know because I lived through it. In fact, it was some of the most formative years of my life in many ways because it encompassed all of my teenage years and my first year in college.

After the end of World War II, birth rates across the world spiked. The explosion of new infants became known as the baby boom. During the boom, an estimated 77 million babies were born in the United States alone.

That's why those of us born in that time frame are called "baby boomers" and we comprise approximately 20 percent of the American population.

Even though much of what defines my generation is negative and things which I believe to have provided fertile soil for many of today's problems, there were also some great things that happened.

Strangely enough, in my opinion the opening paragraph of "A Tale of Two Cities", a historical novel by Charles Dickens written in 1859, provides us with a strikingly accurate assessment of a generation 100 years still removed: "It was the best of times, it was the worst of times, it was the age of wisdom, it was the age of foolishness, it was the epoch of belief, it was the epoch of incredulity, it was the season of Light, it was the season of Darkness, it was the spring of hope, it was the winter of despair, we had everything before us, we had nothing before us, we were all going direct to Heaven, we were all going direct the other way..."

The '60s decade has been described by historians as the decade that resulted in the most significant changes in our history. Among numerable momentous accomplishments, in 1969 the race to space was won by the U.S. by putting a man on the moon. The 1960s were also time of turmoil, probably described as such for the racial unrest during this period, social injustice and because of our involvement in the war in Vietnam. The magnitude of violence in the streets of U.S. cities, as well as on college campuses in protest of the war in Vietnam, was unprecedented in our history. The burning of the flag and draft cards were widely used as tools for protest.

Music and events of the day interacted with one another as we progressed through one of the most turbulent decades in modern history. The assassination of President John F. Kennedy, Dr. Martin Luther King Jr. and presidential hopeful Bobby Kennedy illustrated the turbulent and restless society.

While I embrace many priceless memories of those years, I

also have to honestly acknowledge that in spite of some amazing music and beautiful cars, it was also a time of devastating changes influenced by some of history's worst, such as Madalvn Murrav O'Hair. Best known for the Murray v. Curlett lawsuit, which led to a landmark Supreme Court ruling ending official Bible-reading in American public schools in 1963, she later founded American Atheists and became so controversial that in 1964 "Life" magazine referred to her as "the most hated woman in America." This came one year after the Supreme Court prohibited officially sponsored prayer in schools in Engel v. Vitale.

Reflecting on a generation that stimulated so much revolutionary change inspires me to look at the 21st century with new perspective. Are we as capable of positive change now as we were of negative change then? Or have we already regressed so far that in spite of mind-boggling technology, advanced education. money and political infrastructure we are doomed to destruction?

I believe positive change is always possible because there will always be patriots and visionaries with true hearts willing to pay whatever price is demanded for it. Maria Robinson said, "Nobody can go back and start a new beginning, but anyone can start today and make a new ending." Tony Robbins said, "By changing nothing, nothing changes."

We need Christians and patriots to rise up and realize that our voices must be heard and our actions must correlate in order to usher in the revival of change that is mandatory for our nation's survival and for a restoration of righteousness in America.

You may not agree with anything I've said, but I column as I see 'em.



This administration never passes up a chance to blame the Republicans.




In 1999, when Grace is 98 years old and living out her last days in a nursing home, she is visited by a young director who is making a film about the events of that summer. She takes Grace back to Riverton House and reawakens her memories. This is the story of Grace's youth during the last days of Edwardian aristocratic privilege shattered by war, of the vibrant 1920s and the

changes she witnessed as an entire way of life vanished forever.

The Library also has "The Forgotten Garden" (F LP MOR K), which is similar in nature; a lost child, found on a boat bound for Australia and is taken in by strangers whose life is shattered when secrets are told.

We have another time-traveling story, this one is from Linda Lael Miller and it takes place in modern-day Seattle and on an 18th Caribbean island with a dashing pirate. In "Pirates" (F MIL L), Miller sweeps readers away and through time itself when a thoroughly modern woman encounters a dangerous, dashing 18th-century buccaneer. The result is a sensuous, joyous, utterly heartwarming tale of love.

Phoebe Turlow needs to get out of Seattle and forget about the man she just divorced, her dwindling finances, and the lonely nights that stretch ahead of her. But she can't foresee what awaits her on Paradise Island. Duncan Rourke is known to historians as "the pirate patriot." He's been dead for two centuries — or at least he's supposed to be, until Phoebe Turlow steps out of a van, into a run-down island hotel and into his world. Neither Phoebe nor her pirate can envision the

glorious adventure that is about to unfold.

From Amazon Reviews.com comes a review of Dean Koontz's "One Door Away From Heaven (F KOO D). Koontz practically invented the cross-genre novel, and in this volume, he mixes an action thriller with post-X-Files alien paranoia to remarkable effect.

Micky Bellsong is

a young woman at a crisis point in her life, using a stay at her Aunt Geneva's to sort things out. Then, the precocious and deformed Leilani Klonk walks into her life, telling stories of her stepfather and drugged-up mother, who believe aliens will beam the girl into their mothership and heal her deformities before her 10th birthday. But tales of the stepfather's vicious past, including his hand in several murders. leads Micky to believe that a far more terrible fate awaits her friend. So when the parents take off with Leilani, Micky pursues. As is typical with a Koontz novel, nothing turns out to be what it seems and the meticulously crafted plot tightens like a noose with every turn of the page.

His characters are exceptionally drawn, driving the novel forward with realism and warmth. Micky is one of his more attractive young heroines, but the real star is Leilani, a mature young girl whose plucky nature and sparkling dialogue instantly make her Koontz's most memorable creation. She embodies his belief that despite violence, pain, and suffering, there is always goodness to be found in every person and situation. Koontz has once again proven why he is one of the premier novelists of his generation.

Kathleen Rigdon Highley's latest mystery is here to check out: "106 Arrowhead Drive" (F HIG K). Catherine Baldwin and Nanny Maggie gathered up all five children, the youngest a mere five weeks old, and ran for their lives. Catherine's husband was dead and her mother-in-law

You may recognize some local names in the book, even though it takes place in Lubbock and Ransom Canyon. The pacing is good, but some background is lacking ... why is Elizabeth Baldwin so determined to ruin her daughter-in-law's life? Catherine is certainly not keeping her light under a bushel (so to speak); she could be found at any time with her musical career. Why is Kim so determined to go to Lubbock to find things out? Why not one of the boys who would have remembered leaving town, instead of a three-week child?

the cat stars of the Internet, a place filled with felines and their wacky uploading humans since the dawn of bandwidth. Now, after years in lucrative and altruistic ways.

I speak, of course, of Video Film Festival drew a Woodstock-esque crowd of more than 10,000 - people, that is — to a Minneapolis art museum in August. A fan-voted winner among five scripted finalists some creators received a stipend to enter — will earn \$10,000 after online voting ends later this

month.

In November, Friskies gave a lifetime achievement statue to angsty existentialist Henri, le Chat Noir, at the brand's own awards ceremony and donated 250,000 cans of cat food to shelters around the country. Henri, the troubled Tuxedo, won another statue in Minneapolis and will soon begin a collaboration of food-focused videos with Friskies. Oh, and Henri's putting out his first book in April. Roly poly Maru, the megastar in Japan with millions of views for nearly 300 videos since 2007, has three books and a calendar, among other swag for sale. The squishy-faced, often blissed-out Scottish fold who loves boxes and bags was used by Uniqlo when the Japanese

brand launched its San Francisco store in October. Maru chose boxes, called "Lucky Cubes," stuffed with giveaways for human contest winners.

Not to be outdone, Simon's Cat, a funny feline in a series of line-drawn animated videos out of London, has a book and an online store, as does Henri, who lends his fame and some of his dollars to cat charities. Even the funny faced Grumpy Cat, whose real name is Tartar Sauce, coughs up some bucks to animal welfare groups, while captions for her still photos fly around the Internet and she sells T-shirts off her website. She put out some videos after her existence as a living, breathing and not digitally altered feline was questioned.

## Lifestyle, pop culture drive dog breed popularity

LOS ANGELES (AP) – Help wanted: One trained, easygoing, lowmaintenance dog that will work for next to nothing. It was the classified ad that Matthew VanFossan wrote in his head after going blind.

His Labrador retriever, Achilles, "will guide me across busy streets for nothing more than a pat on the head or 'Good boy," said the 31-yearwriter-counselor old from Los Angeles. "He loves every bit of attention, but he can also go without it. He'll let out a low groan if he's getting too bored."

The breed's friendliness, intelligence and love of physical activity helped make it the most popular dog in America for the last two decades, according to American Kennel Club data released last week. Labrador retrievers are widelv used as search and rescue, guide, therapy and service dogs, and they're also perfect for active, outdoors-loving families with children,

Lisa Peterson.

Labrador retrievers (22 years), cocker spaniels (23) and poodles (22) have been the most popular purebred dog breeds in the United States for a total of 67 of the 128 years the AKC has been counting. The data from the AKC, the country's only nonprofit dog registry, comes from paid registrations by breeders and owners of purebred dogs, and makes the dog eligible for AKC events such as dog shows. More than 40 million purebred dogs have been registered 1884, Peterson since said.

Some critics, like the American Society for the Prevention of Cruelty to Animals and the Humane Society of the United States, argue that owners mistake club registration as a sign of responsible breeding. "Registry with the AKC simply indicates that a dog had two parents of the same breed," said Cori Menkin, senior di-

said club spokeswoman rector of ASPCA's Puppy Mills Campaign. The AKC acknowledged that registration does not guarantee the quality or health of a dog.

> However, Peterson condemned those who increase breeding to meet public demand, "responsible saying breeders do not produce more dogs just to meet popular demand."

> Factors, including Hollywood, pop culture and the economy, help drive changes in breed popularity. For instance, the yellow Lab featured in the bestselling memoir and the subsequent movie "Marley & Me," help the breed's popularity skyrocket, Peterson said.

Likewise, the popularity of other breeds has soared thanks to the beagle Snoopy in Charles Schulz's Peanuts comics, "Lassie" for collies, and cocker spaniels from "Lady and the Tramp." Snoopy has been one of the biggest influences, Peterson said, and is the only

non-dog to be issued an AKC registration certificate.

But "the No. 1 thing that drives changes in dog popularity is people's lifestyles," Peterson said. In New York City last year, larger breeds such as the Labrador retriever and German shepherd jumped over the smaller Yorkshire terrier. Peterson attributed to the economic recovery, saving "people are going back to larger dogs."

The short-haired dogs are easier to groom, easier to walk and to exercise than the smaller, time-intensive more dogs, she said. She believes smaller dogs became popular because of the recession because that trend started in the 1990s.

Another popular breed, the cocker spaniel, has owners coming back for its friendliness. Carol Bryant, a blogger from Forty Fort, Pa., travels frequently and uses her cocker spaniel Dexter as a networking

tool. Dexter is so good that he has his own business cards, she said. Of the breeds that

made most gains in popularity, the most noticeable has been the bulldog, said Peterson. It has inched up the last five years, most recently to No. 5 nationally in 2012, she said.

She attributed some of that to "great visibility. It's the mascot for the U.S. Marines. Think of all the colleges that have bulldog mascots. The Mack truck has a bulldog on the hood. And Tillman and Beefy are real bulldogs who skateboard."

Bulldogs "have such great temperaments, they are adorable puppies, they are sturdy and compact, and they have the wrinkles and the eyes. They don't require a lot of grooming or exercise and they love to stay in the house and be with you or if you like the outdoors, they love that too," Peterson said. The small, sturdy

breed also is compat-

ible with owners of all ages, she added, making it ideal for multi-generational families. That comes in handy as the economy forces more adult children to return home.

When it comes to America's top dog for the past 20 years, practicality beat being fashionable.

The Labrador retriever's intelligence earned high marks among owners who sought out the breed.

VanFossan, who lost sight in both eyes by age 22, has owned two Labs. He tried using a cane for six awkward months, then got a guide dog - aLab named Gilly. Their time together became a book in January -"Through Gilly's Eyes: Memoirs of a Guide Dog" — and his second dog is Achilles.

"Achilles is a little more sensitive but is better at remembering. It's incredible. I can go to a new place just once or twice, and he'll have the route memorized.

#### Small tsunami damages homes in Solomons, 4 believed killed; other warnings canceled

SYDNEY (AP) — A powerful earthquake off the Solomon Islands generated a tsunami of up to 1.5 meters (about 5 feet) that damaged dozens of homes and likely killed several people in the South Pacific island chain Wednesday.

Authorities canceled warnings for tsunamis on more distant coasts.

Solomons officials reported two 1.5-meter (4 foot, 11-inch) waves hit the western side of Santa Cruz Island, damaging between 70 and 80 homes and properties, said George Herming, a spokesman for the prime minister. Many villagers had headed to higher ground as a precaution, Herming said.

Solomon Islands Police Commissioner John Lansley said local police patrols had reported that several people were presumed dead, though the reports were still being verified.

"Sadly, we believe some people have lost their lives," he said. "At the moment we potentially know of four, but there may of course be more."

#### Obama's CIA pick Brennan, once stung by waterboarding, now opposes it

WASHINGTON (AP) — John Brennan, now President Barack Obama's nominee to be CIA director, sat quietly around a conference table at the agency's headquarters in Langley, Va., during briefings about the capture and waterboarding of key al-Qaida operative Abu Zubaydah.

Former and current U.S. intelligence officials who were part of those briefings say Brennan, then deputy executive director of the CIA's administrative arm, did not raise objections to the interrogation practices in those forums. They spoke on condition of anonymity because they are not authorized to discuss the top-secret meetings publicly.

Brennan's silence may have cost him his first chance to lead the spy agency. He withdrew his name from consideration in 2008 following a stream

But in his letter withdrawing his nomination, Brennan wrote that he'd been a "strong opponent" of the program. Throughout Obama's first term, Brennan added to the body of criticism of so-called enhanced interrogation techniques in his role as Obama's counterterrorism adviser.

The same issue that caused him to withdraw from consideration to be the nation's spy chief is likely to come up again this week as Brennan faces his confirmation hearings in Congress to be director of the CIA.

## Obama and GOP want to replace across-the-board cuts, but with what?

WASHINGTON (AP) — After two tumultuous years of budget brinkmanship, President Barack Obama and Republicans in Congress finally agree on something — namely, that a previous 10-year pact to cut \$1 trillion across the board was such a bad idea it must be stopped before it starts.

If consensus counts as good news in an era of divided government, consider this: They also disagree vehemently on a suitable replacement.

As a result, they seem likely to spend the spring and perhaps a good part of the summer struggling to escape a bind of their own making. And this time, Medicare and the rest of the government's benefit programs are likely to face changes.

Already, the two sides are laying down markers. Obama called on Congress on Tuesday to join him in developing a replacement for the across-theboard reductions, "a balanced mix of spending cuts and more tax reform."

#### Boy Scouts of America board meets in Texas amid discussion of changing policy banning gays

IRVING, Texas (AP) — The Boy Scouts of America's policy excluding gay members and leaders could be up for a vote as soon as Wednesday, when the organization's national executive board meets behind closed doors under intense pressure from several sides.

BSA announced last week it was considering allowing troops to decide whether to allow gay membership. That news has placed a spotlight on executive board meetings that began Monday in Irving, Texas, where scouting headquarters is located.

BSA spokesman Deron Smith said last week that the board could take a vote Wednesday or decide to discuss the policy, but the organization would issue a statement either way. Otherwise, the board has remained silent, with reporters barred from the hotel where its meetings are taking place.

At nearby BSA headquarters, a handful of Scouts and leaders delivered petitions Monday in support of letting gay members join. The conservative group Texas Values, meanwhile, says it has organized a Wednesday morning prayer vigil urging the Scouts to keep their policy the same.

President Barack Obama, an opponent of the policy, and Texas Gov. Rick Perry, an Eagle Scout who supports it, both have weighed in. underground bunker, the captor was making plans of his own.

#### Woman charged in lover's slaying in Arizona continues testimony in death penalty trial

PHOENIX (AP) — Jodi Arias' life changed from the moment she met the man she killed. A world of opportunities seemed possible. A good job. A promising future. A potentially loving relationship.

As Arias testifies in her murder trial, she continues to lay out in painstaking detail the events that led up to the day she stabbed and shot Travis Alexander in his suburban Phoenix home.

Her testimony was set to resume Wednesday.

Arias has told jurors of a past marred by abuse at the hands of her parents, the numerous boyfriends who cheated on her and how things seemed to take a turn for the better when she met Alexander.

The 32-year-old is now accused of stabbing and slashing him 27 times, slitting his throat and shooting him in the head in June 2008. She initially denied any involvement, then later blamed it on masked intruders before claiming self-defense.

#### Mexico authorities seeking masked attackers who raped 6 Spanish tourists in Acapulco

ACAPULCO, Mexico (AP) — Authorities have information they hope will lead them to the gang of armed, masked men who raped six Spanish tourists in the Mexican resort of Acapulco, the attorney general in the southern state of Guerrero said.

The vicious, hours-long attack at a beach home on the outskirts of Acapulco before dawn Monday was the latest chapter of violence that has tarnished the once-glamorous Pacific coast resort celebrated in Frank Sinatra songs and Elvis Presley movies.

"Fortunately we have strong evidence to lead us to those responsible for this reprehensible act," Guerrero state Attorney General Martha Garzon Guzman told Mexico's Radio Formula on Monday.

The beach home on an idyllic stretch of coastline had been rented by six Spanish men, six Spanish women and a Mexican woman.

The attackers gained access to the house because two of the Spaniards were in the yard and apparently were forced to open the door, Acapulco Mayor Luis Walton told a news conference late Monday.

## Dell's founder strikes deal to turn company around

NEW YORK (AP) - It's easy to forget now, but Michael Dell was the Mark Zuckerberg of his day. Hailed as a young genius, he created the inexpensive, made-to-order personal computer in his University of Texas dorm room and sold it straight to the public. In the 1980s and '90s, his face appeared on magazine covers, and well before he turned 40, he was a college dropout-turned-billionaire CEO, ranked alongside Bill Gates and Steve Jobs. But that was a long time ago in the fast-moving world of high technology. Now the PC is getting eclipsed by smartphones and tablet computers, and Dell is struggling to save his company — and his legacy. Tuesday's announcement that Michael Dell and the investment firm Silver Lake have struck a \$24.4 billion deal to buy publicly traded Dell Inc. and take it private may well be the founder's last chance to recapture his former glory. The agreement will allow the company to attempt a turnaround without having to worry about pleasing Wall Street with its earnings. For Michael Dell, 47, the attempt to retool the company he built is personal, said technology analyst Patrick Moorhead, who runs Moor Insights & Strategy. "His name is on the logo and all the buildings. So he takes all of this very personally," Moorhead said. "This is a way for him to solidify the way people will look at him and remember him."

**Consider this case** where South wound up in four notrump after North had invited a slam. North's raise to four notrump asked South to continue bidding toward slam if his one-notrump opening was based on 16 or 17 points.

West led the king of clubs, East playing the jack, and continued with the queen of clubs, taken by South with the ace. Anticipating no difficulty at all, declarer next cashed dummy's A-K of diamonds, but when East showed out on the second diamond, South unexpectedly found himself with only nine tricks.

Unfazed by this development, he proceeded to make the contract anyway. He cashed the A-K-Q of hearts and A-K of spades, reducing all hands to four cards. At this point, West was known to be holding the J-9 of diamonds and 10-6 of clubs, while South's last four cards were a spade, a club and the Q-10 of diamonds.

**Declarer now led a club,** and after West collected his two club tricks, he had to lead a diamond into South's Q-10. As a result, South made exactly four potrump.

exactly four notrump. In effect, West's distribution was an open book after the first six tricks had been played. At trick two, it became known that West had started with six clubs. At trick four, South learned that West had also started with four diamonds, and at trick six, South learned that West had started with precisely one heart. West's two unknown cards therefore had to be spades, and all South had to do while cashing his remaining heart and spade winners was to keep an eye on West's discards.

## **Rockets tie NBA record** for 3s against Warriors

HOUSTON (AP) — The Houston fans knew the Rockets were on the verge of history against Golden State on Tuesday night, needing one more 3-pointer to set an NBA record.

Warriors coach Mark Jackson wasn't going to let that happen.

The Rockets settled for tying an NBA record and set a franchise mark with 23 3-pointers in a 140-109 win over the Warriors. Houston matched the single-game record for 3s set by Orlando in a win over Sacramento on Jan. 13, 2009.

The Toyota Center crowd realized the outright record was within reach in the final three minutes, chanting "One more 3!" But the Warriors took away Houston's chances of getting it by fouling at the end.

"We're not going to lay down," Jackson said. "If you're going to try to get the record, we're going to stop it."

The Warriors should've employed that plan sooner.

Jeremy Lin sank five 3-pointers, a career high, and Chandler Parsons and James Harden hit four apiece as the Rockets reached a season-high point total. They also tied an NBA record with 14 3-pointers in the first half and dished out a season-high 35 assists on 46 field goals overall.

"Thankfully, we were just able to get a bunch of open looks and knock them down," Lin said. "That's just the way it is sometimes."

Lin scored 28 points, Harden added 18 and Parsons had 16 for Houston. The Rockets put on the shooting display without their best 3-point shooter

- Carlos Delfino, who sat out with a right elbow injury.

"We just got hot tonight," Harden said.

Jarrett Jack scored 20 points and David Lee had 18 for the Warriors. Stephen Curry, averaging 21 points per game, scored only seven points on 3-for-12 shooting.

Houston set a Toyota Center scoring record and reached 140 points for the first time since April 1995.

"Throughout the whole game, you figured they'd cool off," Curry said. "But we






