Plains Co-op Head Talks To Ladies of Castro Council

"Good cream makes good butter and cream kept one week in a home, sold to the local station, then carried to the creamery, cannot be good cream," club women were told by Mr. Roy Davis of the Plains cooperative creamery of Plainview at a meeting of the Castro Council Tuesday in the District court room in Dimmitt.

Two most important characteristics of good cream are fresh and clean. The water separator is unsatisfactory and one loses enough butter fat in using one to buy a dependable separator, Mr. Davis said.

The producer by producing good cream can increase the use of creamery butter. When people know good clean cream is put in butter they will eat more of it. Some people will not eat creamery butter because they know poor dirty cream is sometimes sold to creameries, said Mr. Davis. No person has a right to sell a thing which they themselves will not eat, he continued.

Mr. Davis believes that within the next five years trucks will go by the homes of the producer and get cream twice or three times a week, thus raising the quality of the butter.

The council made plans to send a county exhibit to the Plainview Dairy Show in April, and to the Lubbock Meat Show in March.

Mrs. Bradley, council delegate of Sunnyside gave a report from the Sunnyside club as follows:

February report: 7 asparagus beds prepared, 257 containers of meat, 3 new clothes closets, 2 remodeled clothes closets, 9 rods, 551 feet of shelving, 2 shoe bags and 11 shoe racks, 3 foundation patterns made.

Twenty dollars has been raised for the club treasury.

The meeting adjourned to meet the first Tuesday in April. Bethel, Sunnyside and Easter clubs had 100 per cent representatives at the Council.

Six Per Cent Cut In Dimmitt Fire Rate

A statement showing that the loss ratio of Dimmitt for the years 1931, 1932 and 1933 is 464 has been filed, checked and approved by the State Fire Insurance Board.

Under the provisions for good fire record in cities and towns this record entitles the City of Dimmitt to a credit of 6 per cent on all fire insurance policies written after March 1, 1934.

The old loss ratio was .661 for the years 1930, '31 and '32.

Well Known Farm Expert to Speak Here Saturday

County Agent E. W. Thomas has announced that L. A. Hawkins, well-known farm authority, will speak to farmers here Saturday afternoon in the District courtroom at 2 o'clock.

The meeting is open to everyone and it is hoped that a good many Castro county farmers will take advantage of this opportunity to hear him.

The talk will be upon a subject of timely interest to every farmer in this section.

Must Reduce Acres To Get Crop Loans

Farmers seeking loans from the \$40,000,000 emergency crop fund will be directed in the near future where to apply in their respective communities, stated Wm. I. Myers, Governor of the Farm Credit Administration. Rules and regulations covering such loans will soon be announced. Application forms are now being prepared.

It is required by the law that borrowers, as a condition to receiving an emergency loan, must furnish proof of cooperation with the Agricultural Adjustment Administration. The nature of proof of cooperation will be similar to that recently announced as applicable to other borrowers who apply for loans under the Farm Credit Administration.

Each applicant must obtain clearance through or furnish a certificate of cooperation with the Agricultural Adjustment Administration. The production control associations will make available lists of those who have signed acreage control contracts. Farmers who are on this list, if otherwise eligible to borrow, will be able to obtain loans.

County councils of the production control associations will certify to representatives of the Farm Credit Administration the names of any farmers who, while not signing acreage control contracts, are cooperating by not increasing their production contrary to the acreage control program.

Where county councils have not been set up, Farm Credit Administration representatives will be instructed to make no loans to farmer who are planning to increase production.

For the time being, according to Governor Myers, the various regional emergency crop loan offices will handle the applications for loans from the \$40,000,000 fund, and these offices will be under the immediate direction of the Emergency Crop Loan Division, which is placed under the supervision of the Production Credit Commissioner, S. M. Garwood and the Governor.

'Duck' Boswell For Commissioner Precinct No 3

Politics in Castro county took on new life this week with the formal announcement of Fred (Duck) Boswell, as a candidate for Commissioner from Precinct No. 3.

Mr. Boswell is quite a well-known local business man, having been wholesale distributor for Conoco products here for the past five years and having lived in the county for the past nine years.

"The Commissioner's office is one requiring good business judgment and a sense of fair play," Mr. Boswell said, "and I think I can handle the duties in a way that will be beneficial and satisfactory both to the people of Precinct No. 3 and to all of the county as a whole. I have no promises to make other than if I am elected I promise to give my very best efforts to the job. I shall make no fight on any opponent, but solicit the support of the voters strictly upon my own qualifications."

Child Falls In Boiling Water Death Results

Mildred Jeraldean Whitefield, 15 months old daughter of Mr. and Mrs. H. A. Whitefield, who live 5 miles northwest of Flagg, died here Tuesday evening following burns received when she fell into a tub of scalding water Tuesday about noon.

Mrs. Whitefield was doing some washing in the kitchen and had removed the container of hot water from the stove and placed it on the floor. The child evidently backed into the water while the mother had her back to her. The unfortunate victim was rushed to Dimmitt for medical attention, but over two-thirds of the child's flesh had been severely burned and she survived only a few hours.

Funeral services were held from the Methodist church Tuesday afternoon at 3:30, with Rev. Armstrong in charge assisted by Rev. Alfred H. Freeman.

Interment was in the Dimmitt cemetery and arrangements were in charge of the E. B. Black Funeral home of Hereford.

Let The Rascals Holler

(An Editorial)

Dimmitt people took a whole lot of printed propaganda out of their mail boxes this week carrying the return address of the "Panhandle Conservation Association." Most local people were not familiar with the subject discussed, i. e. the matter of waste in the Panhandle gas field, for most of the gas in the Panhandle is found north of the Canadian River.

According to the purpose announced by the text of the printed matter, the aim of the Association is to conserve one of the Panhandle's greatest resources—natural gas.

That, in itself, is a worthy objective. BUT—Those familiar with the exact situation know that the Association was created by and for the grasping, greedy utilities operators than run the Panhandle natural gas out of this State to northern and eastern points every day.

Up until a year ago they had everything their own way. They took what gas they wanted at the price they wanted to pay. And suffering landowners and leaseholders who had no outlets for their gas could simply "go to ———". The major pipeline companies were draining the oppressed landowners and laughing at 'em. The major companies were asked time and time again to work out some just and equitable solution to the problem. This, they either could not or would not do. This arrogance proved costly. The small operators and landowners took matters into their own hands and by might and main as well as adroit strategy pushed a bill through the Legislature known as the "Sour Gas Bill." Under the terms of this law they can and are processing the gas which they cannot sell to the monopolistic gas pipeline companies.

These little fellows are at last realizing some money from their investments.

To be sure, there is plenty of waste, millions of feet of the stripped gas going into the air daily. But it is far better to waste it that way—according to our notion—than to have the grasping, greedy rascals who own the big outfits to literally steal it while it is under the ground.

Since the "Sour Gas Bill" became a law the big boys have started to holler. You hear plenty about "waste" but you don't hear any sensible solution offered. They offered none when they had things their own way. They offer none now. They simply want their "gravy" back. You'll hear a lot about waste of gas UNTIL the monopolies get their talon-like fingers back in control of it. We are personally opposed to waste of gas as in the case when it is stripped for natural gasoline. But, thus far, it is the only relief that thousands of landowners and leaseholders have. The Sour Gas law was not intended to be a cureall. It's main purpose was to hand that well known "sack" to the major companies. They had been holding it too long. And the first and only thing the big boys have done is to holler.

If the major gas pipeline companies are really in earnest about this thing and they really want to do some conserving let 'em suggest some feasible plan whereby all will profit and none be "the goat."

You may not think that this issue affects you as a resident of Castro county. But it most assuredly does. It affects every citizen of Texas. The main point we want to make is simple: Don't be stampeded by this propaganda that is being circulated by the Panhandle Conservation Association.

PCA LOANS AVAILABLE

Applications for production credit loans to farmers and stockmen in Briscoe, Hale, Castro, Swisher and Floyd counties are now being received by Frank P. Bain, secretary-treasurer of the Plainview Production Credit Association. According to Mr. Bain, all loans will be made on a business basis and according to the security furnished by the applicant.

"The loans that will be made in Castro and the other four counties served by the Plainview Association must be good loans that are collectible if the association is to continue as a permanent service to farmers in this and other counties, as intended," Mr. Bain said.

Each applicant has to state in his application what property he is offering to secure the loan, Mr. Bain said. Security for these loans will consist of first liens on crops, livestock and other personal property on which a lien or chattel mortgage may be taken to secure the loan adequately.

The lien may be taken on property already in the possession of the borrower, or to be purchased with the money borrowed. It is not intended that production loans shall be secured principally by mortgages on real estate. Where this type of security is taken it will be regarded only as additional collateral.

Mr. Bain said that the charges on production loans would be as low as possible in keeping with business credit. A small fee is charged to inspect the property offered as secured by the applicant, but usually no charge will be made for inspection if the loan is not granted.

The minimum amount that can be loaned to any one eligible borrower is \$50.00. The interest rate is 3 per cent above the discount rate of the Federal Intermediate Credit Bank of Houston, and charged only for the actual number of months the loan is outstanding. The present discount rate of the Federal Intermediate Credit Bank is 3 per cent, which would make the rate to the farmer-borrower 6 per cent per annum.
