T. A. Singer has resigned his place on the Castro County Selective Service Board. His service extends back to the beginning of the war work. Another local man will take over his part in the program, and it is no bed of roses, no soft snap. Singer recently stepped down also as active head of the Dimmitt Lions Club, in which position he was a leader in civic matters, always a hard worker for the community. All of which does not mean that T. A. Singer is "quitting." We rather believe he is just getting started good.

County Commissioners have been left with the full load of expense incident to operating the County library. Government help, as expressed heretofore through the WPA, has been withdrawn from Castro County. In line with the new policy, WPA workers are being retained on the government's payroll only in such localities as Amarillo and other centers where there are War projects, or industries closely related to the War effort. Members of the Court met the issue squarely at their meeting last Monday. The county has been contributing \$20 a month with which to buy new books, and the other major item of expense, which is the salary of a librarian, until now has been paid by the government. As a temporary solution, and in order not to deprive the local public entirety of its fine library here, the Court decided to suspend for a time the purchase of new books each month and apply the money thus spent to paying a part-time librarian. The service of the library, therefore, like Coca Colas, will be with us right on, but not quite so often nor so plentiful as before the War.

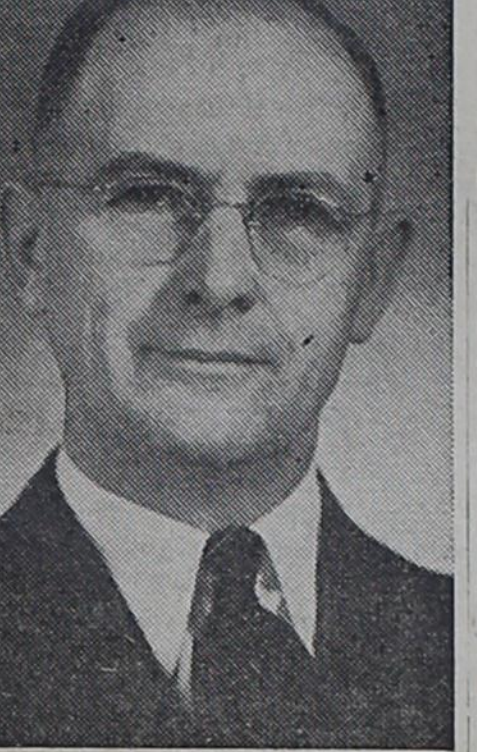

BOND SALES FALL SHORT

Castro County citizens fell down on our War Bond quota for July. Sales totaled \$7,930.25. The July quota was \$9,900.

Sales at the local bank amounted to \$5,118.75, and at the local post office the month's total was \$2,512.50. The shortage is \$1,969.75, which probably will be made up in August, since this month's quota is only \$8,000 and sales since the first have been fairly brisk.

The July quota was first reported over-sold, but the government declined to accept the purchase of \$35,000 worth of bonds by the local bank, and this left other sales totaling less than the quota, and no time left in the month to make up the shortage.

Dimmitt Lions Go After Project Near County Line

Dimmitt Lions Tuesday launched a preliminary effort to obtain a share of recognition in the government's \$2,000,000 war prisoners' internment camp now under construction near here—in Castro County.

Civic leaders see in the project an opportunity for priority purchase of road materials, which may mean more hard-surfacing of highway 51 both in Castro and Deaf Smith Counties. The camp, a war emergency project, can be reached only by travel over road 51 and road 51 is not entirely finished in either Castro or Deaf Smith.

Then there is the matter of branch roads leading from the state highway for three or more miles to the camp property.

The club is undertaking the job of cooperating speedily and practically, and already has a committee ready to go to Austin, Washington, or anywhere else to help effect results.

Transportation, housing, feeding, lodging, and otherwise caring for the workers, the office force, and partially looking out for the soldiers who will be stationed near Dimmitt, or perhaps in Dimmitt, also is to be thought about.

T. A. Singer, P. L. Cunningham, Stub Jones, Ernest Harmon, and other active Lions are at work on the undertaking.

A resolution to back the Castro County Commissioners in their efforts along the same line also was unanimously adopted by the club Tuesday.

Wheat Farmers To Meet Saturday And Judge Seed

Wheat farmers will attend an interesting and informative meeting in Dimmitt Saturday, at which time experts in judging seed wheat will be in attendance and offer advice and judging free to those who wish.

There is known to be a large amount of good seed wheat in the county, including more than one popular variety, and its purity for planting purposes always is a matter of first importance to both the seller and the buyer.

The meeting will be held at the court house, beginning at nine in the morning. Growers are advised to bring in samples of their wheat in not less than pound packages. Judging and testing for purity of breeds, as well as information on wheat diseases, will be given.

"UNCLE" FRANK AXE HAS A NICE CROP OF SPUDS

Castro County potato growers are in the midst of their digging operations. The spuds are yielding from 100 to 150 sacks to the acre.

The editor, in company with the county agent, M. U. May, went to the farm home of "Uncle" Frank Axe, 15 miles north of Dimmitt, Tuesday and witnessed one of the potato digging machines in operation.

"Uncle" Frank came to the county from Hill County in 1903, and says he and a neighbor who is almost as hardy dug Frio Draw.

But Mr. Axe hasn't been growing potatoes very long. He says the biggest hazard is in not knowing when or how to water the crop. There are plenty of other risks.

Mr. Axe is one of the smaller potato growers. He has 17 acres in white cobbler, and will make a nice profit. He also has some fine cotton, and a good feed crop.

News Sponsors Navy Program

Enough men to equal the crews of a submarine and a sub chaser now building will be enlisted from Amarillo Navy recruiting district each month during August and September, Chief C. M. Norman, recruiter in charge of this district, has announced.

The district includes Castro and 24 other Panhandle counties.

Sponsoring the campaign to enlist at least 195 men each month will be American Legion Posts and civic organizations in each of the 25 counties. In Castro County The Castro County News is sponsoring the local Navy recruiting.

Navy enlistment ages now are from 17 to 50 years. Unskilled men have opportunity to attend Navy trade schools. Qualified skilled men may be enlisted as petty officers with monthly pay ranging from \$78 to \$126. It is necessary that application for enlistment be made before induction into the Army.

Mr. Reed, S. W. Lilley of Nazareth, and County Agent M. U. May, visited all the farms in the county where the registered cattle are located, including the farms of J. O. Ayers, G. D. Caison, Frank Huseman, Pete Coke, S. W. Lilley, and T. R. Davis. Mr. Reed expressed surprise when he saw the exceptional growth and the fine condition of the young cattle, and remarked upon the wonderful grass and good feed in this county which made this possible.

Frank Huseman of Nazareth is planning to get a bull from Reed and Butler at Trenton, from one of the most outstanding sires in the United States, and which will be another forward step Castro County farmers are making in the direction of becoming a better dairying section, according to the county agent, M. U. May.

May said dairy cattle in Castro County are being improved each day, which will mean the county can and will do more in producing milk.

Navy who are assigned to duties in State Institutions of higher education.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 33 of Article 16, of the Constitution of the State of Texas, be amended so as to read as follows:

"Section 33. The accounting officers of this State shall neither draw nor pay a warrant upon the Treasury in favor of any person, for salary or compensation as agent, officer or appointee, who holds at the same time any other office or position of honor, trust or profit under this State or the United States, except as prescribed in this Constitution. Provided, that this restriction as to the drawing and paying of warrants upon the Treasury shall not apply to officers of the National Guard of Texas, the National Guard Reserve, the Officers Reserve Corps of the United States, nor to enlisted men of the National Guard, the National Guard Reserve, and the Organized Reserves of the United States, nor to retired officers of the United States Army, Navy, and Marine Corps, and retired warrant officers and retired enlisted men of the United States Army, Navy, and Marine Corps, nor to officers of the United States Army or Navy who are assigned to duties in State Institutions of higher education."

Each voter shall scratch out one of said clauses on the ballots, leaving the one expressing his vote on the proposed amendment.

Sec. 3. The Governor shall issue the necessary proclamation for said election, and have the same published as required by the Constitution and laws of this State, and the sum of Five Thousand (\$5,000.00) Dollars, or so much thereof as may be necessary, is hereby appropriated from any funds in the State Treasury, not otherwise appropriated to defray the expenses of printing said proclamation and of holding said election.

—Castro County business firms this week mailed the following messages to their credit customers in order to inform them of the government's new regulations pertaining to charge accounts.

About Regulation "W"

REGULATION "W," you know, is the emergency measure which has been imposed upon credits and credit practices as an anti-inflationary move. Copies of the ruling have appeared in print and also have been discussed in radio newscasts, but in plain Panhandle language, what it means to us and to our charge customers is this:

FIRST—You won't receive your statement as early as heretofore. We will be required to post charges and credits THRU the last day of the month, so we can't mail your bill until the first of each month.

SECOND—It will in no way affect the big majority of our patrons who pay their accounts in full regularly each month.

THIRD—Regulation "W" requires that no open account shall run longer than the 10th of the second month following date of purchase. This means that charges made during July, for instance, should be paid during August, but MUST BE PAID by September 10 if the account is to remain open to further charges.

FOURTH—Balances now existent are due and payable on or before August 10. In case you cannot pay your account in full by that date, you will please call at our office and we will arrange an instalment deal whereby we can adjust this without undue hardship either to you or to ourselves.

PLEASE REMEMBER THAT THE MERCHANT IS NOT MAKING THE RULES—HE MUST CONFORM TO THEM.

NOTICE:

The Federal Reserve Bank has ordered restrictions placed on all charge accounts. Under this new ruling, with which we must comply, no further credit can be extended on an account that has a past due balance of 40 days.

It also is necessary to list all past due accounts; therefore, we are calling your attention to your balance which we urgently recommend that you take care of at once or make some provision to liquidate it in accordance with the new law. We are only too glad to assist you in every way we can.

A JOINT RESOLUTION proposing an Amendment to Article V of the Constitution of Texas as by providing that the Legislature shall have the power by local or general law, in counties having a population in excess of two hundred thousand (200,000) inhabitants to create other courts having exclusive jurisdiction or concurrent jurisdiction with the county court in civil, criminal or probate matters; fixing the time for an election therefor; prescribing the form of ballot; providing for a proclamation of such election and the advertisement thereof; and making an appropriation therefor.
BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. Article V of the Constitution of the State of Texas be amended by adding thereto a new section to be known as Section 22-a and reading as follows:
"Section 22-a. The Legislature shall have the power, by local or general law (without the necessity of advertising any such local law), in counties having a population in excess of two hundred thousand (200,000) inhabitants according to the then last Federal Census, to create other courts having either exclusive jurisdiction or concurrent jurisdiction with the county court in civil, criminal or probate matters."

Section 2. The foregoing Constitutional Amendment shall be submitted to the qualified voters of the State of Texas at a special election to be held on the first Tuesday after the first Monday in November, 1942, at which time all voters favoring such proposed Amendment shall have written or printed on their ballots the following:
"For the Amendment to the Constitution, providing that the Legislature may in certain counties create other courts having either exclusive jurisdiction or concurrent jurisdiction with the county court in civil, criminal or probate matters."
Those voters opposed to such Amendment shall have written or printed on their ballots the following:
"Against the Amendment to the

Constitution, providing that the Legislature may in certain counties create other courts having either exclusive jurisdiction or concurrent jurisdiction with the county court in civil, criminal or probate matters."

If it appears from the returns of said election that a majority of the vote cast is in favor of the Amendment, the same shall become part of the Constitution of the State of Texas.

Sec. 3. The Governor of the State is hereby directed to issue the necessary proclamation for said election and to have it published as required by the Constitution and existing laws of this State.

Sec. 4. The sum of Ten Thousand Dollars (\$10,000) or so much thereof as may be necessary is hereby appropriated out of the State Treasury not otherwise appropriated to pay the expenses of said publication and election.

A JOINT RESOLUTION

proposing an amendment to Article III of the Constitution of the State of Texas by adding a new section thereto to be known as Section 49-a, requiring all bills passed by the Legislature on and after January 1, 1945, appropriating money for any purpose, to be sent to the Comptroller of Public Accounts for his approval, and fixing the duties of the Comptroller with reference thereto; authorizing the Legislature to provide for the issuance, sale, and retirement of serial bonds, equal in principal to the total outstanding, valid, and approved obligations owing by the General Revenue Fund on September 1, 1943; providing for the submission of this amendment to the voters of this State; prescribing the form of ballot; providing for the proclamation and publication thereof; and providing for the necessary appropriation to defray necessary expenses for the submission of this amendment.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article III of the Constitution of the State of Texas be amended by adding thereto, immediately after Section 49, a section to be known as 49a, to read as follows:

"Section 49a. It shall be the duty of the Comptroller of Public Accounts in advance of each Regular Session of the Legislature to prepare and submit to the Governor and to the Legislature upon its convening a statement under oath showing fully the financial condition of the State Treasury at the close of the last fiscal period and an estimate of the probable receipts and disbursements for the then current fiscal year. There shall also be contained in said statement an itemized estimate of the anticipated revenue based on the laws then in effect that will be received by and for the State from all sources showing the fund accounts to be credited during the succeeding biennium and said statement shall contain such other information as may be required by law. Supplemental statements shall be submitted at any Special Session of the Legislature and at such other times as may be necessary to show probable changes.

"From and after January 1, 1945, save in the case of emergency and imperative public necessity and with a four-fifths vote of the total membership of each House, no appropriation in excess of the cash and anticipated revenue of the funds from which such appropriation is to be made shall be valid. From and after January 1, 1945, no bill containing an appropriation shall be considered as passed or be sent to the Governor for consideration until and unless the Comptroller of Public Accounts endorses his certificate thereon showing that the amount appropriated is within the amount estimated to be available in the affected funds. When the Comptroller finds an appropriation bill exceeds the estimated revenue he shall endorse such finding thereon and return to the House in which same originated. Such information shall be immediately made known to both the House of Representatives and the Senate and the necessary steps shall be taken to bring such appropriation to within the revenue, either by providing additional revenue or reducing the appropriation.

"For the purpose of financing the outstanding obligations of the General Revenue Fund of the State and placing its current accounts on a cash basis the Legislature of the State of Texas is hereby authorized to provide for the issuance, sale, and retirement of serial bonds, equal in principal

"For the Amendment to the Constitution of the State of Texas, requiring appropriation bills passed by the Legislature to be presented to and certified by the Comptroller of Public Accounts as to available funds for payment thereof, limiting appropriations to the total of such available funds, providing for issuance of bonds to pay off State obligations outstanding September 1, 1943, and fixing the duties of the Legislature and Comptroller of Public Accounts with reference thereto."

Those opposing said proposed Amendment shall write or have printed on their ballots, the words:

"Against the Amendment to the Constitution of the State of Texas, requiring appropriation bills passed by the Legislature to be presented to and certified by the Comptroller of Public Accounts as to available funds for payment thereof, limiting appropriations to the total of such available funds, providing for issuance of bonds to pay off State obligations outstanding September 1, 1943, and fixing the duties of the Legislature and Comptroller of Public Accounts with reference thereto."

Sec. 3. The Governor of the State of Texas as hereby directed to issue the necessary proclamation for said election and have same published as required by the Constitution for amendments thereto.

Sec. 4. The sum of Five Thousand Dollars (\$5,000.00), or so much thereof as may be necessary, is hereby appropriated out of any funds in the Treasury of the State of Texas, not otherwise appropriated, to pay the expenses of such publication and election.

LEGAL NOTICE

S. J. R. No. 2—

A JOINT RESOLUTION proposing an amendment to the Constitution of the State of Texas authorizing the Legislature to appropriate Five Hundred Thousand (\$500,000) or so much thereof as may be necessary to pay the debt incurred by John Tarleton Agricultural College for the construction of a building on the campus of such college pursuant to the authorization by the Governor of Texas on August 31st, 1937.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article 3 of the Constitution of the State of Texas be amended by adding thereto a new section, as follows:

Section 49-b. The Legislature may provide by law for the issuance of not more than Two Million Dollars (\$2,000,000) in bonds or obligations of the State of Texas to the Permanent School Fund for the construction in the City of Austin of a State office building or buildings, and the State Board of Education is hereby directed to invest not more than Two Million Dollars (\$2,000,000) of the Permanent School Fund therein. Such bonds shall be executed on behalf of the State of Texas by the Governor and Comptroller, and shall bear a rate of interest not to exceed three (3) per cent per annum, payable annually; they shall be of such denomination as may be prescribed by law, and shall be payable in not to exceed twenty-five (25) equal installments beginning one (1) year from date of issuance; and the State Treasurer is hereby authorized and directed to set aside into a special fund annually at the beginning of each fiscal year until all of said bonds shall have been paid off and discharged, a sufficient amount of the first moneys coming into the Treasury for the use and benefit of the General Revenue Fund not otherwise heretofore obligated to the payment of bonds and interest, a sufficient amount to pay the interest becoming due and the bonds maturing during such fiscal year. From said fund, the Treasurer shall pay the interest on said bonds as it comes due, to the credit of the Available School Fund; and shall pay off said bonds as they become due and deposit the amounts so paid to the credit of the Permanent School Fund. The power hereby granted to issue bonds is expressly limited to the amount stated and to five (5) years from and after the adoption of this grant by the people.

Sec. 2. The foregoing Constitutional Amendment shall be submitted to the qualified voters of the State of Texas at an election to be held on the third day of November, 1942, at which election all voters favoring each proposed Amendment shall write or have printed on their ballots the words: "For the Amendment to the Constitution of the State of Texas authorizing the investment of not more than Two Million Dollars (\$2,000,000) of the Permanent School Fund in bonds of the State of Texas to be issued for the construction of a State office building or buildings and providing for the repayment of the said sum of money to the Permanent School Fund."

Sec. 3. The Governor of the State is hereby directed to issue the necessary proclamation for said election and have the same published as required by the Constitution and existing laws of the State.

Sec. 4. The sum of Eight Thousand Dollars (\$8,000), or so much thereof as may be necessary, is hereby appropriated out of any funds in the Treasury of the State not otherwise appropriated to pay the expenses of said publication and election.
