Higgs, Richardson, Greer take honors

Rev. Joe Higgs, Helen Richardson, and Nancy Greer were honored as Dimmitt's top citizens at last Thursday's Dimmitt Chamber of Commerce banquet at the County Expo Building.

Over 425 persons were on hand for the banquet keynoted by Jack Jackson.

Higgs, minister of music and education at First Baptist Church, was honored as Citizen of the Year for "bringing us all together spiritually," said presenter Deanne Clark.

"Denomination is insignificant to him."

Higgs has been active in the Dimmitt Lions Club, American Cancer Society, Booster Club, American Field Service, the Community Concert Association, Harvest Days Follies, Booster Club, Castro County Ministerial Alliance (serving as president of the organization), and has helped head the spring CUFUPU campaign and the Mayor's Beautification Council, along with counseling and ministering to the entire community.

Mrs. Richardson, presented by Hal Ratcliff (one of her former pupils and now Friona High School principal), was named Citizen Through the Years. She was named the Citizen of the Year in 1966, and served 42 years in Dimmitt as a teacher and principal. In 1975, after her retirement, South Elementary School was renamed Helen Richardson Elementary School.

Ratcliff told the gathering Mrs. Richardson is a member

of the American Legion Auxiliary, Eastern Star, Wesleyan Guild, was a charter member of the Castro County Historical Museum, and is a member of First United Methodist Church.

"She has taken part in all of the activities the town and county have had," Ratcliff said. "She has served on many boards, and usually, they beg her to please keep serving with them after her term expires."

Mrs. Richardson was also named one of the Outstanding

Women in the Panhandle in 1976.

Miss Greer, named Teacher of the Year, is currently serving as president of the local Classroom Teachers Association. During her 18 years in Dimmitt, she has coached girls athletics and physical education, and has taught health, Texas history and driver's education.

She has also been a class and cheerleader sponsor.

Special recognition awards went to Plains Memorial Hospital, winner of the first annual Mayor's Beautification Council Award; the Dimmitt Police Dept., for their work

with the Health Fair, finger-printing school-age children, Christmastime downtown foot patrols and Operation Blue Christmas to help needy families; and American Fructose Corp. for their assistance with Dimmitt's Christmas decorations.

Outgoing Chamber president George Sides passed the gavel to new president Gene King. The new vice-president for 1985 is Doug Pybus, and Martha Hyman takes over as board secretary.

Sides, Clara Patton, Arlie Petty and George Lamberth are all retiring from the board.

Workers, TRLA win \$60,000 award

31 Rio Grande Valley farmworkers have been awarded \$60,000 in connection with a class-action lawsuit against Western Food Products Co. of Dimmitt.

Federal district court Judge Ricardo Hinojosa of Brownsville ruled last Wednesday in favor of the workers, all employed by Western Food in the Dimmitt-Hereford area in 1983.

The suit was filed by the workers in 1983 through the Texas Rural Legal Aid office in Hereford. Attorneys there notified the clients of the ruling Monday.

Hinojosa also certified for class action an injunctive relief against the company, which has operated a cucumber handling facility in Dimmitt since the late 1960s, to be effective for three years.

Under the injunction, Western Food must assume full responsibility for the laborers it contracts to work in fields, and must assure paying the workers the equivalent of minimum wage, \$3.35 an hour.

If the workers are primarily paid by a farmer or another contractor, the company must, under Hinojosa's order, supplement the wages to bring them up to at least minimum wage.

Western Food is also required to keep accurate payroll records on all fieldworkers, and pay social security benefits on the worker's behalf.

Hinojosa also ordered Western Food to insure adequate toilet, drinking and

handwashing facilities for the fieldworkers at all times, and insure that disclosure forms setting forth the terms and conditions of work, how long the work will last, the amount of work to be done, and any benefits, are provided to the workers.

"There are 300 to 400 workers that are covered by the injunctive relief," said TRLA attorney Randall Mar-

CC Grain bought by Dimmitt Agri

In a move seen to strengthen its holdings, Dimmitt Agri Industries has purchased Castro County Grain Co. of Dimmitt. The agreement had been in the mill since December, and was consummated last Thursday, adding 2.2 million bushels to DAI's capacity.

"We listed the elevator as being for sale last month," said Bill Gregory, co-owner of CCG. "DAI showed immediate interest in our facility. We had some other offers, but DAI had a closing date they wanted to meet. Most of the other offers

really came too late to consider."

The Gregory family has had interest in CCG since 1943, when the late A. E. (Jack) Gregory purchased an interest in the facility from C. O. Byrnes. Gregory purchased CCG outright in 1943 after buying the interests of Byrnes, W. E. Harman and W. R. Hackleman.

The current concrete facilities were built in 1958, after a 1957 train-butane truck collision and resulting fire destroyed the old facilities.

The purchase of CCG marks the third time DAI has expanded by purchasing existing elevators in Dimmitt. In 1961, the old Dimmitt Wheat Growers purchased the Dimmitt Gin and Elevator in south Dimmitt, and, in 1979, DAI bought W&C Elevators, immediately south of CCG.

"The acquisition of CCG brings our total capacity to 8.6 million bushels," said DAI general manager Bill Clark. "We really didn't have any immediate plans to do something like this, although we were looking at something like it in our long-range plans."

"CCG really fit like a glove for us," Clark continued. "We have been sharing joint railroad trackage, and their location (across the street, north of the main DAI facilities) really fit into our operations."

Clark also said that all CCG employees have been hired by DAI.

Clark scotched rumors that DAI may have been forced into the acquisition to provide more corn storage for American Fructose.

"They haven't forced us," Clark said. "They do have expansion plans in mind, though, and there will be a need for more storage capacity. When they expand, they will place greater demands on us, I'm sure."

"We really had mixed emotions about placing CCG on the market," Gregory said, "and we still have mixed emotions today."

Gregory said he and his brother, Don, will maintain their seed dealership; however, they will be selling their fertilizer equipment next month.

DPS STEPping on DWI's

Department of Public Safety officials say they are pleased with the first month of the Selective Traffic Enforcement Project (STEP), and will continue the program in Castro and Randall counties through the end of August, 1985.

STEP is designed to curb driving under the influence of alcohol. Castro and Randall

counties were selected for the project after a Texas A&M study commissioned by the DPS showed a higher than usual DWI rate in the counties.

During December, 23 troopers from the Panhandle-South Plains region have worked many early morning hours and driven hundreds of miles, working on their days off with specific instructions to detect

and apprehend DWI suspects. They are being paid through a special funded \$144,000 grant through the office of the Traffic Safety of the State Dept. of Highways and Public Transportation.

In Castro County, troopers working with the STEP program made 77 arrests, with 11 DWI arrests. 104 arrests were

made in Randall County, including 18 DWI arrests. Those figures are on top of those made by regular patrols.

Sgt. Harold Price, who oversees the Castro County project, said, "Even though we are out in force, we know we will never be able to apprehend all intoxicated drivers. However, if we can convince people that there will be serious consequences for those who drink and drive, it should go a long way toward solving the problem."

Four Bobcats scored in double figures, led by Jim Nelson with 19. Blaine Gregory came off the bench to add 15, while Brad Buchanan scored 14 and

Jerry McMillon 12.

The ninth-grade Bobbies could have earned a spot in the finals, "but we didn't play well at all in the middle quarters against Tulia," said coach Roy Dudgeon.

The Bobbies had an easier time, though, in the third place game with Littlefield Saturday evening.

"Our floor play was much better against Littlefield," Dudgeon said. "We didn't have people standing around like they were against Tulia."

Brandy Lowe led the Bobbies in the third place game with 22 points. Britney Lowe added 15.

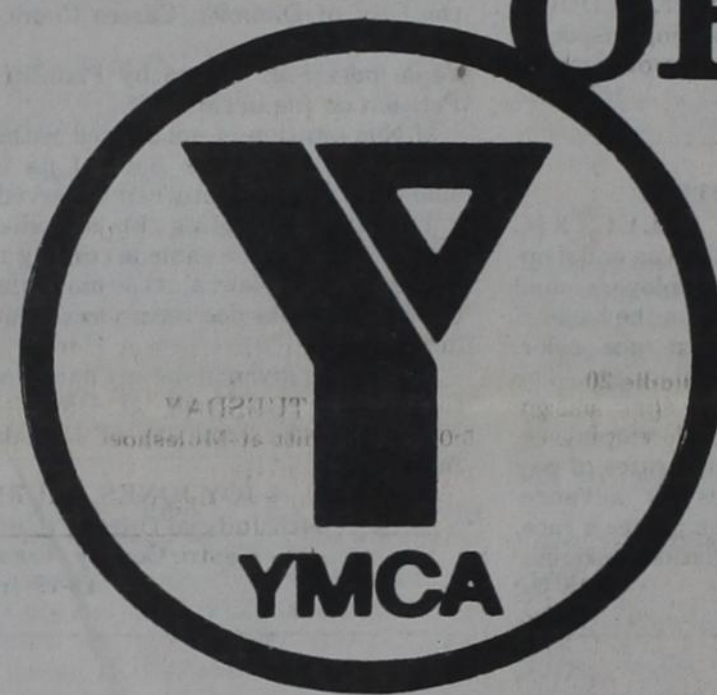
Nazareth's Swiftettes maintained their number-one rating in Class A, with their unbeaten streak now at 55.

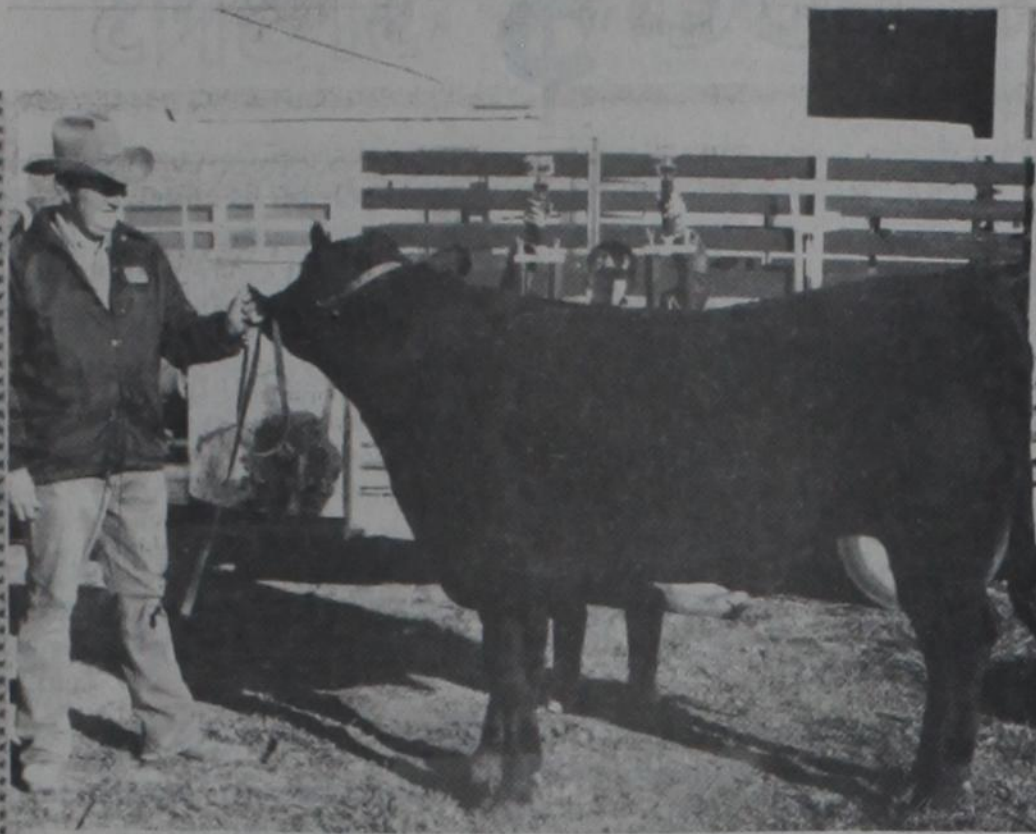

shall of Hereford. "20 of the workers were recruited from the Valley, while the other 11 were from the Laredo area. They worked for Western Food in contracted fields in 1983. Suit could have been filed against the farmers as well, but we opted not to do so.
"We filed the suit in Brownsville because that is the district in which the workers were hired," Marshall explained.
Western Food officials declined to comment on the action.

Aldermen delay airport action

Dimmitt city aldermen Monday delayed any action on the proposed new rules and regulations for the Dimmitt Municipal Airport, seeking further public comment at their Feb. 4 meeting.
A dozen pilots met with the aldermen Monday to discuss the changes, most of which had been proposed by the airport board, made up of pilots and city officials. The board met several times over the past few months to look over Federal Aviation Administration rules, and set up some customized regulations meeting local needs.

"Some of the rules, as stated in this proposal, were supposed to have been deleted or changed," said Buster Tidwell, airport board chairman. Several of the changes concerned agricultural flying, which is granted several exclusions by the FAA, but the changes were not made by City Manager Paul Catoe when he prepared the proposals.

Bob Lassiter of Dimmitt Aerial Spraying opposed the three-year lease agreement limit for land for businesses at the airport.

"Dimmitt Aerial is currently operating under an eight-year agreement," Lassiter said. "We would be reluctant to do anything on a more permanent basis if we can't lease anything for more than three years."

The aldermen also authorized the closing of the east-west alleyways in Blocks 30 and 56, around Dimmitt Agri Industries, and authorized quit-claim deeds for portions of Andrews, Etter, and Northeast Fourth Streets on the former Castro County Grain property.

DAI attorney Jimmy Ross said the streets were closed by the city as far back at 1939, but no quit-claim deeds were ever issued by the city.

No representative appeared on behalf of the Mayor's Beautification Council. Mayor Wayne Collins said the Council was listed on the agenda because a representative "told me they wanted to discuss some projects to spruce up the traffic 'islands' on West Highway 86 and South Highway 385."

The item was tabled indefinitely.

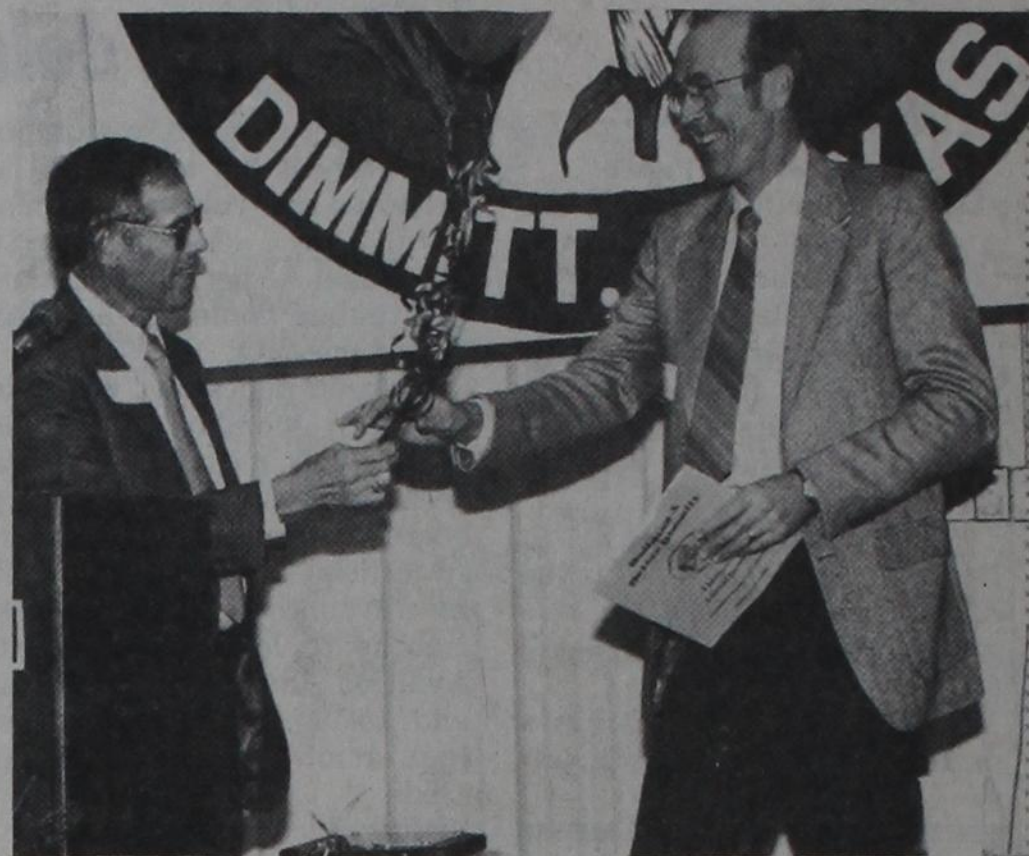
