## LISTEN TO LUKE

A fellow publisher neighbor recently had quite a bit to say concerning his opinion of the federal aid that the school there was getting. His remarks followed our opinion right down the line.

The next week he published a letter from the superintendent of the school there berating him for stepping out of line as a publisher into the role of educator and being out of place completely.

The fact that the superintendent had stepped out of line as an educator and into the role of an expert on finances indicated that it is difficult for us all to walk the straight and narrow all the time.

One thing that the superintendent said that we must go along with is: "I do not know where the funds will come from other than the Federal Government who will have to assume this responsibility if the local people do not".

This is the key to the whole system --- the local people do not want to take the responsibility and the government steps in and does and then the people do not like the governmental control.

Because of the fact that I am a citizen of this country and a tax payer I feel that I have the right to speak my piece about the way the money is being spent, and because I am in the newspaper business and feel that this federal aid to education is wrong, I feel the obligation to talk about it.

Tax money is the source of support of the schools and I am all for it, but I think the tax money should be raised and spent as close to home as is possible.

It's bad enough that we are treating our children the way we are in giving the bills of this era to future generations. And what is worse, we are building for them a governmental system that can't work except at the cost of human freedom. And we are doing this with the attitude that the Federal Government is the "big daddy" to us all and is there only to supply our needs.

Show me a single federal welfare program that has dropped in cost over the years. Show me a single government agency that has decreased in size, in extent of authority, in program. Show me a single bureau of the government that has accomplished its goal then gone out of business and then lessened its demand on our tax money.

I completely respect the privilege of any person to disagree in principle or in fact, and I respectfully request the same privilege.

When a newspaper man gripes about a federal aid program, it is no different than a railroad man, or a filling station employee, or a ranchman doing the same thing. If a minister preaches only against sin, then sin in government circles comes within his jurisdiction. But since when is all the preaching supposed to be done by the minister only?

Just in case anyone should ask me, the pulpit has too long been

**WASHINGTON — U. S. Rep. Richard White of El Paso formally announced Monday his candidacy for a second term in the House.**

White, 42, said he will file immediately for the Democratic primary in each of the 12 counties in the revamped 16th Congressional District.

In announcing his candidacy for re-election, the West Texas Congressman said: "Terrell County and the surrounding West Texas area have made important gains during the first year of my term, but there remains much to be done. A prime item is flood control. \$20,000 is contained in the new Federal budget for the Army Engineers to initiate a flood-control study to prevent a disaster such as occurred in 1965. I was glad that I could immediately call upon the government to cooperate with the people of West Texas in alleviating the damage and suffering.

The freshman lawmaker was rated a moderate supporter of President Johnson's program, both domestic and foreign policy, in last year's session. A survey by Congressional Quarterly showed that White voted with the administration 64 per cent of the time on 112 roll calls in

## Large Group Attends Meeting On Doctor Acquisition For County

Between 250 and 300 people were at the courthouse Monday night to hear John R. Sedgwick, consultant for the Sears-Roebuck Foundation and the American Medical Association, tell of possibilities of acquiring a physician for the county.

Mr. Sedgwick came to Sanderson at the request of the Rotary Club and the Terrell County Chamber of Commerce after a survey in the town had determined the feasibility of the participation by the Foundation.

Under the Foundations leadership and guidance, a plan can be worked out so that by mutual participation of the county and the Foundation, a maximum effort can be exerted to secure a doctor and medical center for the county.

The plan would bring in the participation of the citizens of the county by subscribing to the cost of the building, the Foundation by getting the non-profit organization started, selling shares, offering plans for the building, and a concerted effort to acquire the services of a physician who would be responsible for furnishing his own equipment for the medical center.

After hearing the proposals as set forth by the representative of the Foundation, a vote was taken to determine the interest and there was no dissenting vote cast by any of those present.

After the meeting, Mr. Sedgwick left some literature with the local organizations to show steps to be taken in organizing for the fund drive, and another man from the Sears-Roebuck Foundation would come out and

The deadline for filing for all offices in the county, state, and nation ended at midnight Monday.

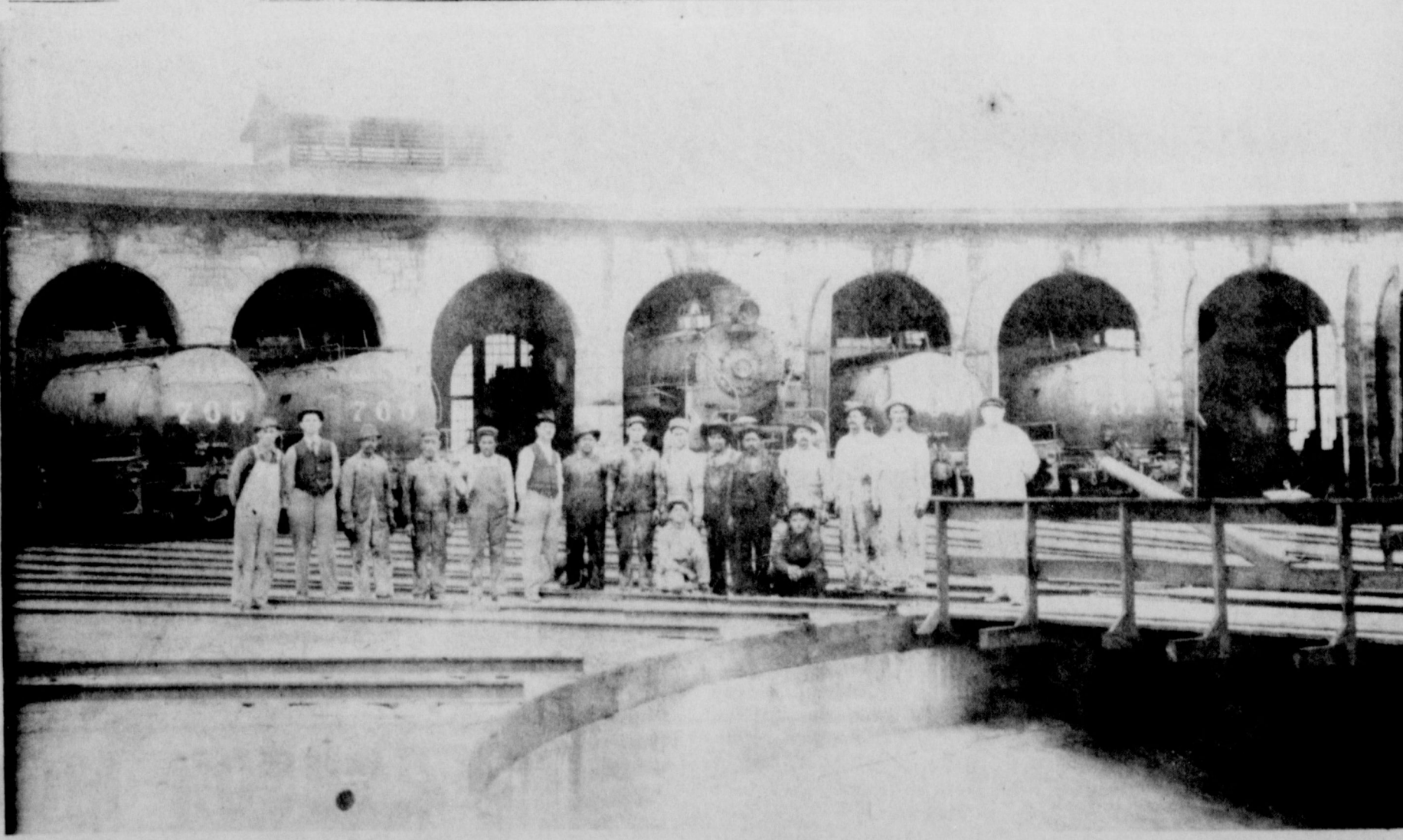
The only opposition locally is in the race for Justice of the Peace of Precinct 1. J. A. Gilbreath, incumbent, has as his opponent, W. G. Shoemaker, a former railroad employee who now operates a service station.

On the state level: Dorsey B. Hardeman and W. E. (Pete) Snelson are opposed to each other in the race for State Senator brought about by the re-districting by the legislature recently. Both are now incumbents.

Others on the ballot will be: Gene Gendryx of Alpine for representative to the state legislature from this district; R. S. Wilkinson for county judge; Ruel Adams for county clerk; Mrs. Ginette Litton for county treasurer; Austin Chriesman for commissioner of Precinct 2 and C. M. Turk for commissioner of Precinct 4. Carlos Dunn has announced for re-election as the Democratic County Chairman, and Mrs. H. E. Ezelle as Democratic chairman of Precinct 1.

It will also be necessary for voters in Precincts 2, 3, and 4 to name Democratic chairmen as that group makes up the Democratic Executive Committee in the county.

## ... about your SOCIAL SECURITY.....

Many persons in this area who are 65 or older are eligible for Medicare, but are not aware of this fact, stated H. P. Thomas, district manager of the Odessa Social Security Office. These persons need to enroll in the program now.

"We know about the folks who are over 65 and are on the social security rolls. We have been informed about those who are on the railroad or civil service retirements lists as well. Through the cooperation of the State Department of Public Welfare and with the assistance of the local public assistance worker, we are enrolling persons receiving State Old-Age Assistance, so," said Thomas.

"Most important at this time," Thomas continued, "is the need to locate and enroll now any individual age 65 or over who do not fall into any of the above situations. Remember that eligibility for Medicare enrollment is age only. Work, earnings, income, or present health are not considerations for enrollment."

"All readers need to be aware that they or their relatives or friends who are 65 or older are eligible for Medicare, and they need to enroll now. Write Odessa or see the social security representative when he is in your area. The schedule of visits is displayed at the post office."

## J. S. Income Tax Questions, Answers

Editors Note: This column of questions and answers on federal tax matters is provided by the local office of the U. S. Internal Revenue Service and is published as a public service to taxpayers. The column answers questions most frequently asked by taxpayers.

Q—A girl in the restaurant where I work told me that tax will be withheld on tips starting the first of the year. If that's right, how will it be done?

A—Changes in the Social Security laws made Congress this year call for the withholding of income taxes on tips in 1966 and thereafter. Those who receive tips of \$20 or more a month should report the amount of their tips to their employer within 10 days after the month in which they were received.

Tips have always been taxable but until the law was changed they had not been subject to withholding. Now tips will be on a pay-as-you-go system just like income from wages and salaries.

Another change in the law affecting tips is the inclusion of this income in total wages for social security purposes. In other words, your tip income can now count toward determining your social security benefits.

Q—I just made a pledge to my church's capital fund drive. Will I be able to deduct this on my 1965 return?

A—You may only deduct what you actually paid on this pledge in 1965.

Q—My wife has been doing some part-time selling for the holidays. If she files her own return will I still be able to claim her as a dependent?

A—No, you may not. The wife is not considered to be a dependent of the husband, and when one of them files separately the other is not permitted to file a return and claim exemptions for both. Under Community Property Law in Texas you must split the income of both spouses if you file separate returns, since each

spouse is entitled to one half of the community income under the law. Ordinarily you would file a joint return.

Q—I turned 65 in November. How should I handle the medical bills I paid last Spring? Are they fully deductible or are they subject to the 3 percent floor?

A—Your age on the last day of your taxable year is the determining factor. Since you reached age 65 in November and you file on a calendar year basis, any medical expenses you paid last Spring are subject to the provisions for those 65 and over. Therefore, they will be fully deductible.

Q—I am retired and have no taxable income. Can I still file a joint return with my wife who is still working?

A—Yes, you may. In fact in Texas (a community property State) you not only can but probably should as Texas law specifies that salaries are community income and legally therefore you do have income.

Q—Why is my wife's Social Security number so important on a joint tax return? Most of the income comes from my salary.

A—According to the law, your wife should show her account number on your joint return if she had: 1) separate gross income of \$600 or more, or \$1200 or more if she was 65 or more before the end of the taxable year, or 2) self-employment income, or 3) separate income, such as wages, dividends, or interest, paid to her which the payer is required to report on a return or statement of information.

If the necessary account numbers are not on a return the matching can not be done, necessitating correspondence with the taxaver. Failure to include your wife's number will delay the processing of your return and any refund due.

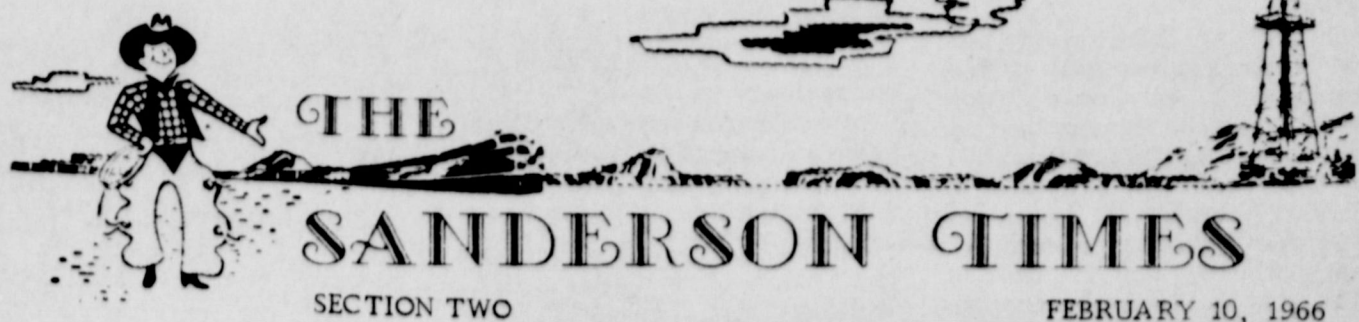
Q—When can I start excluding sick pay?

A—There are two rules governing when and how much sick pay may be excluded from income for federal tax purposes.

First, if the amount you receive as sick pay is more than 75 per cent of your weekly rate of pay, there is a 30 day waiting period before you are entitled to a sick-pay exclusion.

If the amount you receive is 75 per cent or less, the waiting period is 7 days unless you are hospitalized for at least one day during your absence from work. In that event, there is no waiting period. The exclusion is limited to \$75.00 per week for the part of the first 30-day period in which you are entitled to the exclusion. After that, it becomes \$100.00 per week.

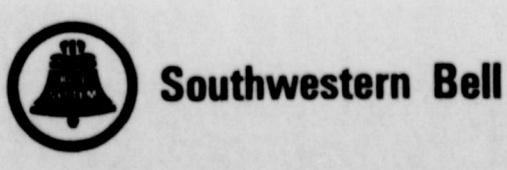

'Gene was loved and admired by everyone, as was evidenced by the crowds who thronged to pay their last respects.



which Johnson took a stand.

White also racked up a perfect attendance score in his maiden session — answering every roll call and quorum call, the only gauge for judging a congressman's attendance.

He is a member of the House Committee on Interior and Insular Affairs and the subcommittees on National Parks and Recreation, Irrigation and Reclamation, and Indian Affairs.

White is the author of legislation to establish two more national parks in West Texas — Guadalupe Mountains National Park in Culberson County and Chamizal National Memorial in El Paso.

He said during his first year in the House facilities were increased at Big Bend National Park and Fort Davis National Historic Site. His objectives also include an airport for the Big Bend.

Working with other West Texas congressmen, White helped get a \$200,000 appropriation for initial study of the West Texas Water Supply project, which would bring East Texas water to western portions of the state.

White also is author of legislation aimed at rehabilitating Red Bluff Irrigation project on the Pecos River. He is seeking government studies of desalination processes.

"While I am pleased with the advances in my district in my first year in office, there are

many major projects which I would like to follow through to a successful conclusion," he said.

He mentioned flood control projects for El Paso, Alpine, Sanderson and Presidio and federal buildings for Midland and El Paso.

White is a Marine combat veteran of World War II. He and his wife have three sons — Rodrick, 14, Richard, 12 and Raymond, 10.
