This doesn't mean that no one is doing anything. It just means that there have been no results to be reported as yet.

The committee continues to get lists of available doctors in the nation from the Sears-Roebuck Foundation, but those lists continue to yield nothing.

Yes, it is discouraging. Yes, it is a slow process. But it is not hopeless, by any means. It just appears to be that way.

The new fire truck is a big boost to the efficiency of the local volunteer firemen. There has been a lot of anxiety at times over the fact that one of the trucks wouldn't start, or we were afraid to start out in the country in one of them for fear we might not make it to a fire, or for fear that some old piece of material or equipment might fail and cause an accident that might injure someone.

Both of the trucks in service have seen a lot of service and a lot of water has been hauled for many miles on both of them.

The Dodge truck has been in service for about 25 years and the Ford truck has been in use about 20 years.

The new truck is being paid for with a 50¢ fee added to the water bills each month, for a painless and slow way of collecting the money - and very effective.

What the volunteers need now more than anything else, though, is some younger men to replace some who are really too old to face the rigors, the heat, smoke, and the work of fighting a fire.

We can remember one time - a long time ago - when James Word and Yours Truly were going to the fire station, and it was so easy then, to hit a high lode on down to the station and get on the trucks. We always had a little contest with Troy Druse to see which could hot-foot it over there the quickest.

SANDERSON'S NEW FIRE TRUCK is pictured above after it arrived last weekend. The Chevrolet body was converted by C. C. Richter of San Antonio. It has a 220-gallon tank, fire extinguishers, two 3/4" hose reels with adjustable nozzles, a gasoline engine powered pump, and fittings for 1 1/2" outlet from pump. The ton pickup chassis is equipped with overload springs and oversize tires and the complete unit cost just over \$5,000.00.

New Fire Truck Put In Service

A long-needed addition to the Sanderson Volunteer Department has been added - a new fire truck.

The 1-ton chassis is equipped with a 220-gallon water tank, 3/4" hoses, and separately-powered pump with fittings for a 1 1/2-inch hose on the outlet and 3-inch inlet hose for boosting.

The truck will furnish the need for getting to a fire rapidly with a supply of water to begin the process of dousing the fire. The Ford truck with a large water capacity may be used to furnish a supply for the booster on the smaller truck or a back-up supply.

Plans are to put the Dodge truck in Dryden, according to W. W. Sudduth, fire chief.

There will be two fire drills a month for several months to acquaint firemen with the new equipment and plans are being made to recruit several younger men in the fire department to replace some who, because of age, have no business at the difficult job of fighting fires.

Prospector Is Staked In N.E. Part Of County

Hunt Industries, Dallas, will drill a 6,000-foot wildcat in Terrell County, 15 miles west-southwest of Sheffield, 11 miles north of an unnamed Pennsylvanian gas discovery and the same distance west of the Yucca Butte (Connell, Ellenburger and Pennsylvanian gas) field and one and one-fourth miles due west of its No. 1 Blackstone-Slaughter, active 12,800-foot wildcat which is being drilled "tight". It is the No. 1-3 Blackstone-Slaughter.

Location is 4,185 feet from the south and 925 feet from the east lines of section 3, Block 162 of the J.A. McGee Survey.

Local CAP Group To Make Fourth Effort for Interest

The local Community Action Program group is asking for the fourth time that a group attend an informative meeting at the court house Monday night. The meeting is to try to organize a plan of action here for the purpose of participating in some of the various federal aid programs aimed at increasing the economic, educational, and social standards of the people in communities where the organization is active.

Walter Parr, who has been instrumental in organizing several West Texas counties in a Community Action group, is the executive director of the five-county area and has been here on three previous occasions to explain to those at the meetings the various ways in which Terrell County can qualify for one of several federal-assistance programs.

Heads of all local organizations have been contacted this week to come to the meeting at the court house Monday night at 8:00 o'clock to hear Mr. Parr in his efforts to get a local interest in some phase of the poverty program for Terrell County.

It has been pointed out repeatedly at the previous meetings that the assistance is available to all who would qualify in one of several programs and that the money will be spent in some other county in the state if it is not used locally and that if Terrell County does not organize with the other counties of the area that they will not be able to secure any of the funds that are being handed out in the various programs.

One of the qualifications for a local organization is that at least 30% of a local group be composed of those who are eligible for help under the program. There has been little indication of interest on the part of this group at any of the various meetings.

Being a Christian today is not the challenge that it used to be. We can practice our beliefs quietly, without fear of persecution or public embarrassment.

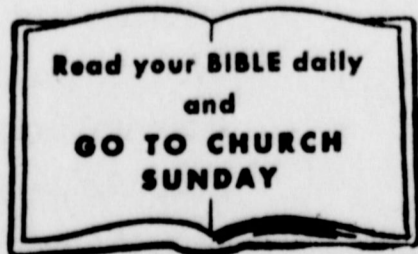
For some of us, it is almost effortless. We live our religion one day a week, and perhaps only part of that day.

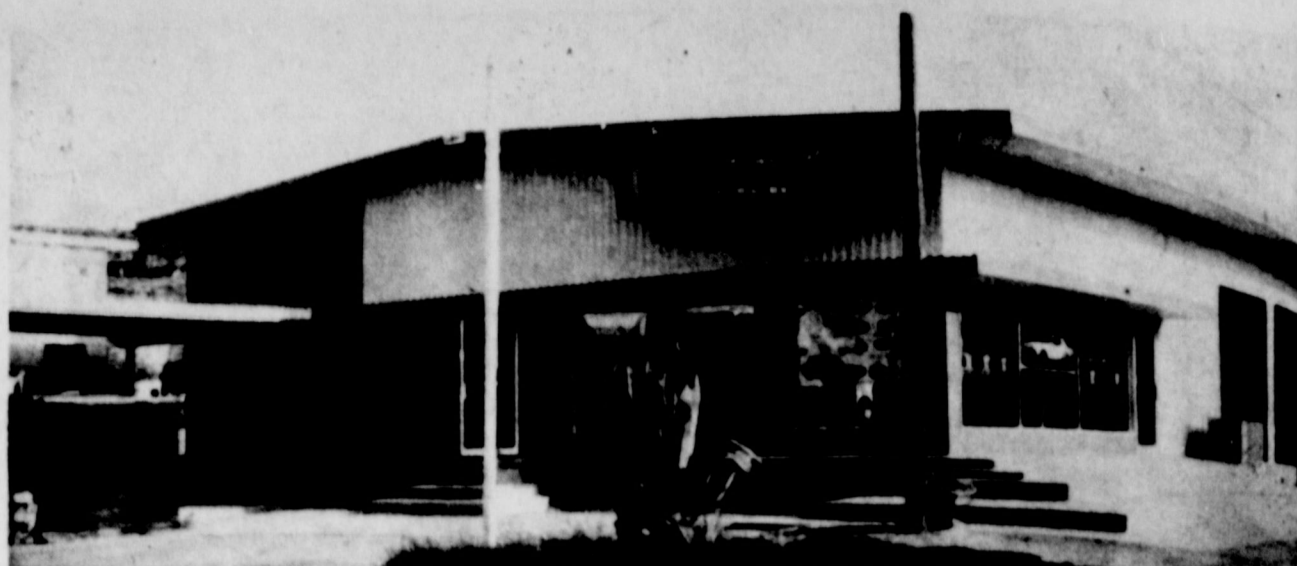

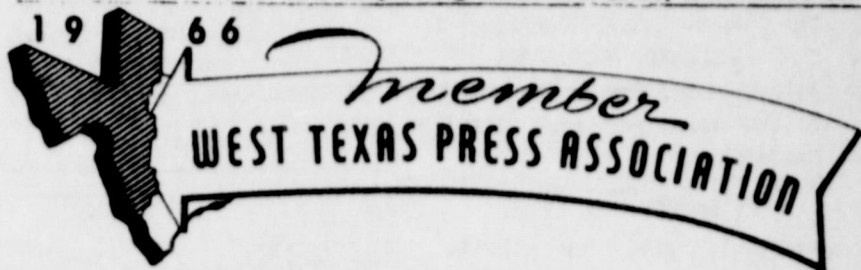
