The Sonora Broncos downed the Sanderson Eagles 58-0 here Friday night of last week. It was the last home game of the season.

The Bronco defensive team put the visitors on the score board first when they blocked a punt on the fourth play of the game and Mitch Trainer picked the ball up on about the 2-yard line and stepped over the goal line for the score. The punt was

from the Sanderson 25. Mike Cosney ran the conversion over for the extra 2 points.

After receiving the kick-off and trying for four downs to get 10 yards, the Eagles lost the ball on downs to the Broncos who scored from the Eagle 20 and Ed Lee Renfro kicked the extra point.

Renfro went over from the 5 for the third tally and kicked the extra point.

Renfro also accounted for the fourth score by running 37 yards to wind up the scoring in the first period.

During the second period, the Eagles had a pass intercepted to set up a TD play which was a 10-yard pass play from J. V. Cook, Bronco quarterback, to Richard Perez.

Gosney scored next from 5 yards out.

Renfro scored on a 13-yard run and the final tally of the game and first half was on a pass from Jesse Cook to Dennis Schmidt for 38 yards with the extra point coming on a kick.

The closest effort to scoring during the second half was early when the Broncos tried a field goal from the 35.

Sanderson will have their final game of the 1967 season next Friday night in Junction.

He is a graduate of Sanderson High School.

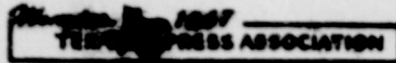

## Voting Saturday On 6 Proposals

Voting over the state is expected to be light on the six proposed constitutional amendments to the Texas Constitution. The amendment changes are the only things to be decided by the voters Saturday.

All four precincts will have balloting places - at the courthouse, the Dryden church, at the gas plant, and at the Sid Harkins ranch - for the convenience of the voters.

Polls will open at 8:00 a. m. and close at 7:00 p. m.

The wording of the propositions to be voted on are listed below for the information of the voters.

### BRICK MASON OF PECOS DIES

Glen Royce Greear, 58, Pecos brick mason, died early Friday evening at Black Gap, 73 miles south of Alpine, where he was working on construction of cabins. He apparently suffered a heart attack.

He is survived by his widow, a son and daughter and four grandchildren.

Mr. Greear was well known here as he had done the brick work on the Trans-Terrell Medical Center and other buildings and homes here.

Our Constitution is our fundamental law, protecting the rights of citizens and limiting and defining legislative, executive and judicial authority. Its purpose is to create and maintain a carefully balanced system of government.

It was intentionally made difficult to amend to insure thoughtful and deliberate consideration of any change. An amendment must first be submitted to the Legislature; this can be done only at a regular session. A two-thirds vote of the membership in the House and a two-thirds vote in the Senate is required to authorize placing a proposed amendment on the ballot for a vote by the electorate of the State.

Because our Constitution is the instrument guaranteeing our liberties and since it is not simple or easy to revise it, citizens have a great responsibility in voting to adopt or reject proposals such as the six which are separately analyzed in the following brief analyses:

#### Proposition I On The Ballot

You will vote FOR or AGAINST:  
"the constitutional amendment allowing counties to put all county taxes into one general fund".

#### Proposition II On The Ballot

You will vote FOR or AGAINST:  
"the constitutional amendment to permit municipalities, other political subdivisions, and state-supported entities located within hospital districts to participate in the establishment, maintenance, support, or operation of mental health services, mental retardation services, or public health services".

#### Proposition III On The Ballot

You will vote FOR or AGAINST:  
"the amendment to extend the Veterans' Land Program by authorizing the sale of bonds to increase the Veterans' Land Fund for the purpose of purchasing land in Texas to be sold to Texas veterans who served in the Armed Services of the United States between September 16, 1940, and the date of formal withdrawal of United States troops from the present armed conflict in Viet Nam, which amendment would amend Section 49-b, Article III of the Constitution of Texas, and provide for an additional \$200,000,000 in bonds, such funds to be expended in accordance with instructions and requirements that may be provided by law".

#### Proposition IV On The Ballot

You will vote FOR or AGAINST:  
"the Amendment to the Constitution authorizing each county in this state to pay the medical bills, doctor bills and hospital bills for all Sheriffs, Deputy Sheriffs, Constables, Deputy Constables and other county and precinct law enforcement officials who are injured in the course of their official duties; providing that the county shall continue to pay the maximum salary of these officials while they are incapacitated, but such salary payment shall not continue beyond the terms of office to which they were elected or appointed."

#### Proposition V On The Ballot

You will vote FOR or AGAINST:  
"the amendment to the Constitution of Texas adding a new section to be known as Section 49-e of Article III, authorizing the issuance and sale of Seventy-Five Million Dollars (\$75,000,000) in bonds by the State of Texas to create the Texas Park Development Fund to acquire lands for State Park sites and to develop State Parks."

#### Proposition VI On The Ballot

You will vote FOR or AGAINST:  
"the constitutional amendment allowing non-elective state officers and employees to serve in other non-elective offices or positions under this state or the United States until September 1, 1969, and thereafter only if authorized by the Legislature, if the offices or positions are of benefit to Texas or are required by state or federal law, and there is no conflict of interest with the original office or position; prohibiting elected officers under this state or the United States from holding any other office or position under this state; and adding members of the Air National Guard, Air National Guard Reserve, Air Force Reserve, and retired members of the Air Force to the list of persons exempted."

Nine members of the Womans Society of Christian Service met at the church Monday afternoon for the annual observance of the Week of Prayer and Self-Denial which was postponed for a week.

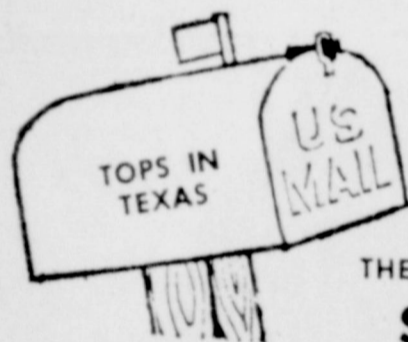

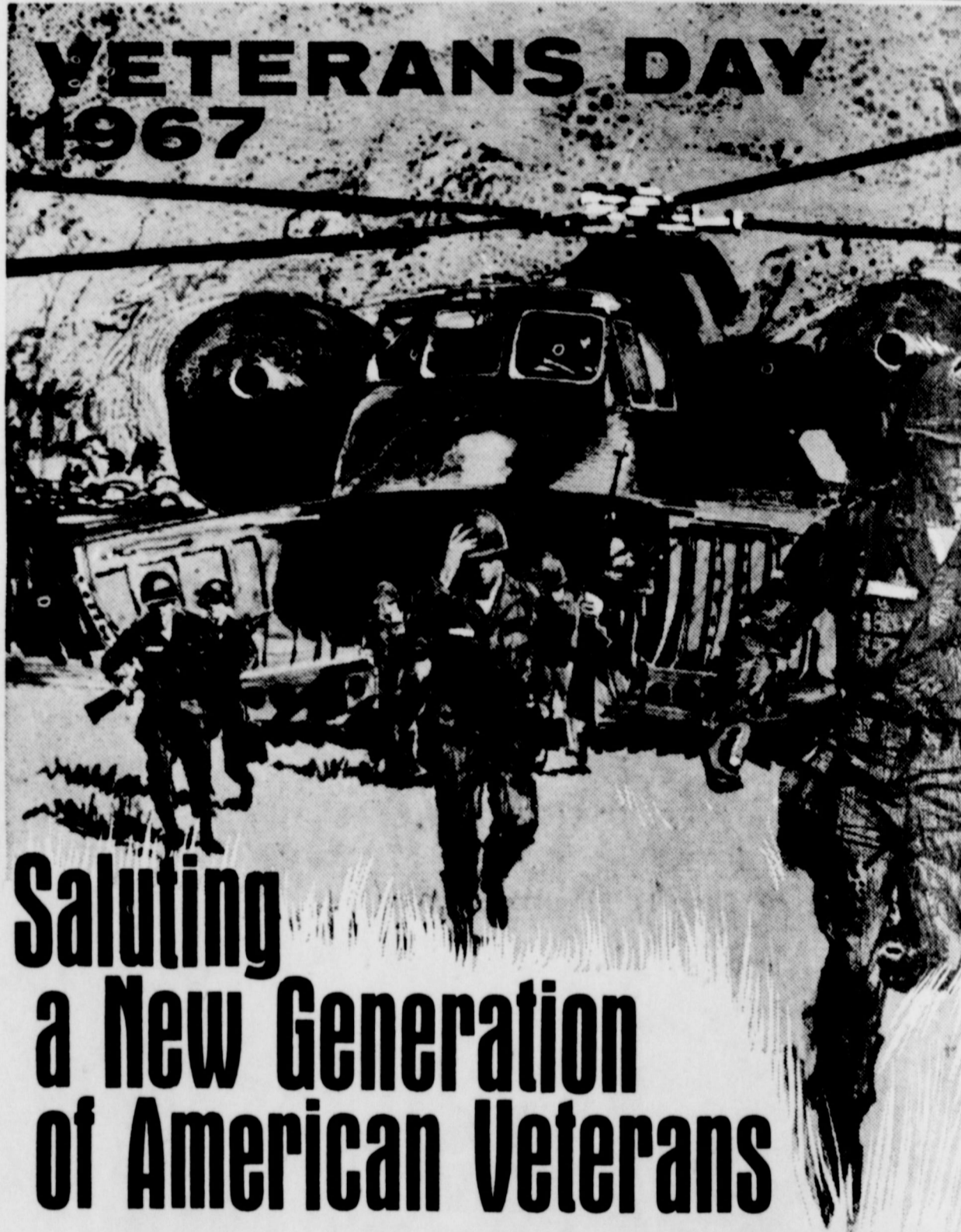

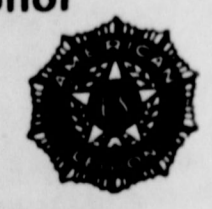

The vacancy in the House of Representatives left by retirement of Rep. Gene Hendryx of Alpine will be sought in the May Democratic primary by George Baker, Fort Stockton newspaper publisher for the last 34 years.

He plans an active campaign in all 13 counties of the 66th district, extending from Valentine and Presidio on the southwest to Bronte and Mertzon on the east.

Baker has a varied business background, with interest in ranching, banking, and an office supply store. He has been active in many phases of civic and community affairs, is a past president of the state-wide newspaper group, Texas Press Association, and as president of the regional West Texas association. He has worked with district Boy Scout and Girl Scout organizations. He was named "Citizen of the Year" for 1966 by the Fort Stockton Chamber of Commerce.

### Deer Season Begins East Of Pecos This Saturday

Deer season east of the Pecos River opens Saturday of this week and hunters of the state are also preparing for the opening of the season west of the Pecos on November 25.

The Terrell County Chamber of Commerce has received literally hundreds of letters from hunters over the state and nation, from as far away as Connecticut, interested in hunting blacktail deer in this area. A story in a nationally-read sports magazine hailed the hunting in this area as among the nation's best and the Texas Parks & Wildlife Department has stated that Terrell County has the largest deer population of any county west of the Pecos.

Approximately 20 ranchers in Terrell County are selling hunting rights this year, most of which are for the weekends or season, with few "day hunting" privileges being sold. Since the season opens on a Saturday and includes three weekends, some of the hunting privileges are being sold in weekend blocks, to include as many days prior to the weekend as the law will allow or the hunter wishes. The price for hunting on most of the ranches in Terrell County this year is \$100 for each hunter.

The law permits the bagging of two whitetail bucks plus one blacktail buck this year, compared with only a total of two bucks last year and previous years, no more than one of

which could be a blacktail. Special permits are issued for the taking of does.

Whitetail deer hunting in this area is being advertised and pushed as much as possible as being a better sport in some ways than the hunting of blacktail. It is hoped that this will increase the demand for whitetail leases by hunters to assist those ranchmen who have whitetail deer only on their ranches. Most people that have never hunted whitetail deer in this area, are of the opinion that it is much the same as in the hill country of Texas in that the hunter stays in a blind waiting for the deer to come within sight out of the heavy brush. The wary, elusive, and speedy whitetail deer of Terrell County, in the rough country where he ranges, offers a challenge to the hunter and then tests the shooting ability of the hunter after he is seen.

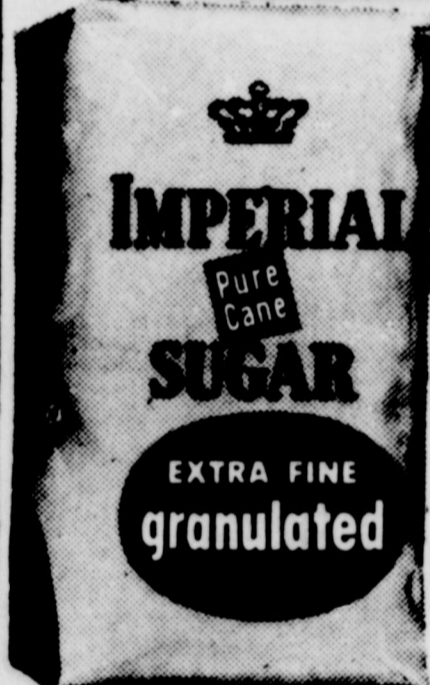
