## 'Jerry' Bell, 59, Former Resident, Buried Here Friday

Funeral services were held here Friday morning in St. James Catholic Church for Gerald G. (Jerry) Bell, 59, of San Antonio. Rev. Dan Dierschke officiated at the rites and burial was in Cedar Grove Cemetery.

Mr. Bell was found dead in bed at his home Wednesday morning, apparently the victim of a heart attack. There was a Rosary in San Antonio Thursday evening before the body was sent by train to Sanderson.

Born in Bingham, Nebraska, he came to this area as a young man and was working on the high school here when he met and married his wife, the former Mattie C. Banner. They resided here and in Dryden where they had a cafe for several years before moving to San Antonio.

He was employed by R. Marvin Shipman and Associates and at a meeting of the directors of the company in October, he was named the most valuable employee of the company.

During World War II he was assistant plant engineer of a tire manufacturer and received a personal commendation from President Roosevelt for two patents he perfected.

Besides his widow, he is survived by a daughter, Mrs. Odell Brotherton, and three grandchildren, Miranda, Bobby and David Brotherton, all of San Antonio.

## Formal Opening of Medical Center Ends 21-Month-Long Effort Locally

A project which began on February 17, 1966, will be formally completed on December 10 this year. The project was the building of a medical facility for Terrell County in Sanderson.

An open house of the Trans-Terrell Medical Center building will be from 2:00 to 5:00 p. m. Sunday and all members of the community are urged to be present during the hours of the open house.

The project, born in the Terrell County Chamber of Commerce, began with the request that each organization in Terrell County name a representative to meet for the initiation of the project of building a medical facility and to lay the plans for some organization to see the project through.

The representatives from all known organizations in the county met at the courthouse on March 21, 1966, and an executive committee consisting of Sid Harkins, Troy Druse, R. S. Wilkinson, Jack Hayre, and Darwin Schrader was named and given authority to select nominees for various sub-committees to carry on the work of the project. The executive committee that night elected officers and Harkins was named president; Druse, vice-president; Wilkinson, secretary-treasurer.

At the original meeting, the plans of the Sears-Roebuck Foundation were adopted as the rule for going on with the project. The Sears-Roebuck Foundation's plans were explained to a mass meeting of the residents of this area on February 7 by John R. Sedgwich, representative of that organization. Mr. Sedgwich came to Sanderson at

the request of the local Rotary Club and the Terrell County C of C after a survey had been made to determine the feasibility of the participation of the Foundation in the project. The Foundation furnished the plans for the organization, the selling of shares, offering plans for the building, and a concerted effort to acquire a physician once the building was completed. All of this was at no cost to the local citizens.

At the subsequent meeting of the representatives of the local organizations with the executive committee, committee chairman and members were named for the various phases of the project as follows: Fund raising, S. D. Harrison, Jolly Harkins, Rev. J. C. Hancock; building, Edward Kerr, Bill Smith, Mrs. J. M. Davis; doctor procurement, M. W. Duncan, Herbert Brown, Mrs. David Mitchell; publicity, J. A. Gilbreath and Mrs. Carlos Dunn.

It was at this meeting that the group selected the name: "Trans-Terrell Medical Center". It was also voted to form a non-



profit corporation and the existing executive committee named as directors of the corporation.

April 30 was set as the date for the beginning of the fund-raising drive and headquarters were set up in the Turner Hotel building. Team captains and workers were named to canvass the town and county and to contact all non-resident property owners, and any others who may be interested in seeing that the project was successful. The details of shares and donations were explained at a subsequent meeting of the fund-raising workers and the goal of \$40,000 was set.

May 12 noted the collection of more than \$33,000 for the goal with the goal reached on May 24.

The search for a doctor intensified on that date with brochures printed and made available to all citizens to mail out to friends who may have contacts with doctors or anyone else who could help the doctor procurement.

The fund increased to approximately \$45,000 by the last of June of last year with the promise of more to come and the project, waiting for a commitment by a physician, was at a standstill until the week of December 22, last year, when it was announced that J. M. Flowers, M. D. had promised to come to Sanderson. Dr. Flowers and his family arrived in Sanderson the latter part of January and it was decided to let the contract for the medical center building on March 13. In the first week of February of this year the Trans-Terrell Medical Center, Inc., a non-profit organization, was completed and the executive committee which had served to that time was re-elected as directors of the board.



**Record Kills By Deer Hunters Noted**

Record kills in numbers and size and condition of buck deer are reported this year by ranchmen of this area.

Most of the ranchmen who are leasing their land for hunting purposes are reporting a very high percentage of bucks killed by hunters, in most cases running 100%. The percentage is some higher in blacktail country due to the action of the game and proximity of the shots.

All of the animals are reported to be in excellent condition and any animals that are not fat are considered to be sick and unfit to be eaten.

Ranchmen who have whitetail deer only and who have paid hunters are pleased with the response given to this type of hunting by the enthusiasts.

The difference in hunting the whitetail deer in the Trans-Pecos country as compared to other areas of the state is that the smaller deer in this country is one of the most elusive animals of big game and offers a real challenge to the sportsman. The difference in the terrain of this whitetail range and the lower country is also attracting sportsmen this year, and their

interest is expected to increase next year.

Most of the hunting parties to this section of the state are coming for the weekends and leaving the first of the week.

The weather has been much

more conducive to good deer hunting this year than for several seasons past since a good hard cold snap preceded the season by several days.




