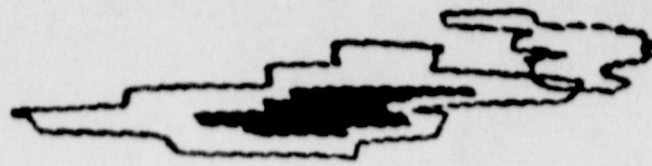

## LISTEN TO LUKE

By Albert:---

In our last week's column, we proposed the naming of a County Democratic chairman to receive filings, and otherwise act in official capacity regarding the duties of the office since this is an election year and certain candidates are interested in getting on the ballot.

So far as we know this action has not been taken.

The returns of the Democratic Primary in 1964 and 1962 will show those who were last elected within each of the four precincts as chairmen - who comprise the executive committee, and there are books that are available that set out very plainly what their actions should be under certain and all circumstances.

The County Democratic chairman's appointment, his qualifications - or disqualifications - are set by law, as are his duties.

We can see no reason why an interim chairman should not be named properly and any who would aspire to the office ascertain the qualifications and duties before they accept or seek it. For example, we are told that holding this and certain other elected offices is verboten.

There are those who would aspire to an elected office but make no apparent effort to learn their duties before seeking or after attaining a public job. This often causes the public to look at the ballot with indifference as to the selection of an official and lose respect for the office continued to second page

## US 90 Paving Is Scheduled In Brewster County

Brewster County Judge Felix McCaughy reports that the Texas Highway Department plans to contract 55.69 miles of asphaltic concrete pavement overlay and shoulder seal from 5 miles east of Alpine, east to Pecos County line on U. S. Highway 90 within the near future.

This work will increase the ability of the road to carry heavy loads and improve the riding qualities. Only minor inconvenience for the traveling public will result and only for a distance of approximately 2 miles at any given time.

This work will be contracted probably in January and will be under the supervision of Resident Engineer Sid Surratt in Alpine, Judge McCaughy said.

Caroline received 47 votes and Duncan and Cooke received 43 each, according to unofficial tabulations. The canvass of the ballots will be at the next meeting of the board.

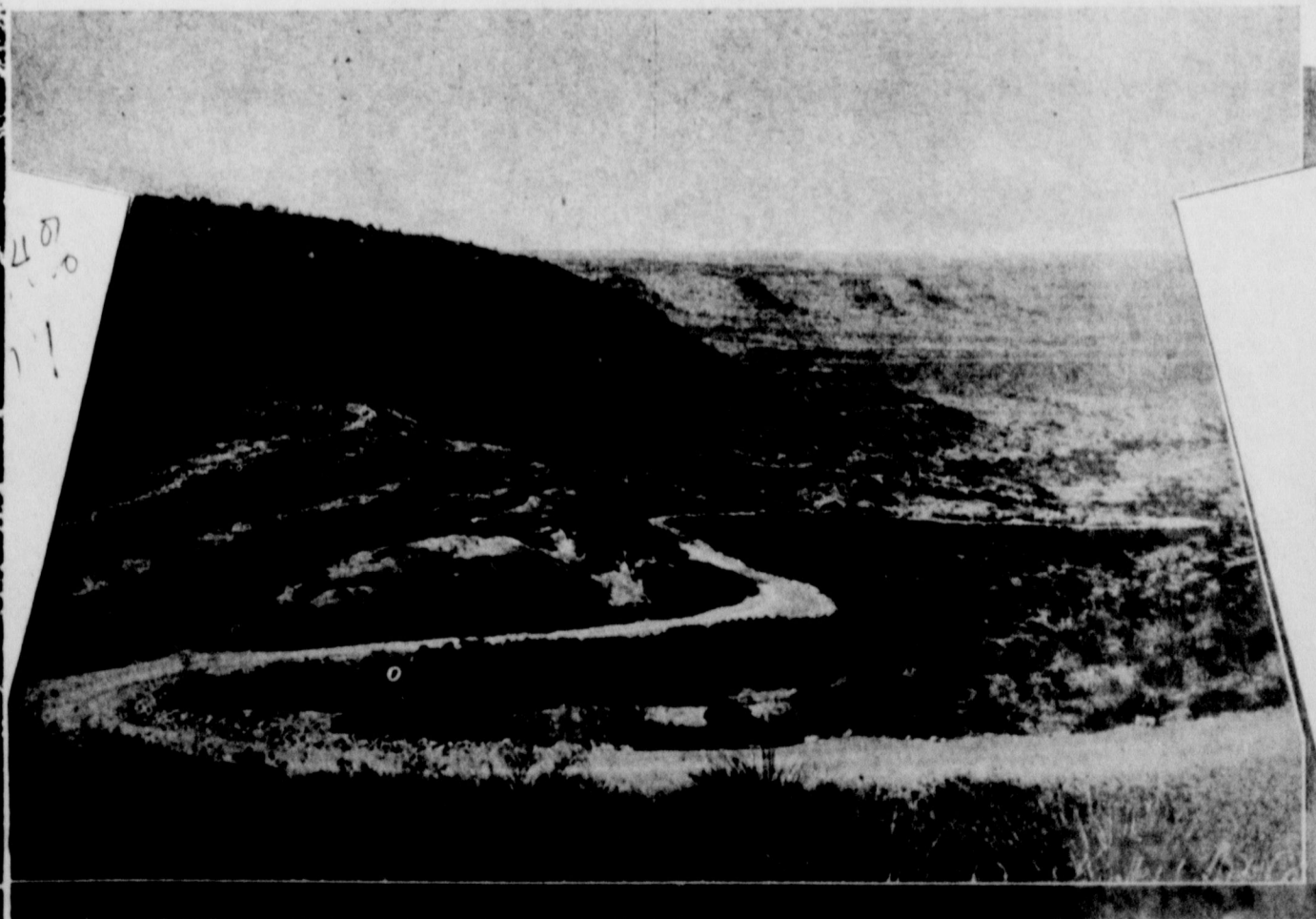
## MRS. UNDERWOOD'S BROTHER DIES IN SAN ANGELO

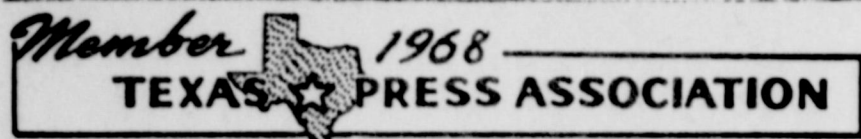

Necessary forms are available from any post office or office of the Immigration and Naturalization Service. Persons who are unable to pick up the forms in person may have a relative or friend obtain a card for them. The cards are to be returned to one of these offices.

Parents or guardians of aliens under 14 years of age should report for their children.

All information reported on the forms is confidential and failure to comply can lead to serious consequences, according to John W. Holland, district director, Immigration and Naturalization Service.

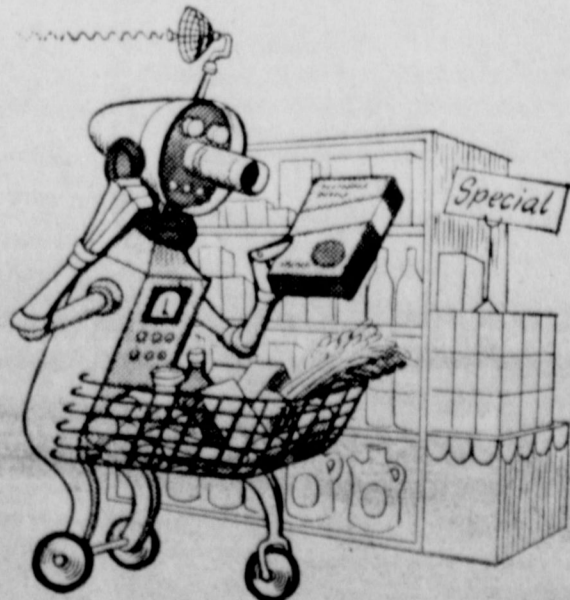

### Cookie-Built House Begun at Scout Camp

Construction began on "The House That Cookies Built" last Monday. A lumber company of Fort Stockton was awarded the bid for the \$48,000 building project at Mitre Peak Girl Scout Camp, near Alpine.

The project includes a year-round all-purpose building to replace the old lodge, a new camp director cabin and a large storage building.

The all-purpose building which is to be constructed of native stone, rough timber and glass is being financed with funds from the Permian Basin Girl Scout Council cookie sales. When the project is completed it will be more than half paid for. A two-year loan, also to be paid off from the annual cookie sales, will complete the financing for the additions to the camp.

In addition to approximately 1,000 square feet of open space, the building will have a kitchen, hobby shop, business office, trading post, three bedrooms for staff and a large dormitory-style room for other staff.

The two smaller buildings will be a cabin of native stone for the camp director and a rat-proof storage and workshop built of concrete blocks.

Mrs. Jack King of Midland, Camp Committee Chairman for the Permian Basin Council, unveiled the plans at a recent Council meeting in Odessa. She said the largest of the new buildings would accommodate troop camping during winter months with total facilities under one roof. Some 38 campers could put down bed-rolls in the main room which has a three-sided fireplace in the center.

Completion and dedication of the new building is slated for May 19, 1968, in plenty of time for the summer camping season.

### Rain, Sleet, Freeze Hit This Area

Sleet and freezing rain came to this area Saturday night making all roads all but impassable. The cold weather continued all day Sunday and Sunday night more moisture fell in the form of rain and sleet. Monday morning the ground was covered with a blanket of ice.

Roads out of Sanderson were negotiable, but unsafe. There were reports of some vehicles having trouble on some of the hills in this area, particularly toward Fort Stockton and Wolf-Field.

North of Sanderson piles of snow were reported Sunday morning and the freeze Saturday night and more moisture Sunday night added to this. The snow was said to be powdery.

Schools were dismissed locally due to the icy road conditions and the inability of trucks to run from the gas plant in Dryden.



# Safe, Effective Vaccine Protects Your Children

There are two kinds of measles.

Today's Health, the magazine of the American Medical Association, reports that the kind of measles against which the vaccines protect is known as rubella, "common measles," or the "seven-day" or "10-day" measles, or the "red" measles.

In rubella, there is a pronounced, long-lasting rash, usu-



ally associated with symptoms of illness for three or four days before the rash appears, such as fever and coughing.

The other kind of measles, rubella, is known as "German measles" or "three-day" measles. Rubella's rash is less pronounced, and there are few pre-rash symptoms. However, if a woman contracts rubella during the first three months of pregnancy, it can affect the fetus and result in birth defects.

An effective and safe vaccine is now available for rubella or red measles. It produces only a few minor reactions, but in return provides almost complete protection which may last a lifetime. If all children between ages of 1 to 9 who have not already had measles or a dose of live virus measles vaccine could be immunized, measles could be eradicated from the United States. Vaccine can be administered by your doctor in his office or during measles vaccination campaigns.

The vaccine against German measles is not yet ready for general use. An effective one appears to have been developed but re-
