There is a multitude of reasons for this—everything from "in the name of progress" on down. The opinions of some people differ as to the cause, and again maybe all are right to some degree. The fact that there was a decrease is no earth-shaking bit of news, nor is the fact of the amount of decrease.

And it doesn't shake some people up to note that one of the good parts of it all is the fact that there are many who are still here and that our efforts to work toward a common goal are just as strong—or maybe stronger than they ever were.

But sometimes we just get too interested in self!

## Sheep Have Good Future, According To Expressed Belief of Illinois Man

Optimism for the sheep industry's future is expressed on every possible occasion by Dana Robes, a sheep nutrition specialist from Quincy, Ill., touring West Texas to speak at a series of meetings sponsored by Moorman Manufacturing Co.

Robes says that the attitudes of many people toward sheep and toward sheepmen need reshaping to reflect the respect that is due the thrifty animal which has meant so much to the economy of West Texas, and to U.S. agriculture generally.

He spoke in Fort Stockton recently the nutritional requirements of sheep, pointing out that the extra production from healthy sheep often spells the difference between profitable operation or loss on the ranch. Dana bases his findings and recommendations on experiments conducted by the company and other research agencies.

Joe N. Brown of Sanderson, area salesman for the company, arranged the meeting. Also on the program was Dr. Russell Benson, with a Kansas City chemical firm. He showed slides and talked on the importance of control-

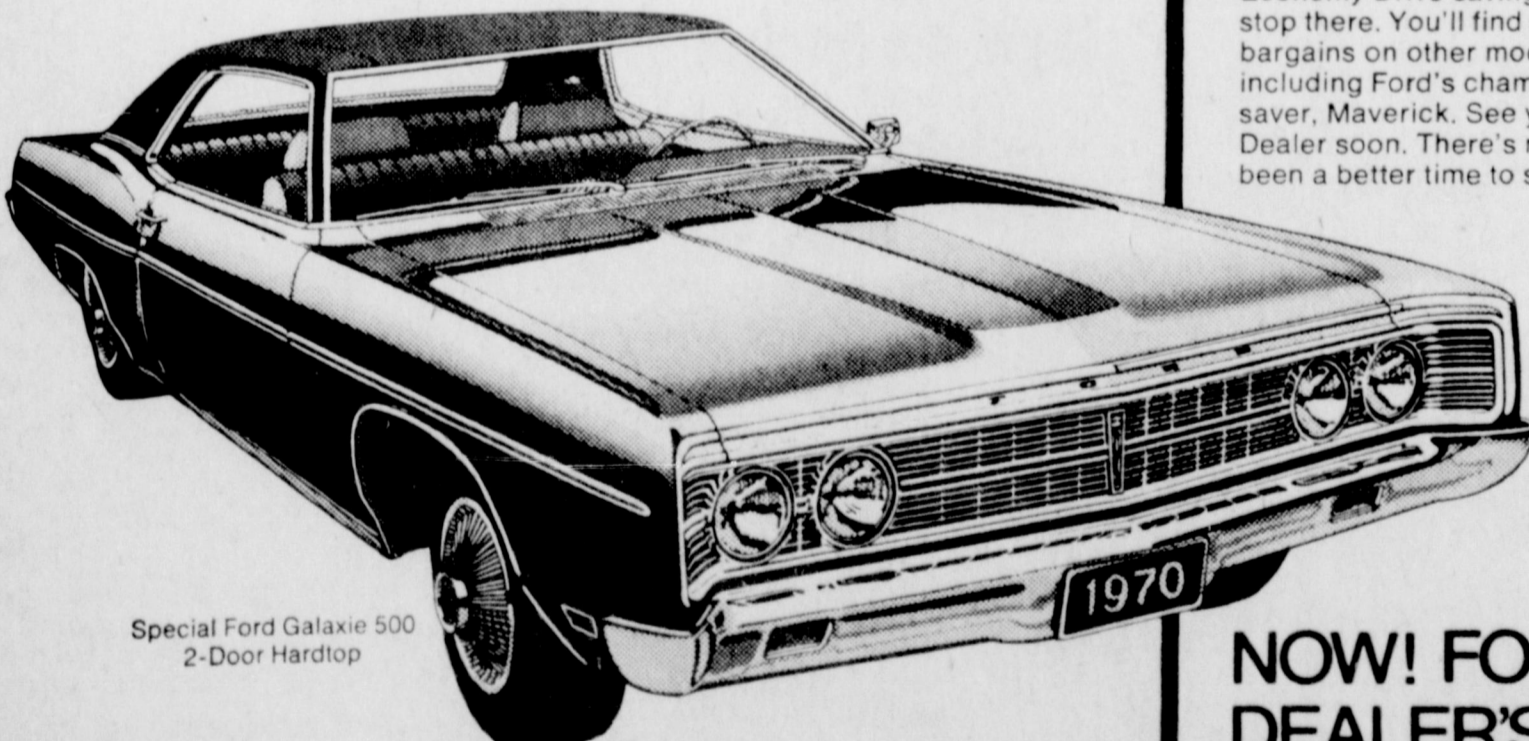
