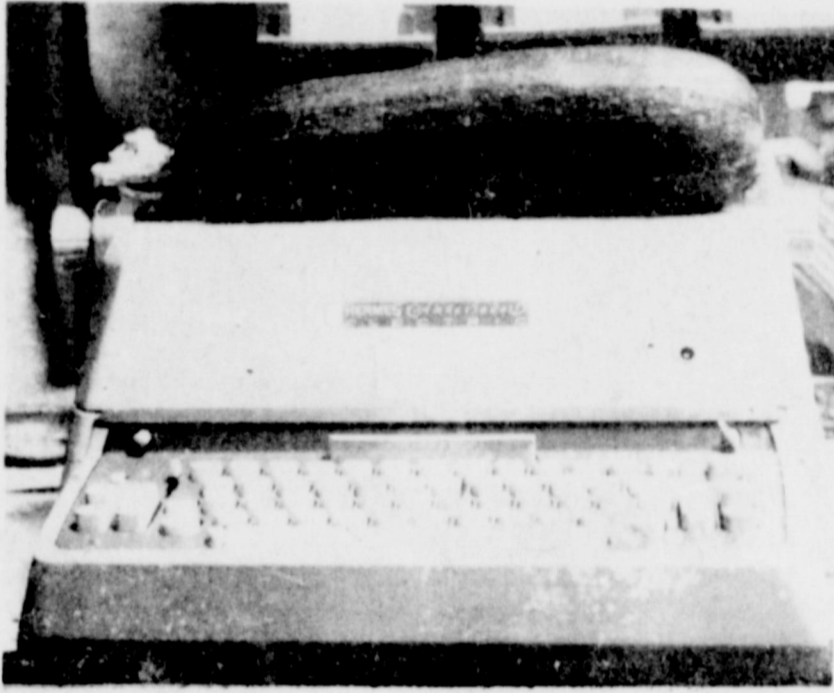

All upcoming elections in Terrell County will have as eligible voters duly registered 18-year-olds, according to information sent out by Martin Dies Jr., Secretary of State for Texas. Prior to the ratification of the United States Constitution by Ohio, states varied as to eligible voting age and in which elections, but the Federal law unified all requirements. And, according to Dies, persons who turned 18 after the close of the regular requirements; and according to Dies, persons who turned 18 after the close of the regular 1971 registration period may still register for the current voting year. The certificate is effective for any election held 30 days after registration. It is not necessary to segregate those late registrations from any other age classification.

We wonder what would be the reaction to an absolute truthful, forthright, and honest effort on the part of all the citizenry and office-seekers to have all subsequent elections to be based on absolute truthful, forthright, and honest campaigning, balloting, and counting.

Flood Control Site Property Owners Show Many Easements To Be Secured

The Rio Grande Soil Conservation District and Terrell County Commissioner's Court has compiled a list of property owners involved in the construction of flood control dams, land treatment, and channelization of Sanderson Canyon Watershed. It will be necessary to obtain easements, property rights, or agreements from those in the list.

Herb Senne, work unit supervisor with the Soil Conservation Service in Sanderson, stated that as easements, property rights, or agreements were received from the landowners, that information would be given to The Times so that the people of Sanderson and the county will know how the work is progressing.

Up to this writing, easements or other land rights had been obtained from the Texas Highway Department and Joe N. Brown.

Pick-up Stolen, Wrecked Saturday

A pick-up truck belonging to J. E. Hasty was wrecked early Saturday after it was stolen by a man who broke away from officers while being incarcerated, according to Terrell County Sheriff Bill C. Cooksey.

The man was acting "strangely" at a local service station and when accosted by Texas Highway Patrolman Tommy Lowrance and Deputy Sheriff Dalton Hogg, he told them that he was having mental problems and they offered to take him to the courthouse for questioning and possible help, the sheriff reported. The officers planned to hold the man in jail for his and their protection until more information could be learned and something done for him, but when the man saw the jail, he shoved both officers against the wall and fled. He got the Hasty pick-up and drove eastward. Hogg summoned more help and Lowrance pursued the man who wrecked the pickup at 5-mile Hill, and escaped barefooted and without a shirt into the night. Area ranchman were told of the facts so they could be on the alert for the man who was later seen crossing the highway southward toward the railroad. An approaching train crew was warned and he was seen to try to board the fast-moving freight train without success. He was later seen on the bridge east of the overpass east of town, according to Cooksey, who ordered all trains held up and it required several hours to talk the man into surrendering so that he could be treated for his bruises, cuts, and thorns resulting from the accident, his barefoot run, and effort to board the train. He was taken to the office of Dr. A. N. Clanton and treated and quietened for emergency entrance in a Big Spring hospital where he was taken, the sheriff related.

Additional Grant Made To Schools

The United States Office of Education, Department of Health, Education and Welfare, has approved grants to twelve school districts in seven counties of the 16th Congressional District, under Part C, Title I, of the Elementary and Secondary Education Act, Congressman Richard C. White announced.

Grants under Part C are made to school districts having substantial numbers of students from low income families, and are to be used solely for programs and projects designed to meet the needs of educationally deprived children. Part C allocations are in addition to the annual allocations under Title I, and go to those schools having an exceptionally high percentage of low income students, and to those who came within five percent of having sufficient number of low income students to qualify under the regular Title I appropriations; and are found by the state educational agency to have special need for the grants.

Grant Will Aid Law Enforcement

The Permian Basin Regional Planning Commission, Odessa, was awarded a \$19,467 criminal justice planning grant for fiscal year 1972.

Part of the funds will be used for preparing a multi-year regional criminal justice plan, the first for the Permian Basin.

Governor Preston Smith made the grant on recommendation of the Texas Criminal Justice Council. The council oversees state law enforcement planning and administers funds from the U. S. Department of Justice under the Omnibus Crime Control Act.

The Permian Basin grant includes funds for planning activities related to: regional basic certification police schools at Big Spring and Odessa; regional advanced schools to include riot planning, drug abuse investigations, and handling of mentally disturbed persons; riot equipment stockpiling to be centrally located and available on a regional basis; a mobile crime laboratory to be coordinated with the state crime laboratory project now in Criminal Justice Council plans; a regional coordinated radio communications system; The commission matched

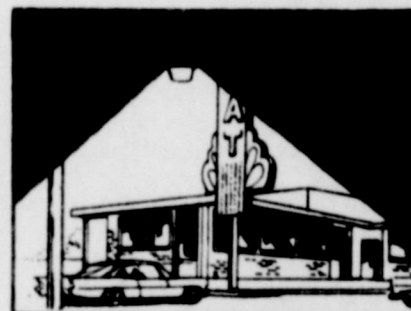

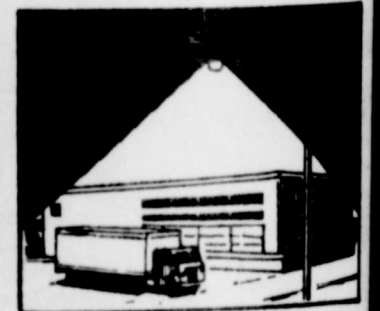

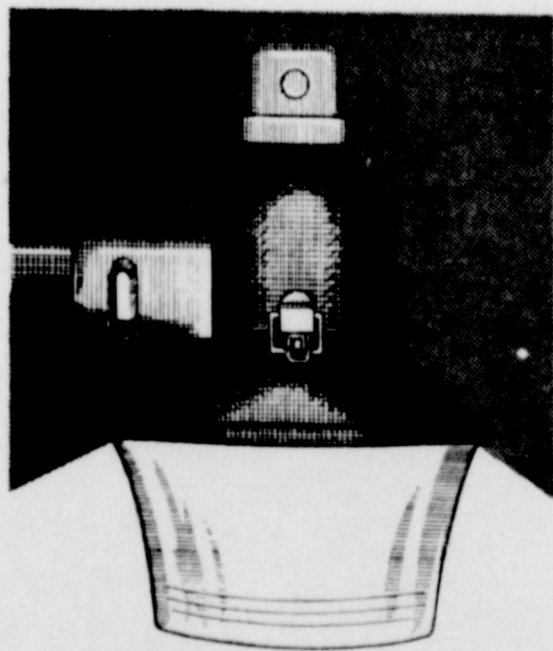

Ybarra is a sergeant and returned home last week from duty in Vietnam and is spending his furlough here with relatives and friends.

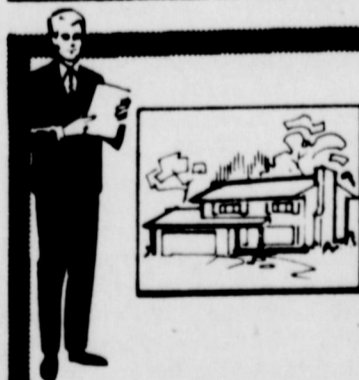
