LISTEN TO LUKE

We continue to wonder, and we will always continue to wonder why we have to have the slaughter that we have on our nation's highways, especially over long weekends. It seems so senseless.

There are those who are most concerned about the population explosion and what it might mean to this nation and to the world. A sordid answer that could have some bearing on the subject, would be to continue to work diligently for the 4-day work week or to work for the replacement of all holidays on Mondays so that there will now be more long homicide-days. Or give more people automobiles!

We would hope that there will be some kind of a solution to the problem we have of self-destruction.

Right after our most disastrous flood in 1965 we started printing pictures of that disaster and the rebuilding that resulted. When we had depleted that project, we thought about a possible interest in old pictures, and so began running some and asking for more. This project has continued since that time and will continue as long as we have interesting old pictures to print.

And by the way, we could use some right now! But our point in starting this subject was to note that we have seen in at least three papers of this area where the editors have begun a similar project. We hope their readers will receive the project in the same way our readers have. It really has been a pleasure to continue this project because of the many very nice things that we have heard from our readers.

Sanderson has seen some kind of results in the increase of travel due to Amistad Dam. We don't know of anyone who has kept any kind of record of this increase, but the number or frequency of boats being pulled to and from the east seems to indicate to us that Amistad is the cause of this travel. Some of them stop on one or the other legs of the trip and maybe some don't, but there is an increase in the travel, at least and this is good!

We noted in daily papers last week that Texas could take over the movie industry business away from California. Wouldn't that be something! Now we really wonder how much that could mean to this particular part of the state. There have been at least two movies made in the Marfa area, several in the Brackettville area, and at least one west of Del Rio on Devil's River. There is a diversity of scenery, there is a suitable climatic condition if sunshine and clear weather is wanted or needed, and there is a suitable atmospheric clearness that probably is conducive to outdoor movie making.

And West Texas - if that is the area chosen - could use an economic shot in the arm.

The game will also be the first outing of the Eagle Band and the first public presentation by Band Director Joe Blatchford.

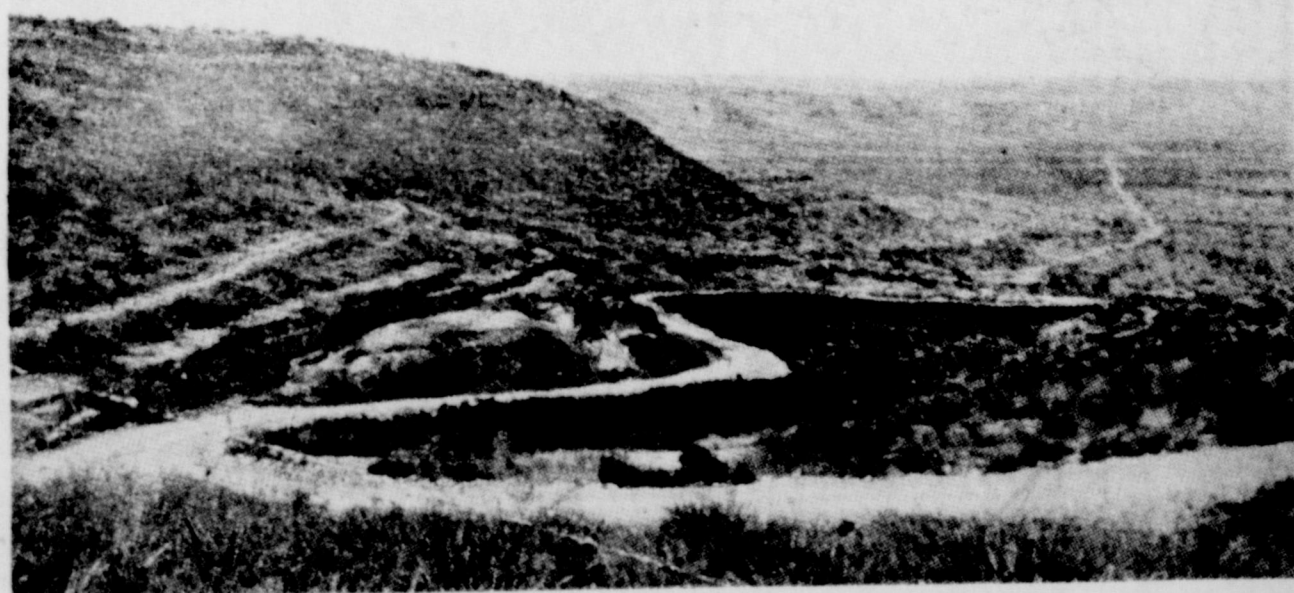
A large crowd of visitors is expected to accompany the Longhorns to Sanderson to view the game which will begin at 8:00 p. m.

Motorists Must Stop For School Buses

A new State Law effective August 30 will no longer permit Texas motorists to stop and then pass a school bus which is loading or unloading children.

Colonel Wilson E. Speir director of the Texas Department of Public Safety, said the new law passed by the 62nd Legislature, applies in both cities and rural areas and requires motorists moving both directions on the same roadway with a school bus to stop and remain stopped as long as the flashing lights on the bus are in operation.

Under current law, which applies only in rural areas, drivers must stop for a stopped school bus, but then proceed around it at a speed of not more than 10 miles per hour if safe to do so.

The new law will not require those vehicles on another roadway of a divided highway to stop, and stops are not required if the bus has stopped in a loading zone of a controlled access highway where pedestrians are not permitted to cross.

Speir noted that provisions of the new law will be strictly enforced to afford maximum protection to the school children of Texas.

NOTICE OF CANCELLATION OF LIVESTOCK BRANDS AND MARKS

All brands and marks on Texas livestock must be rerecorded with the County Clerks after August 30, 1971, according to a new law passed during the last session of the Texas Legislature. Producers will be given a six-month period (August 30, 1971 through February 29, 1972) in which to register these brands and marks and the location on the animal which they are currently using, after which time any unrecorded brand will be available for use on a "first-come" basis.

The law further states that all such brands and marks must be rerecorded every 10 years. Each County Clerk records for his given county only, so many producers may need to record their brands in additional counties if their operations are extensive.

The owner shall have the right during this six-month period to file the mark and brand now recorded in his name. In the event it cannot be determined from the records who first recorded the brand and mark in the county, then the person who has been using such mark and brand the longest shall have the right to have the brand and mark recorded in his name.

It should be noted that it is illegal to brand livestock without first properly recording the brand with the County Clerk in the county in which the livestock are held.

When the brand or brands are recorded, the location on the animal on which the brand is to be applied must be designated. If the brand is to be applied to more than one location on the

animal, it must be so recorded and each additional location for the brand on the animal shall constitute a separate recording of that brand.

There is no limit to the number of brands and/or marks which may be recorded in a county by a person as long as requirements of this law governing the recording and rerecording of livestock brands are met. Minors may have marks or brands separate from that of their father or guardian, which must be recorded or rerecorded as provided by the new law.

The County Clerk of each county shall have this act published in some newspaper of general circulation in the county for a period of 30 days. The act shall be published on the effective date, August 30, 1971, and thereafter for 30 days.

It is the obligation of the County Clerk to assure that no more than one brand of a kind be recorded on the same location of the animal in each county. Therefore, no two people in a county may record the same brand in the same location. It is also the responsibility of the County Clerk to make certain that in recording any brand for a person, that the part of the animal on which the brand is to be placed be designated.

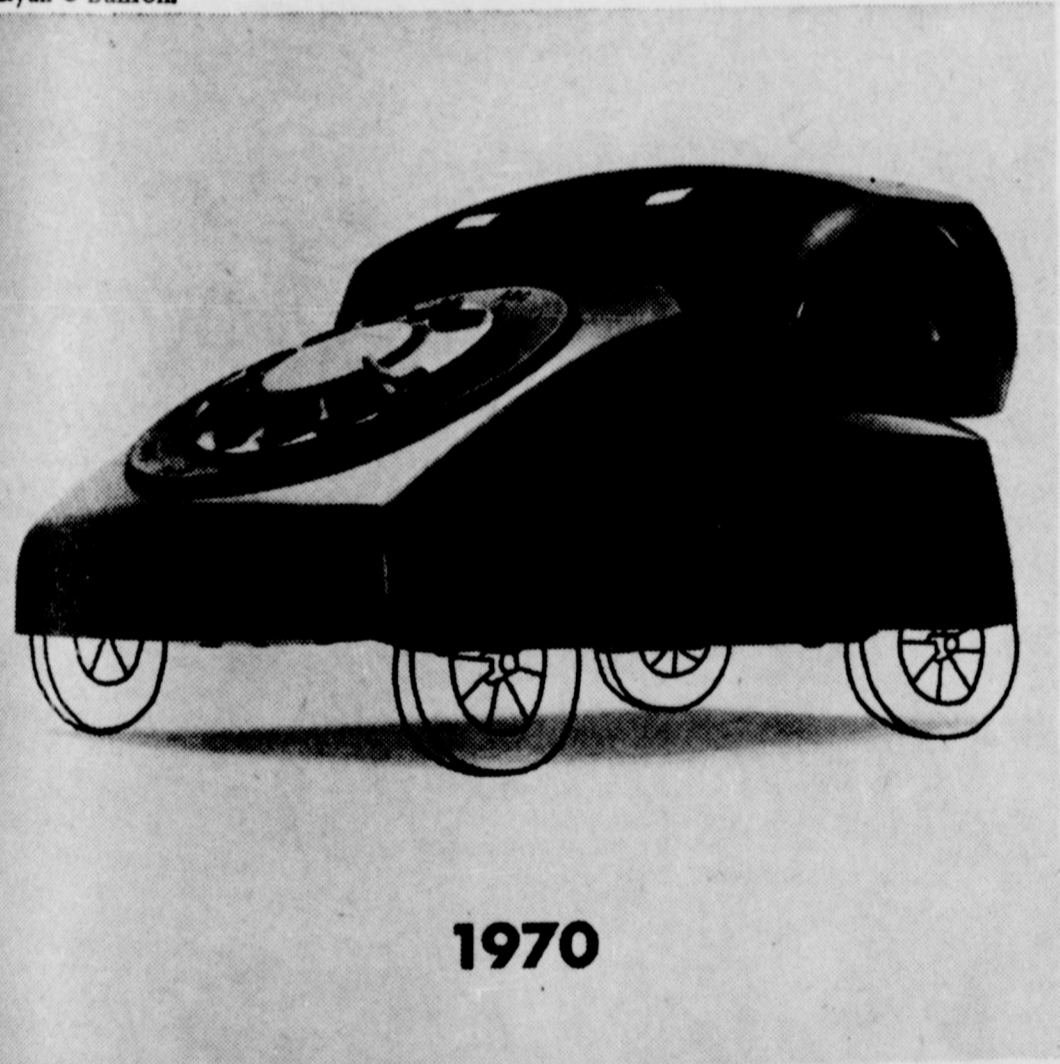

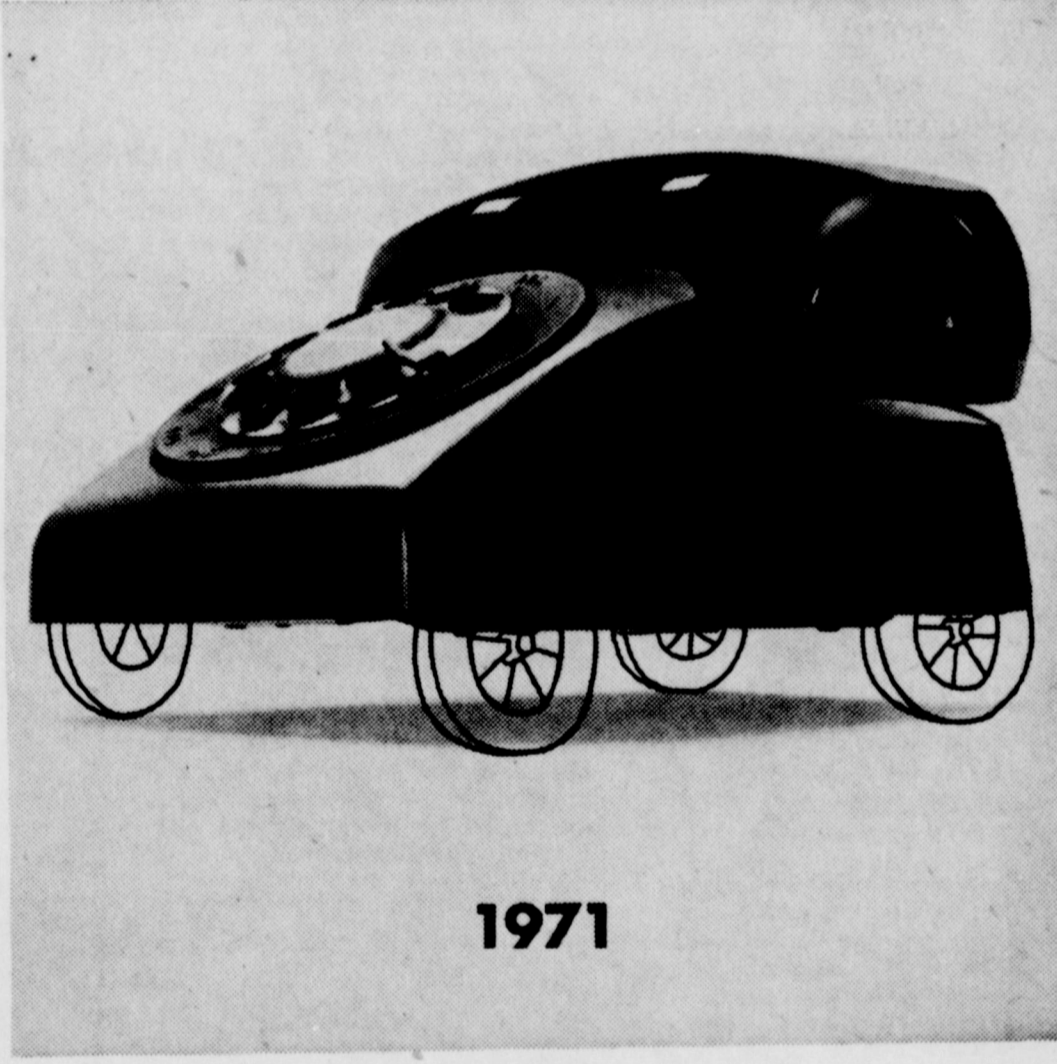

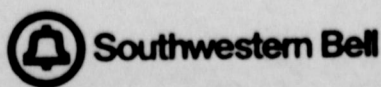
