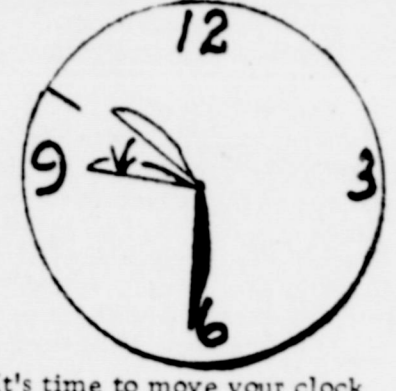

## Prospective Voters Need To Present Info In Person

Persons desiring to exercise the right to vote in 1972 elections will need to make application in person at the office of Sheriff Bill C. Cooksey in order to receive voter registration certificates.

Office personnel emphasized the necessity of registering at the office as the records now being made will remain a permanent one. In order to avoid duplications and to insure that information given on the application is accurate, it is advisable for the prospective voter to be interviewed personally.

Eighteen, 19, and 20-year-olds desiring to vote should also make application for voter certificates. Any person who will be 18 prior to March 1, 1972, should also present application for voter registration in the sheriff's office.

A copy of the application is printed elsewhere in this newspaper and the necessary information may be filled in before presenting it to the sheriff's office for the voter certificate.

The deadline for registering is January 31, 1972, to be eligible to vote in elections after that date next year.

**HISTORIC TERRELL CO. COUNTRY  
Old Ketchem Ranch  
Placed On Auction**

**SAN ANGELO**—An area rich in the history of West Texas is being offered for sale at public auction. This area is presently known as the Old Ketchem Ranch which is the Blackstone part of the massive Blackstone-Slaughter country located in northern Terrell County, south of Sheffield, Texas.

The ranch, about 36,000 acres, is owned by Blackstone heirs including Mrs. Fred (Nina) Elkins of San Angelo, Nip Blackstone of San Saba, Jay and Bob Lane and Mrs. Dorothy Prather of Dallas, the Mary Blackstone Bynum Estate, the Mabson Bartlett Estate, and Mrs. V.M. Bradenberg of San Antonio.

The ranch is recognized as good combination livestock country, well watered and fenced with excellent hunting. It is also one of the few places in West Texas where mineral rights can still be bought. There is oil production surrounding the area but no oil leases were sold on the ranch.

The ranch is currently under lease to James and Bob Childress of Ozona and Birch Woodward of Fort Stockton but possession of the land can be delivered to the buyer at the time of sale.

The historical significance of the country extends from the prehistoric Indian artifacts that can be found on the slopes of the mesas to the coming of the Spaniards in the middle 1500's, and on to the Lipan Apache defeat at the hands of the fierce nomadic Comanches in the mid 1700's and then the termination of the Indian at the hands of the United States

Calvary in the late 1870's. The land was then open range supporting maverick cattle and sheep until settled by Berry Ketchem.

According to Nip Blackstone, Ketchem sold out to Blackstone-Slaughter about 1914. The story goes back that the Blackstones started out in Oklahoma after the Civil War. In Nips' words, "My grandfather came out of the Civil War and went out and settled in the Indian Territory with three other brothers. They had married into the Choctaw Indians out there; I'm not sure exactly how the connections are, but one or two of them had come out of Tennessee over the Trail of Tears."

"Anyhow," Blackstone continued, "this grandfather put together a mercantile company in Oklahoma and when he died, my Uncle Nip and Mrs. W.L. Slaughter were the older children and they kind of handled the business." "And when Mrs. Slaughter married, it just fell natural for the Slaughters and Blackstones to become partners."

The purchase of the Blackston-Slaughter country was "a partnership, more or less," Blackstone said, "and had never been divided among the rest of the children of the grandfather."

"So when my uncle died, rather than make a division among his brothers and sisters, for some reason or other he left the nieces and nephew his part of the ranch and left it in trust with us," Blackstone said.

The uncle was married, Blackston said, but had no children other than a sister of the San Saban whom he adopted, Mrs. Blackstone, whose estate is an heir to the ranch.

Also, he said, the heirs decided to sell the ranch because they had been unable to reach agreement for a land division and "the only alternative is to sell it and that way we'll each get what we feel like is an equal share."

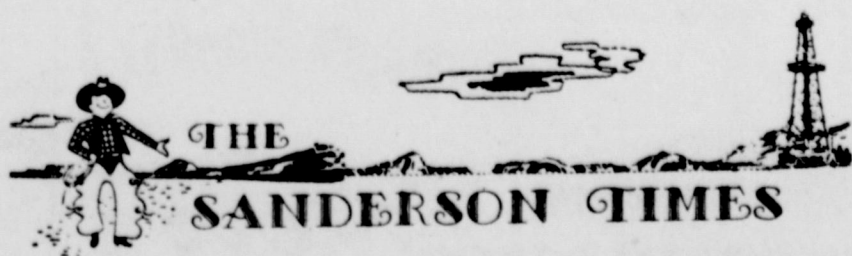
