Last week in the story about the school trustee post, the facts were right, but we just didn't go far enough with our conversation with Herbert Brown to understand all of the facts. This is the rest of the story. At the time of our conversation, the school board had not met and decided anything. He said that "right now we have made no plans to appoint anyone for the unexpired term", and that is what we said that he said, and that was right. What we didn't understand was that the board had not met and so there was no decision.

And well they may decide not to appoint anyone, and they may not. And if they don't appoint anyone this week, they may decide to do so next week, and that is their decision.

This is our opinion only: if a new member is appointed now, he or she would be in on the decisions about the re-hiring of all of the teachers and administrators, etc. And this could be some kind of a disadvantage, maybe. On the other hand, a new member appointed and facing ouster in April might jump in and get his feet wet right off the bat. We never saw a coin that didn't have two sides!

Whatever the board does, there was only the intention on our part to inform the public what the board was doing about filling the vacancy. There has been a lot of speculation and questions asked about the vacancy and we were trying to get the facts.

Troy Druse asked us to appeal to anyone who has any emergency oxygen equipment that is not being used, to please contact him or any member of the emergency squad. There are times when it would be beneficial to have oxygen available for use locally. The ambulance keeps a supply on hand for transporting patients to the hospital under oxygen, but there is nothing extra and sometimes its use seems indicated.

That's another public service accomplished!

There were only 31 people who cared who was elected to the post of directors of the Terrell County Water Control and Improvement District No. 1 in balloting on Tuesday.

At least, there were only 31 voters who cared enough to cast a vote.

What do the members of the board of directors do? Wow!

They determine water rates. They determine whether or not money is to be expended for physical improvements, such as equipment to increase water pressure and/or volume to some parts of town, whether or not to increase storage, to increase the supply by drilling wells, to increase plant facilities, to determine policies of billing and collections, naming the manager and de-

Filing Deadlines For '72 Elections, Dates For Voters

1972 is an important election year with local, state and national elections scheduled. The first one of the year was Tuesday of last week when three directors for the Terrell County Water Control & Improvement District were elected. The next scheduled election will be in April when school trustees are to be named, and the national party primaries will be on May 6.

The terms of Bill TenEyck and Will J. Murrah, as trustees of the Terrell County Independent School District, expire this time and the election of three members of the board will be on April 1. The third post to be filled on the board is due to the resignation of David Mitchell.

In the balloting to be on May 6, there will be elected party nominees for all those holding primaries in the county for the offices of: party chairman in each of the precincts, county party chairman, constables and commissioners in precincts 1 and 3, justices of the peace in precincts 2 and 4, county attorney, and sheriff and tax-collector. On the district level, there will be judge and attorney; state representative and senator, and on up to the governor, as well as president and vice-president and other national offices.

Candidates for school board posts must file 30 days before the election date.

Precinct, county, district, and state candidates must file with the party county chairman by Monday, February 7.

JORDAN'S FATHER DIES

Funeral services were in San Angelo Monday afternoon for T. Wayne Jordan, 79, of that city who died Saturday afternoon at his home. He was the father of Wayne Jordan of Sanderson.

A native of Lufkin, Mr. Jordan had resided in San Angelo for 48 years. He was retired from the Santa Fe Railroad in 1962.

He was married to Irma Rose Dunn in Lufkin on February 28, 1915, and she died in September 1971.

Besides the son, he is survived by two daughters, a brother, nine grandchildren and ten great-grandchildren.

Illness Hits Many Local Residents

An upper respiratory infection and sore throats has invaded many local residents, according to information received from many sources.

There have been over 60 absences in local schools due to illness, it was stated, and there was some consideration of closing the schools due to the many absences.

Boys' and girls' basketball teams were seriously affected by the illness, according to the coaches, and the games scheduled in Fort Davis on Tuesday night were played by some of the reserves rather than the regular starters.

One Fort Stockton physician reported that he had treated 15 families for the illness on Monday alone.

The fluctuating highs and lows of temperature during the past several days has been the contributing factor, according to some people. The thermometer got down to 9 degrees one night last week while day-time temperatures have ranged in the shirt-sleeve area at times.

Commissioners Vote Pay Raise For Many Officials

The Terrell County Commissioners voted a pay raise to all county employees with the exception of themselves and County Attorney Jack Hayre. The action was taken at the regular meeting of the court Monday.

Included in the raise were County Judge R.S. Wilkinson, Sheriff Bill C. Cooksey, Deputy Sheriff Dalton Hogg, Office Deputy Mrs. A.J. Hahn, County Clerk Ruel Adams, and Justice of Peace W.G. Shoemaker.

The raise amounts to 5.5% the maximum allowable under the Office of Economic Stabilization and based on the current amount of salaries received by the employees.

TEN EYCK'S MOTHER DIES

Funeral services were in the First United Methodist Church of Fort Stockton Friday afternoon for Mrs. Ed TenEyck, 81, who died in a nursing home in that city Tuesday night. She had been ill for five months and had spent some time in a Big Spring hospital before being brought to Fort Stockton Christmas week to be near her husband who is in the nursing home there.

She was born in Dodge on May 1, 1890, and was married to Ed TenEyck in San Angelo on September 14, 1921. They moved to Fort Stockton from Tennyson in 1921.

Besides her husband, she is survived by a son, Bill TenEyck of Dryden; a sister, a brother, and four grandchildren.

40 Enrolled In Emergency Classes

There are 40 people enrolled in the emergency preparedness classes being held this week, according to Troy Druse. Six are here from Marfa, 1 from Presidio, and 3 from Fort Stockton, with the balance of the 30 people being from Terrell County.

The classes end tonight, January 13, and began Monday.

Ambulance attendants must renew their certificates every 24 months, according to information received, and this accounts for some of the out-of-town enrollees in the four-night course.

The State Department of Health is sponsoring and conducting the school with the cooperation of the Sanderson Emergency Squad.

The terms of the three directors named is for three years and begins with the day after the election.

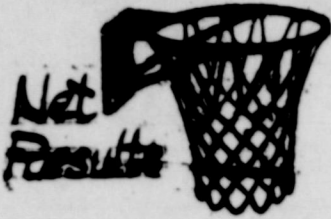

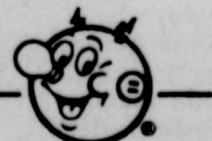

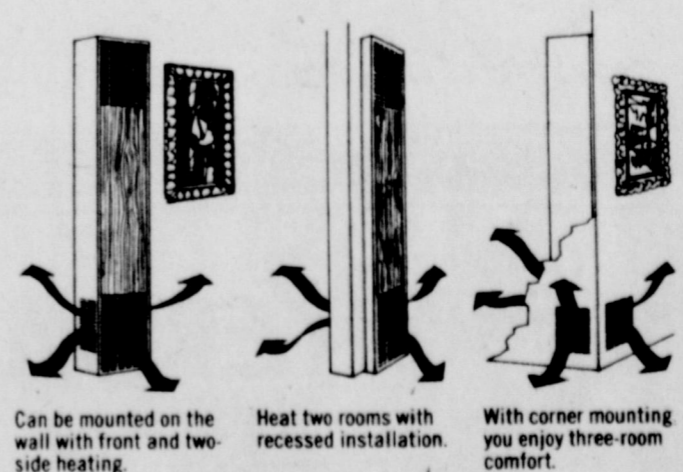

of the park's Christmas counts. These may be considered as the most common of the park-wintering birds.

Each year some variation within the park's birdlife is found. Weather is the greatest influence. The presence of waterbirds along the Rio Grande is predicted upon the weather within the north and central part of the country. Many ducks and other water-

A total of 116 bird species was found on the three 1971 Christmas bird counts in Big Bend National Park. The Rio Grande Village count produced 1020 individuals of 75 kinds, 1510 individuals of 72 kinds were found on the Chisos Mountains count, and 3202 individuals of 78 species were recorded on the Santa Elena Canyon - Castolon count.

Big Bend's bird counts are part of a nation-wide effort of censusing areas throughout the United States to determine bird populations. Sponsored by the National Audubon Society and the U.S. Fish and Wildlife Service, all counts must be taken within any 24-hour period during the last two weeks of the year, and are restricted to an area within a circle with a 15-mile diameter. All birds counted are reported on special forms and published in the journal named "American Birds".

Over the years these counts offer the best possible index to wintering birds; their movements, increases and decreases, and locations of wintering populations became known. This year was the sixth consecutive year that a census of Big Bend National Park's bird life was taken. Seven species were found this year that had not been found on previous counts; these seven bring the grand total of species recorded in park counts to 153. Only 25 kinds of birds have been counted only once in the 18 counts, and 14 species have been recorded on every one

birds can be found when weather to the north has been exceptionally cold. This is also true for ground-feeders. However, when late summer and fall rains fail, there are no accessible grasscrops and so these birds pass on through the area without lingering.

Christmas counts also offer evidence of "invasion years", periods when more than average members of far north birds frequent the area. This usually results from exceptionally cold weather to the north or failures in crops, such as pine cones.

As years go by, and counts continue, it may be possible to not only use the data as an index to the environment changes, but as a sort of weather prophet as well.

New Plates For Vehicles To Sell After February 1

Vehicle registration plates for 1972 have been received in the office of Terrell County Sheriff Bill C. Cooksey. Mrs. A.J. Hahn Jr., deputy tax assessor-collector, stated that the plates for passenger vehicles this year would have the prefix DFM and would run from 10 to 999.

Mrs. Hahn stated that the practice of holding plates for certain individuals would be done this year, the same as last year. Anyone who wants a specific number will give her \$1 and the receipt for the registration last year and she will hold the designated number for them, mailing it to them when the number comes up in rotation. She said that she would not be responsible for keeping the title to the vehicle belonging to the person asking for the special number, but would keep the receipt from last year and mail the license plates to the resident when they were available.

The sale of the registration plates will begin on February 1 and will continue to March 31, after which date all vehicles being used on public roads will be required to have 1972 plates.

The papers for the registration of vehicles this year have been received by most vehicle owners and they are asked to bring these papers with them when they come to register an existing vehicle which was registered in Texas last year.

Persons moving into the state and not having the papers that were mailed to residents, are required to bring titles to the vehicles to secure registration plates this year.

Voter Registration Details Revealed

According to a ruling by U. S. District Judge William Wayne Justice entered September 28, 1971, persons 18-21 years of age are entitled to register as voters under the same terms and conditions generally applicable to persons 21 years of age and older.

Persons 18-21 years of age may acquire a residence where they actually live if they intend to remain there indefinitely and call it their home.

For the first time since Reconstruction, Texas law provides for permanent registration. Under Senate Bill 51, the registration will entitle the voter to vote for three successive "voting years" in place of one year under the current annual registration system. A "voting year" begins on March 1. Every initial registration is good for three successive voting years (with some qualifications); and each time the voter votes in a general or primary election or has his registration extended or renewed by notice, his registration is good for another three successive voting years, provided he remains qualified and his registration has not been cancelled.

For the first time, under Texas law, voters may reregister by voting, a common practice in other states with permanent voter registration systems. An otherwise qualified voter is automatically reregistered for another three successive voting years when he votes in a general or primary election, including a run-off.

The new registration system removes the old January 31 deadline for registration. Any qualified elector may apply for a voter registration certificate at any time. The registrar will issue a voter registration certificate which will be effective for any election held on the 31st day after the application is received in the office of the registrar.

Year round registration removes the need to provide late-registration for persons reaching voting age, residence or citizenship requirements. A person may register 30 days before he becomes 18 years of age and before the completion of his first year of residence in Texas. All registrations received prior to January 31, 1972, are effective on March 1, 1972, and continue in effect through 1975 (with specific exceptions).

Senate Bill 51 retains the present procedures for initial registration. A person may register in person before a registrar or his deputy or by mail or by agent. Only the spouse, parent or child of the voter may act as his agent and then only if a qualified voter of the same county as the voter.

Yet another first for Senate Bill 51 is the requirement that a voter must sign a roster at the polls when he votes. This signature is then compared with that on his voter registration certificate. If the two do not correspond, he will be denied the ballot, subject to challenge regulations. Those who vote on a lost affidavit must also sign the signature roster. The signature roster is also used for absentee voting. Special regulations apply for persons who are unable to sign because of illiteracy, blindness or infirmity.

Several changes have been made by Senate Bill 51 in current law governing voting in precincts of which the voter is not a resident. The general rule is that a person must vote in the precinct where he is domiciled. If a voter votes in a precinct in which he is erroneously registered, his vote will nonetheless be counted in an election contest provided there has been no intentional error on his or the election judge's part, and the vote would have been validly cast in the precinct of which he was a legal resident. If the voter intentionally registers and votes in the wrong precinct, his ballot is void for all purposes. Persons who move from one residence to another within the same precinct must inform the registrar in writing of this fact. Persons who change their residence from one county to another must register anew in accordance with procedures for new registrants but for the first six months he may vote a limited ballot, using the registration certificate of the former county as evidence of registration. The registrar of the county into which the voter transferred his registration must notify the registrar of the county from which the registration was transferred.

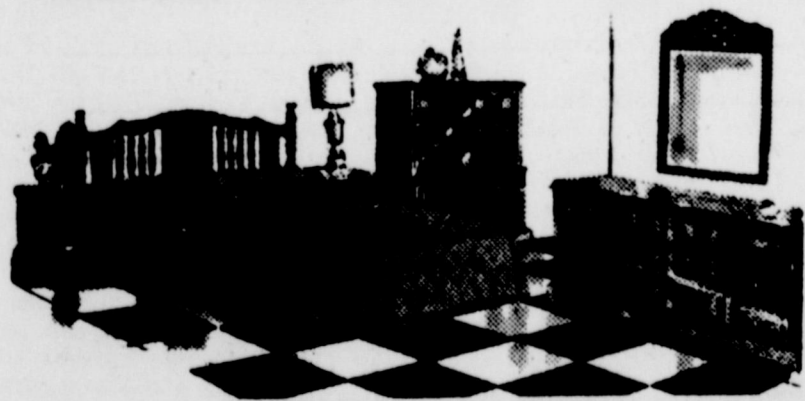

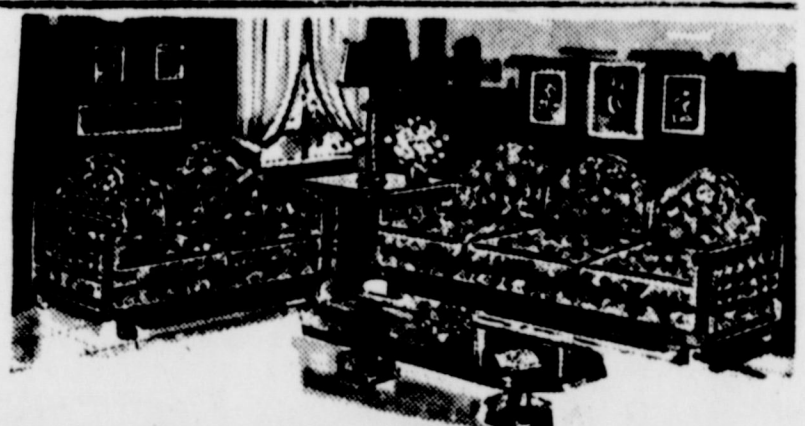

Medicare Has Benefits Limits

An increasing number of Medicare beneficiaries have received notification that some of the medical bills they have submitted for Medicare Part B payment were more than the allowable charge. T. Hedley, field representative, explained that limits on the amounts covered by Medicare have been established to keep down the cost of the Medicare program.

Authority to set the limits is granted by law and is based on amounts doctors customarily have charged in the past. A doctor's customary charge will be covered if it does not exceed the amount most commonly charged by other doctors of the same specialty in a locality.

Part B, also called "medical insurance", pays 80% of the charges for covered medical expenses, except for a \$50 annual deductible. If a claim

is filed on a bill which exceeds the allowable charge, the Medicare payment will be only 80% of the allowable charge.

Medicare claims are handled by insurance companies or governmental agencies, called carriers. In Texas, the insurance carrier is the Group Medical and Surgical Service, Dallas. The carrier arrived at its schedule of allowable charges by considering its knowledge of charging practices, fee surveys, review of claims, and judgments of its own staff physicians.

If you need more information, Mr. Hedley will be here at the county judge's office on January 17 at 1:30 p.m. and will be glad to try to find the proper answers for your questions.

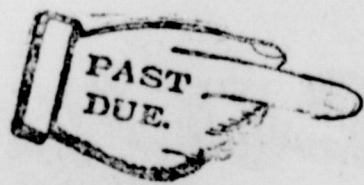
