Mr. Northcut was born November 18, 1895, in Emory. He was married to Pearl Holmes in Big Lake April 25, 1925. He had lived in Sanderson for 44 years, having been engaged in trucking and feed for most of that time until his retirement several years ago. He was a member of the Sanderson Masonic Lodge, the Shrine, and a Baptist.

Survivors include his wife; a son, M.G. Northcut Jr., Fort Stockton; a daughter, Mrs. J. A. Mansfield, Sanderson; two stepsons, Reginald Monroe of Sanderson and H.C. Monroe of Iraan; three sisters, Mrs. C.G. Taylor of Rankin, Mrs. Hanna Sievers of Arkansas Pass, and Mrs. J. D. Swindell of Wanatchee, Wash.; 12 grandchildren, and eight great-grandchildren.

This project and several other projects for the coming months were discussed and voted on for consideration by the YP C of C.

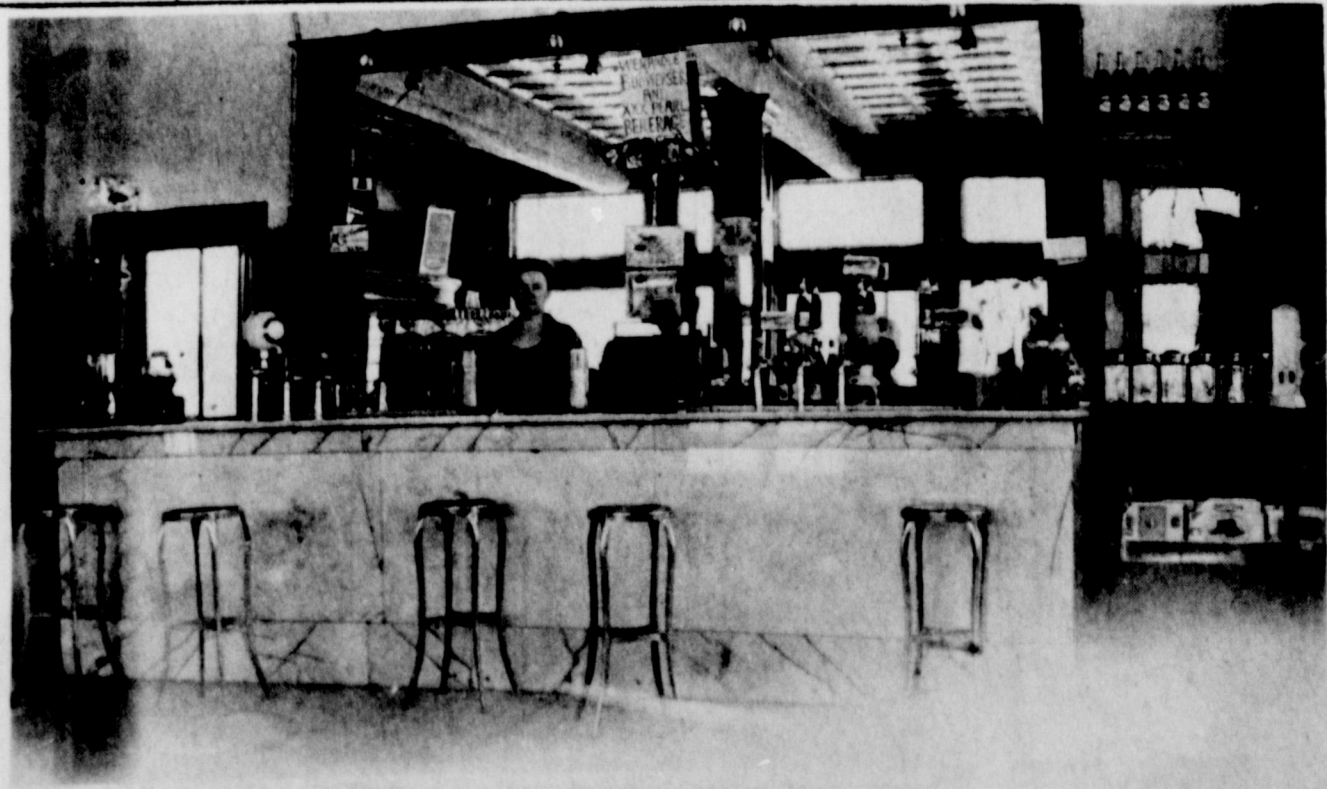

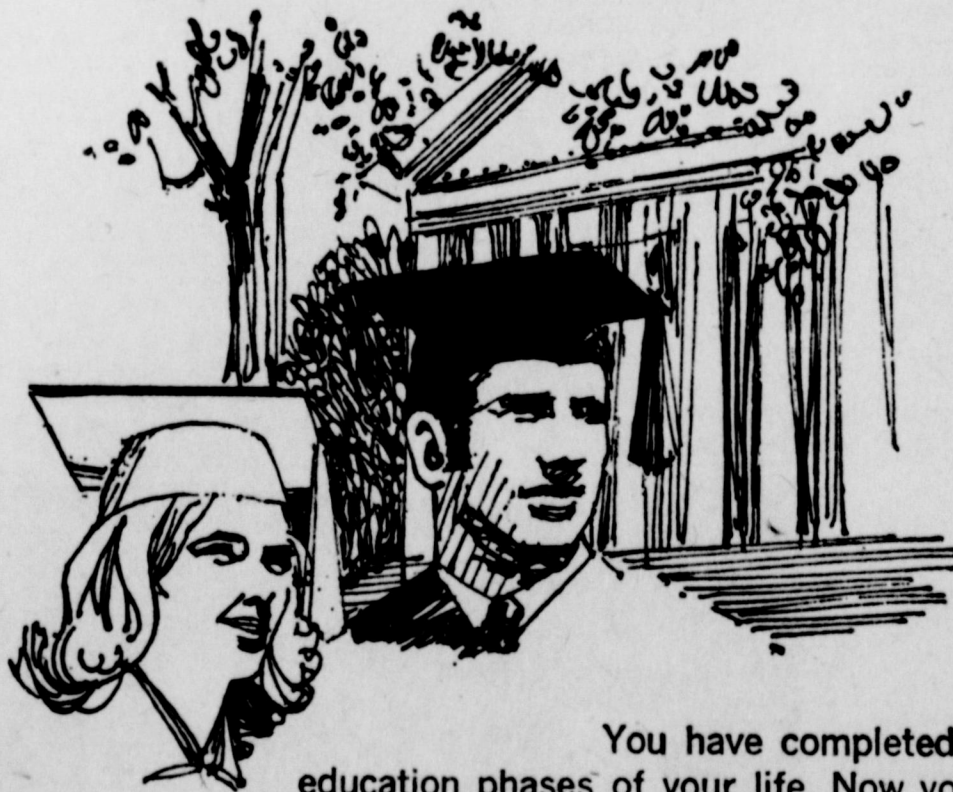

Dr. M. DeBakey Opines Cholesterol

A noted heart surgeon, Dr. Michael DeBakey, president and chairman of surgery of Baylor College of Medicine, said at a cardiovascular disease seminar presented by Danciger Institute of Menorah Medical Center, Kansas City, Mo., that he and his associates have found very little relationship between diet, cholesterol levels, and coronary artery disease progression.

In a story appearing in the April 7, 1971, issue of The Kansas City Times, Dr. DeBakey said, "Much to the chagrin of many of my colleagues who believe in this polyunsaturated fat and cholesterol business, we have put our patients on no dietary program and no anti-cholesterol medications."

He said he had found that 80% of his patients with severe coronary artery disease had had blood cholesterol levels comparable to the levels of normal people.

"When the levels are comparable, it just doesn't make sense that elevated cholesterol levels are the cause of coronary artery disease," he said.

The surgeon, who claims he eats only one meal a day -- late at night -- sleeps only four to five hours a day and practices no exercise regimen except "avoiding elevators at all possible times". He advises his patients to eat a varied diet of fruits, vegetables, and meats, keep their bodies in good tone with moderate exercise, and avoid anything in excess, particularly alcohol and cigarettes.

"I personally think most people eat too much and sleep too much," he said.

Dr. DeBakey thinks hearts damaged by coronary artery disease will be repaired surgically in the future, instead of being replaced.

Surgical techniques which either bypass the clogged heart artery or mechanically clean it have been perfected and he believes this approach is the most promising.

Parents Reminded Of Immunizations For All Students

Beginning in June of 1972, a student will not be allowed to enroll in any Texas school without a complete record of immunization or natural immunities through infection.

The immunizations, or illnesses, that a child must have experienced are: D.P.T., Polio, Measles, Rubella.

Certified copies of immunization records will not be required until June of 1972.

In the meantime, any record of immunizations (showing vaccines and dates received) presented by students will suffice; whether it be notes from physicians, clinics, parents, or one of many personal immunization records in current use.

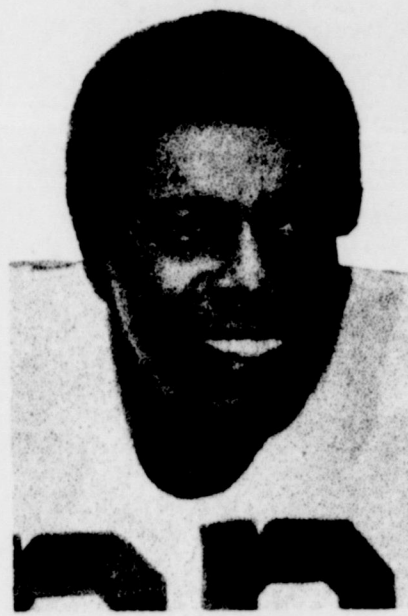

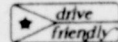

Responsibility of Parents Noted For Child's Development

by Jeannette Watson, Director Office of Early Childhood Development.

The time from pre-natal to four years of age has been identified as the most critical period in a person's total development. One researcher suggests that 50% of a child's thinking patterns are developed before age four. Another researcher goes further to identify the time from 10 months to one and one-half years as the most decisive period in a child's intellectual and social development. Still another study shows the high correlation between health and nutritional care of the mother during the pre-natal period to the future intellectual development of her child.

This information indicates greater parent responsibility for the physical, emotional, and social, as well as the intellectual development of their child.

Many persons become parents with inadequate knowledge of how a child grows and develops, and how to provide an environment for optimal development. These are skills that can be acquired.

Physical development: A child's needs for physical development include nourishing food, protection from heat and cold, diagnosis of handicapping conditions and opportunity for psychomotor coordination. It would seem that providing for a child's physical development would be one of the easier goals of the parent. And yet, some of Texas' families live in poverty and lack funds to meet these basic needs for food, clothing, and shelter.

Other children live in families with bare survival incomes that are not enough for even moderate achievement toward optimal development.

Emotional Development: emotional maturity is "caught" rather than "taught" and a child needs a sense of security, a basic trust in others. A self-identity that tells him he is important to himself and others is also a basic need. A child who has received loving care and gentle restraint is more likely to assume a responsibility for his own behavior as he grows older.

Social Development: As a child grows, he assumes a role and position within his own family. This role is the basis for his ability to form positive social relationships outside his family.

Intellectual Development: A child has a natural curiosity about his environment and a natural instinct to explore will promote thinking and will nourish the child's intellect.

There are 1,221,036 children under the age of six in Texas according to the 1970 Census. Each child is different. Each parent's method of child-rearing is different. There is no single method of child-rearing that should be considered the only correct method. Various methods are effective with different parents, even different children within the family, under different circumstances.
