That is one place where we disagree completely and to the hilt. We are all for "bussing", under certain conditions.

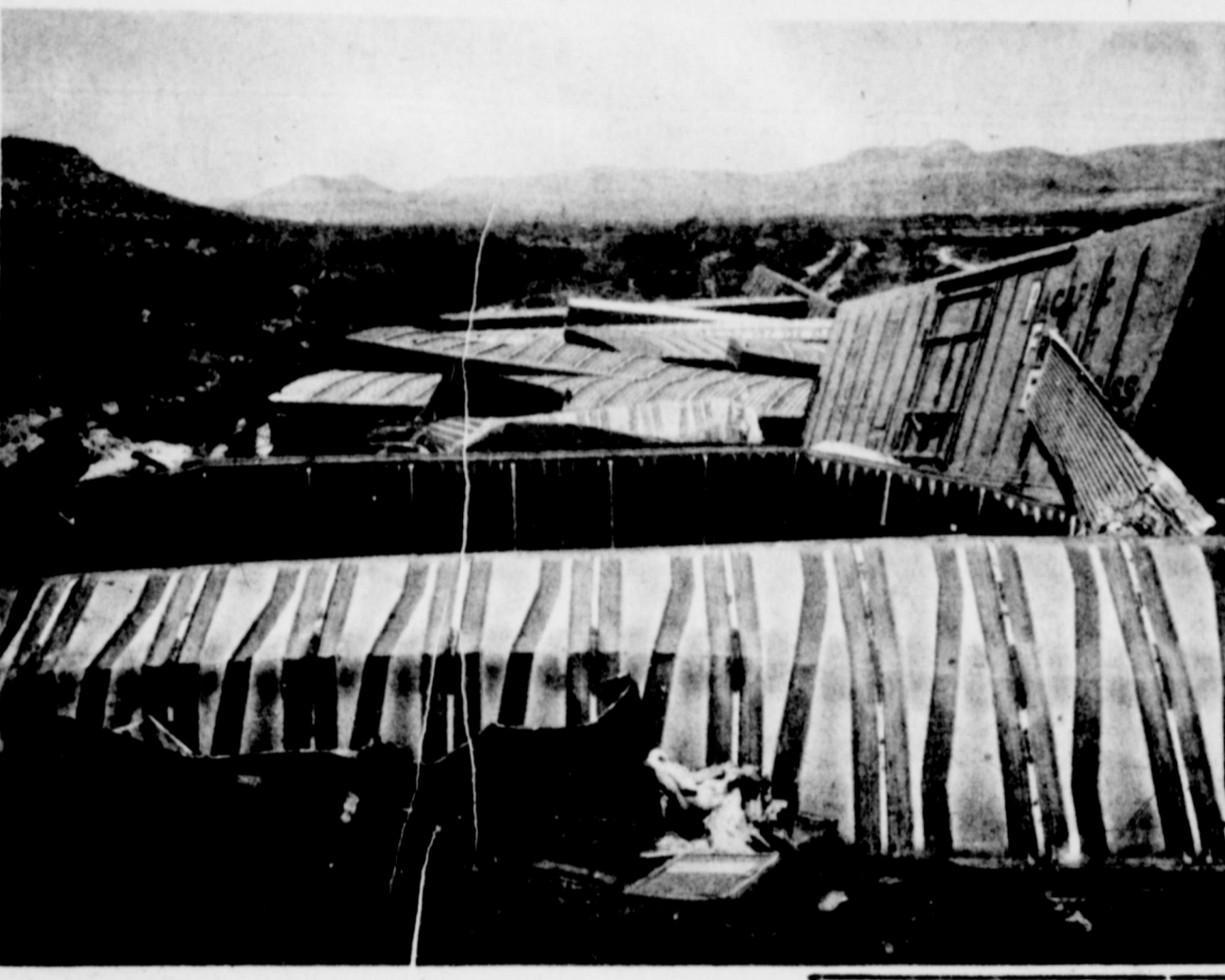
Now we have had some reservations about the advantages of "bussing" and whether or not it should be done. But "bussing" -- now that's another thing!

37 Units Derailed 5 Miles West Sunday Morning

Derailed of 34 freight cars and three units of the engine caused a tie-up of train traffic through Sanderson for several hours Sunday. The derailment was about five miles west of Sanderson. No one was injured in the derailment of the east-bound train. The head unit did not completely leave the tracks, but the other three units received considerable damage.

There was considerable damage to the roadbed and track for several hundred yards and a "shoo-fly" track was laid on the south side of the wreckage to permit passing of other trains. The derailment occurred just after 7:00a.m. Sunday and services was restored Sunday night.

The 34 cars immediately behind the engines were full of produce and perishables and the contents of some of the cars were spilled out due to the impact and wreckage.

The produce included carrots, oranges, lemons, watermelons, grapes, lettuce, celery, and grapefruit.

Equipment, machinery, and workmen for the laying of the "shoo-fly" track, cleaning up the wreckage, and restoring the track began arriving soon after noon Sunday and worked through the night.

Some workmen were able to get the head diesel unit back on the tracks early Sunday afternoon and it was brought into Sanderson.

Southern Pacific special agents from other towns on the railroad who were called in to prevent looting had difficulty preventing the taking of merchandise from the wreckage.

The pile-up of freight cars in the 37-car derailment early Sunday morning is depicted in the picture above taken from a vantage point in the wreckage looking to the west. The derailment was about five miles west of Sanderson and included three units of the diesel engines and 34 cars, according to James Clark, local trainmaster.

Radio System Planned for Area

A \$31,750 grant to design a regional radio communication system was approved this week for the Permian Basin Regional Planning Commission, Midland-Odesa, by Governor Preston Smith.

The money will come from the Criminal Justice Council, which oversees statewide law enforcement planning and administrators funds from the U.S. Department of Justice for crime control projects in Texas.

Because of the technical nature of the project, the major portions of the work must be performed by a consultant engineer. The engineer will inventory existing radio equipment, prepare a detailed system design, coordinate frequency allocation and assist in obtaining FCC licenses, prepare complete specifications, review bids, and supervise system implementation.

Grantee will furnish \$10,-848 in-kind match consisting of time devoted to the project by local law enforcement officials.

Counties served by the Permian Basic RPC are Andrews, Borden, Crane, Dawson, Ector, Gaines, Glasscock, Howard, Loving Martin, Midland, Pecos, Reeves, Terrell, Upton, Ward, and Winkler.

The Permian Basin application was one of 34 totaling \$1,333,746 considered by the CJC Executive Committee on May 12.
