Sanderson has some good things going for it now, and now is the time for all of us to begin to try to boost things and people in Sanderson. We have an increase in population, many of them are young people with new ideas and new ways of doing things, and many of them might get something done because they are going to do them. We have the need for more housing and more business services, we have the need to try our best to improve everything in Sanderson.

We once stated the need for doing some serious thinking about the changes that might come up with the decisions of federal and state parts of the unconstitutionality of locally-imposed property taxes, and we were formed unconditionally that there had been no such thing. And there is no need to begin guessing about the changes that are going to be made at the local schools, we can rest (?) assured that there are going to be changes.

## Representative Candidate On Election Trail



U.S. House of Representative Hopeful Doug Harlan of San Antonio visited in Sanderson last week. He is a Republican candidate in the 21st District and opposing O.C. Fisher of San Angelo in his bid for re-election. Terrell County was assigned to the 21st District in a recent realignment of the state's population and Rep. Fisher is the incumbent representative of the newly-formed district.

Harlan has been active in political campaigns of various Republican candidates for several years and this year decided to work on his own behalf in seeking election. He calls himself a conservative that will try to actively participate in legislative matters that are beneficial to the welfare of the nation, rather than merely "vote" on legislation that is presented. He said that he strongly opposed the McGovern-Democratic principles and felt that he could more adequately and correctly represent the electorate than could a conservative within the untrilateral leadership of the Democratic Party.

Harlan is 29 years of age, has a B.A. Degree in English from Rice University; an M.A. Degree in political science from Duke University, and a Ph.D. in Government from the University of Texas. He has taught as an adjunct professor of Political Science at Trinity University, and was a former visiting professor of political science and politics at Incarnate Word College, Southwestern University in Georgetown, and the University of Texas at Austin.

Candidate Harlan plans more trips to this area between now and election time, and said he hopes to meet and talk to more Terrell County residents during this time. He stated that he would appreciate people considering his candidacy as their representative from this district.

The tax rate was altered by action of the board of trustees of the Terrell County Independent School District at their regular meeting Monday of last week.

The new rate for taxes fixed by the board is \$1.45 for local maintenance and 33¢ for interest and sinking fund. The old tax rate was \$1.50 for local maintenance and 30¢ for the interest and sinking fund.

Other action by the board included the adoption of several new school policies, hiring new teachers, and letting of contracts.

Mrs. C.A. Haynes was hired as a special education teacher.

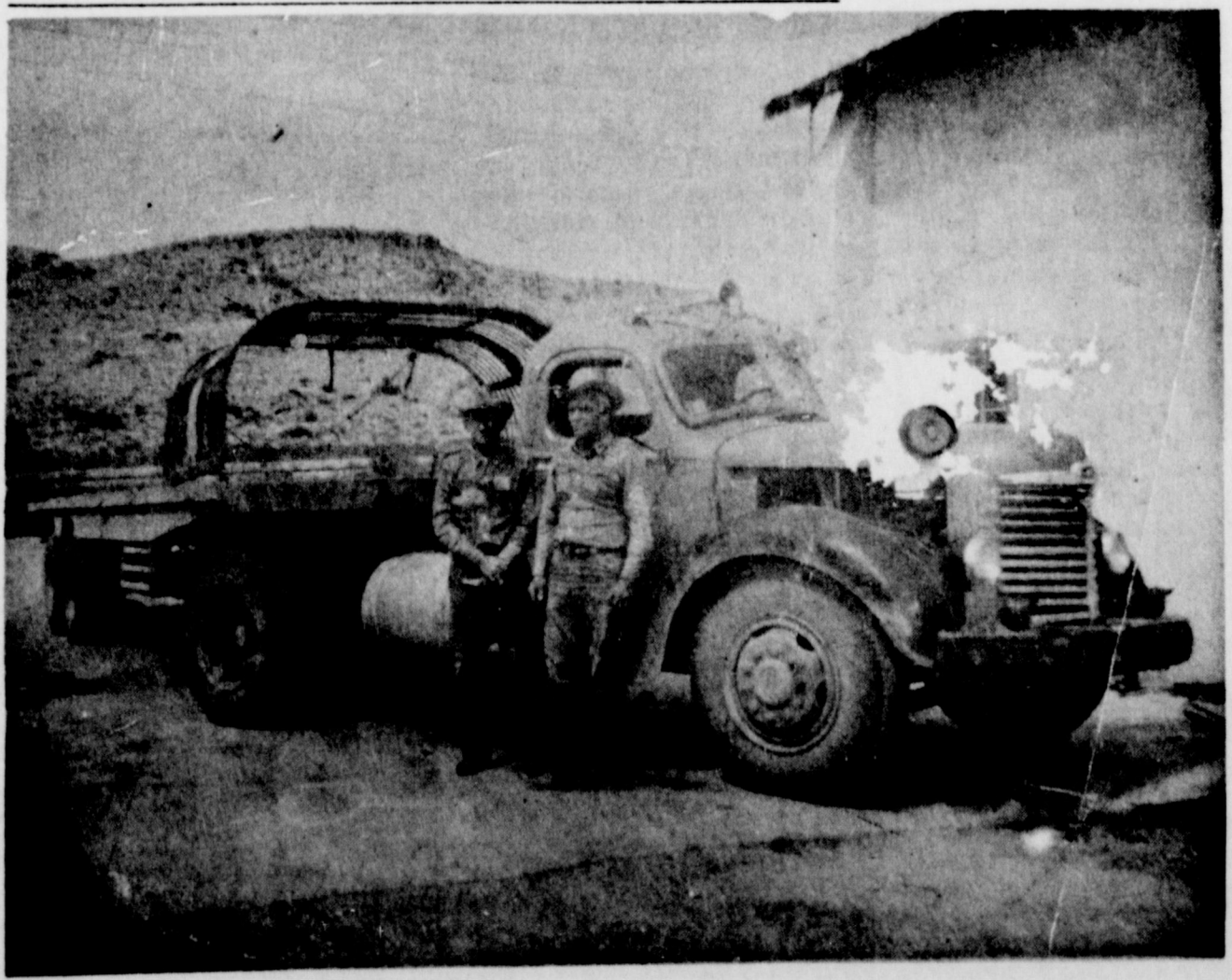
Mrs. Larry Choate was employed as the English teacher in junior high school.

tinues to grow and grow and grow and grow...

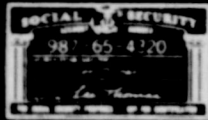
We get nice notes from some of our out-of-town readers when they send in their renewals, and sometimes notes between remittances. We appreciate these little personal remembrances very much.

**Questions and Answers**



**Q.** I'm starting my own selling business and my wife will be working as my employee. If I pay her a salary, are her earnings covered under social security?

**A.** No. This is considered family employment and is not covered by social security.

**Q.** I'm a farm worker. I travel and work in several nearby States, but I'm not part of a farm crew. I report to the State Employment Office in each area to get my work. How much do I have to make before my employers must report my wages for social security?

**A.** Each employer must report your wages and send in the social security contributions if he paid you cash wages of \$150 or more during a calendar year or if you worked for 20 or more days for him during the year for cash wages of any amount figured on a time basis rather than on a piece-rate basis.

**Q.** I work on a farm, and I sometimes get paid in produce, such as milk, eggs, and butter. Should this produce be reported as wages under social security?

**A.** No. Only cash pay for farm work counts as wages under social security.

**Q.** My husband died 3 years ago. I'll be 60 in a few months and I want to apply for monthly social security widow's payments. Must I wait until I'm 60 to apply?

**A.** No. You should apply 2 or 3 months before you reach 60. You'll need proof

**Area Ranchers Aid In Environmental Preservation**

Terrell County residents are doing their part to preserve our environment.

The Soil Conservation Service working through the Rio Grande-Pecos River Soil and Water Conservation District is pleased to report that 182,902 acres of proper grazing use was applied in the district during the year ending June 30, 1972. This means that there was adequate food and cover for wildlife, more soil protection from silt producing erosion, more grass for livestock use, and a better environment to live and work in for Terrell County people.

In conjunction with proper grazing use of our grassland, 86,792 acres were deferred to allow fast recovery of native grasses. Cooperators in the district also constructed 6,360 feet of livestock water pipelines, 6,300 feet of fences, and numerous livestock water troughs in order to manage their livestock better. In all 175 contacts were made involving soil and water conservation in the district during the past year.

During the coming year emphasis will be placed on obtaining proper grazing use, deferred grazing and developing planned grazing systems in order to improve our environment and provide a better place to live.

of your age, proof of your marriage, and your husband's social security number when you apply. If you have a social security number of your own, you'll need that number as well. But you should not delay filing your application because you don't have all of the items listed above. The people at the social security office may be able to help obtain them.

**Q.** After working for nearly 30 years, I can feel myself slowing down physically in the last few years. How serious a disability must I have to get monthly social security disability payments?

**A.** For social security purposes, you are considered disabled if you have a severe physical or mental condition which keeps you from doing any kind of substantial work and which is expected to last a year or longer.

**Q.** I'm a homemaker. I've never worked outside my home except last summer when I worked in a friend's store. Could I get a refund of my social security contributions from that job?

**A.** No.

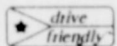

### Household Figures Of Census Told

The 1970 Census of Housing counted 850 housing units in Terrell County, and 581 households had at least one television set, the Bureau of the Census, U.S. Department of Commerce, announced today. The figures are from the first report for Texas which presents detailed statistics on housing for each county.

The report shows that in the county:

There were 546 housing units with air conditioning, 575 units with a clothes washing machine, 217 with a clothes dryer, and 95 with a dishwasher.

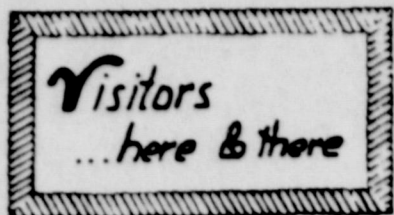
The 1970 population had an average of 3.2 persons per housing unit.

A total of 644 housing units were built before 1949, 114 during the 1950's, 41 during 1960-64, and 51 within the five years preceding the April 1970 census.

Electricity was used to cook the meals in 173 households, and LP gas in yet another 503.

There were 825 housing units with complete kitchen facilities and 763 with complete bathrooms, both for the exclusive use of the households.

Owners occupied 381 units, renters 237 units, and a total of 232 units were vacant year round with 0 for sale and 123 for rent.

## Average Income Is \$6,577.00 For County Residents

Average family income was \$6,577 in Terrell County in 1969, compared with \$8,490 for the State, according to a report on the 1970 census by the Bureau of the Census, U.S. Department of Commerce.

The 1970 census counted 1,916 residents in the county; 4.8 percent were foreign born and 12.3 percent native born with one or both parents of foreign birth.

Among the county's 1,753 inhabitants age 5 and over in 1970, 340 were living in a different county within the state in 1965, and 43 in a different state.

In the population age 16 and over, 72.7 percent of the men and 27.0 percent of the women were in the labor force. Among the employed, 35.5 percent were holding white collar jobs, and 13.7 percent were government workers.

There were 533 persons 3 to 34 years old enrolled in school. In the 25-and-older population, 37.5 percent of the men and 41.6 percent of the women were high school graduates.
