## LISTEN TO LUKE

By Albert: ---  
Our attention was directed last week to the fact that a suit has been filed in Pecos County for redistricting. This is the second suit, if our memory is correct, that they have had in that county in about four years. This suit alleges that there is an excessive inequality in the number of people in the precincts.

There is no point that we can see in not talking about the fact some more that the commissioners of Terrell County have been considering a redistricting for some time. There has been quite a bit of talking, figuring, line-drawing, money spent in counting heads, etc., for some time, but there have been no final plans agreed to as yet. There may be and there probably is 1-jillion different ways to draw the lines equally dividing the population of the county within the limits of the law, and there is little need that we can see in being too particular where the lines are drawn--except to divide the county equally. Regardless of how we might think it should be divided, and regardless of how it is divided, there will always be those that think it should have been divided by a line drawn in another place for some reason.

But the odd part of it is, that regardless of who is in which precinct when there is an agreement, there will be a time when another group of voters come along and there will be other commissioners elected. Time was when some commissioners in some counties felt that if everything was kept quiet that there would be no call for ever considering equalizing the population, then along came some "busybody" butting in where he had no business and forced some counties to abide by the law, and then the word spread and spread and now most every county has either had a re-alignment of precinct lines or is considering one.

The job of commissioner, like several other jobs, appointive, elective, and contracted, have an extreme responsibility with them that many people do not often think about, nor appreciate. School superintendents, water board managers and directors, postmasters, hospital directors and business managers, and many other such officers carry this awesome responsibility. First, they all start out with friends. And strangely enough sometimes your friends put you on a spot that is more precarious than do your enemies. It is not always intended to be spot-putting, but a friend, because he is a friend, needs some little favor done, so he asks it of a friend and in a friendly way.

This is usually an act of friends, because enemies figure that you are not going to do anything for them in the first place!

And a friend who asks this favor, then puts his "friend" on a spot and the ball starts rolling.

"Friend, you will not put us in jail if we have a raffle to

Get the point?  
It is the responsibility of anyone who has a trusteeship of this kind that they work for the best interest of all people concerned -- or to put it another way, to not work to the disadvantage nor for the best interest of everyone involved.  
All of the money belonging to all of these sub-divisions, and all of the properties of all of these subdivisions belong to all of the people of the subdivision equally and the private use of any of it seems to be completely contrary to the law, as we understand it. And, of course, so is the money spent by any of the subdivisions subject to the careful attention of the trustee, that it is spent in a manner that is most beneficial to best interest of all concerned within the sub-division.  
And what's right and wrong depends on how you look at it, sometimes!

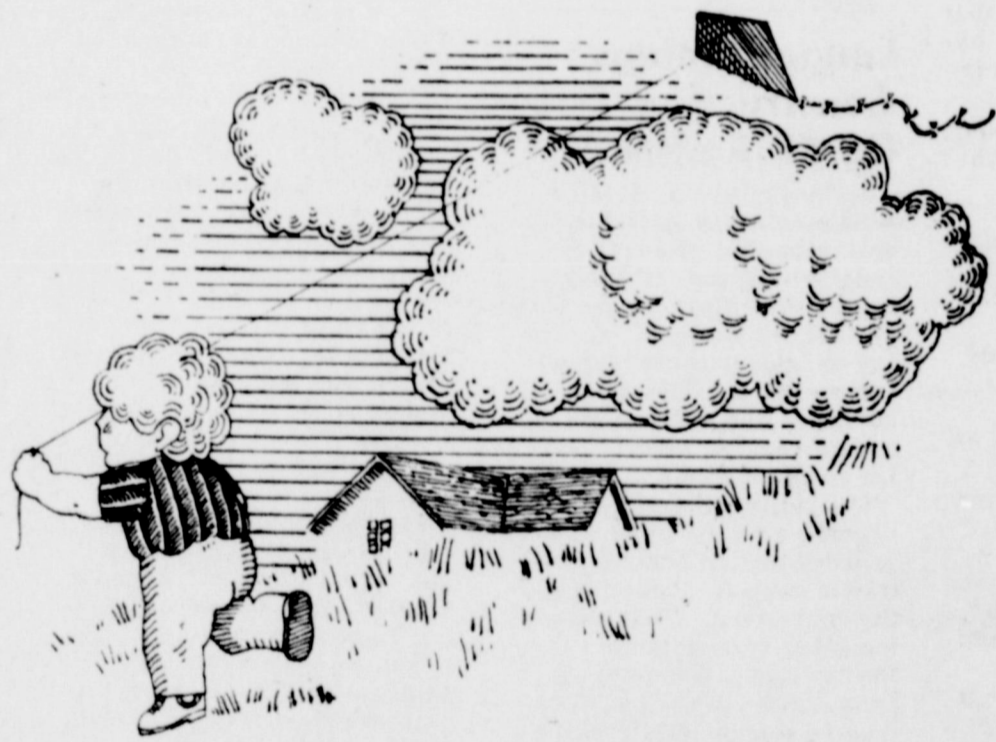

## Disabled with Workmen's Compensation Can Get Larger Social Security Checks

More than 40,000 disabled workers getting both workmen's compensation and social security disability benefits get larger social security checks because of a recent change in law, according to social security officials here.

Combined social security and workmen's compensation monthly payments still can't be over 80 percent of the worker's average monthly earnings before he became disabled, a social security spokesman said, but the new law adds another way to figure the average earnings.

"His average monthly earnings can now be determined by his highest earnings in any one year of the 5 years before he became disabled," he said.

Previously, the average had to be based on earnings in 5 consecutive years, or, if it worked out to a higher figure, the number of years used to figure the amount of the worker's social security disability benefits.

To get social security

disability payments a worker must be severely disabled before 65 and unable to work for a year or more and must have a certain amount of work credit under social security.

"For more information about how workmen's compensation affects social security payments," the spokesman said, "call, write, or visit any social security office."

## Consumers Need to Know

by LEE LANDIS

Americans love appliances. Today they use over one billion, according to the First National City Bank of New York. In fact, the average person is custodian of thousands of dollars worth of large and small appliances. No wonder problems crop up from time to time.

All too often appliances, particularly the small ones, are bought haphazardly. Because they are relatively inexpensive, many customers do not save the guarantees, nor do they read the instructions carefully.

The Better Business Bureau says that many consumer complaints about appliances are due to "abuse, misuse, lack of knowledge about the appliance or the expectation of performance beyond capabilities."

Almost 40 percent of service calls are said to be unnecessary simply because instructions were not followed. Checking to be sure the appliance is plugged in or that the house circuit fuse is not blown should be a 'must' before you make a service call.

It's important not to overload circuits, and appliances should be kept clean, oiled and adjusted according to the maker's instructions. The most frequent causes of breakdowns in washing machines are: overloading or uneven loading; too much soap; things left in pockets such as nails, hairpins or sharp objects that damage the mechanism.

In dryers the trouble-makers are not setting the right temperature for the fabric, and overloading.

In refrigerators, defrosting with a sharp instrument or not defrosting often enough, overloading, and too much jiggling of the temperature setting are reasons for failure to function correctly.

Before buying a major appliance, it is wise to acquaint yourself with the new features, functions and prices.

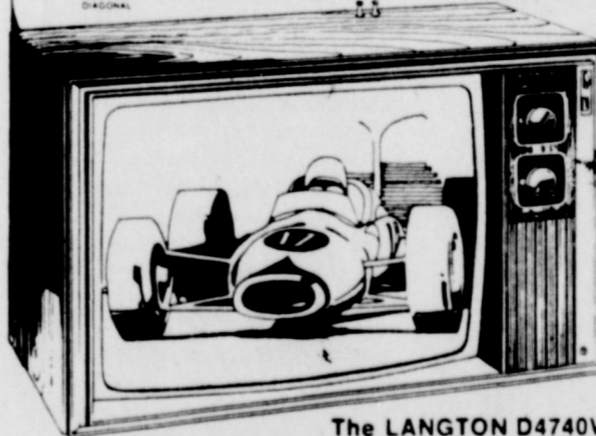

## Easter Seal Sales Benefits Listed

The Texas Easter Seal Society can provide the following services for handicapped persons who cannot afford to pay all or part of the costs involved, and who are not eligible for help from any other resource—public or private.

1. Assistance in paying for physical, occupational, and speech therapy when it is prescribed by a medical doctor.

2. Pay for specific diagnostic evaluation (such as orthopedic, audiological, language and psychological).

3. Purchase orthopedic equipment such as wheelchairs, walkers, crutches, braces, etc., when prescribed by a medical doctor. (There is a \$200 limit placed on artificial limbs. This \$200 is to be used as "seed money" and hopefully will be matched by local resources such as individuals, service clubs, sororities, foundations, etc.).

4. Help to defray transportation costs for treatment or evaluation when the family is unable to meet these costs. This is determined by paying 30¢ per gallon-based on 10 miles per gallon, figured on a round trip basis—or by purchasing round trip bus tickets.

5. Assist families and individuals to reach the right person or agency to obtain help the Easter Seal Society of Texas cannot provide. People are often eligible for services from public or private agencies but do not know the person, eligibility requirements, or place to obtain the services needed.

A limit of \$150 per client per year for therapy and \$150 for transportation has been set except in unusual cases requiring special attention. This limit can be exceeded only with the permission of the Treatment and Service Committee of the State Board.

All services must be authorized before being rendered by the Treatment and Service Department of the Texas Easter Seal Society.






