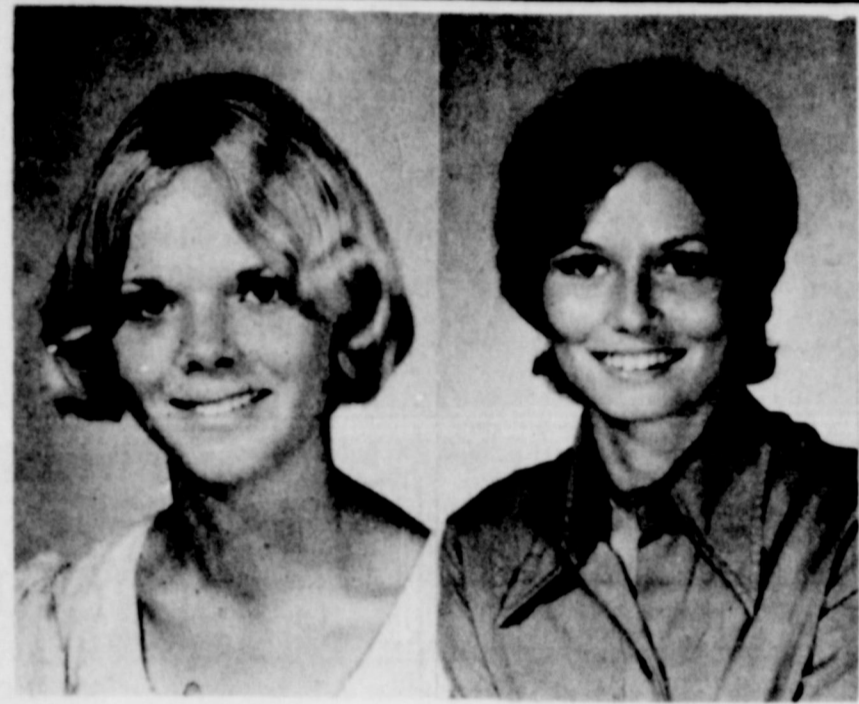

**LISTEN TO LUKE**

By Albert:-----  
Some of the comments heard around town about the amount of money received by certain area ranchmen in the form of subsidy or incentive sounded as though the ranchers were thought to be guilty of criminal acts! Or that they should be ashamed of themselves for taking the money!  
We wondered then, and we wonder now: If we were legally qualified to receive such a sum of money from the government, or from some company, would we turn it down?  
If there is chicanery, deception, or lying involved in the statements sworn to by the ranchmen, then that would be something else.  
Rather than showing our envy by ridicule or anger, we should be more alert to the real cause of anyone's being able to receive such hand-outs: Ourselves! We elect candidates and they pass laws.  
Isn't it a fact that we all search the records and activity of a candidate to see if he is going to be sympathetic to our cause -- not to the cause of the nation as a whole -- but is he going to help ME? The laws that made and will make these things possible are passed by people elected by people. Do you make yourself known to your representative or congressman? Did you know that there was legislation last week to lower the amount of subsidy available to ranchers and farmers from \$55,000 per unit, to \$20,000 per individual, and that this week such a vote came before the senate after being approved by the house?  
If a person does something within the law that we don't like or disapprove, then if there is enough force to change the law, try to do it!  
It is not within my conception of the laws that anyone must be ashamed to some degree proportionate to the dollars received for this kind of a hand-out. But if we had to be ashamed and if we were legally eligible for a \$30,000 or \$40,000 hand-out we probably would try to be appropriately ashamed all the way from the post-office to the bank.  
We had several say something like: "What does all that report about revenue-sharing mean?" and they were referred to the county judge and to the commissioners. The revenue-sharing fund received by the county may be spent in certain ways, only. It is not intended, by our understanding of the law, to be spent for the benefit of only a few, or to the exclusion of many, any more than our tax money is to be spent for the benefit of a few or to the exclusion of many.  
One of the ways in which the tax money may be spent for the benefit of many, without any segment feeling that they are being used or left out would be the redistribution of population by precinct lines rather than an effort to distribute the tax revenue equally. This is an effort that has been a consideration of the commissioners court for several months now. We think that it will

**Wool Incentive Figures Are Given**

Roy Stephenson, county executive director of the Brewster-Terrell County Committee, Agricultural Stabilization and Conservation Service of the United States Department of Agriculture, whose office is in Alpine, furnished The Times with the following figures of payments of incentive to Terrell County ranchers: Unshorn lamb incentive payments received - \$59,906.22; wool incentive payments received - \$580,294.93; or a total of \$640,201.15 received in Terrell County as incentive payments for the wool marketing year of 1972.  
The incentive revenue was for 931,063 pounds of varying grades of unshorn wool, and for four and a quarter million pounds of unshorn lambs, according to the documents filed by county ranchers. The payment rate for shorn wool was 105.7% of the proceeds received in 1972, and for unshorn lambs was \$1.48 per cwt. for the lambs sold during 1972. The Terrell County applicants had received an average of 59.1¢ per pound in contrast to the national average of 35¢ for shorn wool.  
There were 64 producers who received the incentive for unshorn wool and 55 sellers of unshorn lambs who received the total from that source.

**SP Seeks To Abolish Agents**

Testimony for transferring agency functions to a regional agency service center in San Antonio was completed by the Southern Pacific Transportation Co. last week and shippers, patrons, and civic interests in some towns, particularly Del Rio, presented testimony in an effort to stop the move. The hearings were held in San Antonio.  
The request before the Railroad Commission of Texas would abolish all the transportation company's stations east from San Antonio to Schulenburg, and west to Marathon. The regional agency, established in San Antonio, would perform all station functions currently carried out by the individual stations. The railroad plans to adopt the regional agency on a systemwide basis, it was revealed.  
Rail company officials testified that they decided to introduce the regional agency concept along with the Centralized Traffic Control (CTC), now under construction between Flatonia and Sierra Blanca, as a part of the program to automate the railroad's mainline traffic through the state. They said that station personnel at the small points are presently mainly involved in the movement of trains and they receive instructions from train crews from the dispatcher at Houston by telephone which they copy and hand up to the train crews as they pass. In addition they handle agency work for the station. In most of the smaller stations, the day employee has been designated as agent-telegrapher.  
When CTC installation is completed, movement of trains will become a "push button" operation with a dispatcher in Houston opening and closing all switches. Testimony indicated that when the CTC is placed in operation, the railroad plans to eliminate the clerical or telegrapher jobs at such locations as Marathon, Hondo, etc., and to remove the existing railroad station buildings.  
The Southern Pacific witnesses testified that they would

probably work out better for the county.

There are those who do not like the revenue-sharing idea. If there are enough people who are disenchanted with the idea and the action, then it can be changed. To ridicule the county for accepting it, like ridiculing the rancher for the subsidy or incentive money, is a lot like whistling into the wind. If we don't like the law, work for its change. And if the county spends the revenue-sharing money which in some way pleases me or benefits me tremendously, I will be as ashamed as I can be, but I certainly would not curse the reception of the money into one hand and gleefully reach for what it will buy with the other.

Some things that are good about making public certain receipts of money! There is absolutely no connection between the two: In the case of the reported pay-offs in the Watergate hearings, this is good information for the IRS. In the case of the reported revenue of incentive and subsidy, it is good information for those "every-member canvass committees" of the churches. May be we ALL should have to report ALL of our income to our churches! "every member canvass committees" to keep us ALL honest! We wouldn't be surprised but what many of us are much more dishonest with our giving than we are with our getting! And this, too, might depend on how you look at it!

**US90 Sign Owners Need Permits**

Owners of signs along Interstate and federal-aid primary highways face a June 30 deadline to apply for a permit and a license for them.

The Texas Highway Beautification Act, in effect since June of 1972, requires owners of signs which are within 660 feet of Interstate or federal-aid primary highways and are visible from main traffic lanes to file permit requests with the district offices of the Texas Highway Department. The permits cost \$5 each.

Before permits can be approved, sign owners must obtain a \$25 state license and post \$2,500 bond for each county in which they have a sign. Maximum bonds of \$10,000 are required of owners with signs in more than three counties.

Both license and bond applications can be obtained from Right of Way Division, Texas Highway Department, P.O. Box 5075, Austin, 78763, or any Highway Department district office.

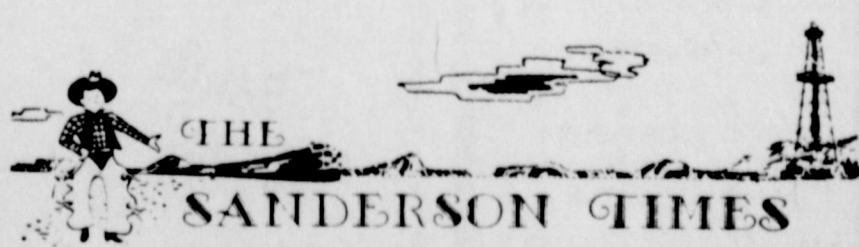
