## How You Look At It

We got a news release this past weekend from the Texas Society for the Prevention of Blindness about people with peripheral vision difficulties and the dangers involved in those with "tunnel" vision driving vehicles.

If we are interested in people, then we are interested in the people who have "tunnel vision", as well as those who may be endangered by "tunnel vision" drivers.

This "tunnel vision" and interest in people led us to be thinking about all of us having "tunnel vision" problems at times that is really not connected with a seeing problem - with a perception problem, instead.

Sometimes most of us are guilty of "zeroing in" on something and our vision being "tunnelled" to seeing only that one thing and from only that angle. This is one of the reasons we were so proud of ourselves for thinking up the new heading and the new object pictured. It is different things to different people and at different times.

Our own problems, or our own ideas at times supercede all bounds of reason, according to the reasoning of some other people, whose vision is sometimes "tunnelled" by their own problems or ideas.

Probably we are all guilty not being able to see two sides of things because our selfishness "tunnels" our vision.

One of the ways we try to look at things - when we are objective enough to recognize that there are two ways to look at something - is to see who is going to get what out of the deal in question!

If all we can see is that we are going to be the greatest benefactor, then we have to admit to selfishness. If all we are getting on the surface is "cussing", then we are sure there is nothing selfish. If we are getting cussed and reaping the most apparent benefits, then we are sure that ultra-selfishness is involved!

One of the cases in point is THE DOG PROBLEM!

Our trash barrel has a lid on it, we do not own any sheep or goats, and our only loss, personally, that we could foresee, would be from a bite of a stray dog and resulting possible rabies shots.

But dogs are taking over the town -- and country! And the more dogs, the greater the loss to livestock, and the greater the possibility of other unfortunate circumstances such as rabies outbreak, poisoning in town that could cause some unhappy circumstances or disastrous circumstances, some child being mauled by a dog, a greater loss of livestock, and on and on and on and on ...

It isn't fair to the ranchers to permit dogs to roam and kill their stock; it isn't fair

## Reports Given Of Immigration Officers' Action

O.D. Stevens, Chief Patrol Agent of the Marfa Border Patrol Sector, quoting L.W. Gilman, Southwest Regional Commissioner, said recently that during the period February 4 through March 1, 1974, some 58,000 illegal aliens were apprehended in the Southwest Region. Chief Stevens further states that from March 1 through March 19, 1974, the Marfa Sector Border Patrol has apprehended 1925 deportable aliens with a daily average of 101.31. Compared with February 1974, which closed with 1601 deportable aliens located for a daily average of 57.18, and March of 1973, during which an average of 76.19 illegal aliens were arrested daily for a total of 2362, March 1974, shows a significant increase in the number of illegal aliens in the Marfa Sector. Chief Stevens points out that of the 1925 aliens arrested thus far this month, 811 were located within 72 hours after their entry into the United States.

While March figures showing the number of aliens arrested while employed are not yet available, during February 1974, some 329 illegal aliens were working in agriculture and 189 were holding down jobs in American industry in the Marfa Sector when arrested by the Border Patrol.

The illegal alien is also a significant factor in the cost of police protection for the American taxpayer. Since

## Wool Prices Low At Recent Sale Here

The first sealed-bid wool sale of 1974 was at the Sanderson Wool Commission Co. Tuesday of last week.

The prices offered were below last year's offerings and several buyers refused the bid proposed by the buyers.

Austin Chriesman, manager of the wool warehouse here, announced last week that between 450,000-500,000 pounds would be offered by the producers.

About 180,000 pounds of 12-months wool sold for between 72-1/2¢ per pound to 88-3/4 cents per pound for the high of the sale. Of that amount, about 50,000 pounds had a low of 85¢, about 82,000 pounds at about 83¢; about 35,500 for 70-73-1/4; and about 28,700 pounds for between 75¢ and 79¢ a pound.

All sales were on a grease basis.

Producers rejected bids on about 132,000 pounds and the bids on about 52,000 pounds were pending approval of the producers.

Bids were rejected on a clip of about 3,000 pounds of 10-months wool; and bidding in the afternoon was on about 63,000 pounds of 8-months wool.

Neighbors to let the dogs mess up their premises in more ways than one, it isn't fair to let the population of dogs grow to detrimental proportions with the resulting possible results.

And if it isn't fair, then we should all be involved in removing the unfairness. When people decide that something is unfair, we believe they will do something about it, whether it's the depredation by dogs, or whatever.

In the case of the dogs, it's not difficult to enumerate the unfairness involved. Dogs can't read, and the reaction of readers toward the elimination of the problem, when it comes, doesn't have to be in a way that can cause other problems. If we were to go to all the dog owners of town who permit their dogs to run loose all the time, some of which are causing losses of livestock, or messiness on the property of others, or some of the other problems, especially that of causing other stray dogs -- then those people might be upset.

Pointing out unfairness specifically to individuals, in other words, is not easy to do, nor is it easy to take. Sometimes our vision gets "tunnelled".

And it depends on how we look at it!

After writing about the dog problem in Sanderson as we see it, we got the Big Lake paper and they, too, have a dog problem. It sounds as though they have what may be a good answer. The county is paying \$2 for every live dog brought to a certain place there.

By the way, in the ad about the "bounty", it was stressed that the county was not liable for injuries to persons who brought the dogs in for the bounty.

the first of March, almost 10 per cent (186) of the deportable aliens located in the Marfa Sector were already in jail for violation of local and state laws.

In the Marfa Sector, 11 illegal aliens have been prosecuted and sentenced in federal court his month, with prosecution pending against several others for violation of the immigration laws. The aggregate sentence imposed was 54-months and 5 days. Only the most flagrant violators of the immigration laws are prosecuted. For example, Mario Aragon-Miramontes, a Mexican illegally in the U.S., was arrested by Marfa Border Patrol Agents on March 2, 1974. Aragon had previously been allowed to depart the United States voluntarily six times, the last being on February 28, 1974. On the present occasion, charges for violation of 8 USC 1325 (entry into the United States without inspection) were filed to which Aragon pled guilty. He was sentenced to three months imprisonment. On February 27, 1974, Fort Stockton Border Patrol Agents arrested Luis Burrola-Gardea, a Mexican national who had been previously formally deported from the United States. Charges for violation of 8 USC 1326 (entry into the U. S. without permission after having been deported) were filed again Burrola to which he pled guilty and was sentenced to two years imprisonment in the Federal District Court in El Paso March 12, 1974.

The Southwest Regional Commissioner stated that from February 4 through March 1, 1974, Immigration Officers apprehended 793 smugglers of aliens and more

than 3900 smuggled aliens. Chief Stevens points out that alien smuggling in the Marfa sector continues to be an escalating problem. Since March 1, 1974, 17 smugglers have been apprehended with 73 smuggled aliens. Thus far, 11 of the smugglers have been prosecuted, including three United States citizens - two males and one female - two resident aliens and five illegal aliens. The aggregate sentence imposed against the smugglers was 71 months imprisonment and fines totaling five hundred dollars. On March 7, 1974, Nestor Campos of Kermit was sentenced in the Federal District Court in El Paso to 18 months' imprisonment. Campos was arrested at his home by Marfa Agents after their investigation identified him as the principal smuggler of six aliens apprehended near Marathon.

The Border Patrol continues to pay an ever-increasing role in stopping the flow of marijuana and narcotics into the United States. The Southwest Regional Commissioner stated that from February 4 through March 1, 1974, Immigration Officers seized marijuana and narcotics with a street value of over \$2,100,000. The largest seizure was 2,820 pounds of marijuana and two others of over 1200

### Governor Names Rural Hearing Commissioners

Governor Dolph Briscoe this week announced that three members of the Texas Industrial Commission will travel across rural Texas during the first two weeks of April conducting 26 hearings to determine the needs of rural Texas and possible programs which can help revitalize the rural areas.

Governor Briscoe said the 26 hearings are the result of the passage of the Texas Rural Development Act during the 63rd Legislature, which authorized special attention to the rural economy and added three more members to the Texas Industrial Commission, all from rural areas.

Appointed by Governor Briscoe as the rural representatives on the Commission are James Bond of Navasota, William Porter of Terrell, and James Hunt of Sonora.

The new rural commissioners will hold hearings in separate sections of the state to feel the pulse of the rural residents and gather facts for implementing a program to stimulate the rural economy.

"The three commissioners want to hear from everyone in rural Texas," Governor Briscoe said. "They will meet with civic leaders, business leaders, and elected officials to determine the best program possible to give rural

Texas an economic shot-in-the arm."

Hunt will hold West Texas area hearings in San Angelo, Monahans, and Lamesa April 9; Plainview, Pampa and Weatherford April 10; and Brownwood, Fredericksburg, and Uvalde on April 11.

After the hearings, the three commissioners will report on their findings to the entire Texas Industrial Commission membership and the Governor. The data will be used to prepare the recommendations on the rural development program to be presented to the Legislature in 1975.
