It Depends on How You Look At It!

The surety with which some people operate is overwhelming at times.... We got a press release Friday morning, post-marked April 17, telling about the election of the new president of the West Texas Chamber of Commerce on Saturday, April 20.

We do not know the new president at all and are not knocking him in any way, but it makes one wonder about certain processes. The news release also carried the list of the full slate of officers which were elected the fourth day after it was written.

If one could predict the election of some other officials as easily....

If Texans were basing their choice of Democratic candidates along with their choice of pari-mutuel betting in Texas, they are going to have to base their choice on some other basis, or get into another party.

We were quite surprised, frankly, to hear that either Governor Briscoe or Candidate Farenthold were personally opposed to pari-mutuel betting, and were more than surprised to know that they would agree in their opposition.

Maybe the choice is not so much of a difference! Maybe it depends on how you look at it!

We got two letters last week from readers on the same subject - residence of candidates. Both were long, both had their individuality, both were in agreement in their expressions of doubt as to the residence of certain candidates.

We feel that the subject has been well aired. We feel that most all of the voters have already determined what they are going to do at the polls. We feel that publishing both of the letters would be too repetitious and too lengthy. We feel that publishing either one would not be fair to the other. We feel that publishing neither or both would not serve any good purpose because of the above.

There is no other motif, whatsoever in our decision to not print the letters!

It was some kind of an accomplishment for Brad Harrison to be chosen the head drum major of the Texas A&M University.

We join other friends in expressing our congratulations to Brad, and we hope that the experience will prove to be very beneficial for him in his future life.

Three students from Sanderson High School will go to Austin the weekend of May 3-4 to compete at the state level in their respective events.

Gaye TenEyck will compete in journalism, headline writing, in the literary events there. Mrs. E.E. Farley is her coach.

Gaye won first place in that event in regional competition in Lubbock last weekend. Wynne Massey was second in informative speaking for girls. Her coach was Mrs. J.L. Whistler.

Ricky Marquez won the mile run at Lubbock with a time of 4:30.8. He will run against the other class A regional winners in Austin.

Bill Mott won the discus throw in Lubbock with a distance of 153'10". He will be another contender for the state championship in Austin May 3-4. Coach Willie Myers has been mentor for the two boys named above during the regular track season.

Kevin Phillips finished 4th in the 440-yard run at Lubbock with a time of 51.1. He did not place in the 220-yard run.

The mile relay team - Phillips, Robert Kline, Ja Chriesman, and Marquez ran their best time of the season, and excellent time taking into account the weather, according to Coach Myers, and had 3:30.1.

Mrs. Ginette Litton, who is seeking re-election as county treasurer; Mrs. T.O. Moore, who is seeking the post of justice of the Peace of precinct 3; W.G. Shoemaker, who is asking election as justice of the Peace of precinct 4; Edward Kerr, who is seeking election as County Democratic Chairman; Vic Littleton, who is seeking election as Demo chairman in precinct 4, are all unopposed in their respective races.

Other races of interest to local residents on the ballot include the race for U.S. Representative of the 21st Congressional District which is being vacated by O.C. Fisher after numerous terms, and the race

for State Representative of the 70th District, in which the incumbent, Hilary Doran, has declined to seek re-election.

A field of six candidates vie for the congressional district. Candidates include Judge Allen Moore of Rankin, Rep. John H. Poerner of Hondo, Rep. Nelson W. Wolff of San Antonio, both the latter are state representatives from their respective districts, Bob Krueger of New Braunfels, Joe Sullivan and Patrick Ainsworth.

Democratic candidates for State Representative include Ozonan Bill T. Williams, E.L. (Lee) Davenport of Del Rio, Stanley C. Hausman of Eagle Pass, Susan Gurley McBee of Del Rio and Dick Ratliff of Alpine.

Another race is for Associate Justice Court of Civil Appeals, Dist. 8, which pits Howard M. Lemmons, formerly of Ozona, against Max N.

Osborn of El Paso. The election is for an unexpired term.

Other incumbents drawing opponents include Governor Dolph Briscoe, who is opposed by Frances Farenthold, W.H. Posey and Steve S. Alexander.

For Comptroller of Public Accounts, Bob Bullock and Hugh Edburg are seeking the spot vacated by Robert Calvert, who did not seek re-election after numerous terms in office. State Treasurer Jesse James is opposed by Donald B. Yarbrough. Commissioner of Agriculture John C. White is opposed by Herbert A. Schroeder. Mack Wallace and C.A. Kelly are on the ballot for the unexpired term of Railroad Commissioner. All other incumbents are running unopposed except for state board of education, 21st District. Seeking the nomination are Jimmy L. Elrod and Tom R. Parrett.

The only proposition on the ballot concerns pari-mutual wagering on horse races by local option in Texas, which voters will vote for or against.
