It Depends on How You Look At It!

The silt deposited by the high water of two weeks ago has been boiling up in the gusts of wind that have been so prevalent during the past few weeks. That plus the regular dust that blows in with the wind is causing some kind of unhappiness among people trying to keep things clean.

The election was not over with the tallying of votes on June 6. There are two local run-offs and some state-district and federal-district races to be decided.

We heard a new one the other day about decisions in picking candidates: some voters do not realize their need of an official, and consequently use all kinds of criteria as a basis for their vote.

The two local offices in the run-off, for example! Who needs a county clerk or a precinct member of the Democratic executive committee?

Our answer: EVERYONE! You may never have any personal contact with either of those officials officially, but the duties of their office are such that they affect very much many things in our lives and they should be given as much thought and serious consideration as if we had official contact with them daily!

At least that is the way it looks to us.

The clerk keeps records of action of the commissioners court, county and district court, files and keeps records of all kinds of legal transactions such as the transfer of titles to property, deeds, etc., keeps records of births and deaths in the county, records and files for record all kinds of agreements, leases, easements, all indexed, properly filed, etc., for easy reference. The clerk also takes acknowledgements of all kinds, sworn statements, duplicates filed records and transactions on demand, records all bills of the county and issues warrants for their payment after authorized to do so by the commissioners, and a thousand and one other little details that affect us all directly or indirectly.

And the party precinct member of the Democratic executive names election judges and clerks, rules on questions brought before the committee about candidates, procedures, canvasses votes, names successors to the committee when vacancies occur by a committeeman moving out of his precinct, or death, or resignation, generally manages and controls the procedures of elections by primaries.

You bet the job is important. And people should be very

Special Education Available Here For Certain Students

Sanderson schools will begin a program for 3, 4, and 5-year old children who may have problems later in school. This may be a full day program, a half-day program, or just an hour or two a day, depending upon the help the child may need, according to Supt. C.B. Card. Screening or finding these children will be done this spring and summer. If a sufficient number of children need this special help, classes will begin with the start of school August 19, 1974.

Was your child slow to begin walking? Did he talk later than other children? Does your child have more accidents than other children of his age? If the answer to any of these questions is "yes", persons should contact Mr. Card, Mrs. C.A. Haynes, or come by the principal's office at the elementary school.

Anyone knowing some child that might need these classes is asked to talk to the parents or notify one of the school teachers.

Mr. Card stated that the characteristics to look for are: Overly active, inferior speech, poor language development, slow to toilet train, physically handicapped, low intelligence, such things as mongolism, epilepsy, cerebral palsy, etc.

There was an application by counties in the 63rd Judicial District to the Texas Criminal Justice Division for assistance in providing the district attorney with office help with administrative tasks.

Commissioners Have Extra Meet

The Terrell County Commissioners Court had a special meeting Saturday of last week at the courthouse. The meeting was to authorize County Attorney Jack Hayre and Sid Harkins to go to California for the securing of easements for the flood control project in Terrell County.

Following the explanation of the considered need for the trip, the authority was granted by the commissioners. The two men went to Midland and flew to California Sunday to accomplish their mission.

The regular meeting of the commissioners was Monday morning at the courthouse. After the reading of the minutes and authorization of the bills presented to the court for payment, it was decided to publish a request for bids on the pump jack and windmill tower behind the courthouse and sell the two items if the bids were sufficient to warrant the sale.

There was a review of the recent accomplishments of securing easements for the flood control project and it was pointed out that much interest had been generated by the high water two weeks ago. The number of easements secured and the number remaining to be secured was reviewed, and it was also pointed out that the trip to California by Messrs. Hayre and Harkins would boost the total considerably, and there was another trip authorized to north and central Texas for the securing of other easements, and a trip to Florida possibly would be necessary to wind up the out-of-state easements.

There was an organization of the board of equalization by the commissioners and initiation of all procedures for action by the commissioners in that capacity.

Run-Off Due In Two Local Races

There will be run-offs in the second Democratic Primary, according to rulings by the Terrell County Democratic Executive Committee and the Texas Democratic Executive Committee.

Locally, the committee ruled that a run-off would be necessary in the race for county clerk as the leader in the race, incumbent Ruel Adams, received 396 votes and other candidates received 399. The run-off will be between Adams and Mrs. Twanna Petty, who got 196 votes in the first primary.

There will also be a run-off between W.C. Baker of El Paso Natural Gas Plant north of Dryden and Mrs. George Escobar, who resides in Sanderson, for the post of Democratic committee-person from Precinct 4 in Terrell County. Both candidates received only write-in votes as there was no name printed on the ballot, as no candidate had filed for the post. Baker received 33 votes and Mrs. Escobar received 29 votes and there were seven votes cast for as many different people in write-ins.

The committee met Tuesday morning of last week to canvass the returns of the primary and made the decision following the canvassing.

There will also be a run-off in the race for 70th District State Representative between Mrs. Susan Gurley McBee of Del Rio, who received 322 votes in Terrell County and led the race in the district, and Stanley C. Hausman of Eagle Pass, who received 117 votes in Terrell County and was the second-high candidate in the race.

Write-in votes will not be counted in the run-off primary, according to information from the committee, and voting will be June 1 from 8:00 a.m. to 7:00 p.m. at the same locations as for the first primary.

Absentee voting for the second primary is for five days only, according to information received - from May 22 through May 28 - at the office of County Clerk Ruel Adams during regular office hours. The above dates include a Saturday and Sunday.

SCS Sets Losses In Recent Flood

Jerry Wenmohs, local work unit supervisor for the Soil Conservation Service recently completed a survey of local and area residents to determine the approximate losses due to the April 29, 1974, flood in Sanderson. He gave the following report to The Times:

"As many people and businesses as possible were contacted and asked to estimate their total damages. Losses were estimated at \$105,200 which does not include indirect damages such as interruption of travel, evacuation of premises and similar losses.

Besides replacing damaged or destroyed material, much livestock was lost, according to Wenmohs. Damage to transportation facilities including the railroad and highway were extensive, he reported, and many miles of fences were damaged or destroyed.

Although losses were not as great as during the 1965 flood, Wenmohs said it represented a considerable monetary loss for Sanderson residents and residents of the area.

interested in who is elected to the posts and vote according to qualification, ability, honesty, integrity, etc., then later go down the list of popularity items, such as color of pajamas, kind of detergent each uses, and favorite color of exterior house paint, etc.

The Times is not being evasive in not publishing all the details of the number of easements received and not received for the flood control project. There is no reason or effort to be evasive.

The fact is that numbers do not mean anything; what is important is that those responsible are really busy trying to get things done! If the list lacked two to complete, the two might or might not be an important or meaningful number, depending on who it was and what was involved.

We do not want to be in a position for possible accusation as being somekind of a hang-up in the process of securing easements. We want to cooperate with all persons who are involved in getting the work done, whether they are party of the first part, the second part, or any other part, as long as some real meaningful effort is being accomplished.

If anyone is interested in knowing what easements have been secured and which ones are lacking, this can be learned from the Soil Conservation Service office, from the county clerk, if the easements have been turned in for filing and recording, from the commissioners or county judge if the information has been passed on to them, or from County Attorney Jack Hayre, who is primarily involved in the securing of the easements.

To point some kind of a finger at the property owners who have not signed easements might be unjustly pointing a finger accusingly at some one who has not had an opportunity to sign an easement. Or to point an accusing finger at all who have had an opportunity to sign an easement and have not signed it, is not a presentation of all of the facts, of which there could be circumstances far-reaching and very involved.

We are not "copping out" on a responsibility, we are only realizing our responsibility, in our opinion! For example, one of the easements has to be obtained by court action, but it will be a "friendly" suit, so the full story is not even told with that statement.

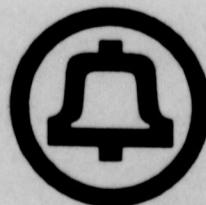

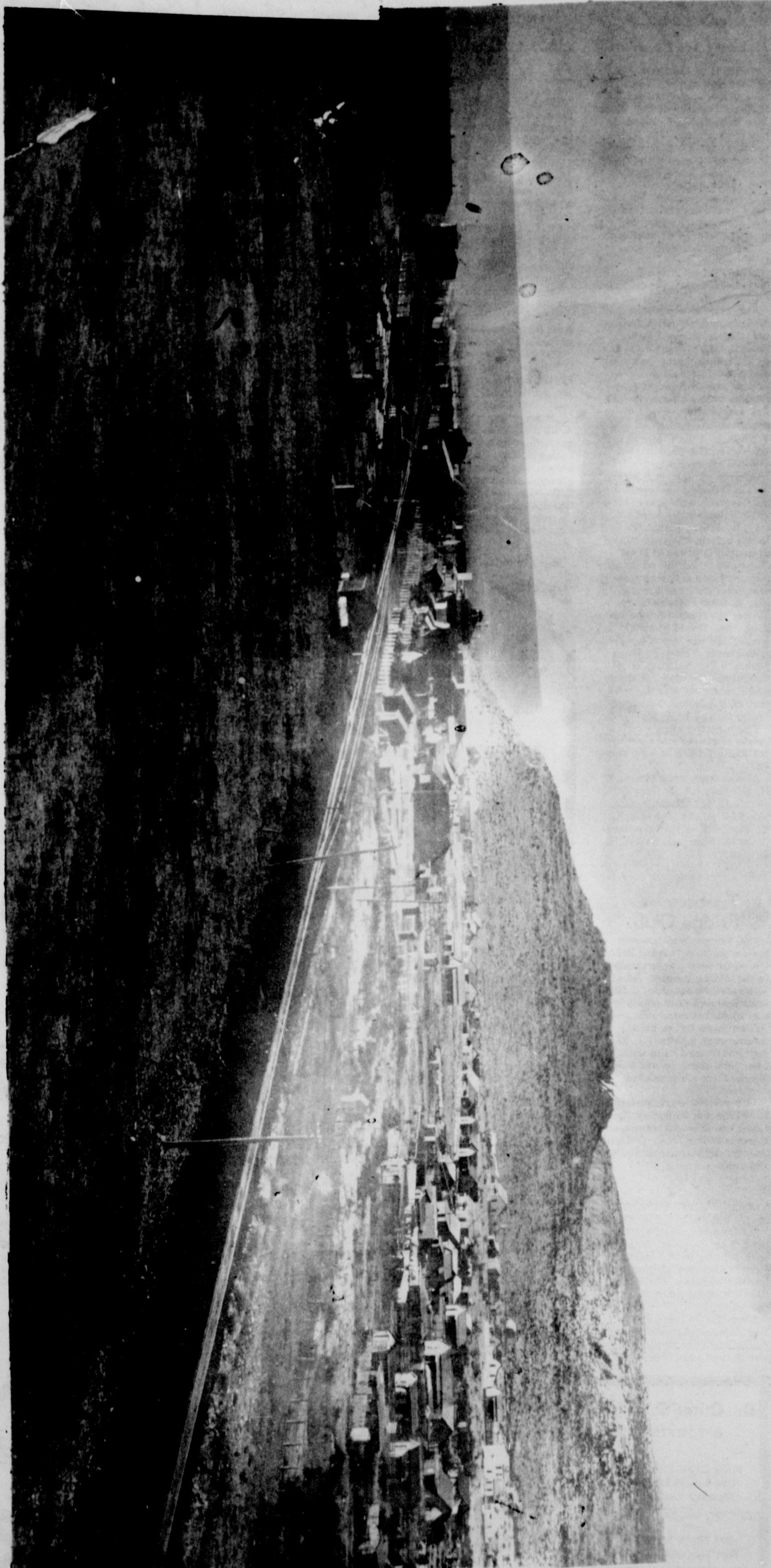

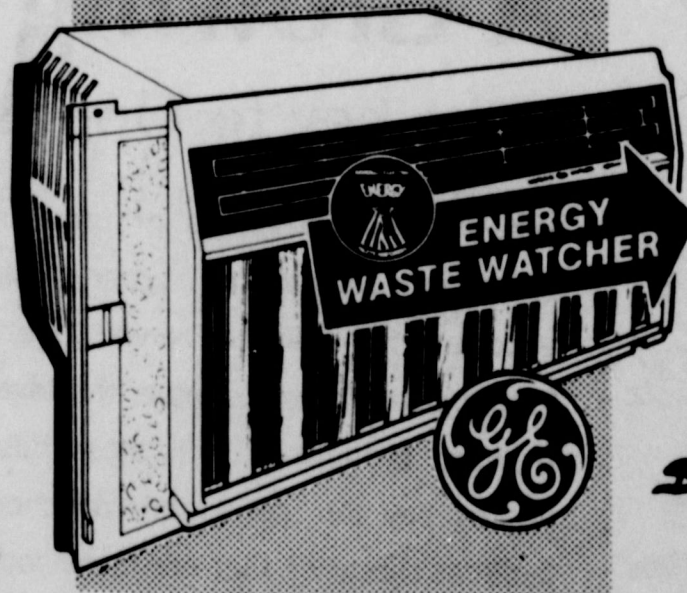
