We hope that all of our readers noted the back page of The Times last week and the "Commentary on the Holy Scriptures" there. The series was offered by Dr. Lang in an effort to help someone to have a greater interest in reading the scriptures themselves and possibly in understanding more with or without the reading. We had a long conversation with him prior to considering the series, and we read the first installment prior to agreeing to publish the series, to which we have made an agreement, even though he is leaving Sanderson next week.

There is no intent or desire of presenting something for the sake of being controversial or argumentative, but to maybe help acquaint someone with the activity and purposes of God as he sees them. Certainly, Sanderson is no heaven on earth, nor is it a hell; nor is any other town! Certainly, there are some things about Sanderson that are not good, but it is not all bad, nor is any other town any different in this respect!

If a man is having trouble with keeping his head above the water, he is not helped by some who only stands on the bank and tries to analyze his problems, or by - after analyzing his problems - the person walking away and saying "he's had it!". The same thing is true of Sanderson, the state, or nation!

Many times many people are satisfied at being analysts. That's the extent of their in-

## S. L. Stumberg, 85, Prominent Rancher Dies In Alpine

Stephen Laredo Stumberg Sr., 85, died Wednesday morning in an Alpine nursing home where he had been a patient in recent months.

Funeral services were in the First Presbyterian Church in that city Friday afternoon with burial in Elm Grove Cemetery.

He was born in Laredo February 19, 1889, and was reared in San Antonio. He had operated extensive ranches in Brewster and Terrell Counties since 1928 until failing health forced his retirement.

The Stumbergs maintained their ranch home about 30 miles west of Sanderson on US90, but in more recent years, had spent most of the time at their home in Alpine. He had been in nursing homes in El Paso, Fort Stockton, Del Rio, and Alpine for several years.

Survivors include his wife, Mrs. Hester Stumberg; a daughter, Mrs. Mary Elizabeth Lee of San Pedro, Calif.; a son, Temple Stumberg, of El Paso; a brother, W.R. Stumberg, of Sanderson; 10 grandchildren and eight great-grandchildren. He was preceded in death by a son, S.L. Stumberg Jr., in 1971.

His grandsons served as pallbearers. Among those attending the funeral services from Sanderson were Messrs. and Mmes. C.G. Riggins, W.R. Stumberg, Austin Nance, R.S. Wilkinson, Carlton White, G.K. Mitchell, and J.A. Gilbreath; Mrs. A.D. Brown; Sid Harkins, Dudley Harrison, and F.G. Hardin.

Mr. Stumberg, a past-president of the Texas Sheep and Goat Raisers Association, had filled various offices and been active in state and national wool and mohair producers' organizations, boards, and associations; had visited Australia and South America in international activity for the wool and mohair producers; and hosted several international representatives of the wool and mohair industry from foreign countries. He was a charter member of the Sanderson Rotary Club and past-president; a Mason, Shriner; member of the Alpine Presbyterian Church, and a former trustee of the First Presbyterian Church of Sanderson.

Dr. Lang stated that he was contacted by the minister of the church there, who was trying to assemble a staff for the ministry of the church and had the consent of the district superintendent and bishop for Lang's transfer if he desired. He stated that the offer had many challenges and opportunities, and working in the fields and areas for which he had academically prepared himself. The entire move-plans began Monday night of last week and were consummated Tuesday night.

Dr. Lang stated that he had many regrets about leaving Sanderson and that when he came here, the possibility of his leaving immediately was not a consideration at all. He stated that it was a possibility that he felt he could not turn down and that it was a door opening to some things that he had tried to prepare himself for and he felt compelled to accept the position.

## Outpost Set On Mitchell Ranch

Coastal States Gas Co., Midland, will drill its No. 2-A G.K. Mitchell, a 1 1/4-mile south-southwest outpost to its recent Wolfcamp gas opener and 1 1/2 miles southwest of the Ellenburger opener and lone producer from that pay in the KM field of Terrell County, 23 miles southwest of Sheffield and 3/4 mile east of a 10,500-foot failure.

Location is 1,930 feet from north and 1,650 feet from west lines of 13-1-CCSD&RGNG. Contract depth is 10,500 feet.

The Wolfcamp opener, the firm's No. 1 G.K. Mitchell was finalized May 1 for a calculated absolute open flow of 16,189,000 cubic feet of gas daily, with gas-liquid ratio of 33,260-1, through perforations at 9,185-668 feet.

The failure, the firm's No. 1-A G.K. Mitchell was plugged July 5 at 10,500 feet.

## Workshops For County Officials Are Available

In addition to the Extension Service specialists, the staffs of the governor, attorney general, state auditor, Texas Highway Department, Texas Department of Public Safety, Texas Department of Health, and the Texas County Judges and Commissioners Association provide resource expertise in the community service and continuing education program.

AUSTIN, Tex.—Fitting together an acceptable constitutional revision package proved to be fully as thorny a job as the most pessimistic forecasters maintained.

Constitutional Convention delegates limped back to Austin this week to try again for a showdown two-thirds majority vote after rejecting 91-86 the initial submission proposal which they had stitched together piece-by-piece earlier.

Hang-ups ranged over a wide area—from the separate right-to-work proposition (which is bitterly opposed by organized labor) to internal provisions of the basic revision document.

Some persistent critics argued special interests had too big a hand in drafting the revision. Members of all factions disagreed over sections of the education article—including guaranteed equal opportunity and earmarked college building funds.

First approaches at compromise centered on efforts to eliminate some of the five "separate submission" items—that is, proposals not included in the basic revision.

**\$72 MILLION TEXAS SHARE**—Texas received \$72 million in federal revenue-sharing funds for the final quarter of fiscal 1974.

The state government's share is \$24,260,347—the same as third quarter of fiscal '74.

Multiple choice is the name of the vacation game in West Texas when it comes to riding the Texas Travel Trails. Four trails fall entirely within the western half of the state, while another three overlap the eastern rim. Entirely West Texan in flavor are the Mountain Trail, Pecos Trail, Plains Trail, and Forts Trail. Sharing part of West Texas' geography are the Lakes, Brazos, and Hill Country Trails. The listed attractions for all seven trails total 354. The four primary West Texas trails count up 202 among themselves, in a region larger than most of the 49 other states. Other states, in fact have begun to emulate Texas' geographic approach to travel -- Montana and Missouri, for example -- while Montana, Wyoming, the Dakotas and Nebraska have formed a region known as the Old West Trail. Information on the seven West Texas trails is available from the West Texas Chamber of Commerce in its new

Wonderful West Texas Fun and Adventure Map. Abilene is the home of the Texas Forts Trail Assoc. and the West Texas Chamber. This spring the Forts Trail Assoc., recognizing new travel needs because of fuel, painlessly "drew and quartered" the trail into four quadrants.

The rangeland trail was presented as four "mini-trails." Each contained two of the old frontier forts: Richardson and Belknap in the northeast, Phantom Hill and Griffin in the northwest, Chadbourne and Concho in the southwest,

and McKavett and Mason in the southeast. The idea was a closer-to-home approach for the 691-mile Forts Trail.

The starting point for each trail and the number of its attractions are: Mountain, El Paso, 59; Pecos, Odessa, 42; Plains, Amarillo, 42; Forts, Abilene, 49; Lakes, Dallas, 62; Brazos, Waco, 43; and Hill Country, San Antonio, 48. Brochures of the travel trails, and the Fun and Adventure Map, may be obtained from the West Texas Chamber of Commerce, Box 1561, Abilene, Texas 79604.

**COMMENTARY ON THE HOLY SCRIPTURES**  
Dr. Edward Lang Jr.

**EXODUS**  
Introduction - Exodus is central to the Old Testament. It lies at the very heart of our faith. Its theme is stated in verse 15:2: "The Lord is my strength and my song, and he has become my salvation; this is my God, and I will praise him, my father's God, and I will exalt him". Exodus is the history of salvation, both for the ancient Jews and for us today. The book divides itself into two parts, the history upon which the faith of Israel is based and the law by which we are made to be part of that history.

**The History**  
In the first half of the book, a story is told which introduces the message of Exodus. Attempting to save her son from murder by Pharaoh, a mother sets her baby afloat in a wicker basket on the River Nile. The child is pulled from the water by Pharaoh's daughter who hires its own mother to be its nurse. This mother entrusted the life which was hers to God and got it back again. That is the message: to have life you must give your life to God. This story foretells what is to happen to the whole Israelite people. Slowly they learn to entrust themselves wholly to God and thereby have life and divine care.

The name of this child pulled from the river was Moses, which means, "Because I drew him out of the water." Even the name foretells what God is to do in saving his people from drowning in the Red Sea. He pulled the Hebrews out of the water while he caused the Egyptian army to drown. This is the history of God salvation for the Hebrew people. The faith of Israel is founded primarily upon this event.

The story of Exodus is one of conflict between the God of Israel and Pharaoh to determine which is lord of life. The Pharaoh of Egypt was considered to be a god. Who then is Lord? Who gives life and cares for it? Who determines

the course of nature and history? The god of this world or the God of Abraham, Isaac, and Jacob, the God of Heaven? The ten plagues are mighty signs to show that God is the lord of nature. The escape of the Hebrews from Egyptian slavery is a sign to show that God is the lord of history. Pharaoh thought himself to direct events, and men today still consider themselves to be directors of history and masters of nature. God had to destroy the Pharaoh and his army to make it known that only God determines the course of nature and historical events. "And the Egyptians shall know that I am the Lord, when I stretch forth my hand upon Egypt and bring out the people of Israel from among them." (7:5). Remember that all events of history and nature are signs to show us the power and glory of God.

This history directed by God gave the Israelite people freedom from the Egyptians and made them to be the people of God. In a sense these people had been Pharaoh's people and now they were God's people. It is not a question of slavery, but of who is master. Moses appealed to Pharaoh asking that the people be released to go into the wilderness to sacrifice to their God. In Leviticus we learn that in essence sacrifice is giving one's own life to God. Moses was asking that the people be released from Pharaoh's service in order to give themselves to the service of God. That question remains today -- not whether we will serve, but whom we will serve. God? Or gods of this world?

A very difficult but important doctrine is raised by this history of the events in the Exodus, the doctrine of election. God elected the Hebrew people and set them free; but he hardened the heart of Pharaoh and led his army to destruction. "...I will be gracious, and show mercy on whom I will show mercy." (33:10) Stated plainly, God elected the Israelites for his mercy, but not Pharaoh. This doctrine is difficult for us for one rea-

son: we think that a thing must be "either/or." The Hebrews thought in different terms: a thing is "both/and". It was not a question of whether God rejected Pharaoh or Pharaoh rejected God. It was a case of both, of God rejecting Pharaoh and of Pharaoh rejecting God. The Bible states both. Pharaoh hardened his heart (9:34). And God hardened Pharaoh's heart (10:1)

**The Law**  
We must leave election to God. But we must also consider what part have we in the covenant. The Law was added as a second part of Exodus to show how a contemporary person can be part of the ancient history of God's salvation. There are conditions to the covenant. "Now therefore, if you will obey my voice and keep my covenant, you shall be my own possession among all peoples..." (19:5). God's covenant blessings are made to be contingent upon obedience. We have a place in the history of God's salvation on the condition that we obey his law.

Three aspects of the Law are described in Exodus. Most people are familiar with the first, the Ten Commandments (20:1-17). An extensive section follows which gives interpretations for social and criminal justice. This second part shows plainly that our relationships with one another are the situation in which we serve God. By the keeping of God's commandments in the social and political arenas of life, we prove whether or not we are God's people.

The third aspect of the Law concerns religious ritual and observances. Consider the one commandment of keeping the Sabbath. The whole point of the Exodus is the lesson that God saves us and cares for us. We are commanded to refrain from work on the Sabbath as a reminder that our lives are dependent upon God's care. A man works on the Sabbath because he thinks that he must in order to make a living. The Sabbath reminds us that provisions in life come from God and not from what man may accomplish. On that day we do nothing but consider what God is doing for us.

**Other Important Points**  
Mixed with the two elements of Exodus, history and law, there are other lessons. We are taught the nature of faith. The Hebrew people had faith in God, they trusted and obeyed God, because they knew the history of their own salvation. Many today think that faith is a leap in the dark. Not at all! Faith is based upon history and upon personal experience. A man can trust God when he knows the history of God's work with his people and when he knows the salvation of God by personal experience.

The nature of ministry is discussed in Exodus. Aaron and his descendants were set apart and consecrated by God to be priests. Their function was to pray for their people. The first duty of a minister is to pray, to ask God to be mindful of his people and their care.
