We believe that equality is the first step toward fairness. And there are ethnic groups that can use help in their native tongue as much as do our Spanish-speaking friends, and they are entitled to the same privileges and rights.

Another drawback to the voter register application form in any foreign language is the necessity of the voter registrar having to speak the language used to print the application, otherwise they cannot really legally register the voter, as they are sworn to correctly conduct their duties, and there's no way to fill out a form that you can't understand -- that's why they're printing some of them in a foreign language!

Can You Vote? ×

The Times is printing a voter registration form for the benefit of those who have attained the age of 18 in time to be eligible to vote in the election in November, and for those who have not previously registered, or those who failed to vote during a period which would extend their registra-

October 3 is the last day to register if you want to vote on November 4 and if you are not now registered.

Information received by The Times is that there will be a re-registration of all voters in the state following the November 4 election, and reregistration every two years after that. Present registration processes, if they are not adhered to strictly to voter registrars of the state, permit persons to be registered in more than one precinct, county or state for voting.

The November 4 election is for considering a new constitution for the state of Texas, a copy of which has been mailed to every post office box holder of the state with the expectation that they would read and understand the proposal and be able to vote intelligently.

Pecos County Well Gets Big Gas Pay

Phillips Petroleum Co. No. 1-E Mitchell has been completed as a Strawn gas strike in Pecos County, 35 miles southwest of Sheffield and six miles southwest of the Hokit (Strawn) field.

Calculated, absolute open flow potential was 67.5 million cubic feet of gas per day, producing through perforations at 11,328-11,896 feet, which had been acidized with 8,000

It is bottomed at 12,114 feet and has 5 1/2-inch casing set

at total depth. Location is 860 feet from north and 660 feet from west lines of section 9, block 102, J.H. Gibson survey.

Drilled to 11,310 feet, it is plugged back to 8,594 feet, and has 5 1/2-inch casing set at 8,950 feet.



Domestic Air Mail Gets Same Service As 1st Class Mail

Sanderson Postmaster Ray Hodgkins announced last week that a change was being made in all domestic first class mail as of October 11. At that time all domestic first class and domestic air mail will receive the same service over the nation.

There will be no service advantage in sending a letter or parcel air mail in the United States, according to Hodgkins, over sending the same letter or parcel first class mail.

This service advantage for parcels mailed first class mail should still have an advantage over the service for parcels sent fourth class mail - the normal method for most parcels mailed.

Airmail postage should still be used on all international mailings for the best possible service, the postmaster stated.



The Terrell County Family History Book will have up to 500 pages, depending on the number of family histories submitted. The book will be hard bound and of high quality. Each article should be signed:

Due to reasons of space or repititions the stories may need to be edited (not changed). Please enclose your telephone number. The price of a book will be \$17.50 plus tax (60¢), and \$1.00 if the book is to be mailed. You do not have to purchase a book to have your story printed, but we believe the book will be of interest and value in the years to come. Since we will have to have enough money in the bank to pay for the printing before it begins, we will need prepaid orders. All payments will be held in escrow in the Sanderson State Bank and if we do not obtain enough orders to print, all money will be returned. We do not anticipate a profit from the printing, but if any occurs the money will be turned over to the Terrell County Historical Commission to be applied to the Museum Fund.

Our county, though small in population, has far reaching ties and influence. You seldom meet a stranger in Texas (sometimes out of state, too!) who has not lived in, stayed over at, or heard about Sanderson, Dryden, and Terrell County. Open Meeting Law Is Explained

There has been much in the news recently about violations of the "open meeting law". There are those who agree with the law and those who disagree. Most of the disagreement, we feel, comes from those who are elected or appointed and feel that this is superior authority that places them beyond the scrutiny or questing of anyone. "If you don't like the way we have conducted the office, wait until the expiration of my term and do something about it then," has been said by some. The only problem with that kind of authority is that there has to be a waiting period of up to four years and not all the answers come out into the open even then!

There are built-in stipulations for "executive sessions", and there should be. But following the considerations, arguments, pros and cons, the voting of each and every member of any public group, appointed or elected, should be available to a constituent. That's one of the best points, in our opinion, of the open meeting law.

"Whenever any deliberations or any portion of a meeting

are closed to the public as permitted by the Act, no final action, decision, or vote with regard to any matter considered in the closed meeting shall be made except in a meeting which is open to the public and in compliance with the requirements of Section 3A of this act."

Public governing bodies are also required to post public notice of all regular meetings at least 72 hours prior to the meeting. Any emergency meetings called by the board must be posted at least two hours prior to the session. Notice is to be posted at a place convenient to the public at its administrative office, and the notice is to be furnished to the county clerk for posting in the county courthouse at a place convenient to the public.
