FISD Trustee Election

Three candidates are vying for two at-large places on the Board of Trustees of the Friona Independent School District. Cindy Moreno, Jeri Lynn White, and Darrin Gilley, are asking voters for the opportunity to represent the

school district as a trustee. Current Board President Becky Riethmayer is retiring this year which leaves Darrin Gilley as the only incumbent in the race. He won a special election last year to complete the final year of that term.

The name of each candidate will appear twice on the ballot. Every voter will have two votes and may use those votes in a variety of ways. You could vote once for two different candidates or you could vote twice for a

single candidate. You could also vote just once for a single candidate or you could choose to not vote for any candidate. The two candidates who receive the most votes in the election will serve full terms.

Friona ISD Proposition A calls for the issuance of \$19,000,000 of bonds by the

Friona Independent School District for the construction, acquisition, renovation, and

equipment of school buildings in the district, and the levying of the tax for payment

thereof. Voters will have the choice to vote for or against the proposition.

Commissioners extend burn ban

Commissioners voted to extend the county burn ban for ninety days. The area has received some nice rain, but they felt it was not widespread enough to warrant a lifting of the ban. The Commissioners also wanted to remind everyone that they can still call the Sheriff's Office at 806-481-3303 and schedule a burn when the wind is below 10 mph.

The Parmer County Commissioners Court met in regular session on Monday, April 29th at 10:00 a.m. in the County Courtroom of the Parmer County Courthouse in Farwell, Texas. The meeting began with prayer and the Pledge of Allegiance to the American Flag and the Texas Flag.

The Minutes from the previous meeting were read and approved. Approval was given for payment of the accounts payables as presented by County Treasurer Sharon May. Commissioners also

reviewed the Treasurer's Report and approved the calculated payroll and disbursement for all county employees and elected officials. The Quarterly Report was also reviewed and approved.

Commissioners approved the purchase of a computer, external hard drive, and a mini-fridge for the Extension Office in Bovina. Also approved was a request to place two 8" PVC pipelines underneath a county road in Precinct 3.

Commissioners also approved the use of forfeiture funds by the 287th Judicial District Attorney to purchase of 2 computers. A resolution from the DA was also approved for the victim Coordinator and Liaison Grant Program.

The Janitorial/Maintenance contract for the Parmer County Courthouse and Parmer County Law Enforcement Center was discussed. The Court determined that the contract should open to a 2-week

bid process. Bids are due by 9:00 a.m. on Monday, May 13th. Bid notices will be published in the local newspapers.

Commissioners approved the renewal of the computer software contract with Southern Software for the Parmer County Law Enforcement Center. Variations of the software are used in dispatch, jail management, and records management. Sheriff Randy Gerries told the Court that he was housing 30 inmates per day. He also reported that the Law Enforcement Center passed inspection and is in full compliance with the State Jail Standards.

Fresh salsa in jeopardy if trade pact not renewed

Tomato prices could increase as much as 40% to 80% this year if the U.S. Department of Commerce withdraws from the Tomato Suspension Agreement by May 7. This will affect Texas consumers and the produce industry significantly, according to experts.

Industry leaders were updated on the implications at

the Texas International Produce Association Viva Fresh Show in San Antonio. The agreement sets a price minimum, or price floor, for imports and provides other protective trade measures.

Dr. Luis Ribera, Texas A&M AgriLife Extension Service economist, College Station, was part of a media briefing

at the show. Ribera said 52% of Mexican tomatoes come through Texas.

"About 41 percent are shipped through Pharr and another 11 percent through Laredo," he said. "This could impact the 8,000 jobs here in Texas that support fresh produce imports from Mexico. This would include every-

thing from packers, brokers, transportation, anything and everything that supports this important industry that gets tomatoes from market to the retailer."

"This makes no sense," said Lance Jungmeyer, president of the Fresh Produce Association of the Americas, based in Nogales, Ariz., in a statement. "Most Americans crave certain kinds of vine-ripened tomatoes, and now they are going to have to pay more, significantly more."

A study conducted by economists at Arizona State University finds that during other periods, such as winter, prices for certain varieties like vine-ripened tomatoes, tomatoes on the vine and Romas could rise more than 85%, according to an analysis, which relies on data from AC Nielsen.

Dramatic price increases could have far-reaching impacts, Ribera said. He said consumers accustomed to dining at Mexican food restaurants and enjoying fresh

salsa with chips and guacamole could pay higher prices.

"The question is are we going to get used to a restaurant not having fresh salsa?" Ribera said. "Or are we going to be going to a restaurant and having not-so-fresh salsa, say something that is prepackaged? When we dine at a Mexican restaurant, we have come to expect fresh salsa with chips and guacamole. Will these restaurants start charging more? We really don't know yet."

Ribera said U.S. consumers spend 6.3% of their annual income on food. That could rise if tomato prices escalate. Consumers might also have to "pay up" for other varieties of tomatoes to have a fresh product available on the dinner table.

Beefsteak and Roma tomatoes are consistent favorites among Texas consumers. If there is a shortage, consumers will be seeking alternatives, such as homegrown tomatoes where available.

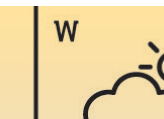

A Friona Star Interview
 with Adriana Ortiz Carrillo • FHS Senior



You are involved in so many activities, how do you manage your time in order to get so much accomplished?

Being in high school and being involved in so many extracurricular activities or community projects actually it is not an easy task. I have a planner and reminders on my phone that are constantly being updated and changed because plans are generally always being changed. I make it a point to always show up to an event or make time for said event when I've promised to be there because I don't like to let people down. I like to help, I always have.

You were recently named female Student of the Year at the Chamber of Commerce Awards Banquet. What does that award mean to you and what has the Friona School system meant to you?

When I received the award I was really shocked in all honesty mostly because everything that I do or have done for the community, comes from the example my mom has set for me and my siblings. I volunteer and get involved because it is a wonderful way to help my community, in projects that I believe will make our community a better place, not because I've ever wanted any recognition. I have always been a behind the scenes person. I am grateful to have been honored with the award because even though my involvement has never been about recognition it's nice to know my actions are being seen and hopefully making an impact to other kids in the community. The Friona School system means every-

thing to me, I haven't met a teacher or staff member who hasn't been supportive of me, my actions or plans for the future. That support plus the support of the community has not only empowered me but encouraged me to pursue my ambitions without fear of failing.

You were a back-to-back State qualifier in Powerlifting. How did you get involved in the sport and what were the keys to your success?

I got involved in powerlifting my sophomore year after doctors told me it was probably the best sport for me to be in. You have to know the backstory so I'll start from my first diagnoses from the 7th grade, after I had to be admitted to the hospital for severe stomach pains I was later diagnosed with Lupus which is an autoimmune disease and juvenile rheumatoid arthritis because I also had severe joint pain. So throughout 8th grade and my first year of high school I was in and out of the hospital and even now many people don't know that this was happening while I was trying to have normal teen experiences, playing basketball, continuing to run track and do everything basically. By the beginning of my sophomore year I was on 12 medications including a drug that cancer patients use and because of this I was advised to not continue with sports but I am so stubborn that I couldn't just quit so I talked to several of my doctors about what sport that my school had would be best and well they all said powerlifting would be the best because I'd be able to take everything at my own pace. They were right and I fell in love with the sport by the end of year because I had lost so much weight and was doing well with my health. I was off all my medications. Powerlifting basically became a lifesaver for me. Some keys to my success are to always push yourself even when it gets hard because this sport is hard and not just physically but mentally. You have to believe that you are capable of lifting that weight before you ever do it because if you don't you've already lost the meet. Eating right is also one of the most important things when doing this sport, don't starve yourself your body needs nutrients in order to get stronger and that's something many fail to realize. Another key to success is to trust your

coaches, they know what they're talking about! Trust the process. I could not have done it without the support and guidance of my mom and all the coaches at Friona high school.

What advice would you give to young people to help them be productive in school and in the community of Friona?

I would tell the young people of Friona to get involved and not be afraid to offer your help. I know from experience that a lot of things may seem like only adults can help or be involved but I can't count how many times I've offered my help and have been able to help even in the smallest of ways. Don't be afraid to reach out, Parmer Paws the rescue shelter always needs help, there are always events that the chamber needs volunteers for, Snack-Pak always needs help, my point is that even though Friona may be a small town we always need help, to help each other really as long as you're willing. In school don't be afraid to try things, try something at least once with 100% of effort and you might actually enjoy it. Ask questions and don't be afraid.

What are your plans for the future?

My plans for the future as of right now are to attend West Texas A&M and major in Biology. I don't know what my career path is yet but I do know that it involves helping people whether it be as a nurse or even physical therapist I want to be helping people. I've also considered coaching and teaching because of the impact that my teachers and coaches had on me. At one point in powerlifting season this year after I had torn my PCL. I'm pretty sure my coaches believed in me more than I had believed in myself and for that I am forever grateful. So whatever is in store for my future I know that I will be helping people whether I'm working in a hospital or teaching kids like myself to become better people. I'd like to thank my parents, coaches, teachers, peers and community for all of their support. Without them I wouldn't be the person I am today or have been able to do everything that I have been able to accomplish.

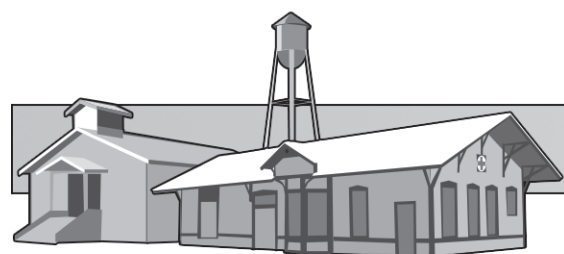

FRIONA FLASHBACKS

From the Friona Star Archives

Thursday, May 24, 2018

Friona, Texas was mentioned on the WFAA Dallas news channel last week for a photo that was submitted of a somewhat rare formation of clouds called Mammatus. The photo, taken by Landon Weatherly, was submitted to the news station by former Friona resident Justin Grimsley, who inquired about the cause of this specific type of cloud. WFAA's Chief Meteorologist Pete Delkus showed various other Mammatus formations sent in by Texas residents before pausing on the photo submitted by Justin and using it to describe the process. He explains how updrafts take moisture-rich air into a storm while heavier, more saturated air sinks, forming the pouch-like clouds in the sky. He also explained to one of the newscasters that Friona is in the panhandle, since upon asking, she claimed she did not know.

April 11, 2003

The Friona Police Department has a new officer. He is Lt. Jerry Morris, most recently employed with the Bailey County Sheriff's Department. After Morris retired from the Midland Police Department, he and wife Rita moved to Arlington where he was an investigator in the Dallas area for CNA Insurance for ten years. The Morrises retired again and moved back to Rita's hometown of Muleshoe. She is the former Rita Black and a Muleshoe native. He was Chief Deputy in Bailey County before accepting the lieutenant's position at the Friona PD.

Funding has been provided by the Texas Department of Health to allow for free breast screenings for women who qualify. The major goal of the clinic is the early detection of breast cancer. The clinic provides low cost screening which includes a breast exam by a Registered Nurse trained in breast cancer detection, teaching of breast self examination and a mammogram. The guidelines for having mammograms are: 1. Learn and perform breast self examination every month; 2. Have a physical examination every year; 3. Have a mammogram according to the recommendations by age. Age: 40- -one baseline mammogram; 40-49- - a mammogram every one to two years; and 50 and over—yearly mammograms.

May 19, 1985

Friona residents are reminded of the Slave Auction to be held at the City Park Saturday, May 18, beginning at 10:15 a.m. Beginning at 10 a.m., the Chamber will treat those on hand to coffee and doughnuts. Larry Potts of Potts Auction Service will be on hand to stage the auction. Ten local men have volunteered their services to clean up Main Street on Saturday, and are hoping to bring at least \$50 each at the auction. Merchants and individuals are urged to attend to bid on the "slaves." Proceeds from the auction will go toward building a new gazebo for

the park. The event is associated with the Chamber's clean-up week activities.

May 5, 1950

Work is now underway on the \$60,000-570,000 church building being built for the First Baptist Church in Friona. The new unit will consist of an auditorium with a seating capacity of 500, offices and additional Sunday School facilities. Steel, concrete and brick are being used in this modern functional-designed building. Being supervised by G.G. Gililand, the plans are from the drawing boards of architects Shaffer and Merrill of Clovis. Rev. Tommie B. Allen is the local Baptist minister, being here since May, 1947. Contract was let Tuesday morning for a new 250,000 bushel elevator for the Black Grain Company, according to announcement just made by J.R. (Pete) Braxton, manager. This will more than double the present capacity of 200,000 bushels in the elevator just completed.

May 9, 1930

Steel workers have arrived in Friona and started work on the new elevated water tank, which is to supply the water works system. When completed, the tank will have a capacity of 50,000 gallons. It is known as the hemispherical bottom type. Elevated storage will give Friona a water system which will be economical to operate and efficient in service. A small pumping unit fills the tank in a short time and will be able to keep it full at all times to meet the demand. This reserve flows by gravity to all parts of the system. The tank is to be elevated to a distance of 92 feet above the ground which means the water will always have a gravity pressure of at least 40 pounds.

Letter to the Editor

To the Editor:

As the general manager of a local business I am writing to express my concerns about the upcoming School bond election, having seen the loss of our production Ag exemption and our taxes increase by 23% since 2013. This bond is being sold to voters as no cost or minimal cost to some, so I ask who is picking up the tab? I would have never believed that our community, one of the most conservative in Texas, would be considering a \$20M bond for our schools that is essentially a blank check with exact expenditures to be determined after bond passage. Reminiscent of The Affordable Care Act (Obamacare), pass it first then we will tell you how we will spend it. Seems to me the prudent course of action is to make an itemized list of improvements based on immediate need and use our available monies to implement them. Is the Primary building really the worst building in the District? It would be nice to see the campus evaluation that was done to assess our buildings. The Ag building and Bus Barn seem to me to be worse off and yet no mention of addressing them. I assume not enough votes to be earned with their inclusion in the debate.

We moved back home to Friona to raise our kids in this community because it is a small inherently safe community where the people help and protect one another. I have heard a lot of discussion about a new primary school, and various improvements to safety and security of our kids in our schools. Which begs the question, are our children unsafe and in peril now? If the answer is yes, we have greater problems than crossing a blocked street. Comparisons to Columbine type events are disingenuous. The fact is none

of the tragedies would have been prevented by the proposed improvements contained in this bond.

As for crossing Hwy 60 for athletics goes, we have an underutilized playground west of the Elementary that could be used by Jr. High Athletics today as well as the last 40 years, or just bus them across the street. No reason to ever cross Hwy 60 again on foot. Are these improvements what is truly needed? In 20 years when this bond is paid off will our Schools be what we need? Bond payback assumptions being made assume valuations, which are at their peak, staying steady even though water tables are dropping, and land values will drop as well. We also assume that wind energy is viable without the government subsidy which is under assault as the Fed is broke.

Food for thought, there is a property tax reform bill moving through the Texas Legislature that has passed the Senate and is in committee in the House. ALL property tax exemptions are being reviewed including Ag exemptions. Cities in our state are tired of picking up our tax base shortage. If farmland is taxed at say half its actual value, does that change the view of any voters. Austin thinks these exemptions are unfair to their taxpayers and are looking to cut their tax bill alone by \$800,000,000. This is the amount they currently send to poorer School districts. Looks like these people are tired of others spending their money. When this bill passes, as rural Texas does not have the votes to stop it, and the property tax playing field is leveled, will you still vote in the same way?

In closing, I encourage all citizens to exercise their right to vote.

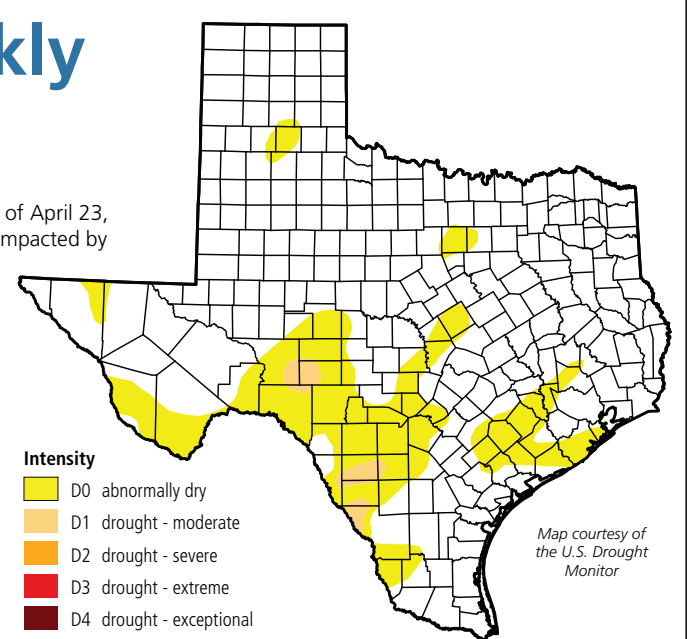

State Capital Highlights

Top issues remain in play as Legislature enters final month

AUSTIN — Only a month is left for lawmakers to get the state's business done in the 86th regular session of the Texas Legislature.

Still unfinished are the issues at the top of a list shared by Gov. Greg Abbott, Lt. Gov. Dan Patrick and House Speaker Dennis Bonnen: the passage of a state budget for fiscal years 2020-2021, property tax reform and school finance reform.

Last week, a conference committee of 10 House and Senate budget writers began negotiations over the two chambers' budget bills. While the negotiators have agreed on \$9 billion to spend on property tax relief and education finance reform, the two versions are about \$400 million apart on state revenue spending and \$3.2 billion apart, out of a total of about \$250 billion in all funds, according to the Senate News Service. "This process is made easier by the fact that both chambers are prioritizing three key issues: that's certainly property tax relief, education reform and teacher salary," said Senate Finance Committee Chair Jane Nelson, R-Flower Mound. "The good news," she added, "is that both chambers have demonstrated their commitment to our top priorities."

Any differences in the House and Senate budgets must be resolved before a final version can be presented for an up or down vote in each chamber before the session ends on its 140th day — Monday, May 27.

Web sales tax bills move

Legislation that would allow Texas to collect sales tax from remote sellers in accordance with the 2018 South Dakota v. Wayfair decision from the U.S. Supreme Court advanced last week.

The Senate Finance Committee on April 24 approved SB 70 and SB 890, both authored by Sen. Nelson, and two companion bills, HB 2153 and HB 1525, authored by House Ways and Means Committee Chair Dustin Burrows, R-Lubbock.

"This legislation paves the way for Texas to fairly collect online sales tax within the parameters outlined by the Supreme Court," Nelson said. "These bills ensure that no undue burdens are placed on remote sellers."

SB 70/HB 2153 would allow for the establishment of a single local use tax to avoid placing an undue burden on remote sellers. The comptroller's office projects that the change would generate \$300 million over the next fiscal biennium.

SB 890/HB 1525 would allow marketplace vendors to collect sales tax from third-party remote sellers. The comptroller's office projects that the change would generate \$550 million in the next two-year budget period.

Time change bill moves

Should Texas do away with "falling back" in November and "springing forward" in March and instead keep clocks on Standard Time or Daylight Saving Time year-round?

On April 23 the Texas House approved, on a vote of 133-9, a measure that would put the question to Texans in the form of a constitutional amendment on the November 5 ballot.

The measure, House Joint Resolution 117 by Rep. Lyle Larson, R-San Antonio, now moves to the Senate for consideration. If the Senate also approves and a statewide ballot measure passes, Congress still would have to amend the Uniform Time Act of 1966 before Texas could stop springing forward and falling back.

"The process of changing our clocks twice each year is primitive and illogical," said Larson. "Time is a human construct. With the passage of this resolution, Texans can decide which time to stick with. We could maintain our sleep schedules, feeling healthier and happier as a result. We could end a senseless practice that has many drawbacks and very few, if any, positive aspects."

Opponents of HJR 117 cited concerns such as safety issues, confusion in scheduling and breaking with tradition.

Jobless rate remains low

The Texas Workforce Commission on April 19 reported the Lone Star State added 22,600 seasonally adjusted non-farm positions in March. The state's unemployment rate stayed at 3.8 percent.

Commission figures also show March marked the 107th consecutive month of annual growth for total non-farm employment. The month proved to be historically significant for the Texas economy, as the civilian labor force reached a record high of more than 14 million workers.

"Texas' economic miracle is a testament to the unmatched innovation of our Texas employers and their dedication to creating jobs and investing in communities across the state," said TWC Chair Ruth Ruggiero Hughs.

According to the U.S. Department of Labor Statistics, the Midland Metropolitan Statistical Area had the lowest unemployment rate among Texas MSAs in March with a non-seasonally adjusted rate of 2.1 percent, followed by the Odessa MSA with 2.5 percent. Tying for third were the Amarillo, Austin-Round Rock and College Station-Bryan MSAs with 2.7 percent unemployment.

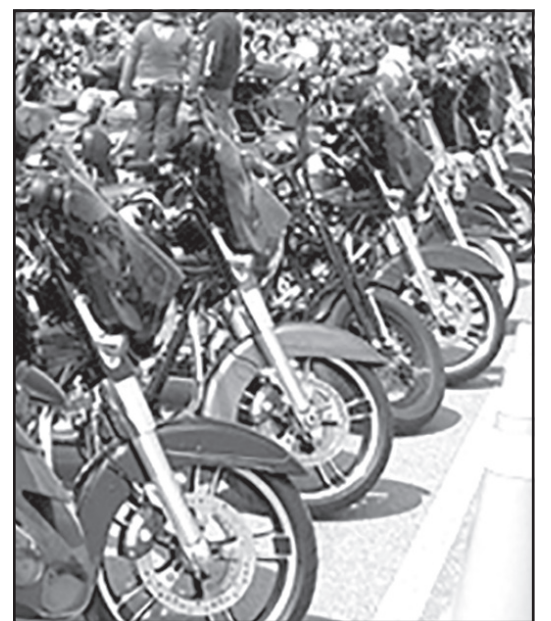

Small Town Cookin'

Cauliflower

I'll be honest; I am not a big fan of cauliflower. One of my memories from growing up is when my mom was following this very specific diet. She had to eat exactly what was on the menu which included tuna, boiled eggs, peanut butter toast, and cauliflower among other things. But the cauliflower sticks out in my mind because when she boiled it, it made the whole house smell something terrible. However, cauliflower is packed with lots of nutrients. And with some new ways to prepare it, it can also taste and smell delicious.

The cauliflower is a vegetable and a member of the cruciferous family which also includes broccoli, brussels sprouts, arugula, bok choy, cabbage, collard greens, and kale. The name is derived from the Latin *caulis* (stalk) and *floris* (flower), meaning "cabbage flower". It is actually a flower, as the name suggests. If the plant were left to

grow, seeds would develop from the flower head. The plant originated from wild cabbage in the modern-day region of Turkey. It became popular in France in the 1500's and was also enjoyed in Northern Europe and Britain. King Louis XIV loved cauliflower and demanded it be served at all state dinners. Today most cauliflower is grown in the U.S., France, Italy, India, and China.

As the vegetable grows, the curd, or compact flowering head, must be blanched. This means the large green leaves must cover the head of the plant. The leaves prevent chlorophyll from developing so the head remains white. If the head is not covered, the curd becomes green or yellow. Newer varieties are becoming available with orange, purple, and green heads.

In doing my research I discovered the reason behind my childhood memory. Cauliflower contains high levels

of sulfur-containing compounds called glucosinolates. By utilizing shorter cooking times, the pungent odor can be minimized.

Cauliflower is considered a super food. It is a great source of vitamin C, fiber, vitamin K, and vital B-complex vitamins such as folate, B5, B6, B1, and B3. Minerals such as manganese, copper, iron, calcium, and potassium are also found in this vegetable. Phytochemicals and antioxidants which help prevent chronic diseases are found in cauliflower. On top of all these nutrients, cauliflower is low in fat, cholesterol, and calories.

The best ways to enjoy cauliflower is raw with dip or hummus, roasted, used in stir fry, mashed, or pulsed in a food processor to make cauliflower rice.

Ingredients

- 1 large head cauliflower (about 2-1/2 pounds), broken into florets
- 1 cup shredded Parmesan cheese, divided
- 1/3 cup heavy whipping cream or half-and-half cream
- 1 tablespoon butter
- 1/2 teaspoon pepper
- Minced fresh parsley, optional

Directions

Place 1 in. of water and cauliflower in a large saucepan; bring to a boil over high heat. Cook, covered, 10-12 minutes or until soft. Drain. Mash cauliflower to desired consistency. Stir in 1/2 cup cheese, cream, butter and pepper. Sprinkle with remaining cheese and, if desired, parsley.

- 6 tablespoons butter, cubed
- 4 ounces cooked ham, chopped
- 1 to 2 garlic cloves, minced
- 1 head cauliflower, broken into florets
- 1-1/2 cups heavy whipping cream
- 2 tablespoons all-purpose flour
- 1/4 teaspoon salt
- 1/4 teaspoon pepper
- Dash cayenne pepper
- 1-1/2 cups shredded Swiss cheese
- 2 to 3 tablespoons minced fresh parsley

Directions

Preheat broiler. Meanwhile, in a large skillet, heat butter over medium heat. Add ham and garlic; sauté for 2 minutes. Add cauliflower and cook just until crisp-tender. Combine cream and flour; stir into skillet and blend well. Add salt, pepper and cayenne pepper. Cook and stir until thickened and bubbly; cook and stir 1 minute longer. Pour into a 2-qt. baking dish. Sprinkle with cheese. Broil until lightly browned, 2-4 minutes. Sprinkle with parsley. Serve immediately.



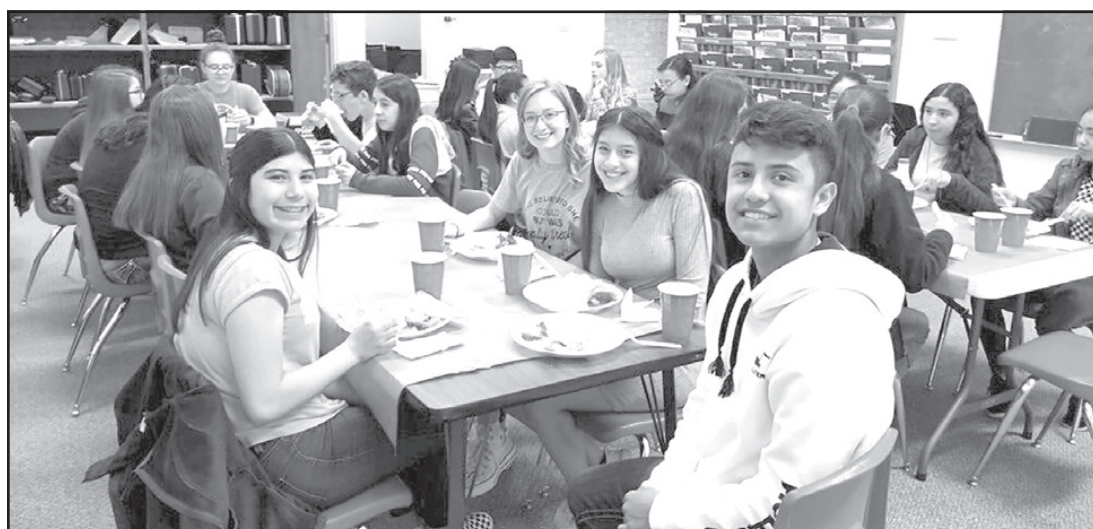

AGP Grain Marketing, LLC, 12700 West Dodge Road, Omaha, Nebraska 68154, which operates Lariat Flaking Facility, a steam flaking plant which makes corn flakes for cattle feed, has applied to the Texas Commission on Environmental Quality (TCEQ) for a renewal of TCEQ Permit No. WQ0004816000, which authorizes the discharge of water treatment wastes and boiler blowdown at a daily average flow not to exceed 12,000 gallons per day via evaporation ponds. This permit will not authorize a discharge of pollutants into water in the state. TCEQ received this application on August 30, 2018.

The facility and land application site are located at 770 County Road DD, Farwell, in Parmer County, Texas 79325 at the southeast corner of the intersection of Loop 403 and County Road DD. The facility and land application site are located in the drainage basin of the Double Mountain Fork Brazos River, in Segment No. 1241 of the Brazos River Basin.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, Executive Director's preliminary decision, and draft permit are available for viewing and copying at Parmer County Courthouse, 401 3rd Street, Farwell, Texas. PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ holds a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for submitting public comments, the Executive Director will consider the comments and prepare a response to all relevant and material, or significant public comments. **Unless the application is directly referred for a contested case hearing, the response to comments will be mailed to everyone who submitted public comments and to those persons who are on the**

mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the Executive Director's decision. A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period; and the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting. The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. **If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period. TCEQ may act on an application to renew a permit for discharge of wastewater without providing an opportunity for a contested case hearing if certain criteria are met.**

EXECUTIVE DIRECTOR ACTION. The Executive Director may issue final approval of the application unless a timely contested case hearing request or request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the Executive Director will not issue final approval of the permit and will forward the application and request to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

MAILING LIST. If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and (2) the mailing list for a specific county. If you wish to be placed on the permanent or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.

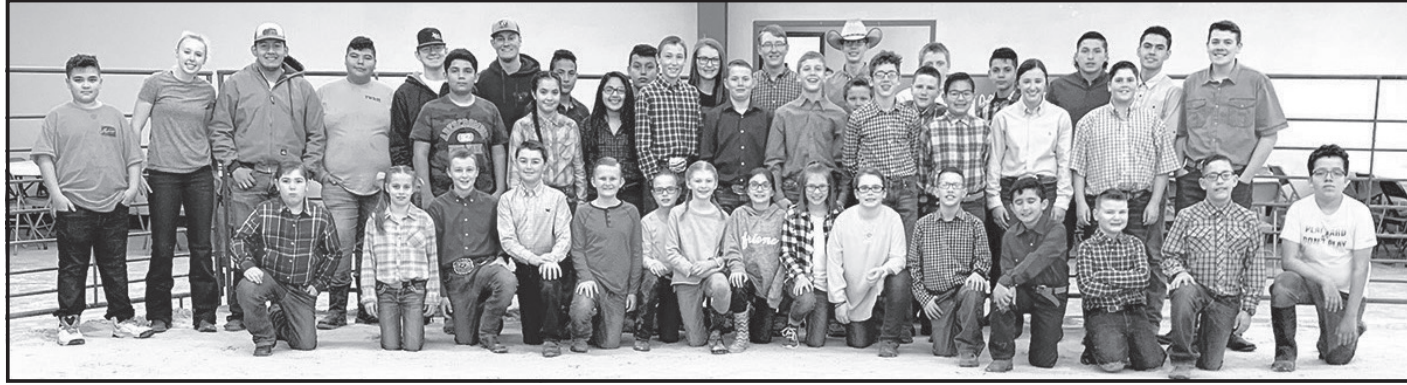

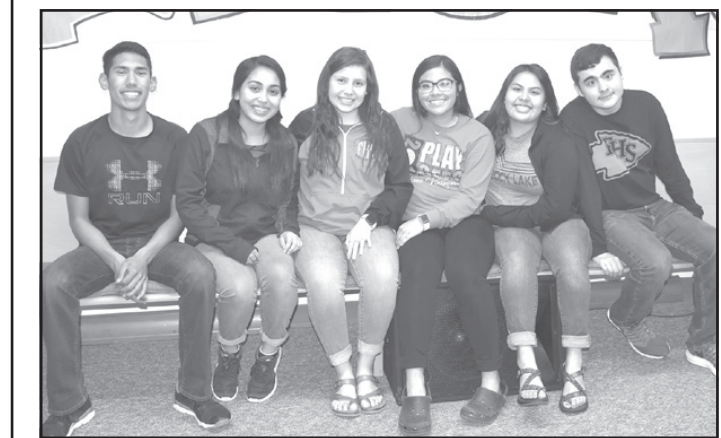

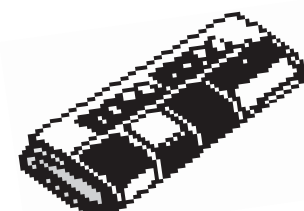
