## Red Devils Eye Shorthorn Barbecue

It's another super bowl night as far as the Red Devils are concerned — and the Marfa Shorthorns— when they meet at 7:30 Friday night in the Horn's home corral. Both are undefeated in district play and only the winner will have much hope of advancing to the big shoot out with what should be the district's only other undefeated team, the Iraan Braves.

All standings, "what ifs" and "wherefores" will account for little; however, Friday night, Marfa has traditionally been a compeditor that comes up with the unexpected and seems to always play well at home. In district statistics there is very little difference between Rankin and Marfa— Rankin having put 75 marks on the scoreboard in winning their two district encounters over Wink and Balmorhea, while Marfa is right behind with 66 points. On defense, it is even closer with Rankin having allowed only 12 points to

their opponents and Marfa only 13. Marfa holds wins over Clint and Wink in district standings.

For the season, Rankin, of course, has managed a 7-0 record, scoring 238 points to 53 while the Shorthorns are at 3-2-2; scoring 118 points and giving the opposition 121; however, a large portion of the points they have given up were to the very strong AA Alpine Bucks.

This will mark the seventh meeting of Rankin and Marfa on the gridiron with the Red Devils having a one-game edge— four wins to three for Marfa— and some of them have been wild affairs. Friday night, if the defensive records of both teams is any indication, will not be a run-away for either side.

In their first meeting in 1957, Marfa won 1-0 when Rankin had to give it up to the flu bug and cancelled out the game. Following is the record:

# The Scoop

**VOTING TIME —**

Next Tuesday is voting time again—the November 5 General Election. A sample of the ballot which will be voted is carried in this issue of The News.

Along about this time when an election comes up, we see and hear a lot about how all of us should "do our duty and go and vote—that it's a right and an obligation." I guess that is a legitimate reason for voting; although I've always felt that a person had an equal right not to vote if he so desired. Still, under the present laws of Texas, it's a good idea to take a few minutes and mark a ballot.

For one thing, if you put off voting in a primary or general election for as long as three years, you are not a qualified voter any longer—not only for primary and general elections,

but for all elections—school, city hospital, bond— whatever. The only way you can requalify is to go to the Tax Assessor's office and sign up as a voter all over again. It's a lot easier to go and vote a ballot.

Another thing that counts — especially in general elections— has to do with the number of voters who cast ballots in the governor's race. I think this has something to do with the number of delegates a state can send to a party's National Convention. The more people who turn out in Texas for next Tuesday's election, the more "pull" Texans will have when the conventions start putting together a party platform in '76 and in picking who will be the party's Presidential candidate.

Admittedly, there are few if any hot races in next Tuesday's election; yet, your vote will make a difference. So take a few minutes and go up and vote for somebody, particularly in the governor's race. It is important.

## AND AGAIN -

Well, how do you like living in a place where it rains every time you turn around? From the comments one hears, it's not all that popular with a lot of West Texans — even ranchers. As of now, Rankin's rainfall for the year is past the average for Nueces County, located down on the coast with Corpus Christi being the main city. Now I ask you, isn't that a little nutty?

As for the ranchers, it must be downright frustrating. Most of the time they would give an arm and a leg for some rain in West Texas. Now it has rained so much that the grass is full of water and sappy — doesn't have a lot of nutritional value for cattle and horses, and as for sheep, well, they're just not very well equipped by nature to eat long grass—they much prefer the short stuff, so I'm told.

In addition, many head of livestock have been lost to high water, miles of fences are gone and roads are in poor condition. Rusty Ratliff said he got his pickup stuck on a road that had been used in all sorts of weather for forty years—had to

walk off and leave his unit until it dried up some. And it's not just the ranchers who are having trouble with all this wet. It's bloody heck for those who work the oil patch. In many instances, it has been impossible to attend to wells—along rivers and big draws, a lot of tanks and other equipment have been washed out—and whole fleets of trucks for Halliburton and the Western Company have been stranded for several days at a time.

In the country below Sheffield, it is reported that several of the counties that try to maintain roads along the Pecos River have equipment stuck or bogged down—and have had for over a month now. And on top of it all, those of us who have fishing leases along the Pecos can't get to them most of the time—and the fish are biting like crazy. Some of us did make it to the river week-before-last and the entire area looked like it had been hit by an atomic bomb.

For fifty yards or so on either side of the river, not a living sprig was visible, not a tree had a leaf on it—many were just not there anymore; and miles of "fishing roads" were tinned into sand dunes and holes that could swallow a pickup.

But we've all known that too much of a good thing can be as bad as not enough and in the case of all this rain, I'm not sure but that it's worse. And if you will recall, it all started after Ford became President. Since he's the goat for everything else that goes wrong, might as well lay the blame for this on him, too.



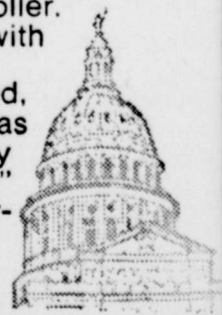

I've never fished in

with the exception of the size—  
as to the condition of football  
fields. They should. There is no  
excuse—considering the amount  
of money spent on athletics in  
Texas schools, to ever allow a  
bunch of boys to even attempt  
to play a football game on a  
field such as the one at Balmor-  
hea. Dirt is not all that expen-  
sive and any field could be so  
constructed as to at least drain  
from the center to the outside—  
not into the middle.

And that wasn't mud those

boys were playing in Friday. It  
was slime. I'll bet a million  
mosquitoes were mashed, tramp-  
led, squished or otherwise mutu-  
lated by the two teams. In fact,  
I believe that was why Fitzhugh  
had such a poor night passing.  
He was throwing the ball so  
hard the skeeters couldn't get  
out of the way and it was bounc-  
ing off some of the really big  
ones.

And oddly enough, it is said  
that when the field is dry, it's  
worse. The ground cracks open  
and players get their cleets  
hung in the cracks. I'm sure  
that Balmorhea Schools are  
hard pressed to have enough

money for operations; but it  
would seem that community  
pride would demand that some  
effort be made to improve the  
school's field. That's without  
even mentioning a lighting sys-

### OBSERVATION —

In connection with football,

eat it up every time that Good  
Ole Red Devil Band whips it on,  
and they can really hack it.  
If you have ever had occasion  
to stand with the fence riders at  
a Rankin game, you might  
note their reactions. Most of the  
time, especially during the half  
time, they are gabbing and visit-  
ing with one another—until the  
band strikes up "The Rose".  
That's about the only thing that  
gets the fence riders' full at-  
tention. I don't know why is that  
way. It just is.

Still another observation: that  
was the first ball game I ever

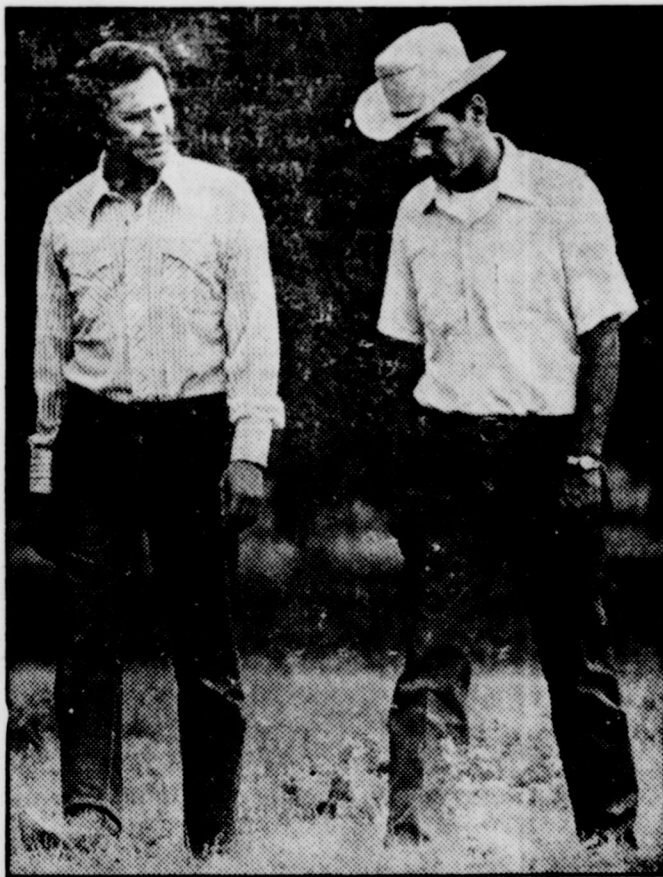

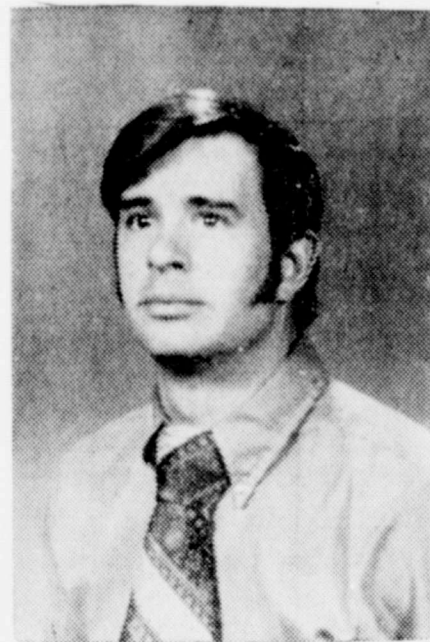

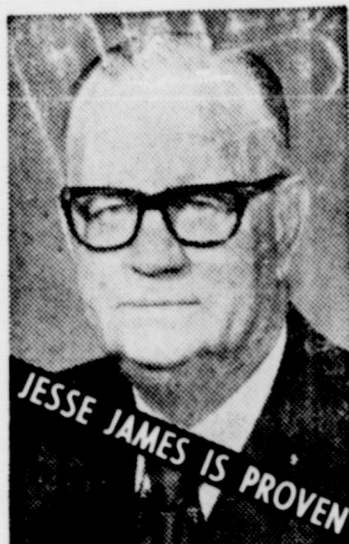
